

#### STANDARD SPECIFICATIONS

The City of Madison's Standard Specifications for Public Works Construction - 2013 Edition, as supplemented and amended from time to time, forms a part of these contract documents as if attached hereto.

These standard specifications are available on the City of Madison Public Works website, [www.cityofmadison.com/Business/PW/specs.cfm](http://www.cityofmadison.com/Business/PW/specs.cfm).

The Contractor shall review these Specifications prior to preparation of proposals for the work to be done under this contract, with specific attention to Article 102, "BIDDING REQUIREMENTS AND CONDITIONS" and Article 103, "AWARD AND EXECUTION OF THE CONTRACT." For the convenience of the bidder, below are highlights of three subsections of the specifications.

#### SECTION 102.1: PRE-QUALIFICATION OF BIDDERS

In accordance with Wisconsin State Statutes 66.0901 (2) and (3), all bidders must submit to the Board of Public Works proof of responsibility on forms furnished by the City. The City requires that all bidders be qualified on a biennial basis.

Bidders must present satisfactory evidence that they have been regularly engaged in the type of work specified herein and they are fully prepared with necessary capital, materials, machinery and supervisory personnel to conduct the work to be contracted for to the satisfaction of the City. All bidders must be pre-qualified by the Board of Public Works for the type of construction on which they are bidding prior to the opening of the bid.

In accordance with Section 39.02(9)(a)l. of the General Ordinances, all bidders shall submit in writing to the Affirmative Action Division Manager of the City of Madison, a Certificate of Compliance or an Affirmative Action Plan at the same time or prior to the submission of the proof of responsibility forms.

The bidder shall be disqualified if the bidder fails to or refuses to, prior to opening of the bid, submit a Certificate of compliance, Affirmative Action Plan or Affirmative Action Data Update, as applicable, as defined by Section 39.02 of the General Ordinances (entitled Affirmative Action) and as required by Section 102.11 of the Standard Specifications.

#### SECTION 102.4 PROPOSAL

No bid will be accepted that does not contain an adequate or reasonable price for each and every item named in the Schedule of Unit Prices.

A lump sum bid for the work in accordance with the plans and specifications is required. The lump sum bid must be the same as the total amounts bid for the various items and it shall be inserted in the space provided.

All papers bound with or attached to the proposal form are considered a part thereof and must not be detached or altered when the proposal is submitted. The plans, specifications and other documents designated in the proposal form will be considered a part of the proposal whether attached or not.

A proposal submitted by an individual shall be signed by the bidder or by a duly authorized agent. A proposal submitted by a partnership shall be signed by a member/partner or by a duly authorized agent thereof. A proposal submitted by a corporation shall be signed by an authorized officer or duly authorized registered agent of such corporation, and the proposal shall show the name of the State under the laws of which such corporation was chartered. The required signatures shall in all cases appear in the space provided thereof on the proposal.

Each proposal shall be placed, together with the proposal guaranty, in a sealed envelope, so marked as to indicate name of project, the contract number or option to which it applies, and the name and address of the Contractor or submitted electronically through Bid Express ([www.bidexpress.com](http://www.bidexpress.com)). Proposals will be accepted at the location, the time and the date designated in the advertisement. Proposals received after the time and date designated will be returned to the bidder unopened.

The Bidder shall execute the Disclosure of Ownership form. REFER TO SECTION F.

#### SECTION 102.5: BID DEPOSIT (PROPOSAL GUARANTY)

All bids, sealed or electronic, must be accompanied with a Bid Bond equal to at least 5% of the bid or a Certificate of Annual/Biennial Bid Bond or certified check, payable to the City Treasurer. Bid deposit of the successful bidders shall be returned within forty-eight (48) hours following execution of the contract and bond as required.

## SECTION D: SPECIAL PROVISIONS

### HOYT PARK FENCE REPLACEMENTS CONTRACT NO. 7150

It is the intent of these Special Provisions to set forth the final contractual intent as to the matter involved and shall prevail over the Standard Specifications and plans whenever in conflict therewith. In order that comparisons between the Special Provisions can be readily made, the numbering system for the Special Provisions is equivalent to that of the Specifications.

Whenever in these Specifications the term "Standard Specifications" appears, it shall be taken to refer to the City of Madison Standard Specifications for Public Works Construction and Supplements thereto.

#### **SECTION 102.10: MINIMUM RATE OF WAGE SCALE**

For this project, payment of prevailing wages (white sheet) is not required if either: a single trade accounts for 85% or more of the total labor costs of the project and the bid is less than \$48,000; or no single trade accounts for 85% or more of the total labor costs of the project and the bid is less than \$100,000. For bids not meeting either of these conditions, prevailing wages shall be required.

If required, the wages and benefits paid on the contract shall not be less than those specified in the Prevailing Wage Determination included with these contract documents for the following types of work:

- Building and Heavy Construction
- Sewer, Water, and Tunnel Construction
- Local Street and Miscellaneous Paving Operations
- Residential and Agricultural Construction

All bidders are notified that all labor employed on City contracts must be paid in accordance with the minimum rate of wage scale included in the Contract Documents.

For the information of the employees working on the project, a copy of the wage scale included in the contract documents and the provisions of Section 66.0903(8) of the Wisconsin Statutes shall be kept posted by the employer and in at least one conspicuous and easily accessible place at the site of the project.

The Contractor shall keep weekly payroll records setting forth the name, address, telephone number, classification, wage rate and fringe benefit package of each employee who worked on such City project and all other projects the employee worked in the same period, and the Contractor must keep records of the individual time each employee worked on the project and for each day of the project. Records shall include employee demographics or contractor can submit a one-time report of all employee demographics that can be matched up with weekly payrolls. Reports shall only include last four social security digits. Such records shall also set forth the total number of hours of overtime credited to each such employee for each day and week and the amount of overtime pay received in that week. Such records shall, in addition, set forth the full weekly wages earned by each such employee and the actual hourly wage paid to that employee. The Contractor shall submit payroll records to the Engineer every week for those periods when work is being done on the project. Said submittal shall be within twenty-one (21) calendar days of the end of the Contractor's weekly pay period.

The Contractor shall ensure that employees shall be paid unconditionally and shall receive the full amounts accrued at the time of payment, computed at rates not less than those stated in the City of Madison "Minimum Rate of Wage Scale" and that each employee's rate shall be determined by the work that is done within the trade or occupation classification which should be properly assigned to such employee. Questions regarding an employee's classification or rate of pay within that classification, shall be resolved by the practice that predominates in the industry and on which the trade or occupation rate/classification is based. Therefore, rate of pay, classification and work jurisdiction disputes shall be

resolved by relying upon practices established by collective bargaining agreements and guidelines used in such determinations by appropriate recognized trade unions operating within the City of Madison.

The Contractor shall agree that the normal rate of wage paid to the Contractor's employees on other projects shall not be reduced or otherwise diminished as a result of the requirement to pay no less than the minimum rate of wage scale on a City project. Mulcting of employees on City projects by contractors, such as by kickbacks or other such devices, is prohibited.

These contract provisions shall apply to all work performed on the contract by the Contractor with its own organization and with assistance of laborers under its immediate superintendency and to all work performed by piecework or by subcontract. No laborer, worker, or mechanic shall be employed directly upon the site of the work except on a wage basis, but this shall not be construed to prohibit the rental of equipment from individuals.

In the event of a refusal by the Contractor to submit payroll records as required by the contract, the City of Madison shall have the option to cancel this contract and request the Surety to perform or to re-let the balance of the work for bids, and in that event, to charge the Contractor for any loss which the City may incur thereby.

#### **SECTION 102.12: BEST VALUE CONTRACTING**

This Contract shall be considered a Best Value Contract if the Contractor's bid is equal to or greater than \$53,000 for a single trade contract; or equal to or greater than \$257,500 for a multi-trade contract pursuant to MGO 33.07(7).

#### **SECTION 104 SCOPE OF WORK**

This Contract is for repairs to the existing chain link fence at Hoyt Park. The existing fence includes a variety of types and heights of posts and chain link fabric through both public and private property. This project involves repairing the fence only on public Hoyt Park property as identified in the plans and special provisions of this contract.

The goal of this project is to install a consistent 6' ht. tensile wire chain link fabric along the entire fence, except from posts #007 through #068 which shall involve replacement of the existing 8' ht chain link fabric with top rail.

Fabric will be installed on existing posts, except posts #316 through #331; these posts are only 5.5' ht. and need to be replaced with 6' ht posts.

This contract also includes tree removal necessary to make repairs to the fence, and in order to limit damage of the new fence fabric from existing vegetation.

#### **SECTION 105.1: AUTHORITY OF THE ENGINEER**

The Engineer shall resolve all questions which arise as to the quality and acceptability of materials furnished, work performed, manner of performance, rate of progress of the work, interpretation of the plans and Specifications, acceptable fulfillment of the contract, compensation, and disputes and mutual rights between Contractors under the Specifications. The Engineer shall determine the amount and quantity of work performed and materials furnished.

All decisions of the Engineer shall, when so requested, be rendered in writing. They shall be final and conclusive in all matters unless within ten (10) days after such decision the Contractor applies in writing to the Board of Public Works for a review of such decision.

Any change proposed by a Contractor in SBE subcontractors, vendors or suppliers from those SBEs indicated on the SBE Compliance Report must be approved by the Engineer and the City's Manager of the Affirmative Action Division (hereafter, AAD). When requested, such decision shall be rendered in

writing. Such decisions shall be final and conclusive in all matters unless within ten (10) days after such decision the Contractor or the affected SBE applies in writing to the Board of Public Works for a review of such decision.

In the event the Engineer and the AAD disagree over the proper decision to be made regarding an SBE, the Mayor shall appoint a third person to resolve the disagreement, within 30 days of appointment. The decision thus rendered may be reviewed by the Board of Public Works upon request of the Contractor or the affected SBE as set forth in Sections 105.1 and 105.2 of the City's standard specifications.

**SECTION 105.9: SURVEYS, POINTS, AND INSTRUCTION**

The City of Madison will be responsible for delineating the property line of Hoyt Park for the Contractor's reference at locations where the fence borders private and City of Madison Hoyt Park property. Any questions regarding surveying of this project should be directed to Sarah Lerner at the Parks Division at 261-4281.

**SECTION 105.12: COOPERATION BY CONTRACTOR**

The Contractor shall perform a One Call through Digger's Hotline at least three days prior to beginning construction.

The Contractor shall secure materials at the end of each work day to deter any potential vandalism and theft.

A pre-construction meeting will be required prior to the start of construction.

The Contractor warrants that its services are performed, within the limits prescribed by the City, with the usual thoroughness and competence of the consulting profession; in accordance with the standard for professional services at the time those services are rendered. The Contractor shall be responsible for the accuracy of the work performed under this Agreement, and shall promptly make necessary revisions or corrections resulting from their negligent acts, errors or omissions without additional compensation. The Contractor shall be responsible for any damages incurred as a result of their errors, omissions, or negligent acts and for any losses or costs to repair or remedy construction.

**SECTION 109.2: PROSECUTION OF THE WORK**

Construction work must begin within seven (7) calendar days after the date appearing on the mailed notice that was sent to the Contractor. Construction work shall be carried on at a rate so as to secure full completion within the contract times outlined in Section 109.7, the rate of progress and the time of completion being essential conditions of this Agreement.

The fixed, agreed upon, liquidated damages for failure to complete all work within the contract, unless otherwise specified in this section, shall be calculated in accordance with Article 109 of the Standard Specifications. The Contractor shall limit workdays from 7:00 am to 7:00 pm, unless approved by the Engineer in writing.

**SECTION 109.7: TIME OF COMPLETION**

Work cannot start on this contract until after the "Start to Work" letter has been received. Work on the Hoyt Park Fence Replacements will start on or around 10/01/13 and must be completed by 11/30/2013.

## **BID ITEM 10911- MOBILIZATION**

### **DESCRIPTION**

Work under this item shall include all costs associated with mobilization of the Contractor to the site. Parking of equipment, storage of materials, and staging shall be allowed in the Hoyt Park parking lot and Overlook as shown on the plans as "Construction Staging Area"

**The Contractor shall note that access to this site is difficult and may require additional clearing not identified in this Contract. The Contractor is required to visit this site prior to bidding, and to include any additional clearing needed for construction access in this bid item.**

**The Contractor shall also note that several areas of the park have been restored with native plants. The Contractor will NOT have construction access through areas that have been planted with native plants; these areas are identified on the plans.**

**The Contractor must submit a construction access plan subject to approval by the Engineer at least 10 days prior to the start of construction. This plan must show proposed construction routes, phasing of construction, staging areas, additional areas to be cleared for construction access, and construction vehicles planned for construction routes.**

**The Contractor must limit equipment to small vehicles subject to the approval of the Engineer prior to construction.**

### **METHOD OF MEASUREMENT**

Mobilization shall be paid as a lump sum.

### **BASIS OF PAYMENT**

Mobilization shall be measured as described above which shall be full payment for all work as described above.

## **BID ITEM 20405–CLEARING AND TREATING**

### **DESCRIPTION**

Clearing and Treating shall be consistent with the requirements of Article 204 of the City of Madison Standard Specifications for Public Works Construction, and as described below:

All invasive shrubs within 5' of the fence on City of Madison property shall be cleared and treated with herbicide with the exceptions noted below:

- Do not clear any vegetation along the existing fence from post #001 through #007
- Do not clear any vegetation along the existing fence from post #068 through #108; the fence is located on private property at this location.
- Do not clear any vegetation on the western side of the existing fence between posts #113 through #160 except for removal of trees that are growing in the existing fence and that have been identified below in this bid item
- Do not clear the north side of the existing fence between post #165 through #282

Absolutely no vegetation shall be removed on private property, with the exception of trees and branches on Lot 1 that have been identified for removal in this bid item (between post #007 and #068).

The Contractor shall remove all dead branches that have fallen on the fence.

The Contractor shall be responsible for offsite disposal of trees, shrubs, brush and for removing and disposing, off site, of stumps, logs, windfalls and any other vegetation to be cleared. All material shall be disposed of offsite at a location to be determined and provided by the Contractor.

**Per City of Madison General Ordinance Section 23.40(7) the Contractor must secure written permission from the City Forester for approval to remove, prune or trim oak trees prior to October 15<sup>th</sup>.**

For the Contractor's reference, L-6 through L-12 provides a detailed inventory of existing fence type, poles, and trees along the existing fence.

Prior to application, the Contractor must submit herbicide application product information to the Engineer for approval. The Contractor must also furnish the Engineer with product labeling and material safety data sheets for each product applied and documentation of applicator certification and conformance with other Federal and State laws. The Contractor must contact Russ Hefty, Conservation Resource Supervisor at 267-4918 at least 48 hours prior to herbicide application to inform the Conservation Resource Supervisor the date and time the Contractor will be applying herbicide.

The Contractor must provide, at a minimum, readily visible posting for a period of 24 hours prior to a pesticide application (when possible) and a minimum of 48 hours following the application. These time intervals may be extended based on health or safety concerns.

Upon completion of the herbicide application, the Contractor must submit a completed pesticide application summary which shall include purpose of application, location, estimated size of total area managed, and amount of pesticide product applied including the amount of active ingredient.

The Contractor must inform the Engineer if there are any complaints received during the application including the date of complaint(s) and the nature of the complaint(s).

If the Contractor is found to be out of compliance with these herbicide application requirements, this non-compliance will be considered grounds for terminating an existing City contract with the Contractor and the Contractor will not be allowed enter into a contract with any City department for 1 year after the date that non-compliance was determined.

Any use of a pesticide under EPA Special Review is prohibited.

## **METHOD OF MEASUREMENT**

Clearing and Treating shall be measured by the lump sum for the completed work.

## **BASIS OF PAYMENT**

Clearing and Treating shall be measured as described above and shall be paid for at the contract unit price which shall be full compensation for all work, materials, tools, equipment, labor, hauling, placement, disposal and incidentals required to complete the work as described above.

## **BID ITEM 90001 - REMOVE EXISTING POST**

### **DESCRIPTION**

Work under this item shall include all work, materials, labor, and incidentals required to remove existing posts bracing, footings and incidental hardware from posts #316 through #331. All other posts will be reused.

Removal of existing footings and incidental hardware is incidental to this bid item.

Installation of new 6' Ht. posts shall be paid for under BID ITEM 90002 - INSTALL 6' HT. POST.

Removed posts and associated debris shall be disposed offsite at a location to be determined and provided by the Contractor at no extra cost to the City.

For the Contractor's reference, L-6 through L-12 provides a detailed inventory of existing fence type, poles, and trees along the existing fence.

#### **METHOD OF MEASUREMENT**

Remove Existing Post shall be measured per individual post for the completed work as described above.

#### **BASIS OF PAYMENT**

Remove Existing Post shall be measured as described above and shall be paid for at the contract unit price which shall be full compensation for all work, materials, tools, equipment, labor, hauling, placement, disposal and incidentals required to complete the work as described above.

#### **BID ITEM 90002 - INSTALL 6' HT. POST**

##### **DESCRIPTION**

Work under this item shall include all work, materials, labor, and incidentals required to install 6' ht. posts, anchoring, bracing and footings at post #316 through #331.

Post construction shall conform to the special provisions outlined in this bid item.

##### **Fence Post Materials**

All metal materials, except high strength steel posts, rails and braces, and ground rods must comply with AASHTO M181, and the following:

- a. Use type I zinc-coated steel or type II aluminum-coated steel tension wire.
- b. Use type II aluminum-coated steel fence fabric.
- c. Use type I zinc-coated steel posts, rails, and frames.
- d. Use type I zinc-coated steel, cast iron, or malleable iron hardware and fittings.
- e. Do not use AASHTO grade 2 steel posts, rails, or frames.

Ensure that hot-dipped coatings are applied to rolled sections after rolling. The contractor may substitute zinc-5 percent aluminum-misch metal alloy for hot-dipped zinc as allowed under AASHTO M181. Unless specified otherwise, furnish the same type of material for all fence fabric required under the contract. Make all posts, hardware, and fittings used on the contract the same kind, unless specified otherwise.

##### **Posts**

Use posts of the type, size, and length the plans show. Conform to ASTM F1043 and use one of the following:

- a. Group IA or group IC round steel pipe with a type A coating.
- b. Group IIA roll-formed steel C-sections with a type A coating.
- c. Group III hot rolled H beams with a type A coating.

##### **Post Tops**

Fit all posts, except roll formed terminal posts, with ornamental tops of the type shown on sheet L-5, CHAIN LINK FENCE DETAIL. Ensure ornamental tops are of department-approved design, made of metal, have a flanged base that fits snugly over top and around outside of post, and is securely fastened in place. Provide the base of each line post top with an opening for passage and support of the top tension wire.

##### **Bracing**

Use brace rail of the type, size, and weight the plans show for horizontal and diagonal bracing. Conform to ASTM F1043 and use one of the following:

- a. Group IA round steel pipe with a type A coating.
- b. Group IIA roll-formed steel C-sections with a type A or C coating.

Make horizontal and diagonal pipe, or roll formed braces and diagonal truss rods extend from all terminal, corner, intersection, or intermediate braced posts to the first adjacent line post, and fasten them securely to the posts with suitable connectors. Use zinc coated 3/8 inch round steel rods equipped with a threaded take-up adapter for diagonal truss rods.

#### Pipe Fittings

Use malleable iron, cast iron, or pressed steel pipe fittings.

#### Construction

Remove and dispose of all trees, brush, logs, stumps, or other debris that might interfere with fence construction as identified in BID ITEM 20405 – CLEARING AND TREATING.

Excavate minor ridges and humps in the ground surface, necessary to correctly erect the fence.

Erect the fence using existing posts at the existing fence location. Where the Engineer directs or allows the contractor to leave trees on the fence line, deviate the fence line past the tree as the plans show.

Before final acceptance, remove and dispose of all excess excavation and surplus materials from the fence site.

#### Chain Link Fence

Erect chain link fencing fabric, of the required height, attached at the top and bottom to a tension wire, on driven unbraced metal line posts.

#### Setting Posts and Anchors

Set or drive posts, in a vertical position, at the required location and alignment, and at as uniform spacing as local conditions allow. Space posts, center to center, according to the following situations as follows:

- a. On a tangent or on a curve of 500 feet or more radius; space posts at no more than 10 feet.
- b. On a curve of from 200 feet to 500 feet radius, space posts at no more than 8 feet.
- c. On a curve of from 100 feet to 200 feet radius, space posts at no more than 6 feet.
- d. On a curve of less than 100 feet radius, space posts at no more than 5 feet.

Set or drive posts, with their tops at the required elevation to provide a smooth profile at the top wire without abrupt changes. Conform to the general contour of the terrain.

Place an end post with anchor (or attach anchor bracing to existing post) at each end of each run of fence. Place a corner post and anchor at breaks of 30 degrees or more in the horizontal alignment. Set an intersection post in line with an intersecting chain link fence, and brace with the adjacent post of the intersecting fence.

Place an intermediate braced post if there is over a 5 degrees change in the vertical alignment or a change in the fence line grade of greater than 9 percent that results in wire uplift on the post.

Coat the portion of aluminum-coated posts to be set in concrete with a uniform, thin application of asphaltic or other engineer-approved material. Ensure this coating is firmly set before placing the posts.

Set the end, corner, angle, intersection, and intermediate braced posts in concrete footings or anchors as shown in the CHAIN LINK FENCE DETAIL.

Ensure the top of the concrete footing is approximately 6 inches below the ground line and slopes slightly away from the post. Locate the footing to allow centering of the post. Backfill the top of the footing with topsoil or other suitable material.

In firm ground, excavate holes for the footings to the neat dimensions and place concrete directly in the excavation. Remove rock or other obstructions encountered in the excavation to the required depth.

If unstable soils or other areas prevent making footing excavations to neat dimensions, use forms. Keep the form in place until the concrete cures for at least 24 hours. After removing the form, backfill the footing with suitable material. Ensure the backfill material has the correct moisture content for compacting and place and compact in layers.

Set the posts, anchor the braces in place, and wait at least 7 days before placing the top and bottom tension wires.

Place an intermediate braced post with anchor midway between end posts and corner posts if the fence run is more than 1000 feet, but not more than 2000 feet. For fence runs greater than 2000 feet, make the maximum spacing of intermediate braced posts 1000 feet.

Set in concrete or drive unbraced line posts, provided the contractor drives them plumb, to the required depth and alignment, and with adequate lateral stability. Remove and replace any post that fails to conform to the above requirements, or that the contractor damages during driving, with an undamaged post. In unstable soils, increase the length of driven posts by multiples of 2 feet, as the engineer directs, to increase the stability of the post.

Install electrical grounds at locations where primary electrical transmission or distribution lines, other than secondary feeder lines for individual service, cross the fence. Install one ground rod along the fence at the point of crossing and one 25 to 50 feet in each direction from the crossing.

Install additional ground rods in each fence spaced approximately every 500 feet. Install at least one ground rod on each electrically isolated section of fence, defined as a run with no interruptions in electrical continuity.

Removal of these posts shall be paid for under BID ITEM 90001 – REMOVE EXISTING POST.

For the Contractor's reference, L-6 through L-12 provides a detailed inventory of existing fence type, poles, and trees along the existing fence.

## **METHOD OF MEASUREMENT**

Install 6' Ht. Post shall be measured per each individual post for the completed work as described above.

## **BASIS OF PAYMENT**

Install 6' Ht. Post shall be measured as described above and shall be paid for at the contract unit price which shall be full compensation for all work, materials, tools, equipment, labor, hauling, placement, disposal and incidentals required to complete the work as described above.

## **BID ITEM 90003 - REMOVE EXISTING FABRIC AND INCIDENTAL HARDWARE**

### **DESCRIPTION**

Work under this item shall include all work, materials, labor, and incidentals required to remove all existing fabric, brackets, top rails, tension wire and other incidental fencing hardware from post #007 through #068 and post #109 through #332. If it is determined after clearing that some sections of fence do not need to be replaced, this bid item quantity will be reduced.

The Contractor shall contact the Engineer prior to fence removal to review the condition of the existing fence prior to removing fabric. If the Engineer determines that sections of fence do not need to be replaced, this bid item quantity will be reduced.

Do not replace the existing fence fabric from post #068 through #108; the fence is located on private property at this location.

Do not remove wire mesh fence between post #112 and #113. The wire mesh shall be preserved to allow animals to pass through this section of fence.

Remove 5' section of existing wire mesh perpendicular to fence line near post #127.

This bid item includes removing the gate located between post #288 and #289.

Removed fabric and incidental hardware shall be disposed offsite at a location to be determined and provided by the Contractor at no extra cost to the City.

For the Contractor's reference, L-6 through L-12 provides a detailed inventory of existing fence type, poles, and trees along the existing fence.

### **METHOD OF MEASUREMENT**

Remove Existing Fabric and Incidental Hardware shall be measured by linear foot for the completed work as described above.

### **BASIS OF PAYMENT**

Remove Existing Fabric and Incidental Hardware shall be measured as described above and shall be paid for at the contract unit price which shall be full compensation for all work, materials, tools, equipment, labor, hauling, placement, disposal and incidentals required to complete the work as described above.

### **BID ITEM 90004 - 6' HT. CHAIN LINK FABRIC AND INCIDENTAL HARDWARE**

#### **DESCRIPTION**

Work under this item shall include all work, materials, labor, and incidentals required to install a 6' ht. chain link fabric and incidental hardware as shown on sheet L-5, CHAIN LINK FENCE DETAIL and outlined in these special provisions. Installation of all chain link fabric and incidental hardware including post tops/caps, bracing, footings, fittings, tension bars, anchors, and electrical grounds shall be incidental to this bid item.

The Contractor shall contact the Engineer prior to fence removal to review the condition of the existing fence prior to removing fabric. If the Engineer determines that sections of fence do not need to be replaced, this bid item quantity will be reduced.

Between post #046 and #047 chain link fence fabric shall be a min. of 5" above the ground elevation to allow wildlife to pass through this section of fence.

Do not replace chain link fence between post #112 and #113. There is wire mesh at this location, this wire mesh should be preserved to allow animals to pass through fence.

Posts #138 through #156 are square H posts with no post cap. A loop post cap shall be installed on these posts to accommodate the tensile wire shown in Sheet L-5, CHAIN LINK FENCE DETAIL.

Between post #288 and #289 is an existing gate over a swale. The gate shall be removed and replaced with 6' Ht. chain link fabric as described in this bid item. The Contractor shall extend the chain link fence fabric to within 5" of edge of the ground.

#### **Chain Link Fence Materials**

Furnish new material for all parts. The City will not allow used, re-rolled, or open seam material in posts, rails, and braces.

All metal materials, except high strength steel posts, rails and braces, and ground rods must comply with AASHTO M181, and the following:

- f. Use type I zinc-coated steel or type II aluminum-coated steel tension wire.
- g. Use type II aluminum-coated steel fence fabric.
- h. Use type I zinc-coated steel posts, rails, and frames.
- i. Use type I zinc-coated steel, cast iron, or malleable iron hardware and fittings.
- j. Do not use AASHTO grade 2 steel posts, rails, or frames.

Ensure that hot-dipped coatings are applied to rolled sections after rolling. The contractor may substitute zinc-5 percent aluminum-misch metal alloy for hot-dipped zinc as allowed under AASHTO M181. Unless specified otherwise, furnish the same type of material for all fence fabric required under the contract. Make all posts, hardware, and fittings used on the contract the same kind, unless specified otherwise.

#### Fence Fabric

Use fence fabric woven of 9-gauge wire in 2-inch diamond pattern mesh with both the top and bottom selvages knuckled. Ensure the furnished fence fabric is the same nominal height as the designated fence height.

#### Post Tops

Fit all posts, except roll formed terminal posts, with ornamental tops of the type shown in the CHAIN LINK FENCE DETAIL. Ensure ornamental tops are of department-approved design, made of metal, have a flanged base that fits snugly over top and around outside of post, and is securely fastened in place. Provide the base of each line post top with an opening for passage and support of the top tension wire.

#### Bracing

Use brace rail of the type, size, and weight the plans show for horizontal and diagonal bracing. Conform to ASTM F1043 and use one of the following:

- c. Group IA round steel pipe with a type A coating.
- d. Group IIA roll-formed steel C-sections with a type A or C coating.

Make horizontal and diagonal pipe, or roll formed braces and diagonal truss rods extend from all terminal, corner, intersection, or intermediate braced posts to the first adjacent line post, and fasten them securely to the posts with suitable connectors. Use zinc coated 3/8 inch round steel rods equipped with a threaded take-up adapter for diagonal truss rods.

#### Pipe Fittings

Use malleable iron, cast iron, or pressed steel pipe fittings.

#### Fabric Fasteners

Use clips made of 9-gauge zinc coated steel or 0.179-inch diameter aluminum tie wires as fasteners for securing the fence fabric to H column line posts. Use 9-gauge zinc coated steel or 0.179-inch diameter aluminum tie wires as fasteners for securing the fence to posts or top tension wires and braces. Use tie wires not smaller than 12-gauge zinc coated steel, or 0.149-inch diameter aluminum wire, as fasteners for securing to bottom tension wires.

#### Tension Bars

Use zinc-coated flat mild or rail steel of the required length.

#### Construction

Remove and dispose of all trees, brush, logs, stumps, or other debris that might interfere with fence construction as identified in BID ITEM 20405 – CLEARING AND TREATING.

Excavate minor ridges and humps in the ground surface, necessary to correctly erect the fence.

Erect the fence using existing posts at the existing fence location. Where the engineer directs or allows the contractor to leave trees on the fence line, deviate the fence line past the tree as the plans show.

Before final acceptance, remove and dispose of all excess excavation and surplus materials from the fence site.

#### Chain Link Fence

Erect chain link fencing fabric, of the required height, attached at the top and bottom to a tension wire, on driven unbraced metal line posts.

#### Setting Posts and Anchors

Attach anchor bracing to existing post at each end of each run of fence. Place a corner post and anchor at breaks of 30 degrees or more in the horizontal alignment. Set an intersection post in line with an intersecting chain link fence, and brace with the adjacent post of the intersecting fence.

Place an intermediate braced post if there is over a 5 degrees change in the vertical alignment or a change in the fence line grade of greater than 9 percent that results in wire uplift on the post.

Coat the portion of aluminum-coated posts to be set in concrete with a uniform, thin application of asphaltic or other engineer-approved material. Ensure this coating is firmly set before placing the posts.

Set the end, corner, angle, intersection, and intermediate braced posts in concrete footings or anchors as shown in the CHAIN LINK FENCE DETAIL.

Ensure the top of the concrete footing is approximately 6 inches below the ground line and slopes slightly away from the post. Locate the footing to allow centering of the post. Backfill the top of the footing with topsoil or other suitable material.

In firm ground, excavate holes for the footings to the neat dimensions and place concrete directly in the excavation. Remove rock or other obstructions encountered in the excavation to the required depth.

If unstable soils or other areas prevent making footing excavations to neat dimensions, use forms. Keep the form in place until the concrete cures for at least 24 hours. After removing the form, backfill the footing with suitable material. Ensure the backfill material has the correct moisture content for compacting and place and compact in layers.

Set the posts, anchor the braces in place, and wait at least 7 days before placing the top and bottom tension wires.

Set in concrete or drive unbraced line posts, provided the contractor drives them plumb, to the required depth and alignment, and with adequate lateral stability. Remove and replace any post that fails to conform to the above requirements, or that the contractor damages during driving, with an undamaged post. In unstable soils, increase the length of driven posts by multiples of 2 feet, as the engineer directs, to increase the stability of the post.

#### Erecting Fence Fabric

Place, tension, and secure the top and bottom tension wires before erecting the fence fabric. Anchor the tension wires securely to each end, corner, intersection, or intermediate braced post. Fasten the tension wires to each line post.

Attach the end of the fabric to the post with a tension bar threaded through the end loops of the fabric and secured to the post with clamps and bolt. Stretch the fabric with engineer-approved stretching equipment to remove all slack. Secure the stretched fabric to line posts, braces, and tension wires with specified

fabric fasteners. Place fabric fasteners on line posts at no greater than 14 inch centers; and on braces and tension wires at no greater than 18 inch centers. Repeat stretching operations at approximately every 100 feet for each run of fence.

Splice fabric by interweaving a wire picket through each end loop of each piece of fabric. Ensure that the splice is neat and secure.

#### Electrical Grounds

Ground woven and high tensile wire fence. Use 1/2 inch minimum diameter zinc coated or copper clad steel rod at least 8 feet long, driven vertically into the ground along the fence line, near a post, until approximately 6 inches extends above the ground. Securely clamp, bolt, or braze at least 3 fence wires to the ground rod. Electrically ground barbed wire as the plans show.

Install electrical grounds at locations where primary electrical transmission or distribution lines, other than secondary feeder lines for individual service, cross the fence. Install one ground rod along the fence at the point of crossing and one 25 to 50 feet in each direction from the crossing.

Install additional ground rods in each fence spaced approximately every 500 feet. Install at least one ground rod on each electrically isolated section of fence, defined as a run with no interruptions in electrical continuity.

For the Contractor's reference, L-6 through L-12 provides a detailed inventory of existing fence type, poles, and trees along the existing fence.

#### **METHOD OF MEASUREMENT**

6' Ht. Chain Link Fabric and Incidental Hardware shall be measured by linear foot for the completed work as described above.

#### **BASIS OF PAYMENT**

6' Ht. Chain Link Fabric and Incidental Hardware shall be measured as described above and shall be paid for at the contract unit price which shall be full compensation for all work, materials, tools, equipment, labor, hauling, placement, disposal and incidentals required to complete the work as described above.

#### **BID ITEM 90005 - 8' HT. CHAIN LINK FABRIC AND INCIDENTAL HARDWARE**

#### **DESCRIPTION**

Work under this item shall include all work, materials, labor, and incidentals required to install 8' Ht. chain link fabric and associated top rail, bottom brace, tension wire and fabric connections on existing posts #007 through #068.

The Contractor shall contact the Engineer prior to fence removal to review the condition of the existing fence prior to removing fabric. If the Engineer determines that sections of fence do not need to be replaced, this bid item quantity will be reduced.

For the Contractor's reference, L-6 through L-12 provides a detailed inventory of existing fence type, poles, and trees along the existing fence.

All existing posts for 8' Ht. chain link fabric between post #007 and #068 shall be preserved. Top rail that is not damaged may be reused on site.

Chain link fence fabric between posts #046 through #047 shall be a minimum of 5" off of the ground to allow wildlife to pass through this section of fence.

## Materials

The chain link fabric between posts #007 through #068 shall be replaced in its entirety to meet the following specifications:

### Chain Link Fence Fabric Material

The total height of fence shall be 8' above grade when erected. The fence shall be chain link fence. The fabric shall be aluminized coated steel chain link 96" high, No. 9 gauge wire woven in 2" chain link mesh. Top and bottom selvages will be twisted. The aluminized fabric shall conform to ASTM designation A-491-63T in its entirety. The coating shall be a minimum of .40 ounces of aluminized 9 gauge fabric. The weight of coating shall be determined by mill certifications.

The Contractor is required to visit the site prior to bidding to determine what locations the top rail will need to be replaced, and where it can be salvaged. The top rail has been damaged throughout the years by falling limbs and trees. The Contractor is also required to determine whether replacement of the fabric will also require replacing the brace pipe, fabric connections, tension wire and entire top rail.

Replacement of top rail, fabric connections, and tension wire shall meet the following specifications:

Brace pipe shall be the same as top rail and shall be installed midway between the top rail and the ground and extend from the terminal post to the first adjacent line post. Braces shall be securely fastened to posts by heavy pressed steel and malleable fittings, then securely trussed from line post to base of terminal post with a 3/8" truss rod and tightener.

The top rail shall be 1 5/8" O.D. 2.27 pounds per foot minimum provided with couplings approximately every 20 feet. Couplings are to be outside sleeve type at least 7" long. The top rail is to pass through the line post tops and form a continuous brace from end to end of each stretch of fence. The top rail to be securely fastened to the terminal posts by heavy pressed steel brace bands and malleable rail connections. The Contractor is required to visit the site prior to bidding to determine how much of the top rail is damaged and needs replacing.

The bottom tension wire shall be No. 7 gauge aluminum coated spring coil or crimped wire with a minimum weight of aluminum coating of .40 ounces per square foot of wire surface. Tension wire shall be stretched taut from terminal to terminal post and securely fastened to each intermediate post. Tension wire shall be attached to the fence fabric with hot rings every 24 inches. There shall be approximately 1000 pounds of tension in the bottom tension wire between terminal posts.

The chain link fabric shall be securely fastened to all terminal posts using 3/16" x 3/4" tension bars and heavy 11 gauge tension bands. There shall be one (1) band for each foot in the height of the fence. The fabric shall be fastened to all intermediate posts with aluminum alloy band ties, spacing not to exceed 14 inches apart. Fabric shall be tied to top, center and bottom rail with aluminum alloy band ties. There shall be approximately 2000 pounds of tension in fabric between terminal posts.

Upon the completion of the installation all debris created by the installation shall be removed from the site.

## **METHOD OF MEASUREMENT**

8' Ht. Chain Link Fabric and Incidental Hardware shall be measured by linear foot for the completed work as described above.

## **BASIS OF PAYMENT**

8' Ht. ## SECTION H: AGREEMENT

THIS AGREEMENT made this \_\_\_\_\_ day of \_\_\_\_\_ in the year Two Thousand and Thirteen between \_\_\_\_\_ hereinafter called the Contractor, and the City of Madison, Wisconsin, hereinafter called the City.

WHEREAS, the Common Council of the said City of Madison under the provisions of a resolution adopted \_\_\_\_\_, and by virtue of authority vested in the said Council, has awarded to the Contractor the work of performing certain construction.

NOW, THEREFORE, the Contractor and the City, for the consideration hereinafter named, agree as follows:

1. **Scope of Work.** The Contractor shall, perform the construction, execution and completion of the following listed complete work or improvement in full compliance with the Plans, Specifications, Standard Specifications, Supplemental Specifications, Special Provisions and contract; perform all items of work covered or stipulated in the proposal; perform all altered or extra work; and shall furnish, unless otherwise provided in the contract, all materials, implements, machinery, equipment, tools, supplies, transportation, and labor necessary to the prosecution and completion of the work or improvements:

2. **Completion Date/Contract Time.** Construction work must begin within seven (7) calendar days after the date appearing on mailed written notice to do so shall have been sent to the Contractor and shall be carried on at a rate so as to secure full completion SEE SPECIAL PROVISIONS, the rate of progress and the time of completion being essential conditions of this Agreement.
3. **Contract Price.** The City shall pay to the Contractor at the times, in the manner and on the conditions set forth in said specifications, the sum of \_\_\_\_\_ (\$ \_\_\_\_\_) Dollars being the amount bid by such Contractor and which was awarded to him/her as provided by law.
4. **Wage Rates for Employees of Public Works Contractors**

**General and Authorization.** The Contractor shall compensate its employees at the prevailing wage rate in accordance with section 66.0903, Wis. Stats., DWD 290 of the Wisconsin Administrative Code and as hereinafter provided.

"Public Works" shall include building or work involving the erection, construction, remodeling, repairing or demolition of buildings, parking lots, highways, streets, bridges, sidewalks, street lighting, traffic signals, sanitary sewers, water mains and appurtenances, storm sewers, and the grading and landscaping of public lands.

"Building or work" includes construction activity as distinguished from manufacturing, furnishing of materials, or servicing and maintenance work, except for the delivery of mineral aggregate such as sand, gravel, bituminous asphaltic concrete or stone which is incorporated into the work under contract with the City by depositing the material directly in final place from transporting vehicle.

"Erection, construction, remodeling, repairing" means all types of work done on a particular building or work at the site thereof in the construction or development of the project, including without limitation, erecting, construction, remodeling, repairing, altering, painting, and decorating, the transporting of materials and supplies to or from the building or work done by the employees of the Contractor, Subcontractor, or Agent thereof, and the manufacturing or furnishing of materials, articles, supplies or equipment on the site of the building or work, by persons employed by the Contractor, Subcontractor, or Agent thereof.

"Employees working on the project" means laborers, workers, and mechanics employed directly upon the site of work.

"Laborers, Workers, and Mechanics" include pre-apprentices, helpers, trainees, learners and properly registered and indentured apprentices but exclude clerical, supervisory, and other personnel not performing manual labor.

**Establishment of Wage Rates.** The Department of Public Works shall periodically obtain a current schedule of prevailing wage rates from DWD. The schedule shall be used to establish the City of Madison Prevailing Wage Rate Schedule for Public Works Construction (prevailing wage rate). The Department of Public Works may include known increases to the prevailing wage rate which can be documented and are to occur on a future specific date. The prevailing wage rate shall be included in public works contracts subsequently negotiated or solicited by the City. Except for known increases contained within the schedule, the prevailing wage rate shall not change during the contract. The approved wage rate is attached hereto.

**Workforce Profile.** The Contractor shall, at the time of signature of the contract, notify the City Engineer in writing of the names and classifications of all the employees of the Contractor, Subcontractors, and Agents proposed for the work. In the alternative, the Contractor shall submit in writing the classifications of all the employees of the Contractor, Subcontractors and Agents and the total number of hours estimated in each classification for the work. This workforce profile(s) shall be reviewed by the City Engineer who may, within ten (10) days, object to the workforce profile(s) as not being reflective of that which would be required for the work. The Contractor may request that the workforce profile, or a portion of the workforce profile, be submitted after the signature of the contract but at least ten (10) days prior to the work commencing. Any costs or time loss resulting from modifications to the workforce profile as a result of the City Engineer's objections shall be the responsibility of the Contractor.

**Payrolls and Records.** The Contractor shall keep weekly payroll records setting forth the name, address, telephone number, classification, wage rate and fringe benefit package of all the employees who work on the contract, including the employees of the Contractor's subcontractors and agents. Such weekly payroll records must include the required information for all City contracts and all other contracts on which the employee worked during the week in which the employee worked on the contract. The Contractor shall also keep records of the individual time each employee worked on the project and for each day of the project. Such records shall also set forth the total number of hours of overtime credited to each such employee for each day and week and the amount of overtime pay received in that week. The records shall set forth the full weekly wages earned by each employee and the actual hourly wage paid to the employee.

The Contractor shall submit the weekly payroll records, including the records of the Contractor's subcontractors and agents, to the City Engineer for every week that work is being done on the contract. The submittal shall be within twenty-one (21) calendar days of the end of the Contractor's weekly pay period.

Employees shall receive the full amounts accrued at the time of the payment, computed at rates not less than those stated in the prevailing wage rate and each employee's rate shall be determined by the work that is done within the trade or occupation classification which should be properly assigned to the employee.

An employee's classification shall not be changed to a classification of a lesser rate during the contract. If, during the term of the contract, an employee works in a higher pay classification than the one which was previously properly assigned to the employee, then that employee shall be considered to be in the higher pay classification for the balance of the contract, receive the appropriate higher rate of pay, and she/he shall not receive a lesser rate during the balance of the contract. For purposes of clarification, it is noted that there is a distinct difference between working in a different classification with higher pay and doing work within a classification that has

varying rates of pay which are determined by the type of work that is done within the classification. For example, the classification "Operating Engineer" provides for different rates of pay for various classes of work and the Employer shall compensate an employee classified as an "Operating Engineer" based on the highest class of work that is done in one day. Therefore, an "Operating Engineer's" rate may vary on a day to day basis depending on the type of work that is done, but it will never be less than the base rate of an "Operating Engineer". Also, as a matter of clarification, it is recognized that an employee may work in a higher paying classification merely by chance and without prior intention, calculation or design. If such is the case and the performance of the work is truly incidental and the occurrence is infrequent, inconsequential and does not serve to undermine the single classification principle herein, then it may not be required that the employee be considered to be in the higher pay classification and receive the higher rate of pay for the duration of the contract. However, the Contractor is not precluded or prevented from paying the higher rate for the limited time that an employee performs work that is outside of the employee's proper classification.

Questions regarding an employee's classification, rate of pay or rate of pay within a classification, shall be resolved by reference to the established practice that predominates in the industry and on which the trade or occupation rate/classification is based. Rate of pay and classification disputes shall be resolved by relying upon practices established by collective bargaining agreements and guidelines used in such determination by appropriate recognized trade unions operating within the City of Madison.

The Contractor, its Subcontractors and Agents shall submit to interrogation regarding compliance with the provisions of this ordinance.

Mulcting of the employees by the Contractor, Subcontractor, and Agents on Public Works contracts, such as by kickbacks or other devices, is prohibited. The normal rate of wage of the employees of the Contractor, Subcontractor, and Agents shall not be reduced or otherwise diminished as a result of payment of the prevailing wage rate on a public works contract.

**Hourly contributions.** Hourly contributions shall be determined in accordance with the prevailing wage rate and with DWD. 290.01(10), Wis. Admin. Code.

**Apprentices and Subjourney persons.** Apprentices and sub journeypersons performing work on the project shall be compensated in accordance with the prevailing wage rate and with DWD 290.02, and 290.025, respectively, Wis. Admin. Code.

**Straight Time Wages.** The Contractor may pay straight time wages as determined by the prevailing wage rate and DWD 290.04, Wis. Admin. Code.

**Overtime Wages.** The Contractor shall pay overtime wages as required by the prevailing wage rate and DWD 290.05, Wis. Admin. Code.

**Posting of Wage Rates and Hours.** A clearly legible copy of the prevailing wage rate, together with the provisions of Sec. 66.0903(10)(a) and (11)(a), Wis. Stats., shall be kept posted in at least one conspicuous and easily accessible place at the project site by the Contractor and such notice shall remain posted during the full time any laborers, workers or mechanics are employed on the contract.

**Evidence of Compliance by Contractor.** Upon completion of the contract, the Contractor shall file with the Department of Public Works an affidavit stating:

- a. That the Contractor has complied fully with the provisions and requirements of Sec. 66.0903(3), Wis. Stats., and Chapter DWD 290, Wis. Admin. Code; the Contractor has received evidence of compliance from each of the agents and subcontractors; and the names and addresses of all of the subcontractors and agents who worked on the contract.

- b. That full and accurate records have been kept, which clearly indicate the name and trade or occupation of every laborer, worker or mechanic employed by the Contractor in connection with work on the project. The records shall show the number of hours worked by each employee and the actual wages paid therefore; where these records will be kept and the name, address and telephone number of the person who will be responsible for keeping them. The records shall be retained and made available for a period of at least three (3) years following the completion of the project of public works and shall not be removed without prior notification to the municipality.

**Evidence of Compliance by Agent and Subcontractor.** Each agent and subcontractor shall file with the Contractor, upon completion of their portion of the work on the contract an affidavit stating that all the provisions of Sec. 66.0903(3), Wis. Stats., have been fully complied with and that full and accurate records have been kept, which clearly indicate the name and trade or occupation of every laborer, worker or mechanic employed by the Contractor in connection with work on the project. The records shall show the number of hours worked by each employee and the actual wages paid therefore; where these records shall be kept and the name, address and telephone number of the person who shall be responsible for keeping them. The records shall be retained and made available for a period of at least three (3) years following the completion of the project of public works and shall not be removed without prior notification to the municipality.

**Failure to Comply with the Prevailing Wage Rate.** If the Contractor fails to comply with the prevailing wage rate, she/he shall be in default on the contract.

5. **Affirmative Action.** In the performance of the services under this Agreement the Contractor agrees not to discriminate against any employee or applicant because of race, religion, marital status, age, color, sex, disability, national origin or ancestry, income level or source of income, arrest record or conviction record, less than honorable discharge, physical appearance, sexual orientation, political beliefs, or student status. The Contractor further agrees not to discriminate against any subcontractor or person who offers to subcontract on this contract because of race, religion, color, age, disability, sex or national origin.

The Contractor agrees that within thirty (30) days after the effective date of this agreement, the Contractor will provide to the City Affirmative Action Division certain workforce utilization statistics, using a form to be furnished by the City.

If the contract is still in effect, or if the City enters into a new agreement with the Contractor, within one year after the date on which the form was required to be provided, the Contractor will provide updated workforce information using a second form, also to be furnished by the City. The second form will be submitted to the City Affirmative Action Division no later than one year after the date on which the first form was required to be provided.

The Contractor further agrees that, for at least twelve (12) months after the effective date of this contract, it will notify the City Affirmative Action Division of each of its job openings at facilities in Dane County for which applicants not already employees of the Contractor are to be considered. The notice will include a job description, classification, qualifications and application procedures and deadlines. The Contractor agrees to interview and consider candidates referred by the Affirmative Action Division if the candidate meets the minimum qualification standards established by the Contractor, and if the referral is timely. A referral is timely if it is received by the Contractor on or before the date started in the notice.

The Contractor shall take affirmative action in accordance with the provisions of this contract to insure that applicants are employed, and that employees are treated during employment without regard to race, religion, color, age, marital status, disability, sex or national original and that the

employer shall provide harassment free work environment for the realization of the potential of each employee. Such action shall include, but not be limited to, the following: employment, upgrading, demotion or transfer, recruitment or recruitment advertising, layoff or termination, rates of pay or other forms of compensation and selection for training including apprenticeship insofar as it is within the control of the Contractor. The Contractor agrees to post in conspicuous places available to employees and applicants notices to be provided by the City setting out the provisions of the nondiscrimination clauses in this contract.

#### Article II

The Contractor shall in all solicitations or advertisements for employees placed by or on behalf of the Contractors state that all qualified or qualifiable applicants will be employed without regard to race, religion, color, age, marital status, disability, sex or national origin.

#### Article III

The Contractor shall send to each labor union or representative of workers with which it has a collective bargaining agreement or other contract or understanding a notice to be provided by the City advising the labor union or worker's representative of the Contractor's equal employment opportunity and affirmative action commitments. Such notices shall be posted in conspicuous places available to employees and applicants for employment.

#### Article V

The Contractor agrees that it will comply with all provisions of the Affirmative Action Ordinance of the City of Madison, including the contract compliance requirements. The Contractor agrees to submit the model affirmative action plan for public works contractors in a form approved by the Director of Affirmative Action.

#### Article VI

The Contractor will maintain records as required by Section 39.02(9)(f) of the Madison General Ordinances and will provide the City Affirmative Action Division with access to such records and to persons who have relevant and necessary information, as provided in Section 39.02(9)(f). The City agrees to keep all such records confidential, except to the extent that public inspection is required by law.

#### Article VII

In the event of the Contractor's or subcontractor's failure to comply with the Equal Employment Opportunity and Affirmative Action Provisions of this contract or Section 39.03 and 39.02 of the Madison General Ordinances, it is agreed that the City at its option may do any or all of the following:

1. Cancel, terminate or suspend this Contract in whole or in part.
2. Declare the Contractor ineligible for further City contracts until the Affirmative Action requirements are met.
3. Recover on behalf of the City from the prime Contractor 0.5 percent of the contract award price for each week that such party fails or refuses to comply, in the nature of liquidated damages, but not to exceed a total of five percent (5%) of the contract price, or five thousand dollars (\$5,000), whichever is less. Under public works contracts, if a subcontractor is in noncompliance, the City may recover liquidated damages from the prime Contractor in the manner described above. The preceding sentence shall not be construed to prohibit a prime Contractor from recovering the amount of such damage from the non-complying subcontractor.

#### Article VIII

The Contractor shall include the above provisions of this contract in every subcontract so that such provisions will be binding upon each subcontractor. The Contractor shall take such action with respect to any subcontractor as necessary to enforce such provisions, including sanctions provided for noncompliance.

#### Article IX

The Contractor shall allow the maximum feasible opportunity to small business enterprises to compete for any subcontracts entered into pursuant to this contract.

(a) Each contractor, subcontractor, or contractor's or subcontractor's agent performing work on a project of public works that is subject to this section shall keep full and accurate records clearly indicating the name and trade or occupation of every person performing the work described in sub. (4) and an accurate record of the number of hours worked by each of those persons and the actual wages paid for the hours worked.

**s. 66.0903 (11) LIABILITY AND PENALTIES.**

(a) 1. Any contractor, subcontractor, or contractor's or subcontractor's agent who fails to pay the prevailing wage rate determined by the department under sub. (3) or who pays less than 1.5 times the hourly basic rate of pay for all hours worked in excess of the prevailing hours of labor is liable to any affected employee in the amount of his or her unpaid wages or his or her unpaid overtime compensation and in an additional amount as liquidated damages as provided under subd. 2., 3., whichever is applicable.

2. If the department determines upon inspection under sub. (10) (b) or (c) that a contractor, subcontractor, or contractor's or subcontractor's agent has failed to pay the prevailing wage rate determined by the department under sub. (3) or has paid less than 1.5 times the hourly basic rate of pay for all hours worked in excess of the prevailing hours of labor, the department shall order the contractor to pay to any affected employee the amount of his or her unpaid wages or his or her unpaid overtime compensation and an additional amount equal to 100 percent of the amount of those unpaid wages or that unpaid overtime compensation as liquidated damages within a period specified by the department in the order.

3. In addition to or in lieu of recovering the liability specified in subd. 1. as provided in subd. 2., any employee for and in behalf of that employee and other employees similarly situated may commence an action to recover that liability in any court of competent jurisdiction. If the court finds that a contractor, subcontractor, or contractor's or subcontractor's agent has failed to pay the prevailing wage rate determined by the department under sub. (3) or has paid less than 1.5 times the hourly basic rate of pay for all hours worked in excess of the prevailing hours of labor, the court shall order the contractor, subcontractor, or agent to pay to any affected employee the amount of his or her unpaid wages or his or her unpaid overtime compensation and an additional amount equal to 100 percent of the amount of those unpaid wages or that unpaid overtime compensation as liquidated damages.

5. No employee may be a party plaintiff to an action under subd. 3. unless the employee consents in writing to become a party and the consent is filed in the court in which the action is brought. Notwithstanding s. 814.04 (1), the court shall, in addition to any judgment awarded to the plaintiff, allow reasonable attorney fees and costs to be paid by the defendant.
