This addendum is issued to modify, explain or correct the original Drawings, Specifications, or Contract Documents marked as *Storm Sewer and Trench Patching at West Transfer Station, City of Madison, Contract #7911, as issued on February 9, 2017* and is hereby made a part of the contract documents.

Please attach these Addendum documents to the Drawings and Project manual in your possession.

1. GENERAL CONTRACT CONDITIONS

- A. Add Exhibit D – Geo Technical Report to the bid document set.
- B. This contractor **shall** be responsible for installing, maintaining and removing the silt sock depicted on the plan set during the execution of the trenching portion of this contract. Silt sock will not be required during placement of the bollards at the end of the contract. See itemized changes to proposal below.
- C. This contractor **shall not** be responsible for installing, maintaining and removing the construction fence depicted on the plan set during the execution of this contract.
- D. This contractor **shall** be responsible for installing, maintaining and removing any construction fence, barricade or trench plate needed for protecting open trenches and structure pits until completed. Cost of such devices shall be incidental to existing bid items 50221, 50223, 50723, and 50741.
- E. Concrete and Asphalt pavement replaced during trench patching **shall** be replaced to standard thickness as described in the Public Works Standard Specifications. It **shall not** be replaced to the existing site depths.

2. PROPOSAL

- A. Add Bid Item 21017 Silt Sock (8”) – Complete; 300 LF
 - i. Provide, install, maintain and remove. Staking in place is not permitted.
