SECTION D: SPECIAL PROVISIONS

**MEZZANIE CONSTRUCTION-SYCAMORE
CONTRACT NO. 6505**

It is the intent of these Special Provisions to set forth the final contractual intent as to the matter involved and shall prevail over the Standard Specifications and plans whenever in conflict therewith. In order that comparisons between the Special Provisions can be readily made, the numbering system for the Special Provisions is equivalent to that of the Specifications.

Whenever in these Specifications the term "Standard Specifications" appears, it shall be taken to refer to the City of Madison Standard Specifications for Public Works Construction and Supplements thereto.

SECTION 102.10: MINIMUM RATE OF WAGE SCALE

For this project, payment of prevailing wages (white sheet) is not required if either: a single trade accounts for 85% or more of the total labor costs of the project and the bid is less than \$48,000; or no single trade accounts for 85% or more of the total labor costs of the project and the bid is less than \$100,000. For bids not meeting either of these conditions, prevailing wages shall be required.

If required, the wages and benefits paid on the contract shall not be less than those specified in the Prevailing Wage Determination included with these contract documents for the following types of work:

- Building and Heavy Construction
- Sewer, Water, and Tunnel Construction
- Local Street and Miscellaneous Paving Operations
- Residential and Agricultural Construction

All bidders are notified that all labor employed on City contracts must be paid in accordance with the minimum rate of wage scale included in the Contract Documents.

For the information of the employees working on the project, a copy of the wage scale included in the contract documents and the provisions of Section 66.0903(8) of the Wisconsin Statutes shall be kept posted by the employer and in at least one conspicuous and easily accessible place at the site of the project.

The Contractor shall keep weekly payroll records setting forth the name, address, telephone number, classification, wage rate and fringe benefit package of each employee who worked on such City project and all other projects the employee worked in the same period, and the Contractor must keep records of the individual time each employee worked on the project and for each day of the project. Such records shall also set forth the total number of hours of overtime credited to each such employee for each day and week and the amount of overtime pay received in that week. Such records shall, in addition, set forth the full weekly wages earned by each such employee and the actual hourly wage paid to that employee. The Contractor shall submit payroll records to the Engineer every week for those periods when work is being done on the project. Said submittal shall be within twenty-one (21) calendar days of the end of the Contractor's weekly pay period.

The Contractor shall ensure that employees shall be paid unconditionally and shall receive the full amounts accrued at the time of payment, computed at rates not less than those stated in the City of Madison "Minimum Rate of Wage Scale" and that each employee's rate shall be determined by the work that is done within the trade or occupation classification which should be properly assigned to such employee. Questions regarding an employee's classification or rate of pay within that classification, shall

be resolved by the practice that predominates in the industry and on which the trade or occupation rate/classification is based. Therefore, rate of pay, classification and work jurisdiction disputes shall be resolved by relying upon practices established by collective bargaining agreements and guidelines used in such determinations by appropriate recognized trade unions operating within the City of Madison.

The Contractor shall agree that the normal rate of wage paid to the Contractor's employees on other projects shall not be reduced or otherwise diminished as a result of the requirement to pay no less than the minimum rate of wage scale on a City project. Mulcting of employees on City projects by contractors, such as by kickbacks or other such devices, is prohibited.

These contract provisions shall apply to all work performed on the contract by the Contractor with its own organization and with assistance of laborers under its immediate superintendency and to all work performed by piecework or by subcontract. No laborer, worker, or mechanic shall be employed directly upon the site of the work except on a wage basis, but this shall not be construed to prohibit the rental of equipment from individuals.

In the event of a refusal by the Contractor to submit payroll records as required by the contract, the City of Madison shall have the option to cancel this contract and request the Surety to perform or to relet the balance of the work for bids, and in that event, to charge the Contractor for any loss which the City may incur thereby.

SECTION 102.12: BEST VALUE CONTRACTING

This Contract shall be considered a Best Value Contract if the Contractor's bid is equal to or greater than \$53,000 for a single trade contract; or equal to or greater than \$257,500 for a multi-trade contract pursuant to MGO 33.07(7).

SECTION 104: SCOPE OF WORK

These special provisions are intended to provide a plan and performance specification for the design and construction of an engineered free standing steel mezzanine structure consisting of columns, framing, decking, hardware, and accessories as indicated in these documents.

The scope of work includes the following but is not limited to:

- Furnishing all labor, equipment, materials, and services required for performing site visits during the design phase.
- Providing three (3) sets of preliminary structural framing plans and details at a 50% design development meeting with the owner, the owner's fire protection consultant, and the owner's lighting design consultant. Provide CAD drawings of said plans to be used by these consultants in their design process.
- Furnishing all labor, equipment, materials, and services necessary in completing the design, details, manufacturing, and installation documents. Design shall be supervised and stamped by a State of Wisconsin licensed Professional Engineer or Architect.
- Furnishing all documentation required to receive State of Wisconsin Department of Commerce review approval of the design.
- The design/build contractor shall be responsible for payment of all costs for application fees and permits required during the execution of this contract.
- Furnishing all labor, equipment, materials, and services required to manufacture and install the steel mezzanine structure, components, and accessories.
- Providing two (2) complete sets of stamped approved drawings prior to manufacturing components of the structure to the City's Project Manager. One (1) additional copy shall be kept on site at all times.

- Providing two (2) complete sets of as-builts upon completion of this contract.
- This contract **IS NOT** responsible for any required modifications to the fire sprinkler system or electrical power and lighting.

Unless specifically directed by the Project Manager (for the City of Madison) as work or materials by others the contractor shall assume the responsibilities of work and materials for this contract. The Contractor shall furnish any apparatus, appliance, material, or labor that may be necessary to complete the work, in accordance with the intent of this contract. The Contractor shall use properly functioning equipment capable of performing the tasks required. The Contractor shall furnish workers who perform quality work and who are experienced and knowledgeable in the work proposed.

SECTION 104.1 LANDS FOR WORK

All lands for work shall be located in Garage Bay 1 located at 4206 Sycamore Ave. also known as Streets Division East. The contractor shall mark out the designated project limits and make coordination with the Streets East Superintendent for any additional space required for material and equipment storage.

SECTION 104.10 CLEANING UP

The contractor shall be responsible for keeping the immediate area around the project limits and other areas designated as Lands for Work (Section 104.1) clean and free of all loose construction materials, parts, equipment, and debris. The contractor may dispose of general construction debris in the appropriate designated bins located in the Streets Division waste drop off site located outside the north entrance to the building.

SECTION 105.1: AUTHORITY OF THE ENGINEER

The Engineer shall resolve all questions which arise as to the quality and acceptability of materials furnished, work performed, manner of performance, rate of progress of the work, interpretation of the plans and Specifications, acceptable fulfillment of the contract, compensation, and disputes and mutual rights between Contractors under the Specifications. The Engineer shall determine the amount and quantity of work performed and materials furnished.

All decisions of the Engineer shall, when so requested, be rendered in writing. They shall be final and conclusive in all matters unless within ten (10) days after such decision the Contractor applies in writing to the Board of Public Works for a review of such decision.

Any change proposed by a Contractor in SBE subcontractors, vendors or suppliers from those SBEs indicated on the SBE Compliance Report must be approved by the Engineer and the City's Manager of the Affirmative Action Division (hereafter, AAD). When requested, such decision shall be rendered in writing. Such decisions shall be final and conclusive in all matters unless within ten (10) days after such decision the Contractor or the affected SBE applies in writing to the Board of Public Works for a review of such decision.

In the event the Engineer and the AAD disagree over the proper decision to be made regarding an SBE, the Mayor shall appoint a third person to resolve the disagreement, within 30 days of appointment. The decision thus rendered may be reviewed by the Board of Public Works upon request of the Contractor or the affected SBE as set forth in Sections 105.1 and 105.2 of the City's standard specifications.

SECTION 107.2 PROTECTION AND RESTORATION OF PROPERTY

The contractor shall protect all existing interior structural and utility components from damage. The contractor shall be responsible for full restoration or replacement to pre construction serviceability of any structural or utility component that is damaged through the performance of this contract. The City of Madison shall specify the authorized contractor for any repair work needed to fiber optic, computer cables and other Information Technology (IT) devices.

SECTION 108.2 PERMITS

The contractor shall be responsible for applying, obtaining, and paying for all required plan reviews and construction permits required for the completion of this contract.

SECTION 109.7 TIME OF COMPLETION

Work shall begin only after the contract is executed and the start work letter is received. **The contract shall be completed within One Hundred and Two (102) CALENDAR DAYS of the start work letter.** (It is anticipated the start work letter will be issued on or about May 27, 2013 and project completion would be on or about September 13, 2013). The Contractor shall schedule a pre-construction meeting at the site prior to beginning design. Coordinate a meeting room with the Streets East Supervisor. Attendees shall include Streets East staff, Facility Management staff, contractor and sub contractor staff as needed.

BID ITEMS - STANDARD BID ITEMS

There are no standard bid items in this contract.

BID ITEM 9000X – NON STANDARD BID ITEMS

90001 – Mezzanine design, manufacture, and installation

- Specification: The mezzanine deck system shall be a design/build steel structure. The Contractor has the option of using either hot rolled steel, cold formed steel, or a pre-engineered mezzanine floor system as manufactured by Wildeck, Inc., American Warehouse Systems, or approved equal, provided the system used meets the minimum performance specifications below.
- Method of Measurement: The mezzanine design and construction shall be measured in two separate phases.
 - Phase 1 shall be the completion of design prior to fabrication and installation of any structural components.
 - Phase 2 shall be the fabrication, delivery, and installation of the structural components. Phase 2 shall not begin until the Owner or Project Manager has signed off that Phase 1 is complete.
- Basis of Payment: The Contractor shall be paid at the LUMP SUM contract price for all design and construction of the mezzanine and all associated components required for a complete installation including all labor, equipment, materials, and incidentals required to complete the work per these specifications, plans and details.

Performance Specification – Design Phase

The Design Phase shall consist of the following performance steps:

- During the Design Phase the Contractor shall meet on site with City Staff to verify the intent of the contract drawings and specifications.
- The Contractor shall be responsible for field verifying all existing conditions and dimensions to include but not limited to verifying the slope of the existing floor; location of existing walls, columns and footings; location of all existing above floor mechanical systems within the construction area to include fiber optic, network wiring, electrical conduit, HVAC equipment/ductwork, and fire suppression equipment.
- The design and all components (including accessories) shall meet all federal, state, and local building codes and safety codes applicable to this type of construction.
- The Contractor shall submit final plans, details, and specifications to City Staff for review of the design.
- The Contractor shall be responsible for submitting final plans, details, and specifications to the Wisconsin Department of Commerce for structural review/approval prior to beginning the manufacturing of mezzanine components required for this contract. Submittal shall include all required structural calculations and shall be stamped by a licensed State of Wisconsin Professional Engineer or Architect. All costs associated with the application and plan submittal shall be the responsibility of the design/build contractor.
- The following design criteria shall apply:
 - See Owner provided plans, notes, and details for additional information.
 - The design/build contractor shall be responsible for determining all existing conditions of the existing concrete floor slab. The existing floor shall be laser leveled to determine the required length of each individual mezzanine column. Shimming or grouting of columns in excess of one-half inch (0'-0 1/2") will not be permitted.
 - The mezzanine structure shall be completely free standing. No direct structural connections to existing masonry walls or steel columns shall be permitted.
 - The mezzanine shall not require cross bracing in any direction.
 - The finished mezzanine deck height shall match the existing top of roof slab over the Womens Locker Room addition (+/- 10'-6 1/4"). The finished main floor clearance shall be 8'-1 3/4" minimum.
 - The mezzanine shall support a maximum of a 2000 pound pallet on a manual pallet jack anywhere on the mezzanine floor. Design live load =125 PSF.
 - Provide kick plates, stairs, gates, railings, and guard rails as indicated on plans or as required by all applicable codes.
 - The existing floor is a 6" concrete slab with 6x6 #4/#4 WWF.

Performance Specification – Materials

- A. Framing shall be structural steel, all connections shall be bolted. Required holes for connections shall be pre-punched. Depth shall be sufficient to meet the main floor clearance and finished mezzanine floor requirements stated in the Design Specifications above.
 - a. Cold formed steel shapes shall meet the requirements of ASTM C995, Grade 50, Fy=33ksi.
 - b. Wide flanged rolled steel shapes shall meet the requirements of ASTM A-992, Grade 50, Fy=50ksi.
- B. Support columns shall be structural steel. Individual column lengths shall be as determined by laser leveling of the existing floor slope as stated in the Design Specifications above. Tube steel columns shall meet the requirements of ASTM A-500, Grade 50, Fy=46 ksi
- C. Column base plates shall be structural steel. The maximum shim/grout depth requirements stated in the Design Specifications above.

- D. Column base floor anchors shall be high tensile and shear strength steel SAE Grade 5 or better, zinc plated, meeting the requirements of ASTM A325 type 3-B bolts. Anchors shall not exceed 5" in length.
- E. Framing Fasteners: Frame to column and frame to frame fasteners shall be high strength zinc plated steel bolts meeting the requirements of ASTM A325. TEC SCREWS SHALL NOT BE ALLOWED.
- F. Angle Brackets shall be 1/4" thick steel (min.) with pre-punched holes meeting the requirements of ASTM A36.
- G. Decking (Mezzanine Floor Deck & Moisture Resistant Resinboard)
 - a. Mezzanine floor decking shall be 1-1/2" deep, 20 gauge steel, wide rib, painted grey on the top side with one (1) mil white paint on the bottom side.
 - b. Moisture Resistant Resin board, placed over the wide rib metal deck, shall be 3/4" thick, tongue and groove on 2 long sides.
 - c. Plywood fasteners shall be steel screws 10-16 x 1-13/16", PFH T/3, cadmium plated.
 - d. Kick plates shall be a minimum of 14 gauge steel at all deck edges and non-stair sides of stair openings. Kick plates shall be painted safety yellow.
- H. Stairs shall consist of structural steel stringers, 12 gauge diamond plate steel treads with open risers, 1-1/2" O.D. railing and all associated hardware. Stair and stair platform floor anchors shall be high tensile and shear strength steel, SAE Grade 5 or better, zinc plated.
- I. Painting: The mezzanine components shall be cleaned and etched with a phosphoric acid rinse, dried and painted with a 2-part (electrostatically applied) polyurethane paint. The automated application system shall utilize a heat-assisted, air-dry, cure process. Color shall be gray unless specified by code to be safety yellow.
- J. Deck Railing shall meet all applicable codes and OSHA standards, shall be either 2 or 3 rail steel fastened to the mezzanine, minimum of 1-1/2" O.D. tube. Railings shall be painted safety yellow.
- K. Slide Gate:
 - a. Slide gate shall be as supplied and manufactured by Wildeck or approved equal with all mounting hardware and standard features including integral 4" high steel kick plate.
 - b. Slide gate shall be manually operated.
 - c. Slide gate assembly shall be painted safety yellow.
 - d. Slide gate shall meet all IBC and OSHA standards and other applicable codes.
- L. Guard Rails:
 - a. Steel guard rails shall be as supplied and manufactured by Wildeck or approved equal with all mounting hardware, two (2) rails, 44" height.
 - b. Lengths and locations as noted on plans.
 - c. Guard rail assemblies shall be painted safety yellow.
 - d. Guard rail assemblies shall meet all IBC and OSHA standards and other applicable codes.
- M. Pedestrian Pass Thru Gates:
 - a. Pedestrian Pass Thru Gate shall be as supplied and manufactured by Wildeck or approved equal with all mounting hardware, two (2) rails, 44" height.
 - b. Lengths and locations as noted on plans.
 - c. Pedestrian Pass Thru Gate assemblies shall be painted safety yellow.
 - d. Pedestrian Pass Thru Gate assemblies shall meet all IBC and OSHA standards and other applicable codes.

Quality Assurance

- A. Contractor shall be an established firm with previous experience in installing steel structure systems.
- B. System design shall be performed under the direct supervision of a licensed Professional Engineer or Architect by the State of Wisconsin. The engineer/architect shall be experienced in

the design of mezzanines and in accordance with AISC specifications and where applicable AISI specifications.

- C. All welding performed shall be done by certified welders. Certifications shall be presented during the preconstruction meeting.
- D. Regulatory requirements: System components (handrails, kick plate, stairways, etc) shall conform to OSHA requirements

Submittals

- A. Submit approval drawings showing size and height of mezzanine, type of decking, length and number of framing members, column locations, orientation of base plates, and location and type of accessories.

Warranty

- A. The Contractor shall provide a written warranty for the design and installation of the completed mezzanine system for a minimum of two (2) years.
- B. Warranty does not cover damage caused by conditions beyond the control of the supplier or installer such as faulty construction of the building, ordinary wear and tear, fire, water, or chemical action, separation of concrete slab or settling of walls.

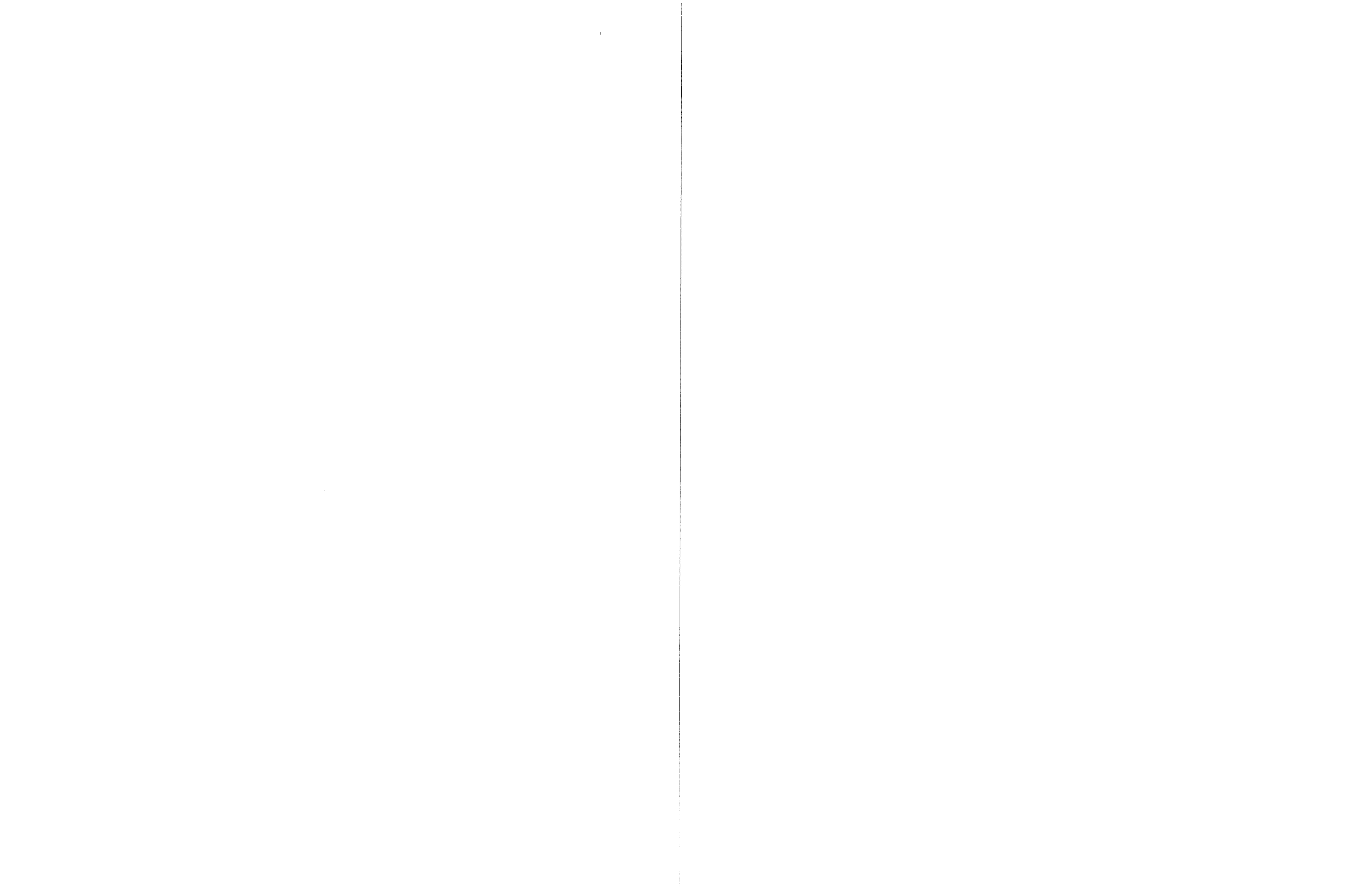

NOTICE OF ADDENDUM

ADDENDUM NO. 1

CONTRACT NO. 6505, Project 53W1033
Mezzanine Construction- Sycamore

April 3, 2013

Revise and amend the contract document(s) for the above project as stated in this addendum, otherwise, the original document shall remain in effect.

This addendum is issued to modify, explain, or correct the original Drawings and Specifications marked as *Mezzanine Construction-Sycamore, City of Madison Project #53W1033, Contract #6505* dated *March 14, 2013* and to answer general questions asked during the bidding process. This addendum consists of six (6) pages total, three (3) pages of text and three (3) sketches. Please attach this Addendum to the Drawings and Specifications in your possession.

I. GENERAL CONTRACT CONDITIONS

- A. This addendum does not extend the bid date. Bids are due at 1:00pm on April 12, 2013.
- B. Bidding contractors are reminded they must be pre-qualified in either category 415 or 499 no later than 1:00pm April 5, 2013. See appendix B of the bid documents for more information.

II. GENERAL QUESTIONS & CLARIFICATIONS

- A. **Q.** Proposed floor plans indicate existing building columns and intermediate columns for the mezzanine is there a specific spacing for the mezzanine columns?
 - A. The existing building's column lines are at 25'-0" spacing running north/south. The intent is to place mezzanine column lines on the existing building lines and subdivide each space equally no more than once. Therefore the mezzanine column spacing should have a 12'-6" spacing running north/south (see Sketch 1 below). The east/west spacing needs to be divided once and equally spaced as well. The City also stresses that there shall be no cross bracing allowed, all below deck space must be fully useable space. It is also the intent of the city that each column load shall be supported by the existing floor slab. The existing slab is 6" concrete slab with 6x6 #4x#4 WWF.

- B. Q. Why is the stair way on the proposed plan located in the middle of the deck?
A. Preliminary code interpretation indicates that the means of egress from the farthest point on the mezzanine shall not exceed 100 feet along the normal path of egress to a point where at least 2 exits are visible. This approximate location meets the requirement; the designer will need to refine it to meet code.
- C. Q. The stair shown is a switch back stair with an intermediate landing; can a single run be used?
A. No, this stair has been selected for the following reasons:
- Meets the requirements in B above for egress
 - Maximizes storage space on both levels while minimizing un-useable space.
 - Access off the top level is in the safety aisle not center of floor. Discharge is into a safety aisle not the center of the floor.
- D. Q. What is the minimum clear height of the main floor?
A. The minimum clear height of the main floor shall be per the specification (8'-1 3/4"). Since the floor has a pitch to it this height will increase as you move away from the outside (west) wall of the main building structure.
- E. Q. What is the construction of the woman's locker room roof?
A. The locker room roof is constructed of 8" precast plank. Maximum live load = 125 PSF (5PSF superimposed dead load), 2 hour fire rated with all joints grouted.
- F. Q. How does the mezzanine floor meet the existing woman's locker room wall/roof?
A. Metal deck and plywood over the roof; see sketch 2 description below. The finished mezzanine deck over the locker room shall be level. If shimming of the metal decking is required it shall be the responsibility of the Professional Engineer/Architect to specify appropriate bearing plates, spacing and fasteners as required so as not to create an excessive point load on the existing precast plank.
- G. Q. The proposed plan indicates that there may be mezzanine columns bearing on existing column footings. What information on the existing column footings is available?
A. See sketch 3 below. Existing load calculations for the interior columns are no longer available. The intent is that the floor slab shall be able to take the column load with no additional footings.

III. ACCEPTABLE EQUIVALENTS

- A. None were requested.

IV. SPECIFICATIONS (SPECIAL PROVISIONS)

- A. No changes were made to the written Special Provisions pages D-1 through D-7
B. Sketch 1 (below) indicates corrections to notes on the plan sheet.

V. DRAWINGS

- A. Sketch 1 is a revised sheet 2 of the plan set. Revisions are as follows:
- The left floor plan corrects the bearing height to match the text on sheet D-5 of the Special Provisions which is correctly stated.
 - The left floor plan now indicates recommended intermediate dimensions for the mezzanine column spacing.
 - The right floor plan corrects the note in the lower left hand corner.

- B. Sketch 2 is a diagram sketch of General Questions E & F above. It is the responsibility of the contractor to verify during the design process that this detail will work and advise the city of options in the event it will not work. Clearance code requirements will take precedence.
- C. Sketch 3 is a compilation of information for the original 1967 blueprints. The sketch consist of the only interior footing detail, a portion of the structural floor plan indicating the interior columns in the area of the mezzanine are type "F-2", and the interior footing reinforcing schedule which indicates the size and reinforcing of the footings.

STREETS DIVISION, EAST 4602 SYCAMORE AVE

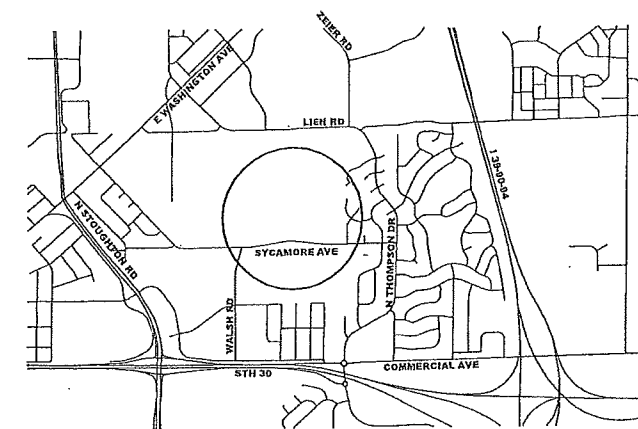

AREA LOCATION







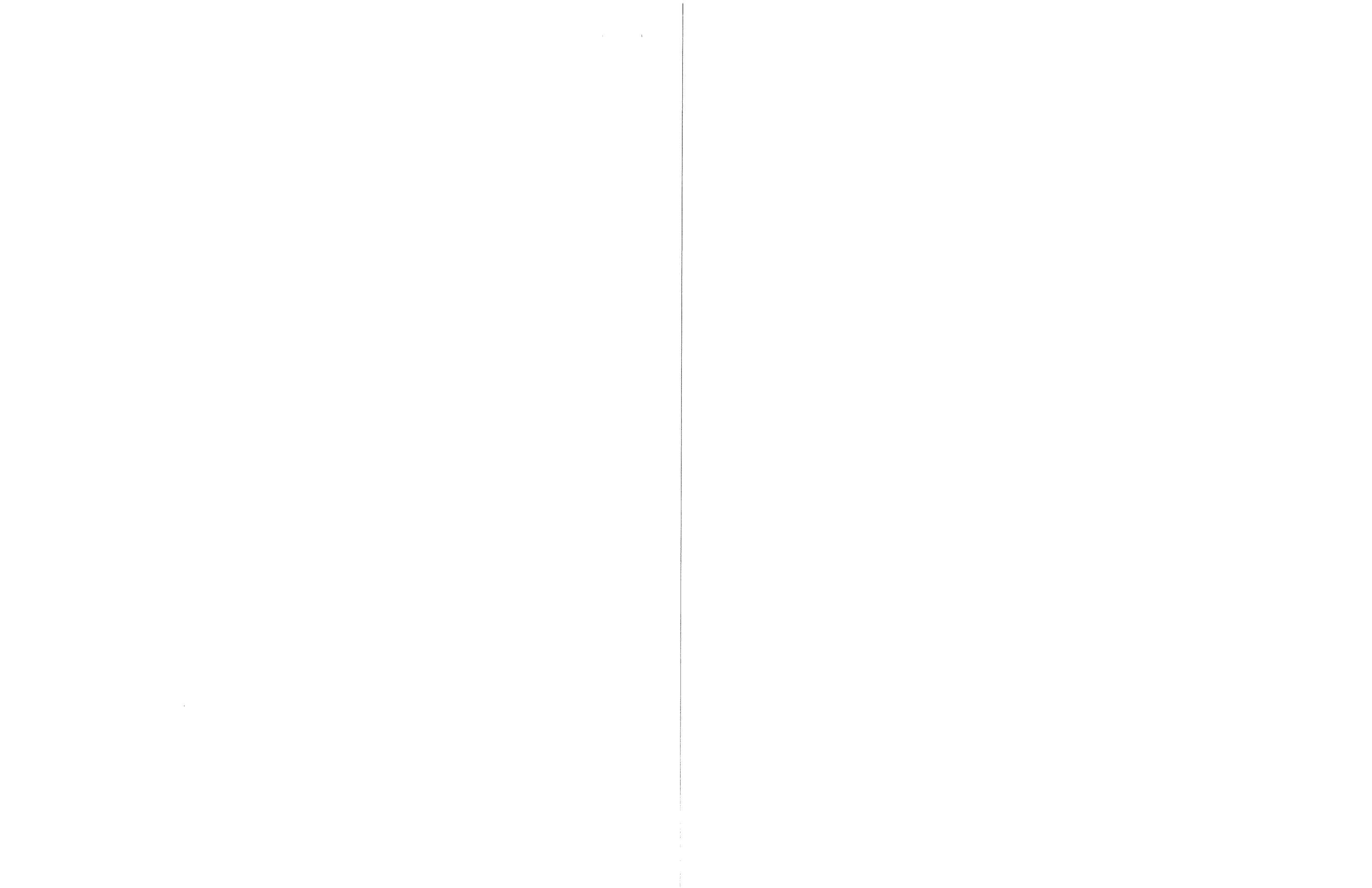

THIS AGREEMENT made this 1 day of MAY in the year Two Thousand and Thirteen between JOE DANIELS CONSTRUCTION CO., INC. hereinafter called the Contractor, and the City of Madison, Wisconsin, hereinafter called the City.

WHEREAS, the Common Council of the said City of Madison under the provisions of a resolution adopted APRIL 30, 2013, and by virtue of authority vested in the said Council, has awarded to the Contractor the work of performing certain construction.

NOW, THEREFORE, the Contractor and the City, for the consideration hereinafter named, agree as follows:

1. **Scope of Work.** The Contractor shall, perform the construction, execution and completion of the following listed complete work or improvement in full compliance with the Plans, Specifications, Standard Specifications, Supplemental Specifications, Special Provisions and contract; perform all items of work covered or stipulated in the proposal; perform all altered or extra work; and shall furnish, unless otherwise provided in the contract, all materials, implements, machinery, equipment, tools, supplies, transportation, and labor necessary to the prosecution and completion of the work or improvements:

MEZZANINE CONSTRUCTION-SYCAMORE CONTRACT NO. 6505

2. **Completion Date/Contract Time.** Construction work must begin within seven (7) calendar days after the date appearing on mailed written notice to do so shall have been sent to the Contractor and shall be carried on at a rate so as to secure full completion SEE SPECIAL PROVISIONS, the rate of progress and the time of completion being essential conditions of this Agreement.
3. **Contract Price.** The City shall pay to the Contractor at the times, in the manner and on the conditions set forth in said specifications, the sum of ONE HUNDRED FIVE THOUSAND FOUR HUNDRED NINETY-FOUR (\$105,494.00) Dollars being the amount bid by such Contractor and which was awarded to him/her as provided by law.
4. **Wage Rates for Employees of Public Works Contractors**

General and Authorization. The Contractor shall compensate its employees at the prevailing wage rate in accordance with section 66.0903, Wis. Stats., DWD 290 of the Wisconsin Administrative Code and as hereinafter provided.

“Public Works” shall include building or work involving the erection, construction, remodeling, repairing or demolition of buildings, parking lots, highways, streets, bridges, sidewalks, street lighting, traffic signals, sanitary sewers, water mains and appurtenances, storm sewers, and the grading and landscaping of public lands.

“Building or work” includes construction activity as distinguished from manufacturing, furnishing of materials, or servicing and maintenance work, except for the delivery of mineral aggregate such as sand, gravel, bituminous asphaltic concrete or stone which is incorporated into the work under contract with the City by depositing the material directly in final place from transporting vehicle.

“Erection, construction, remodeling, repairing” means all types of work done on a particular building or work at the site thereof in the construction or development of the project, including without limitation, erecting, construction, remodeling, repairing, altering, painting, and decorating, the transporting of materials and supplies to or from the building or work done by the employees of the Contractor, Subcontractor, or Agent thereof, and the manufacturing or furnishing of materials, articles, supplies or equipment on the site of the building or work, by persons employed by the Contractor, Subcontractor, or Agent thereof.

“Employees working on the project” means laborers, workers, and mechanics employed directly upon the site of work.

“Laborers, Workers, and Mechanics” include preapprentices, helpers, trainees, learners and properly registered and indentured apprentices but exclude clerical, supervisory, and other personnel not performing manual labor.

Establishment of Wage Rates. The Department of Public Works shall periodically obtain a current schedule of prevailing wage rates from DWD. The schedule shall be used to establish the City of Madison Prevailing Wage Rate Schedule for Public Works Construction (prevailing wage rate). The Department of Public Works may include known increases to the prevailing wage rate which can be documented and are to occur on a future specific date. The prevailing wage rate shall be included in public works contracts subsequently negotiated or solicited by the City. Except for known increases contained within the schedule, the prevailing wage rate shall not change during the contract. The approved wage rate is attached hereto.

Workforce Profile. The Contractor shall, at the time of signature of the contract, notify the City Engineer in writing of the names and classifications of all the employees of the Contractor, Subcontractors, and Agents proposed for the work. In the alternative, the Contractor shall submit in writing the classifications of all the employees of the Contractor, Subcontractors and Agents and the total number of hours estimated in each classification for the work. This workforce profile(s) shall be reviewed by the City Engineer who may, within ten (10) days, object to the workforce profile(s) as not being reflective of that which would be required for the work. The Contractor may request that the workforce profile, or a portion of the workforce profile, be submitted after the signature of the contract but at least ten (10) days prior to the work commencing. Any costs or time loss resulting from modifications to the workforce profile as a result of the City Engineer’s objections shall be the responsibility of the Contractor.

Payrolls and Records. The Contractor shall keep weekly payroll records setting forth the name, address, telephone number, classification, wage rate and fringe benefit package of all the employees who work on the contract, including the employees of the Contractor’s subcontractors and agents. Such weekly payroll records must include the required information for all City contracts and all other contracts on which the employee worked during the week in which the employee worked on the contract. The Contractor shall also keep records of the individual time each employee worked on the project and for each day of the project. Such records shall also set forth the total number of hours of overtime credited to each such employee for each day and week and the amount of overtime pay received in that week. The records shall set forth the full weekly wages earned by each employee and the actual hourly wage paid to the employee.

The Contractor shall submit the weekly payroll records, including the records of the Contractor’s subcontractors and agents, to the City Engineer for every week that work is being done on the contract. The submittal shall be within twenty-one (21) calendar days of the end of the Contractor’s weekly pay period.

Employees shall receive the full amounts accrued at the time of the payment, computed at rates not less than those stated in the prevailing wage rate and each employee's rate shall be determined by the work that is done within the trade or occupation classification which should be properly assigned to the employee.

An employee's classification shall not be changed to a classification of a lesser rate during the contract. If, during the term of the contract, an employee works in a higher pay classification than the one which was previously properly assigned to the employee, then that employee shall be considered to be in the higher pay classification for the balance of the contract, receive the appropriate higher rate of pay, and she/he shall not receive a lesser rate during the balance of the contract. For purposes of clarification, it is noted that there is a distinct difference between working in a different classification with higher pay and doing work within a classification that has varying rates of pay which are determined by the type of work that is done within the classification. For example, the classification "Operating Engineer" provides for different rates of pay for various classes of work and the Employer shall compensate an employee classified as an "Operating Engineer" based on the highest class of work that is done in one day. Therefore, an "Operating Engineer's" rate may vary on a day to day basis depending on the type of work that is done, but it will never be less than the base rate of an "Operating Engineer". Also, as a matter of clarification, it is recognized that an employee may work in a higher paying classification merely by chance and without prior intention, calculation or design. If such is the case and the performance of the work is truly incidental and the occurrence is infrequent, inconsequential and does not serve to undermine the single classification principle herein, then it may not be required that the employee be considered to be in the higher pay classification and receive the higher rate of pay for the duration of the contract. However, the Contractor is not precluded or prevented from paying the higher rate for the limited time that an employee performs work that is outside of the employee's proper classification.

Questions regarding an employee's classification, rate of pay or rate of pay within a classification, shall be resolved by reference to the established practice that predominates in the industry and on which the trade or occupation rate/classification is based. Rate of pay and classification disputes shall be resolved by relying upon practices established by collective bargaining agreements and guidelines used in such determination by appropriate recognized trade unions operating within the City of Madison.

The Contractor, its Subcontractors and Agents shall submit to interrogation regarding compliance with the provisions of this ordinance.

Mulcting of the employees by the Contractor, Subcontractor, and Agents on Public Works contracts, such as by kickbacks or other devices, is prohibited. The normal rate of wage of the employees of the Contractor, Subcontractor, and Agents shall not be reduced or otherwise diminished as a result of payment of the prevailing wage rate on a public works contract.

Hourly contributions. Hourly contributions shall be determined in accordance with the prevailing wage rate and with DWD. 290.01(10), Wis. Admin. Code.

Apprentices and Subjourneypersons. Apprentices and subjourneypersons performing work on the project shall be compensated in accordance with the prevailing wage rate and with DWD 290.02, and 290.025, respectively, Wis. Admin. Code.

Straight Time Wages. The Contractor may pay straight time wages as determined by the prevailing wage rate and DWD 290.04, Wis. Admin. Code.

Overtime Wages. The Contractor shall pay overtime wages as required by the prevailing wage rate and DWD 290.05, Wis. Admin. Code.

Posting of Wage Rates and Hours. A clearly legible copy of the prevailing wage rate, together with the provisions of Sec. 66.0903(10)(a) and (11)(a), Wis. Stats., shall be kept posted in at least one conspicuous and easily accessible place at the project site by the Contractor and such notice shall remain posted during the full time any laborers, workers or mechanics are employed on the contract.

Evidence of Compliance by Contractor. Upon completion of the contract, the Contractor shall file with the Department of Public Works an affidavit stating:

- a. That the Contractor has complied fully with the provisions and requirements of Sec. 66.0903(3), Wis. Stats., and Chapter DWD 290, Wis. Admin. Code; the Contractor has received evidence of compliance from each of the agents and subcontractors; and the names and addresses of all of the subcontractors and agents who worked on the contract.
- b. That full and accurate records have been kept, which clearly indicate the name and trade or occupation of every laborer, worker or mechanic employed by the Contractor in connection with work on the project. The records shall show the number of hours worked by each employee and the actual wages paid therefor; where these records will be kept and the name, address and telephone number of the person who will be responsible for keeping them. The records shall be retained and made available for a period of at least three (3) years following the completion of the project of public works and shall not be removed without prior notification to the municipality.

Evidence of Compliance by Agent and Subcontractor. Each agent and subcontractor shall file with the Contractor, upon completion of their portion of the work on the contract an affidavit stating that all the provisions of Sec. 66.0903(3), Wis. Stats., have been fully complied with and that full and accurate records have been kept, which clearly indicate the name and trade or occupation of every laborer, worker or mechanic employed by the Contractor in connection with work on the project. The records shall show the number of hours worked by each employee and the actual wages paid therefor; where these records shall be kept and the name, address and telephone number of the person who shall be responsible for keeping them. The records shall be retained and made available for a period of at least three (3) years following the completion of the project of public works and shall not be removed without prior notification to the municipality.

Failure to Comply with the Prevailing Wage Rate. If the Contractor fails to comply with the prevailing wage rate, she/he shall be in default on the contract.

5. **Affirmative Action.** In the performance of the services under this Agreement the Contractor agrees not to discriminate against any employee or applicant because of race, religion, marital status, age, color, sex, disability, national origin or ancestry, income level or source of income, arrest record or conviction record, less than honorable discharge, physical appearance, sexual orientation, political beliefs, or student status. The Contractor further agrees not to discriminate against any subcontractor or person who offers to subcontract on this contract because of race, religion, color, age, disability, sex or national origin.

The Contractor agrees that within thirty (30) days after the effective date of this agreement, the Contractor will provide to the City Affirmative Action Division certain workforce utilization statistics, using a form to be furnished by the City.

If the contract is still in effect, or if the City enters into a new agreement with the Contractor, within one year after the date on which the form was required to be provided, the Contractor will provide updated workforce information using a second form, also to be furnished by the City. The second form will be submitted to the City Affirmative Action Division no later than one year after the date on which the first form was required to be provided.

The Contractor further agrees that, for at least twelve (12) months after the effective date of this contract, it will notify the City Affirmative Action Division of each of its job openings at facilities in Dane County for which applicants not already employees of the Contractor are to be considered. The notice will include a job description, classification, qualifications and application procedures and deadlines. The Contractor agrees to interview and consider candidates referred by the Affirmative Action Division if the candidate meets the minimum qualification standards established by the Contractor, and if the referral is timely. A referral is timely if it is received by the Contractor on or before the date started in the notice.

Articles of Agreement
Article I

The Contractor shall take affirmative action in accordance with the provisions of this contract to insure that applicants are employed, and that employees are treated during employment without regard to race, religion, color, age, marital status, disability, sex or national origin and that the employer shall provide harassment free work environment for the realization of the potential of each employee. Such action shall include, but not be limited to, the following: employment, upgrading, demotion or transfer, recruitment or recruitment advertising, layoff or termination, rates of pay or other forms of compensation and selection for training including apprenticeship insofar as it is within the control of the Contractor. The Contractor agrees to post in conspicuous places available to employees and applicants notices to be provided by the City setting out the provisions of the nondiscrimination clauses in this contract.

Article II

The Contractor shall in all solicitations or advertisements for employees placed by or on behalf of the Contractor state that all qualified or qualifiable applicants will be employed without regard to race, religion, color, age, marital status, disability, sex or national origin.

Article III

The Contractor shall send to each labor union or representative of workers with which it has a collective bargaining agreement or other contract or understanding a notice to be provided by the City advising the labor union or worker's representative of the Contractor's equal employment opportunity and affirmative action commitments. Such notices shall be posted in conspicuous places available to employees and applicants for employment.

Article V

The Contractor agrees that it will comply with all provisions of the Affirmative Action Ordinance of the City of Madison, including the contract compliance requirements. The Contractor agrees to submit the model affirmative action plan for public works contractors in a form approved by the Director of Affirmative Action.

Article VI

The Contractor will maintain records as required by Section 39.02(9)(f) of the Madison General Ordinances and will provide the City Affirmative Action Division with access to such records and to persons who have relevant and necessary information, as provided in Section 39.02(9)(f). The City agrees to keep all such records confidential, except to the extent that public inspection is required by law.

Article VII

In the event of the Contractor's or subcontractor's failure to comply with the Equal Employment Opportunity and Affirmative Action Provisions of this contract or Section 39.03 and 39.02 of the Madison General Ordinances, it is agreed that the City at its option may do any or all of the following:

1. Cancel, terminate or suspend this Contract in whole or in part.
2. Declare the Contractor ineligible for further City contracts until the Affirmative Action requirements are met.
3. Recover on behalf of the City from the prime Contractor 0.5 percent of the contract award price for each week that such party fails or refuses to comply, in the nature of liquidated damages, but not to exceed a total of five percent (5%) of the contract price, or five thousand dollars (\$5,000), whichever is less. Under public works contracts, if a subcontractor is in noncompliance, the City may recover liquidated damages from the prime Contractor in the manner described above. The preceding sentence shall not be construed to prohibit a prime Contractor from recovering the amount of such damage from the non-complying subcontractor.

Article VIII

The Contractor shall include the above provisions of this contract in every subcontract so that such provisions will be binding upon each subcontractor. The Contractor shall take such action with respect to any subcontractor as necessary to enforce such provisions, including sanctions provided for noncompliance.

Article IX

The Contractor shall allow the maximum feasible opportunity to small business enterprises to compete for any subcontracts entered into pursuant to this contract.

s. 66.0903 (10) RECORDS; INSPECTION; ENFORCEMENT.

(a) Each contractor, subcontractor, or contractor's or subcontractor's agent performing work on a project of public works that is subject to this section shall keep full and accurate records clearly indicating the name and trade or occupation of every person performing the work described in sub. (4) and an accurate record of the number of hours worked by each of those persons and the actual wages paid for the hours worked.

s. 66.0903 (11) LIABILITY AND PENALTIES.

(a) 1. Any contractor, subcontractor, or contractor's or subcontractor's agent who fails to pay the prevailing wage rate determined by the department under sub. (3) or who pays less than 1.5 times the hourly basic rate of pay for all hours worked in excess of the prevailing hours of labor is liable to any affected employee in the amount of his or her unpaid wages or his or her unpaid overtime compensation and in an additional amount as liquidated damages as provided under subd. 2., 3., whichever is applicable.

2. If the department determines upon inspection under sub. (10) (b) or (c) that a contractor, subcontractor, or contractor's or subcontractor's agent has failed to pay the prevailing wage rate determined by the department under sub. (3) or has paid less than 1.5 times the hourly basic rate of pay for all hours worked in excess of the prevailing hours of labor, the department shall order the contractor to pay to any affected employee the amount of his or her unpaid wages or his or her unpaid overtime compensation and an additional amount equal to 100 percent of the amount of those unpaid wages or that unpaid overtime compensation as liquidated damages within a period specified by the department in the order.

3. In addition to or in lieu of recovering the liability specified in subd. 1. as provided in subd. 2., any employee for and in behalf of that employee and other employees similarly situated may commence an action to recover that liability in any court of competent jurisdiction. If the court finds that a contractor, subcontractor, or contractor's or subcontractor's agent has failed to pay the prevailing wage rate determined by the department under sub. (3) or has paid less than 1.5 times the hourly basic rate of pay for all hours worked in excess of the prevailing hours of labor, the court shall order the contractor, subcontractor, or agent to pay to any affected employee the amount of his or her unpaid wages or his or her unpaid overtime compensation and an additional amount equal to 100 percent of the amount of those unpaid wages or that unpaid overtime compensation as liquidated damages.

5. No employee may be a party plaintiff to an action under subd. 3. unless the employee consents in writing to become a party and the consent is filed in the court in which the action is brought. Notwithstanding s. 814.04 (1), the court shall, in addition to any judgment awarded to the plaintiff, allow reasonable attorney fees and costs to be paid by the defendant.

BUILDING OR HEAVY CONSTRUCTION

Includes sheltered enclosures with walk-in access for the purpose of housing persons, employees, machinery, equipment or supplies and non-sheltered work such as canals, dams, dikes, reservoirs, storage tanks, etc. A sheltered enclosure need not be "habitable" in order to be considered a building. The installation of machinery and/or equipment, both above and below grade level, does not change a project's character as a building. On-site grading, utility work and landscaping are included within this definition. Residential buildings of four (4) stories or less, agricultural buildings, parking lots and driveways are NOT included within this definition.
