 - \$64M for streets and associated water and sewer. This includes engineering and real estate purchases. \$10M of this is for HWY M & PD.

 - Request was made for City to carry Builders Risk insurance or include in contract special provisions that the contractor is required to carry. A.I.A contract specifications include the building owner carrying this insurance. Rob to review with City Risk Manager.
 - Urban League acquired CTI Group to improve apprenticeship training opportunities. They are always looking for opportunities to partner with the City for training.
 - DCR is setting up training in 2017 for SBE and DBE certification and training on the most common discrimination issues.
