**NOTICE OF ADDENDUM**

**ADDENDUM NO. 2**

**SOUTH INGERSOLL STREET AND RUTLEDGE STREET**  
**ASSESSMENT DISTRICT – 2012**

**CONTRACT NO. 6803**

Revise and amend the contract document for the above project as stated in this addendum, otherwise the original documents shall remain in effect.

**SPECIAL PROVISIONS:**

**ADD TO SECTION 511.1 PIPE SPECIFICATIONS**

24" DIPS pipe with no spacers shall be provided.

**DELETE SECTION 511.2 PIPE SPACERS**

**ADD SECTION 511.2 PIPE SPACERS**

No pipe spacers shall be used or required on this project.

**DELETE THE FOLLOWING FROM SECTION 512 INSTALLATION PROCEDURE**

8) Spacers: Non-Center Stainless Restrained Steel Spacers (PSIS8GN-2 or approved equivalent) shall be installed in the 30" VP pipe to fix the new 24" pipe to the bottom of the 30" VP pipe. Spacer-Isolators shall be installed in conformance manufacture's recommendation for required spacing and attachment to the new HDPE pipe. The annular space between the 24" SDPE pipe and the 30" VP shall be pressure grouted. Spacer outside diameter shall not exceed 28" in the 30" VP to allow for movement within the host pipe.

**ADD THE FOLLOWING TO SECTION 512 INSTALLATION PROCEDURE**

8) Spacers: No spacers shall be used or required.
