## CONTRACT NO. 7398 POLICE DEPARTMENT MIDTOWN DISTRICT – HAZMAT ABATEMENT

#### 1. GENERAL CONTRACT CONDITIONS

A. NOTE The contractor has had an opportunity to visit the site so as to familiarize them to the current condition of the building. Please note that the City of Madison will not acknowledge any effort by the contractor to submit for any condition changes, nor will the City of Madison accept any additions to the contract amount related to the current condition of the buildings. Please assure that you are fully aware of the current condition of the buildings.

#### 2. GENERAL QUESTIONS AND ANSWERS

- A. Q1 Will water and electric be supplied by the City on site.
  - A1 No. The contractor will need to supply temporary water and electric for the asbestos removal activities.
- B. Q2 Has asbestos been detected in the center ceiling panels in Sanctuary Room 101?
   A2 A&A Environmental, Inc. (Kim Sopha) verbally reported to the City of Madison (Dave Schaller) that no asbestos was detected in the center ceiling panels in the Sanctuary Room 101.

#### 6. PROPOSAL PAGE

- A. NOTE Bid Item 90001 TSI fittings note in the A&A Environmental, Inc assessment dated 2/8/2014, that it states 530 fittings of asbestos thermal insulation on piping throughout the building located at 4018 Mineral Point Road in Madison, WI. The report should state 93 LF and 440 fittings. These are estimated quantities because some of the fittings are in walls and above ceilings. The plumbing lines are only partially exposed; enough to know asbestos is present on the roof drains. The overall fitting quantity does not change as one fitting equals 1 LF. The overall units for item 90001 will remain the same as originally listed on the proposal page as 917. Delete the word "EACH" and add the "LF" designation in its place.
- B. <u>NOTE</u> Bid Item 90004 Roof tar flashing and paper This item will not be included in this contract. Therefore this bid item needs to be shown as \$0 on the proposal page.
- C. <u>NOTE</u> Bid Item 90005.1 Exterior transite window panels above windows (Sanctuary 101 south wall) This item was verbally reported to the City of Madison (Dave Schaller) by A&A Environmental, Inc. (Kim Sopha) as no asbestos detected. This bid item needs to show \$0 on the proposal page.
