

The Contractor shall review these Specifications prior to preparation of proposals for the work to be done under this contract, with specific attention to Article 102, "BIDDING REQUIREMENTS AND CONDITIONS" and Article 103, "AWARD AND EXECUTION OF THE CONTRACT." For the convenience of the bidder, below are highlights of three subsections of the specifications.

SECTION 102.1: PRE-QUALIFICATION OF BIDDERS

2 Small Business Enterprise (SBE) Program Information

2.1 Policy and Goal

The City of Madison reaffirms its policy of nondiscrimination in the conduct of City business by maintaining a procurement process which remains open to all who have the potential and ability to sell goods and services to the City. It is the policy of the City of Madison to allow Small Business Enterprises (SBE) maximum feasible opportunity to participate in City of Madison contracting. The bidder acknowledges that its bid has been submitted in accordance with the SBE program and is for the public's protection and welfare.

Please refer to the "ADVERTISEMENT FOR BIDS" for the goal for the utilization of SBEs on this project. SBEs may participate as subcontractors, vendors and/or suppliers, which provide a commercially useful function. The dollar value for SBE suppliers or 'materials only' vendors shall be discounted to 60% for purposes of meeting SBE goals.

A bidder which achieves or exceeds the SBE goal will be in compliance with the SBE requirements of this project. In the event that the bidder is unable to achieve the SBE goal, the bidder must demonstrate that a good faith effort to do so was made. Failure to either achieve the goal or demonstrate a good faith effort to do so will be grounds for the bidder being deemed a non-responsible contractor ineligible for award of this contract.

A bidder may count towards its attainment of the SBE goal only those expenditures to SBEs that perform a commercially useful function. For purposes of evaluating a bidder's responsiveness to the attainment of the SBE goal, the contract participation by an SBE is based on the percentage of the total base bid proposed by the Contractor. The total base bid price is inclusive of all addenda.

Work performed by an SBE firm in a particular transaction can be counted toward the goal only if it involves a commercially useful function. That is, in light of industry practices and other relevant considerations, does the SBE firm have a necessary and useful role in the transaction, of a kind for which there is a market outside the context of the SBE Program, or is the firm's role a superfluous step added in an attempt to obtain credit towards goals? If, in the judgment of the Affirmative Action Division, the SBE firm will not perform a commercially useful function in the transaction, no credit towards goals will be awarded.

The question of whether a firm is performing a commercially useful function is completely separate from the question of whether the firm is an eligible SBE. A firm is eligible if it meets the definitional criteria and ownership and control requirements, as set forth in the City of Madison's SBE Program.

If the City of Madison determines that the SBE firm is performing a commercially useful function, then the City of Madison must then decide what that function is. If the commercially useful function is that of an SBE vendor / supplier that regularly transacts business with the respective product, then the City of Madison will count 60% of the value of the product supplied toward SBE goals.

To be counted, the SBE vendor / supplier must be engaged in selling the product in question to the public. This is important in distinguishing an SBE vendor / supplier, which has a regular trade with a variety of customers, from a firm which performs supplier-like functions on an <u>ad hoc</u> basis or for only one or two contractors with whom it has a special relationship.

A supplier of bulk goods may qualify as an eligible SBE vendor / supplier if it either maintains an inventory or owns or operates distribution equipment. With respect to the distribution equipment; e.g., a fleet of trucks, the term "operates" is intended to cover a situation in which the supplier leases the equipment on a regular basis for its entire business. It is not intended to cover a situation in which the firm simply provides drivers for trucks owned or leased by another party; e.g., a prime contractor, or leases such a party's trucks on an ad hoc basis for a specific job.

If the commercially useful function being performed is not that of a qualified SBE vendor / supplier, but rather that of delivery of products, obtaining bonding or insurance, procurement of personnel, acting as a broker or manufacturer's representative in the procurement of supplies, facilities, or materials, etc., only the fees or commissions will apply towards the goal.

For example, a business that simply transfers title of a product from manufacturer to ultimate purchaser; e. g., a sales representative who re-invoices a steel product from the steel company to the Contractor, or a firm that puts a product into a container for delivery would not be considered a qualified SBE vendor / supplier. The Contractor would not receive credit based on a percentage of the cost of the product for working with such firms.

Concerning the use of services that help the Contractor obtain needed supplies, personnel, materials or equipment to perform a contract: only the fee received by the service provider will be counted toward the goal. For example, use of a SBE sales representative or distributor for a steel company, if performing a commercially useful function at all, would entitle the Contractor receiving the steel to count only the fee paid to the representative or distributor toward the goal. This provision would also govern fees for professional and other services obtained expressly and solely to perform work relating to a specific contract.

Concerning transportation or delivery services: if an SBE trucking company picks up a product from a manufacturer or a qualified vendor / supplier and delivers the product to the Contractor, the commercially useful function it is performing is not that of a supplier, but simply that of a transporter of goods. Unless the trucking company is itself the manufacturer or a qualified vendor / supplier in the product, credit cannot be given based on a percentage of the cost of the product. Rather, credit would be allowed for the cost of the transportation service.

The City is aware that the rule's language does not explicitly mention every kind of business that may contribute work on this project. In administering these programs, the City would, on a case-by-case basis, determine the appropriate counting formula to apply in a particular situation.

2.3 Certification of SBE by City of Madison

The Affirmative Action Division maintains a directory of SBEs which are currently certified as such by the City of Madison. Contact the Contract Compliance Officer as indicated in Section 2.2 to receive a copy of the SBE Directory or you may access the SBE Directory online at www.cityofmadison.com/dcr/aaTBDir.cfm.

All contractors, subcontractors, vendors and suppliers seeking SBE status must complete and submit the **Targeted Business Certification Application** to the City of Madison Affirmative Action Division by the time and date established for receipt of bids. A copy of the Targeted Business Certification Application is available by contacting the Contract Compliance Officer at the address and telephone indicated in Section 2.2 or you may access the Targeted Business Certification Application online at www.cityofmadison.com/dcr/aaTBDir.cfm. Submittal of the Targeted Business Certification Application by the time specified does not guarantee that the applicant will be certified as a SBE eligible to be utilized towards meeting the SBE goal for this project.

2.4 Small Business Enterprise Compliance Report

2.4.1 Good Faith Efforts

Bidders shall take all necessary affirmative steps to assure that SBEs are utilized when possible and that the established SBE goal for this project is achieved. A contractor who self performs a portion of the work, and is pre-qualified to perform that category of work, may subcontract that portion of the work, but shall not be required to do so. When a bidder is unable to achieve the established SBE goal, the bidder must demonstrate that a good faith effort to do so was made. Such a good faith effort should include the following:

- 2.4.1.1 Attendance at the pre-bid meeting.
- 2.4.1.2 Using the City of Madison's directory of certified SBEs to identify SBEs from which to solicit bids.
- 2.4.1.3 Assuring that SBEs are solicited whenever they are potential sources.
- 2.4.1.4 Referring prospective SBEs to the City of Madison Affirmative Action Division for certification.
- 2.4.1.5 Dividing total project requirements into smaller tasks and/or quantities, where economically feasible, to permit maximum feasible SBE participation.
- 2.4.1.6 Establishing delivery schedules, where requirements permit, which will encourage participation by SBEs.
- 2.4.1.7 Providing SBEs with specific information regarding the work to be performed.
- 2.4.1.8 Contacting SBEs in advance of the deadline to allow such businesses sufficient time to prepare a bid.
- 2.4.1.9 Utilizing the bid of a qualified and competent SBE when the bid of such a business is deemed reasonable (i.e. 5% above the lowest bidder), although not necessarily low.
- 2.4.1.10 Contacting SBEs which submit a bid, to inquire about the details of the bid and confirm that the scope of the work was interpreted as intended.

2.4.2 Reporting SBE Utilization and Good Faith Efforts

The Small Business Enterprise Compliance Report is to be submitted by the <u>bidder</u> with the bid: This report is due by the specified bid closing time and date. Bids submitted without a completed SBE Compliance Report as outlined below

shall be deemed non-responsible and the bidder ineligible for award of this contract.

- 2.4.2.1 If the Bidder meets or exceeds the goal established for SBE utilization, the Small Business Enterprise Compliance Report shall consist of the following:
 - 2.4.2.1.1 Cover Page, Page C-6; and
 - 2.4.2.1.2 **Summary Sheet,** C-7.
- 2.4.2.2 If the bidder <u>does not meet</u> the goal established for SBE utilization, the Small Business Enterprise Compliance Report shall consist of the following:
 - 2.4.2.2.1 **Cover Page**, Page C-6;
 - 2.4.2.2.2 **Summary Sheet,** C-7; and
 - 2.4.2.2.3 **SBE Contact Report,** C-8 and C-9. (A <u>separate</u> Contact Report must be completed for <u>each applicable</u> SBE which is not utilized.)

2.5 Appeal Procedure

A bidder which does not achieve the established goal and is found non-responsible for failure to demonstrate a good faith effort to achieve such goal and subsequently denied eligibility for award of contract may appeal that decision to the Small Business Enterprises Appeals Committee. All appeals shall be made in writing, and shall be delivered to and received by the City Engineer no later than 4:30 PM on the third business day following the bidder's receipt of the written notification of ineligibility by the Affirmative Action Division Manager. Postmark not acceptable. The notice of appeal shall state the basis for the appeal of the decision of the Affirmative Action Division Manager. The Appeal shall take place in accordance with Madison General Ordinance 33.54.

2.6 SBE Requirements After Award of the Contract

The successful bidder shall identify SBE subcontractors, suppliers and vendors on the subcontractor list in accordance with the specifications. The Contractor shall submit a detailed explanation of any variances between the listing of SBE subcontractors, vendors and/or suppliers on the subcontractor list and the Contractor's SBE Compliance Report for SBE participation.

No change in SBE subcontractors, vendors and/or suppliers from those SBEs indicated in the SBE Compliance Report will be allowed without prior approval from the Engineer and the Affirmative Action Division. The contractor shall submit in writing to the City of Madison Affirmative Action Division a request to change any SBE citing specific reasons which necessitate such a change. The Affirmative Action Division will use a general test of reasonableness in approving or rejecting the contractor's request for change. If the request is approved, the Contractor will make every effort to utilize another SBE if available.

The City will monitor the project to ensure that the actual percentage commitment to SBE firms is carried out.

2.7 SBE Definition and Eligibility Guidelines

A Small Business Enterprise is a business concern awarded certification by the City of Madison. For the purposes of this program a Small Business Enterprise is defined as:

- A. An independent business operated under a single management. The business may not be a subsidiary of any other business and the stock or ownership may not be held by any individual or any business operating in the same or a similar field. In determining whether an entity qualifies as a SBE, the City shall consider all factors relevant to being an independent business including, but not limited to, the date the business was established, adequacy of its resources for the work in which it proposes to involve itself, the degree to which financial, equipment leasing and other relationships exist with other ineligible firms in the same or similar lines of work. SBE owner(s) shall enjoy the customary incidents of ownership and shall share in the risks and profits commensurate with their enjoyment interests, as demonstrated by an examination of the substance rather than form or arrangements that may be reflected in its ownership documents.
- B. A business that has averaged no more than \$4.0 million in annual gross receipts over the prior three year period and the principal owner(s) do not have a personal net worth in excess of \$1.32 million.

Firm and/or individuals that submit fraudulent documents/testimony may be barred from doing business with the City and/or forfeit existing contracts.

SBE certification is valid for one (1) year unless revoked.

SECTION D: SPECIAL PROVISIONS

MATC NORTH DITCH RESTORATION CONTRACT NO. 7722

It is the intent of these Special Provisions to set forth the final contractual intent as to the matter involved and shall prevail over the Standard Specifications and plans whenever in conflict therewith. In order that comparisons between the Special Provisions can be readily made, the numbering system for the Special Provisions is equivalent to that of the Specifications.

Whenever in these Specifications the term "Standard Specifications" appears, it shall be taken to refer to the City of Madison Standard Specifications for Public Works Construction and Supplements thereto.

SECTION 102.9: BIDDER'S UNDERSTANDING

<u>Tax Exempt Status</u>: Effective with all contracts executed after January 1, 2016, the sales price from the sale, storage, use or other consumption of tangible personal property that is used in conjunction with a public works improvement for a tax exempt entity (including the City of Madison), is exempt from State sales tax. Said property must become a component of the project owned by the tax exempt entity and includes: any building; shelter; parking lot; parking garage; athletic field; storm sewer; water supply system; or sewerage and waste water treatment facility, but does not include a highway, street or road.

The contractor shall ensure that the exemption for sales and use tax available under Wis. Stat. Sec. 77.54(9m) applies where available. The contractor shall provide all necessary documentation as required by the State of Wisconsin and the City of Madison to comply with this exemption.

SECTION 102.10: PREVAILING WAGE

For this project, payment of prevailing wages (white sheet prevailing wages are not required is checked below.) shall be required unless the box indicating

When multiple boxes are checked, worker's wages may vary according to the type and area of work performed. It is the responsibility of the Contractor to determine and apply the appropriate wage rate for the specific work assigned.

SECTION 102.12: BEST VALUE CONTRACTING

This Contract shall be considered a Best Value Contract if the Contractor's bid is equal to or greater than \$56,500 for a single trade contract; or equal to or greater than \$277,000 for a multi-trade contract pursuant to MGO 33.07(7).

SECTION 102.14 BAN THE BOX – ARREST AND CRIMINAL BACKGROUND CHECKS (SEC. 39.08, MGO)

This provision applies to all prime contractors on contracts entered into on or after January 1, 2016, and all subcontractors who are required to meet pregualification requirements under MGO 33.07(7)(I), MGO

as of the first-time they seek or renew pre-qualification status on or after January 1, 2016. The City will, monitor compliance of subcontractors through the pre-qualification process.

A. Definitions. For purposes of this section, "Arrest and Conviction Record" includes, but is not limited to, information indicating that a person has been questioned, apprehended, taken into custody or detention, held for investigation, arrested, charged with, indicted or tried for any felony, misdemeanor or other offense pursuant to any law enforcement or military authority.

"Conviction record" includes, but is not limited to, information indicating that a person has been convicted of a felony, misdemeanor or other offense, placed on probation, fined, imprisoned or paroled pursuant to any law enforcement or military authority.

"Background Check" means the process of checking an applicant's arrest and conviction record, through any means.

- B. Requirements. For the duration of this Contract, the Contractor shall:
 - 1. Remove from all job application forms any questions, check boxes, or other inquiries regarding an applicant's arrest and conviction record, as defined herein.
 - 2. Refrain from asking an applicant in any manner about their arrest or conviction record until after conditional offer of employment is made to the applicant in question.
 - 3. Refrain from conducting a formal or informal background check or making any other inquiry using any privately or publicly available means of obtaining the arrest or conviction record of an applicant until after a conditional offer of employment is made to the applicant in question.
 - 4. Make information about this ordinance available to applicants and existing employees, and post notices in prominent locations at the workplace with information about the ordinance and complaint procedure using language provided by the City.
 - 5. Comply with all other provisions of Sec. 39.08, MGO.
- **C. Exemptions:** This section shall not apply when:
 - 1. Hiring for a position where certain convictions or violations are a bar to employment in that position under applicable law, or
 - 2. Hiring a position for which information about criminal or arrest record, or a background check is required by law to be performed at a time or in a manner that would otherwise be prohibited by this ordinance, including a licensed trade or profession where the licensing authority explicitly authorizes or requires the inquiry in question.

To be exempt, Contractor has the burden of demonstrating that there is an applicable law or regulation that requires the hiring practice in question, if so, the contractor is exempt from all of the requirements of this ordinance for the position(s) in question.

SECTION 104: SCOPE OF WORK

The proposed channel improvements consist of reconfiguring approximately 1450 linear feet of existing drainage channel that is located between Stoughton Road (USH 51) and Wright Street. The project will consist of removing existing vegetation, including shrubs, trees, and dense herbaceous vegetation (cattails, reed canary grass, etc.), dredging the channel as shown in the plan set, placing a clay liner on the channel banks, and constructing grade control structures at the locations and elevations shown in the plan set.

SECTION 104.4: INCREASED OR DECREASED QUANTITIES

The Contractor shall note that some bid item quantities may increase or decrease based on what is encountered in the field. If the actual field conditions vary from the plan quantity, no additional compensation shall be given for increasing or decreasing quantities. Any overruns shall be paid for under the appropriate bid items(s) without any penalty or change to the bid price for the associated bid item.

The Contractor shall not be reimbursed for any deletions to the contract. No change to the unit bid price will be allowed for changes in the quantities.

SECTION 105.12: COOPERATION BY THE CONTRACTOR

This project will be completed on the MATC campus, and will require the use of MATC roads and facilities to complete the work as designed. The Contractor shall coordinate use of all access roads, parking lots, etc., with MATC staff. Appropriate contacts for coordination are:

SECTION 107.2: PROTECTION AND RESTORATION OF PROPERTY

This project will be completed on the MATC campus, and will require the use of MATC roads and facilities to complete the work as designed. The Contractor shall take all necessary precautions to prevent damage to asphalt, curb and gutter, concrete flumes, existing storm pipes, signs, trees, etc. If, during the course of the project, any facility or structure is damaged, it shall be replaced or repaired at no cost to the City. The Construction Engineer shall determine if private property damage has occurred and the extent to which it shall be repaired.

If the Contractor determines that the project, or a portion of the project, cannot be completed without damage to a private facility, it shall be immediately brought to the attention of the Project Engineer.

SECTION 107.7: MAINTENANCE OF TRAFFIC

The Contractor shall be permitted to use the southeast portion of the parking lot on the north side of the channel as equipment storage and as a general lay down area. The Contractor shall also be permitted to work from the access road to the south of the channel, provided that one way traffic is maintained. The Contractor shall not store equipment or materials within the access road over night. As defined in Section 107.2 of these Special Provisions, the Contractor shall be responsible for repairing any construction damage to these facilities. No equipment or materials may be stored within the channel or floodplain.

SECTION 107.13: TREE PROTECTION SPECIFICATIONS

The Contractor is advised to review Article 107.13 of the Standard Specifications for tree protection. Note that Articles 107.13(a) Underground Utility Excavation & Installation, 107.13(b) Curb Excavation and Installation, and 107.13(c) Sidewalk Excavation and Installation are not applicable to this project except as noted below.

Although clearing will be a significant portion of this contract, the ornamental trees adjacent to the access road will not be removed and shall be protected. These trees are designated on the plan set. It is recognized that grading operations will need to occur within 5 feet of the trunk in order to complete the specified work. Care shall be taken in these areas. For trees where construction operations, including grading, stone placement, filling, etc. occur within 5 feet of the trunk, construction operations near these trees shall be done under the supervision of a City of Madison Arborist. The sequence to perform construction activities adjacent to trees shall be as follows:

- 1. Trees within 5 feet of construction operations shall not be disturbed until inspected by a City of Madison Arborist. The Project Engineer can schedule this.
- 2. The Contractor shall place a yellow ribbon around the tree to highlight these trees for equipment operators
- 3. The ribbon shall remain until the area is fine graded and seeded. If necessary, roots shall be cut cleanly by using a saw, ax, lopping shears, chain saw, stump grinder, or other means which will

produce a clean cut. Exposed roots shall be converted as soon as excavation and installation are complete. All roots over one (1) inch in diameter that are damaged shall be cleanly cut immediately back of the damaged section on the same day of the excavation. The Contractor shall not rip or pull roots out towards the trunk if a tree while excavating with a backhoe. The use of a backhoe to cut roots is NOT acceptable.

4. If grading, etc. does not need to occur within 5 feet of the trunk, or final grading has been completed but construction activities will continue in the vicinity, Construction Fencing shall be placed around the tree. Provision of Construction Fencing shall be paid under Bid Item 90040.

All provisions of Articles 107.13(d), 107.13(f) Bank Abrasions and Limb Damage, 107.13(g) Soil Compaction, 107.13(h) Contractor/Foreperson Acknowledgement, and 107.13(i) Cost Recovery and Liquidated Damages are applicable to this contract.

Protection of these trees shall be considered incidental to Bid Item 10911 - Mobilization, with the exception of Temporary Fencing provision, which shall be paid under Bid Item 90040.

SECTION 108.2: PERMITS

The following permits are required for this project and have been obtained by the City of Madison:

- Army Corps of Engineers Permit See Attached Permit
- WI-DNR Chapter 30 Permit See Attached Permit Conditions
- WI-DNR WRAPP Water Resources Application for Project Permit, formerly known as a Notice of Intent NOI) for construction site erosion control
- City of Madison Erosion Control and Stormwater Management Permit

It shall be the responsibility of the Contractor to obtain the permits listed below, if required, and to pay all applicable charges and fees associated with these permits.

Wisconsin DNR Dewatering

All permit costs shall be considered incidental to the various Mobilization bid items for the Contract.

The Contractor shall meet the conditions of all permits and must keep a copy of each individual permit on site at all times throughout construction.

With regard to Control of Invasive or Exotic Species, the Chapter 30 permit will stipulate that any equipment or materials that may be in contact with invasive or exotic species must be decontaminated prior to and after work at the project site. It shall be the Contractor's responsibility to comply with decontamination requirements.

The Contractor shall meet the conditions of the permits involving including properly installing and maintaining the erosion control measures shown on the plans, specified in these Special Provisions, or as directed by the Construction Engineer or his designees. This work will be paid for under the appropriate bid items, or if appropriate items are not included in the contract, they shall be paid for as Extra Work.

The City's obtaining these permits is not intended to be exhaustive of all permits that may be required to be obtained by the Contractor for construction of this project. It shall be the responsibility of the Contractor to identify and obtain any other permits needed for construction.

SECTION 109.2: PROSECUTION OF THE WORK

The Contractor shall begin work on or before <u>June 13, 2016</u>. The time of completion shall be <u>July 22, 2016</u>. The Contractor shall be required to complete the work in the time frame provided. No alternative schedules will be permitted.

Work shall begin only after the start of work letter is received. If it is desirable to begin work before the above-mentioned date, the Contractor shall establish a mutually acceptable date with the City Engineer (contact the Construction Engineer at 266-4089). The Contractor shall be required to limit workdays to Monday through Saturday, 7:00 AM to 7:00 PM. Work shall not be performed on holidays.

The Contractor shall not work on days when rain is anticipated. The Contractor shall not stockpile any materials that are susceptible to suspension within the floodplain, including topsoil, fill, and clay.

The Contractor shall not disturb more channel than can be restored within one working day. Special permission may be granted by the Construction Engineer to leave banks disturbed over night, provided local forecasts predict less than a 30% chance for rain.

SECTION 109.5: METHODS AND EQUIPMENT

The Contractor is encouraged to visit the site prior to bidding. Working space and lay down areas are limited. As a result, smaller equipment may be the preferred working method.

BID ITEMS 10911: MOBILIZATION

DESCRIPTION

This bid item includes all work, equipment, materials, and incidentals necessary to mobilize equipment, personnel, and materials required to complete the channel grading and associated construction, as shown in the plan set. Mobilization activities shall be completed in accordance with Article 109.14 of the Standard Specifications for Public Works Construction.

This bid item shall include all labor, equipment, and materials necessary to protect trees as shown in the plan set, with the exception of any Temporary Fencing deemed necessary for the job. Provision, placement, removal, and restoration activities associated with Temporary Fencing shall be paid under Bid Item 90040.

METHOD OF MEASUREMENT

Mobilization shall be measured as a Lump Sum.

BASIS OF PAYMENT

Mobilization shall be paid for at the contract unit price for work as described and measured above, which shall be full compensation for all labor, tools, equipment, and incidentals necessary to complete the work described above and within Article 109.14 of the Standard Specifications.

BID ITEM 20201: EXCAVATION CUT

DESCRIPTION

Excavation Cut shall include all excavation from within the limits shown on the plans. Excavation Cut shall be completed in accordance with Article 201 of the Standard Specifications and has been divided into the following three categories:

• Channel Excavation 3,000 c.y. This quantity includes excavation to the lines and grades of the channels as shown on Sheets X-1 through X-18.

Clay Liner Excavation 712 c.y. This quantity includes the maximum potential excavation required to place the clay liner within the channel, as shown on Sheet D-1. If clay, meeting the specifications defined in Bid Item 90032 exists naturally at the base of the excavation, additional excavation and

subsequent placement of a clay liner is not necessary. This excavation quantity shall be considered incidental to Bid Item 90032 – Lean Clay Import.

• Grade Control Structure and Riprap Excavation

This quantity includes the excavation necessary to construct 5 grade control structures and place riprap as shown in the plan sets.

No bulking/expansion or shrink factors were applied when determining earthworks quantities for this project. No adjustments have been made to above quantities for topsoil or root masses. In cut sections, or at-grade sections, if over-excavation is required to place adequate topsoil thicknesses, over excavation shall be considered to be incidental to Bid Item 20221-Topsoil.

METHOD OF MEASUREMENT

Excavation Cut within the limits shown on the plans and cross-sections will be paid based on the "Plan Quantity" without measurement thereof, with the exception of excavation associated with the placement of the clay liner within the channel. The plan quantity was computed by average end area based on cross-sections. No changes to this quantity shall be approved unless there are modifications to the plan that result in significant (>15%) increase or decrease in quantity.

BASIS OF PAYMENT

Excavation Cut shall be paid for at the contract unit price for work as described and measured above, which shall be full compensation for all labor, tools, equipment, and incidentals necessary to complete this item of work.

BID ITEMS 20404 & 20409: CLEARING AND GRUBBING

DESCRIPTION

Work performed under these bid items shall include all labor, materials, equipment, and incidentals necessary to fully remove all trees, brush, dense herbaceous vegetation, and associated root systems from within the boundary marked on the plan set. Work shall be completed in accordance with Article 204 of the Standard Specifications. All hauling and disposal of cleared and grubbed material shall be considered incidental to this bid item.

Clearing and Grubbing

23,506 sf (0.54 ac)

The Contractor shall be aware that the ornamental trees along the access road are to remain and shall be protected, as shown on the plan set. Tree Protection shall be paid under Bid Items 10911, Mobilization and 90040 Temporary Fencing.

If additional Clearing and Grubbing is determined to be necessary outside of the marked clearing limits, additional work shall be paid under one of the following bid items: 20401, Clearing (Inch Diameter); 20403, Clearing (Square Yard); 20406, Grubbing (Inch Diameter); 20408, Grubbing (Square Yard). A measurement determination will be made by the Construction Engineer and will be based on the most applicable method of measurement.

METHOD OF MEASUREMENT

Both bid items 20404 and 20409, Clearing and Grubbing respectively, shall be measured based on "Plan Quantity" without measurement thereof. If Clearing or Grubbing outside of the limits shown on the plan set is required, it shall be measured per Square Yard or Inch Diameter.

BASIS OF PAYMENT

Clearing and Grubbing shall be paid for at the contract unit prices for work as described and measured above, which shall be considered full compensation for all labor, tools, equipment, and incidentals necessary to complete this item of work.

BID ITEM 90030: STORM/STREAM CONTROL

DESCRIPTION

Work under this item shall include all work, materials, equipment, and incidentals required to control dry and wet weather flow in the storm sewer system and channel for the duration of the project. The Contractor shall take all necessary steps to protect the new and existing structures and grading from damage during construction, and to accommodate the existing flows during construction.

Due to the minimal slope within the channel, the contractor shall anticipate wet conditions within the channel at all times. During even small rain events, the channel can rapidly fill and may contain drainage flows for several days. The Contractor shall anticipate these conditions.

This item also covers all work, materials, equipment, and incidentals required to control any ground water encountered when excavating within the channel or installing the grade control structures. The Contractor shall be responsible for designing a dewatering plan to fit his/her construction methods and for permitting said plan if that is required. No masonry shall be installed in water.

The Contractor shall be aware that any dewatering (including trench dewatering or pumping water from between grade control structures) shall be treated prior to discharge. The pumped water shall be treated to remove suspended solids. At a minimum, this treatment shall include running the pump water through a geotextile sediment bag, or allow it to settle between two grade control structures, prior to discharge to the storm sewer. This geotextile sediment bag shall have a 0.040 mm apparent opening size (AOS). If, at the determination of the Construction Engineer, this treatment process is not providing sufficient sediment removal the Contractor shall add a polymer to the sediment bag. These polymers shall comply with the WDOT standards for Polyacrylamide Soil Stabilizers and shall conform to the WDOT's Product Acceptability List (PAL) for Soil Stabilizers, Type B.

Polymer would be added to the sediment bag in amounts as recommended by the manufacturer based on the pump rates being experienced on the site.

If necessary the Contractor shall obtain, from the Wisconsin Department of Natural Resources (WDNR), in accordance with Paragraph 144.025(2)(e), Wisconsin Statutes, permits for all groundwater control wells which singly or in aggregate produce 70 or more gallons per minute. All wells shall be drilled and sealed in accordance with requirements of the WDNR for installing and abandoning wells. The address for obtaining well permits is:

Wisconsin Department of Natural Resources Private Water Supply Section BOX 7921 Madison, Wisconsin 53707

The Contractor shall be solely responsible for choosing a method of groundwater control, which is compatible with the constraints defined. The Contractor shall be responsible for the adequacy of the groundwater control system and shall take all necessary measures to ensure that the groundwater control operation will not endanger or damage any existing adjacent utilities or structures.

The method or methods shall be designed, installed and operated in such a manner to provide satisfactory working conditions and to maintain the progress of work. The methods and systems shall be designed so as to avoid settlement or damage to adjacent property in accordance with the applicable legislative statutes and judicial decisions of the State of Wisconsin. All required pumping, drainage and

disposal of groundwater shall be done without damage to adjacent property or structures, or to the operations of other contractors and without interference with the access rights of public or private parties.

METHOD OF MEASUREMENT

Storm/Stream Control shall be measured as a Lump Sum for all stream control, storm control, and dewatering necessary throughout construction.

BASIS OF PAYMENT

Storm/Stream Control shall be measured as described above and shall be paid at the contract unit price, which shall be considered full compensation for all labor, materials, equipment, and incidentals necessary to manage storm sewer and greenway flows for the duration of construction.

BID ITEM 90031: SEEDING – NATIVE GRASS MIX

DESCRIPTION

Work under this bid item shall include all labor, equipment, and incidentals necessary to provide, store, and place Native Grass Seed Mix in the locations shown on the plan set. All work, including the addition of soil stabilizers, fertilizers, and the addition of the specified cover crop, shall be completed in accordance with Article 207 of the Standard Specifications. Following seeding, the site shall be stabilized with erosion matting as shown on Sheet EC-1, which shall be paid separately under the appropriate bid item.

The seed mix, as defined below, was provided by Agrecol in Madison, Wisconsin (608-223-3571). The Contractor may choose to use an alternate supplier, but shall submit the seed mix and supplier contact information to the Engineer for approval.

This seed mix shall be accompanied with a cover crop consisting of 65 pounds per acre of Winter Wheat and 15 pounds per acre of Annual Ryegrass. This cover crop shall be used regardless of what time of year the site is seeded.

METHOD OF MEASUREMENT

Seeding – Native Grass Mix within the limits shown on the plan set shall be paid per Square Yard based on the "Plan Quantity" without measurement thereof. Plan quantity is based on planar measurements of the area between the top of bank of the dredged channel and the outward extent of the grading limits. If additional Native Grass seeding is required outside of the limits shown on the plan set, provision and placement as defined above shall be measured per Square Yard as measured in the field.

BASIS OF PAYMENT

Seeding – Native Grass Mix shall be measured as described above and shall be paid at the contract unit price, which shall constitute full compensation for provision and placement of seed as defined in this section and Article 207 of the Standard Specifications.

BID ITEM 90032: LIGHT RIPRAP – GLACIAL FIELD STONE

DESCRIPTION

Work under this item includes all equipment, materials, labor, and incidentals required to provide and install glacial field stone as shown in the plan set and described in these Special Provisions. The stone shall meet the sizing requirements defined in Article 212.2 of the Standard Specifications and have an average stone size of 12 inches.

The material shall be comprised of rounded, weathered, durable, glacial till that has been sorted for size and is not susceptible to freeze-thaw degradation. Crushed, blasted, or "made" stone will not permitted on site.

Prior to placement, the Contractor shall submit sourcing information to the Project Engineer or Construction Engineer. The Project Engineer, or their representative, may choose to evaluate the material at the source prior to acceptance.

Stone shall be placed in accordance with Article 212 of the Standard Specifications, with the exception that it shall be placed to a thickness of 18 inches. The stone shall be underlain with Riprap Filter Fabric, Type HR, which shall be paid separately under Bid Item 20233.

METHOD OF MEASUREMENT

Light Riprap - Glacial Field Stone shall be measured per Ton of material provided, transported, and placed on site.

BASIS OF PAYMENT

Light Riprap — Glacial Field Stone shall be measured as described above and shall be paid for at the contract unit price which shall be considered full compensation for all work, materials, equipment, and incidentals necessary to source, transport, and place stone as defined in the plan set and these Special Provisions.

BID ITEM 90033: MEDIUM RIPRAP – GLACIAL FIELD STONE

DESCRIPTION

Work under this item includes all equipment, materials, labor, and incidentals required to provide and install glacial field stone as shown in the plan set and described in these Special Provisions. The stone shall meet the sizing requirements defined in Article 212.2 of the Standard Specifications and have an average stone size of 14 inches.

The material shall be comprised of rounded, weathered, durable, glacial till that has been sorted for size and is not susceptible to freeze-thaw degradation. Crushed, blasted, or "made" stone will not permitted on site.

Prior to placement, the Contractor shall submit sourcing information to the Project Engineer or Construction Engineer. The Project Engineer, or their representative, may choose to evaluate the material at the source prior to acceptance.

Stone shall be placed in accordance with Article 212 of the Standard Specifications with the exception that it shall be placed to a thickness of 2 feet. The stone shall be underlain with Riprap Filter Fabric, Type HR, which shall be paid separately under Bid Item 20233.

METHOD OF MEASUREMENT

Medium Riprap – Glacial Field Stone shall be measured per Ton of material provided, transported, and placed on site.

BASIS OF PAYMENT

Medium Riprap – Glacial Field Stone shall be measured as described above and shall be paid for at the contract unit price which shall be considered full compensation for all work, materials, equipment, and incidentals necessary to source, transport, and place stone as defined in the plan set and these Special Provisions.

BID ITEM 90034: 16" – 18" GLACIAL BOULDERS

DESCRIPTION

Work under this item includes all equipment, materials, labor, and incidentals required to provide glacial field stone on the face and rear slopes of the grade control structures. Installation of the stone shall be paid under Bid Item 90036 – Grade Control Structures.

The material shall be comprised of rounded, weathered, durable, glacial till that has been sorted for size and is not susceptible to freeze-thaw degradation. Crushed, blasted, or "made" stone will not permitted on site.

The Contractor shall submit sourcing information to the Project Engineer or Construction Engineer. The Project Engineer, or their representative, may choose to evaluate the material at the source prior to acceptance.

METHOD OF MEASUREMENT

16" – 18" Glacial Boulders shall be measured per Ton of material provided and transported to the site.

BASIS OF PAYMENT.

16" – 18" Glacial Boulders shall be measured as described above and shall be paid for at the contract unit price which shall be considered full compensation for all work, materials, equipment, and incidentals necessary to source and transport the material described in these Special Provisions to the site.

BID ITEM 90035: 3" - 9" GLACIAL FIELD STONE

DESCRIPTION

Work under this item includes all equipment, materials, labor, and incidentals required to provide glacial field stone on the top of the grade control structures. Installation of the stone shall be paid under Bid Item 90036 – Grade Control Structures.

The Contractor shall submit sourcing information to the Project Engineer or Construction Engineer. The Project Engineer, or their representative, may choose to evaluate the material at the source prior to acceptance.

METHOD OF MEASUREMENT

3" - 9" Glacial Field Stone shall be measured per Ton of material provided and transported to the site.

BASIS OF PAYMENT

3" - 9" Glacial Field Stone shall be measured as described above and shall be paid for at the contract unit price which shall be considered full compensation for all work, materials, equipment, and incidentals necessary to source and transport the material described in these Special Provisions to the site.

BID ITEM 90036: GRADE CONTROL STRUCTURES

DESCRIPTION

Work performed under this bid item shall include all labor, equipment, and incidentals necessary to fully to construct five grade control structures as shown in the plan set. The grade control structures shall be constructed to the extents and elevations shown on Sheets P-1 through P-3. This bid item is intended to only pay for the construction of the grade control structures. Material used to construct the structures shall be paid individually, under the appropriate bid items.

Lean Clay – Import

The Contractor shall construct a clay core within the grade control structure, consisting of material as described in Bid Item 90039. The clay shall be placed and compacted in 6 inch to 8 inch lifts, to an ultimate height of approximately 6 feet. Please note that approximately 2.5 feet of the overall 6-foot height will be placed below the ultimate depth of the channel, as shown on Sheet D-1. Provision of the clay, including salvage from the site, shall be paid under Bid Item 90036

Filter Fabric Type HR

Filter fabric shall be placed as shown on Sheet D-1. The Contractor shall place the filter fabric in a manner that prevents excess fabric from showing above the installed stone (above the water table). Provision of material shall be paid for under Bid Item 20233.

Clear Stone

Clear stone meeting the material described in Article 401.1(b) Gradation No. 1 of the Standard Specifications shall be placed between the clay core and 16" – 18" Glacial Field Stone. This shall be used to provide a stable and malleable bed into which the boulders

can be set. Provision of the Clear Stone shall be paid under Bid Item 20217 - Clear Stone.

• 16" - 18" Glacial Boulders

Provision of the glacial boulders shall be paid under Bid Item 90034, 16" – 18" Glacial Boulders. The Contractor shall place glacial boulders on the upstream and downstream slopes of the grade control structure, as shown on Sheet D-1. Please note that boulders shall be buried to an approximate depth of 2.5 feet on the downstream side of the structure. The boulders shall be placed at a maximum slope of 1 H:1V.

• 3" - 9" Glacial Field Stone

Provision of the filed stone shall be paid under Bid Item 90035, 3" – 9" Glacial Field Stone. The Contractor shall place field stone on the top of the grade control structure, as shown on Sheet D-1. The thickness of the field stone at the edges of the channel shall be approximately 1.5 feet. The stone shall be placed in a concave shape, with the smallest depth of 9 inches occurring in the center of the channel.

METHOD OF MEASUREMENT

Grade Control Structures shall be measured per Each structure constructed in the field.

BASIS OF PAYMENT

Grade Control Structures shall be measured as provided above and shall be paid at the contract price, which shall be considered full compensation for all labor, equipment, and incidentals necessary to construct the grade control structures.

BID ITEM 90037: CONTAMINATED SOIL DEWATERING AND DISPOSAL

DESCRIPTION

Work under this bid item shall include all work, equipment, materials, and incidentals required to dewater and haul material excavated from the main channel, between stations 18+75 and 25+00. This material has been found to contain low level polynuclear aromatic hydrocarbons (PAHs) and shall be treated as a solid waste. The Contractor is not responsible for identifying or segregating contaminated material.

Dense root masses shall be separated from the soil in this section of the channel. The Contractor shall be responsible for the disposal of vegetative material.

If the material is fully saturated, meaning containing any free-phase water that may drip or run, the Contractor shall haul the material in water-tight trucks to the Madison Metropolitan Sewerage District (MMSD) drying beds, located southeast of MMSD treatment facility, off Moorland Road. The material shall remain in the drying beds until all free liquid has drained or been evaporated. If necessary, the Contractor shall rake or turn the material to speed drying. The material generated at this site shall be kept separate from any other material stockpiled at the drying beds.

There will be no fee to the Contractor for using this facility. The Contractor shall notify the Project Engineer 2 days prior to hauling any material to MMSD.

Once the material is sufficiently dry, or if it is dry enough at the time of excavation, the Contractor shall haul the soil to the bioremediation facility at the Waste Management Madison Prairie Landfill on 3490 Nelson Road Sun Prairie, WI 53590 (608.837.9031). The City will pay the landfill disposal costs.

Contractor shall perform this work in accordance to standard spec 205 and with pertinent parts of Chapters NR 700-754 of the Wisconsin Administrative Code, as supplemented herein. Per NR 718.07, a

solid waste collection and transportation service-operating license is required under NR 502.06 for each vehicle used to transport contaminated soil.

If contaminated soils—based on unusual odor, presence of cinder, staining, etc.—are encountered elsewhere on the project, terminate excavation activities in the area and notify the Engineer.

The role of the environmental consultant will be limited to:

- 1. Identifying contaminated soils to be hauled to the bioremediation facility;
- 2. Obtaining the necessary approvals for disposal of contaminated soil from the bioremediation facility.

METHOD OF MEASUREMENT

Contaminated Soil Dewatering and Disposal shall be measured in Tons of contaminated soil accepted by the bioremediation facility as documented by weight tickets generated by the bioremediation facility.

BASIS OF PAYMENT

Contaminated Soil Dewatering and Disposal shall be paid at the contract price which shall be full compensation for all work set forth in the description above. Payment is full compensation for excavating, segregating, loading, and hauling to the Madison Prairie Landfill; obtaining solid waste collection and transportation service operating licenses; assisting in the collection soil samples for field evaluation if needed; and dewatering of soils prior to transport, if necessary.

Lean Clay – Import shall be measured per Cubic Yard of clay salvaged or imported to the site, based on the "Plan Quantity" without measurement thereof. Plan quantity is based on average end area calculations and does not include any expansion or compaction factors.



- 2. Non-compliance violations and warnings for administrative and field items will be tracked separately.
- 3. <u>Administrative non-compliance</u> shall include, but not be limited to: failure to hold a required preconstruction meeting, failure to submit erosion control plan initial implementation certification form, failure to complete weekly inspection report, or failure to complete a post-rain event inspection report.
- 4. For permitted projects that are required to submit weekly inspection reports, compliance checks are run automatically every Monday morning at 6:00 AM. To be considered in compliance, an online inspection report must be completed before this automatic compliance check is performed. Property owners, applicants, and authorized inspectors will receive an automatic email notice that the required inspection report has not been completed. This is not to be considered a reminder system; if this email notice is sent, the site is already in non-compliance.
- 5. Post-rain event inspection report compliance will be run manually by City Engineering 48 hours after the rain event day. Notices of non-compliance will be sent to property owners, applicants, and authorized inspectors for permitted projects that have not completed the required inspection report.
- 6. Property owners, applicants, and their authorized inspectors will **NOT** be reminded by City Engineering when a rain event requiring inspection occurs (0.5 inches or larger). The permit holder or their authorized inspector(s) will need to check for rainfall amounts. The rain gauge closest to the construction site should be used to determine rainfall amount.

In the event the closest rain gauge is out of order, the gauge for the other side of town shall be referenced. If both gauges are out of order, default to the "Madison Area" Location on the National Weather Service website: http://www.nws.noaa.gov/climate/xmacis.php?wfo=mkx

Rain gauges at the construction site or any other location will not be acceptable, as they cannot be verified by City inspection staff in a timely manner.

- 7. Field non-compliance shall include, but is not limited to: land disturbance work without a permit, working without erosion control measures installed, improperly installed erosion control measures, failure to maintain erosion control measures, tracking of sediment onto adjacent streets or property, discharge of silt laden runoff or pump discharge from the site, etc.
- 8. Field violations will generate warnings from the City inspector that will be conveyed on-site to the project superintendant (if available) and by email notice to the property owner, applicant, and authorized inspector.
- 9. If the usual notice and citation methods fail to result in the permitted site being brought into compliance with MGO Ch 37 requirements, additional enforcement measures such as, but not limited to, stop work orders or referral to the City Attorney will be used.
- 10. In the case of a safety hazard, City inspection staff will attempt to obtain immediate corrective action to remedy on the part of the contractor, property owner, or applicant. If immediate action is not available (unable to contact, or parties refuse to comply immediately), then City Engineering will take measures necessary to correct the hazard. These costs will be billed to the property owner as a special charge per Madison General Ordinances. In the case of a refusal to comply, this will result in an immediate field violation and issuance of a citation as well.

PERMIT

- 1. You must notify Wendy Peich at phone (608) 275-3481 or email wendy peich@wisconsin.gov before starting construction and again not more than 5 days after the project is complete.
- 2. You must complete the project as described on or before March 21st, 2019. If you will not complete the project by this date, you must submit a written request for an extension prior to expiration of the initial time limit specified in the permit. Your request must identify the requested extension date. The Department shall extend the time limit for an individual permit or contract for no longer than an additional 5 years if you request the extension before the initial time limit expires. You may not begin or continue construction after the original permit expiration date unless the Department extends the permit in writing or grants a new permit.
- 3. This permit does not authorize any work other than what you specifically describe in your application and plans, and as modified by the conditions of this permit. If you wish to alter the project or permit conditions, you must first obtain written approval of the Department.
- 4. Before you start your project, you must first obtain any permit or approval that may be required for your project by local zoning ordinances and by the U.S. Army Corps of Engineers. You are responsible for contacting these local and federal authorities to determine if they require permits or approvals for your project. These local and federal authorities are responsible for determining if your project complies with their requirements.
- 5. Upon reasonable notice, you shall allow access to your project site during reasonable hours to any Department employee who is investigating the project's construction, operation, maintenance or permit compliance.
- 6. The Department may modify or revoke this permit for good cause, including if the project is not completed according to the terms of the permit or if the Department determines the activity is detrimental to the public interest.
- 7. You must post a copy of this permit at a conspicuous location on the project site, visible from the waterway, for at least five days prior to construction, and remaining at least five days after construction. You must also have a copy of the permit and approved plan available at the project site at all times until the project is complete.
- 8. Your acceptance of this permit and efforts to begin work on this project signify that you have read, understood and agreed to follow all conditions of this permit.

- 9. You must submit a series of photographs to the Department, within one week of completing work on the site. The photographs must be taken from different vantage points and depict all work authorized by this permit.
- 10. You, your agent, and any involved contractors or consultants may be considered a party to the violation pursuant to Section 30.292, Wis. Stats., for any violations of Chapter 30, Wisconsin Statutes, or this permit.
- 11. Construction shall be accomplished in such a manner as to minimize erosion and siltation into surface waters. Erosion control measures (such as silt fence and straw bales) must meet or exceed the technical standards of ch. NR 151, Wis. Adm. Code. The technical standards are found at: http://dnr.wi.gov/topic/stormwater/standards/const_standards.html.
- 12. All equipment used for the project including but not limited to tracked vehicles, barges, boats, hoses, sheet pile and pumps shall be de-contaminated for invasive and exotic viruses and species prior to use and after use.

The following steps must be taken <u>every time</u> you move your equipment to avoid transporting invasive and exotic viruses and species. To the extent practicable, equipment and gear used on infested waters shall not be used on other non-infested waters.

- 1. Inspect and remove aquatic plants, animals, and mud from your equipment.

FINDINGS OF FACT

- 1. The City of Madison and Madison College have filed an application for a permit to remove materials from the bed of near Starkweather Creek, in the City of Madison, Dane County, also described as being in the SE1/4 of the SE1/4 of Section 29, Township 8 North, Range 10 East.
- 2. The City of Madison Engineering Division project is to re-grade a drainage ditch on the Madison Area Technical College campus in Madison located between Stoughton Road (US 51) and Wright Street, north of Anderson Street. Approximately 1350 linear feet of the channel and a small side channel, approximately 125 feet long, currently serve as storm water drainage and only receive water during storm events. This project proposes clearing accumulated vegetation and sediment from the channel in order to restore adequate drainage. The City is proposing to remove the existing vegetation and regrade approximately 1475 linear feet of channel, including the side channel. The channel will be over-

excavated to a depth of approximately 2.5 feet to re-create a wet channel. The water depth will be controlled by a stepped channel profile and six grade control structures with impermeable clay interiors, surrounded by glacial field stone.

- 3. The Department has completed an investigation of the project site and has evaluated the project as described in the application and plans.
- 4. This tributary to Starkweather Creek is a navigable water (and no bulkhead exists at the project site.)
- 5. The proposed project, if constructed in accordance with this permit will not adversely affect water quality, will not increase water pollution in surface waters and will not cause environmental pollution as defined in s. 283.01(6m), Wis. Stats.
- 6. The proposed project will minimally impact wetlands if constructed in accordance with this permit.
- 7. The Department of Natural Resources has determined that the agency's review of the proposed project constitutes an equivalent analysis action under s. NR 150.20(2), Wis. Adm. Code. The Department has considered the impacts on the human environment, alternatives to the proposed projects and has provided opportunities for public disclosure and comment. The Department has completed all procedural requirements of s. 1.11(2)(c), Wis. Stats., and NR 150, Wis. Adm. Code for this project.
- 8. The Department of Natural Resources and the applicant have completed all procedural requirements and the project as permitted will comply with all applicable requirements of Sections 30.20(2), Wisconsin Statutes and Chapters NR 102, 103, 328 of the Wisconsin Administrative Code.
- 9. The structure or deposit will not materially obstruct navigation, will not be detrimental to the public interest and will not materially reduce the flood flow capacity of a stream.
- 10. The activity will not cause environmental pollution as defined in s. 299.01(4).
- 11. No material injury will result to the riparian rights of any riparian owners of real property that abuts any water body that is affected by the activity.

CONCLUSIONS OF LAW

1. The Department has authority under the above indicated Statutes and Administrative Codes, to issue a permit for the construction and maintenance of this project.

NOTICE OF APPEAL RIGHTS

If you believe that you have a right to challenge this decision, you should know that the Wisconsin statutes and administrative rules establish time periods within which requests to review Department decisions shall be filed. Stats., you have 30 days after the decision is mailed, or otherwise served by the Department, to serve a petition for hearing on the Secretary of the Department of Natural Resources, P.O. Box 7921, Madison, WI, 53707-7921. The petition shall be in writing, shall be dated and signed by the petitioner, and shall include as an attachment a copy of the decision for which administrative review is sought. If you are not the applicant, you must simultaneously provide a copy of the petition to the applicant. If you wish to request a stay of the project, you must provide information, as outlined below, to show that a stay is necessary to prevent significant adverse impacts or irreversible harm to the environment. If you are not the permit applicant, you must provide a copy of the petition to the permit applicant at the same time that you serve the petition on the Department.

The filing of a request for a contested case hearing is not a prerequisite for judicial review and does not extend the 30 day period for filing a petition for judicial review.

A request for contested case hearing must meet the requirements of section 30.209, Wis. Stats., and sections NR 2.03, 2.05, and 310.18, Wis. Admin. Code, and if the petitioner is not the applicant the petition must include the following information:

- A description of the objection that is sufficiently specific to allow the department to determine which provisions of this section may be violated if the proposed permit or contract is allowed to proceed.

WHEREAS, the Common Council of the said City of Madison under the provisions of a resolution adopted MAY 17, 2016, and by virtue of authority vested in the said Council, has awarded to the Contractor the work of performing certain construction.

NOW, THEREFORE, the Contractor and the City, for the consideration hereinafter named, agree as follows:

Scope of Work. The Contractor shall, perform the construction, execution and completion of the following listed complete work or improvement in full compliance with the Plans, Specifications, Standard Specifications, Supplemental Specifications, Special Provisions and contract; perform all items of work covered or stipulated in the proposal; perform all altered or extra work; and shall furnish, unless otherwise provided in the contract, all materials, implements, machinery, equipment, tools, supplies, transportation, and labor necessary to the prosecution and completion of the work or improvements:

- 2. Completion Date/Contract Time. Construction work must begin within seven (7) calendar days after the date appearing on mailed written notice to do so shall have been sent to the Contractor and shall be carried on at a rate so as to secure full completion <u>SEE SPECIAL PROVISIONS</u>, the rate of progress and the time of completion being essential conditions of this Agreement.
- 3. Contract Price. The City shall pay to the Contractor at the times, in the manner and on the conditions set forth in said specifications, the sum of TWO HUNDRED THIRTY-FIVE THOUSAND SIX HUNDRED NINETY-THREE AND 10/100 (\$235,693.10) Dollars being the amount bid by such Contractor and which was awarded to him/her as provided by law.
- 4. Wage Rates for Employees of Public Works Contractors

General and Authorization. The Contractor shall compensate its employees at the prevailing wage rate in accordance with section 66.0903, Wis. Stats., DWD 290 of the Wisconsin Administrative Code and as hereinafter provided unless otherwise noted in Section D: Special Provisions, Subsection 102.10 – Minimum Rate of Wage Scale.

"Public Works" shall include building or work involving the erection, construction, remodeling, repairing or demolition of buildings, parking lots, highways, streets, bridges, sidewalks, street lighting, traffic signals, sanitary sewers, water mains and appurtenances, storm sewers, and the grading and landscaping of public lands.

"Building or work" includes construction activity as distinguished from manufacturing, furnishing of materials, or servicing and maintenance work, except for the delivery of mineral aggregate such as sand, gravel, bituminous asphaltic concrete or stone which is incorporated into the work under contract with the City by depositing the material directly in final place from transporting vehicle.

"Erection, construction, remodeling, repairing" means all types of work done on a particular building or work at the site thereof in the construction or development of the project, including without limitation, erecting, construction, remodeling, repairing, altering, painting, and decorating, the transporting of materials and supplies to or from the building or work done by the employees of the Contractor, Subcontractor, or Agent thereof, and the manufacturing or furnishing of

materials, articles, supplies or equipment on the site of the building or work, by persons employed by the Contractor, Subcontractor, or Agent thereof.

"Employees working on the project" means laborers, workers, and mechanics employed directly upon the site of work.

"Laborers, Workers, and Mechanics" include pre-apprentices, helpers, trainees, learners and properly registered and indentured apprentices but exclude clerical, supervisory, and other personnel not performing manual labor.

Establishment of Wage Rates. The Department of Public Works shall periodically obtain a current schedule of prevailing wage rates from DWD. The schedule shall be used to establish the City of Madison Prevailing Wage Rate Schedule for Public Works Construction (prevailing wage rate). The Department of Public Works may include known increases to the prevailing wage rate which can be documented and are to occur on a future specific date. The prevailing wage rate shall be included in public works contracts subsequently negotiated or solicited by the City. Except for known increases contained within the schedule, the prevailing wage rate shall not change during the contract. The approved wage rate is attached hereto.

Workforce Profile. The Contractor shall, at the time of signature of the contract, notify the City Engineer in writing of the names and classifications of all the employees of the Contractor, Subcontractors, and Agents proposed for the work. In the alternative, the Contractor shall submit in writing the classifications of all the employees of the Contractor, Subcontractors and Agents and the total number of hours estimated in each classification for the work. This workforce profile(s) shall be reviewed by the City Engineer who may, within ten (10) days, object to the workforce profile(s) as not being reflective of that which would be required for the work. The Contractor may request that the workforce profile, or a portion of the workforce profile, be submitted after the signature of the contract but at least ten (10) days prior to the work commencing. Any costs or time loss resulting from modifications to the workforce profile as a result of the City Engineer's objections shall be the responsibility of the Contractor.

Payrolls and Records. The Contractor shall keep weekly payroll records setting forth the name, address, telephone number, classification, wage rate and fringe benefit package of all the employees who work on the contract, including the employees of the Contractor's subcontractors and agents. Such weekly payroll records must include the required information for all City contracts and all other contracts on which the employee worked during the week in which the employee worked on the contract. The Contractor shall also keep records of the individual time each employee worked on the project and for each day of the project. Such records shall also set forth the total number of hours of overtime credited to each such employee for each day and week and the amount of overtime pay received in that week. The records shall set forth the full weekly wages earned by each employee and the actual hourly wage paid to the employee.

The Contractor shall submit the weekly payroll records, including the records of the Contractor's subcontractors and agents, to the City Engineer for every week that work is being done on the contract. The submittal shall be within twenty-one (21) calendar days of the end of the Contractor's weekly pay period.

Employees shall receive the full amounts accrued at the time of the payment, computed at rates not less than those stated in the prevailing wage rate and each employee's rate shall be determined by the work that is done within the trade or occupation classification which should be properly assigned to the employee.

An employee's classification shall not be changed to a classification of a lesser rate during the contract. If, during the term of the contract, an employee works in a higher pay classification than the one which was previously properly assigned to the employee, then that employee shall be considered to be in the higher pay classification for the balance of the contract, receive the appropriate higher rate of pay, and she/he shall not receive a lesser rate during the balance of the

contract. For purposes of clarification, it is noted that there is a distinct difference between working in a different classification with higher pay and doing work within a classification that has varying rates of pay which are determined by the type of work that is done within the classification. For example, the classification "Operating Engineer" provides for different rates of pay for various classes of work and the Employer shall compensate an employee classified as an "Operating Engineer" based on the highest class of work that is done in one day. Therefore, an "Operating Engineer's" rate may vary on a day to day basis depending on the type of work that is done, but it will never be less than the base rate of an "Operating Engineer". Also, as a matter of clarification, it is recognized that an employee may work in a higher paying classification merely by chance and without prior intention, calculation or design. If such is the case and the performance of the work is truly incidental and the occurrence is infrequent, inconsequential and does not serve to undermine the single classification principle herein, then it may not be required that the employee be considered to be in the higher pay classification and receive the higher rate of pay for the duration of the contract. However, the Contractor is not precluded or prevented from paying the higher rate for the limited time that an employee performs work that is outside of the employee's proper classification.

Questions regarding an employee's classification, rate of pay or rate of pay within a classification, shall be resolved by reference to the established practice that predominates in the industry and on which the trade or occupation rate/classification is based. Rate of pay and classification disputes shall be resolved by relying upon practices established by collective bargaining agreements and guidelines used in such determination by appropriate recognized trade unions operating within the City of Madison.

The Contractor, its Subcontractors and Agents shall submit to interrogation regarding compliance with the provisions of this ordinance.

Mulcting of the employees by the Contractor, Subcontractor, and Agents on Public Works contracts, such as by kickbacks or other devices, is prohibited. The normal rate of wage of the employees of the Contractor, Subcontractor, and Agents shall not be reduced or otherwise diminished as a result of payment of the prevailing wage rate on a public works contract.

Hourly contributions. Hourly contributions shall be determined in accordance with the prevailing wage rate and with DWD. 290.01(10), Wis. Admin. Code.

Apprentices and Subjourney persons. Apprentices and sub journeypersons performing work on the project shall be compensated in accordance with the prevailing wage rate and with DWD 290.02, and 290.025, respectively, Wis. Admin. Code.

Straight Time Wages. The Contractor may pay straight time wages as determined by the prevailing wage rate and DWD 290.04, Wis. Admin. Code.

Overtime Wages. The Contractor shall pay overtime wages as required by the prevailing wage rate and DWD 290.05, Wis. Admin. Code.

Posting of Wage Rates and Hours. A clearly legible copy of the prevailing wage rate, together with the provisions of Sec. 66.0903(10)(a) and (11)(a), Wis. Stats., shall be kept posted in at least one conspicuous and easily accessible place at the project site by the Contractor and such notice shall remain posted during the full time any laborers, workers or mechanics are employed on the contract.

Evidence of Compliance by Contractor. Upon completion of the contract, the Contractor shall file with the Department of Public Works an affidavit stating:

a. That the Contractor has complied fully with the provisions and requirements of Sec. 66.0903(3), Wis. Stats., and Chapter DWD 290, Wis. Admin. Code,* the Contractor has received evidence of compliance from each of the agents and subcontractors; and the

names and addresses of all of the subcontractors and agents who worked on the contract.

b. That full and accurate records have been kept, which clearly indicate the name and trade or occupation of every laborer, worker or mechanic employed by the Contractor in connection with work on the project. The records shall show the number of hours worked by each employee and the actual wages paid therefore; where these records will be kept and the name, address and telephone number of the person who will be responsible for keeping them. The records shall be retained and made available for a period of at least three (3) years following the completion of the project of public works and shall not be removed without prior notification to the municipality.

Evidence of Compliance by Agent and Subcontractor. Each agent and subcontractor shall file with the Contractor, upon completion of their portion of the work on the contract an affidavit stating that all the provisions of Sec. 66.0903(3), Wis. Stats., have been fully complied with and that full and accurate records have been kept, which clearly indicate the name and trade or occupation of every laborer, worker or mechanic employed by the Contractor in connection with work on the project. The records shall show the number of hours worked by each employee and the actual wages paid therefore; where these records shall be kept and the name, address and telephone number of the person who shall be responsible for keeping them. The records shall be retained and made available for a period of at least three (3) years following the completion of the project of public works and shall not be removed without prior notification to the municipality.

Failure to Comply with the Prevailing Wage Rate. If the Contractor fails to comply with the prevailing wage rate, she/he shall be in default on the contract. In addition, if DWD finds that a contractor or subcontractor violated the prevailing wage law, DWD will assess liquidated damages of 100% of the wages owed to employees.

Establishment of Wage Rates. The Department of Public Works shall periodically obtain a current schedule of prevailing wage rates from DWD. The schedule shall be used to establish the City of Madison Prevailing Wage Rate Schedule for Public Works Construction (prevailing wage rate). The Department of Public Works may include known increases to the prevailing wage rate which can be documented and are to occur on a future specific date. The prevailing wage rate shall be included in public works contracts subsequently negotiated or solicited by the City. Except for known increases contained within the schedule, the prevailing wage rate shall not change during the contract. The approved wage rate and DWD prevailing wage requirements are attached hereto as Sec. I of the contract.

5. Affirmative Action. In the performance of the services under this Agreement the Contractor agrees not to discriminate against any employee or applicant because of race, religion, marital status, age, color, sex, disability, national origin or ancestry, income level or source of income, arrest record or conviction record, less than honorable discharge, physical appearance, sexual orientation, gender identity, political beliefs, or student status. The Contractor further agrees not to discriminate against any subcontractor or person who offers to subcontract on this contract because of race, religion, color, age, disability, sex, sexual orientation, gender identity or national origin.

The Contractor agrees that within thirty (30) days after the effective date of this agreement, the Contractor will provide to the City Affirmative Action Division certain workforce utilization statistics, using a form to be furnished by the City.

If the contract is still in effect, or if the City enters into a new agreement with the Contractor, within one year after the date on which the form was required to be provided, the Contractor will provide updated workforce information using a second form, also to be furnished by the City. The second form will be submitted to the City Affirmative Action Division no later than one year after the date on which the first form was required to be provided.

The Contractor further agrees that, for at least twelve (12) months after the effective date of this contract, it will notify the City Affirmative Action Division of each of its job openings at facilities in Dane County for which applicants not already employees of the Contractor are to be considered. The notice will include a job description, classification, qualifications and application procedures and deadlines. The Contractor agrees to interview and consider candidates referred by the Affirmative Action Division if the candidate meets the minimum qualification standards established by the Contractor, and if the referral is timely. A referral is timely if it is received by the Contractor on or before the date started in the notice.

Articles of Agreement Article I

The Contractor shall take affirmative action in accordance with the provisions of this contract to insure that applicants are employed, and that employees are treated during employment without regard to race, religion, color, age, marital status, disability, sex, sexual orientation, gender identity or national original and that the employer shall provide harassment free work environment for the realization of the potential of each employee. Such action shall include, but not be limited to, the following: employment, upgrading, demotion or transfer, recruitment or recruitment advertising, layoff or termination, rates of pay or other forms of compensation and selection for training including apprenticeship insofar as it is within the control of the Contractor. The Contractor agrees to post in conspicuous places available to employees and applicants notices to be provided by the City setting out the provisions of the nondiscrimination clauses in this contract.

Article II

The Contractor shall in all solicitations or advertisements for employees placed by or on behalf of the Contractors state that all qualified or qualifiable applicants will be employed without regard to race, religion, color, age, marital status, disability, sex, sexual orientation, gender identity or national origin.

Article III

The Contractor shall send to each labor union or representative of workers with which it has a collective bargaining agreement or other contract or understanding a notice to be provided by the City advising the labor union or worker's representative of the Contractor's equal employment opportunity and affirmative action commitments. Such notices shall be posted in conspicuous places available to employees and applicants for employment.

Article V

The Contractor agrees that it will comply with all provisions of the Affirmative Action Ordinance of the City of Madison, including the contract compliance requirements. The Contractor agrees to submit the model affirmative action plan for public works contractors in a form approved by the Affirmative Action Division Manager.

Article VI

The Contractor will maintain records as required by Section 39.02(9)(f) of the Madison General Ordinances and will provide the City Affirmative Action Division with access to such records and to persons who have relevant and necessary information, as provided in Section 39.02(9)(f). The City agrees to keep all such records confidential, except to the extent that public inspection is required by law.

Article VII

In the event of the Contractor's or subcontractor's failure to comply with the Equal Employment Opportunity and Affirmative Action Provisions of this contract or Section 39.03 and 39.02 of the Madison General Ordinances, it is agreed that the City at its option may do any or all of the following:

- 1. Cancel, terminate or suspend this Contract in whole or in part.
- 2. Declare the Contractor ineligible for further City contracts until the Affirmative Action requirements are met.
- 3.  - 2. Refrain from asking an applicant in any manner about their arrest or conviction record until after conditional offer of employment is made to the applicant in question.
 - 3. Refrain from conducting a formal or informal background check or making any other inquiry using any privately or publicly available means of obtaining the arrest or conviction record of an applicant until after a conditional offer of employment is made to the applicant in question.
 - 4. Make information about this ordinance available to applicants and existing employees, and post notices in prominent locations at the workplace with information about the ordinance and complaint procedure using language provided by the City.
 - 5. Comply with all other provisions of Sec. 39.08, MGO.
- c. Exemptions: This section shall not apply when:
 - 1. Hiring for a position where certain convictions or violations are a bar to employment in that position under applicable law, or
 - 2. Hiring a position for which information about criminal or arrest record, or a background check is required by law to be performed at a time or in a manner that would otherwise be prohibited by this ordinance, including a licensed trade or profession where the licensing authority explicitly authorizes or requires the inquiry in question.

To be exempt, Contractor has the burden of demonstrating that there is an applicable law or regulation that requires the hiring practice in question, if so, the contractor is exempt from all of the requirements of this ordinance for the position(s) in question.

THE 2015-17 BUDGET BILL MADE SIGNIFICANT CHANGES TO WISCONSIN'S PREVAILING WAGE LAWS. HOWEVER, THOSE CHANGES DO NOT GO INTO EFFECT UNTIL JANUARY 1, 2017.

During calendar year 2016, DWD will continue to enforce prevailing wage laws for local governmental unit and state agency public works projects under current prevailing wage laws.

2015 Wisconsin Act 55 (the budget bill) repealed the state prevailing wage law for local governmental units such as villages, towns, cities, school districts, or sewerage districts effective January 1, 2017. However, if a local governmental unit:

- eissues a Request for Bids before January 1, 2017, for a project of public works that is subject to bidding or,
- enters into a contract before January 1, 2017, for a project of public works that is not subject to bidding,

then those public works projects are subject to the current prevailing wage law (§66.0903, Wis. Stats.) through the life of the project. Projects of public works with prevailing wage project determinations issued prior to 2017 continue to be subject to the current prevailing wage law through the life of the project even though the project may have work going on in 2017 or subsequent years.

Contractors working on local governmental unit projects with prevailing wage rate determinations must continue to pay employees the appropriate prevailing wage and maintain required prevailing wage payroll records. For instance, if a contractor is working in 2018 on a public works project with a project determination issued prior to 2017, then the contractor is required to comply with the "old" prevailing wage rate law (§66.0903, Wis. Stats.). After January 1, 2017, DWD will continue to enforce prevailing wage requirements for projects with DWD prevailing wage determinations issued under the "old" prevailing wage laws (§§ 66.0903 & 103.49, Wis. Stats.).

For new public works projects starting on January 1, 2017, state prevailing wage law will only apply to state agency and state highway projects. Prevailing wage rates applicable to state agencies will be those issued by the U.S. Department of Labor under the Davis-Bacon Act, 40 U.S.C. 3142. The Wisconsin Department of Administration will enforce the new state agency prevailing wage law (§16.856, Wis. Stats.) and the Wisconsin Department of Transportation will continue to enforce prevailing wage on state highway projects (under a law renumbered as §84.062, Wis. Stats.).

POST THE WHITE SHEET

As the public entity receiving this prevailing wage rate determination, YOU ARE REQUIRED by law to post the prevailing wage rate determination (i.e., white sheet) in at least one conspicuous and easily accessible place on the project site that is available to all construction workers. The white sheet must remain posted from the onset of the project until all construction labor on the project has been completed.

Posting the white sheet inside the general contractor's trailer does not meet this requirement. That placement is not available/accessible to all workers and is not a location over which you have control.

PREVAILING WAGE - Contractors

Any public works project that has a total estimated project cost that equals or exceeds prevailing wage project thresholds requires a prevailing wage rate determination issued by the Department of Workforce Development (DWD). Public works include erecting, constructing, remodeling, repairing, demolishing, alterations, painting and decorating projects for a local governmental unit or state agency. State law excludes minor service or maintenance work, warranty work, or work under a supply-andinstallation contract. There is a statutory definition for most of these exclusions. The prevailing wage laws that apply to local governmental units and their contractors are §§66.0903 and 103.503, Wis. Stats. The prevailing wage laws that apply to state agencies and their contractors are §§103.49 and 103.503, Wis. Stats. The applicable administrative rules for all prevailing wage projects are DWD 290 and DWD 294, Wis. These laws include provisions that apply to all contractors and subcontractors working on prevailing wage projects.

Any contractor or subcontractor working on a local governmental unit or state agency's public works project that equals or exceeds current prevailing wage project thresholds must do all of the following:

- Receive and review the project's prevailing wage rate determination (i.e., white sheet).
- Tell subcontractors the project is subject to state prevailing wage law and include the prevailing wage rate determination in the construction contract, or if there is no written contract, provide a copy of the project determination to each subcontractor.
- Hire subcontractors who do not appear on the "Consolidated List of Debarred Contractors."
- Have a written substance abuse testing program in place that fulfills the requirements of §103.503, Wis. Stats., before commencing work on the project.

- Notify subcontractors that if DWD finds that a contractor or subcontractor violated the prevailing wage law, DWD will assess liquidated damages of 100% of the wages owed to employees.
- Apply to DWD for subjourney wage rates prior to employing these individuals on the project.
- Receive and retain a completed Affidavit of Compliance from each subcontractor brought on to the project before providing final payment to those subcontractors.
- Submit a completed Affidavit of Compliance to the contractor who brought the subcontractor on to the project before receiving final payment for the project.
- Maintain payroll records for 3 years that comply with §§66.0903(10)(a) or 103.49(5)(a), Stats. and DWD 274.06.
- Respond to requests from DWD or the project owner to provide payroll records and/or respond to prevailing wage complaints filed by employees or third parties.
