



PROJECT – LOCATION



THE LOCATION AND INFORMATION FOR PROPOSED NEW TREES, IN THE PUBLIC RIGHT OF WAY OR ON PUBLIC LANDS ARE APPROXIMATE AND ARE SHOWN FOR REFERENCE ONLY. THE LOCATIONS, SPECIFICATIONS AND PLANTING METHODS OF ALL PROPOSED NEW OR REPLACEMENT TREES IN THE PUBLIC RIGHT OF WAY OR ON PUBLIC LANDS SHALL BE APPROVED BY THE CITY FORESTER PRIOR TO INSTALLATION.

NO TREES IN THE RIGHT OF WAY OR ON PUBLIC LANDS SHALL BE TRIMMED, PRUNED, REMOVED OR ADVERSELY AFFECTED IN ANY WAY UNTIL THE DEVELOPER HAS RECEIVED WRITTEN PERMISSION FROM THE CITY ENGINEER OR CITY FORESTER. SAID WRITTEN PERMISSION SHALL INCLUDE LANGUAGE INDICATING THAT SECTION 10.101 OF THE MADISON GENERAL ORDINANCES AND ADMINISTRATIVE PROCEDURE MEMORANDUM NO. 6–2, REFERING TO NOTIFICATION OF PROPERTY OCCUPANTS AND/OR OWNERS, HAS BEEN COMPLIED WITH. ALL PAVEMENT IN THE SATURN DRIVE RIGHT-OF-WAY SHALL AND ALL OTHER PAVEMENT SHALL BE TYPE "A" PER STANDAR DRAWING 4.02.

ALL ISLANDS SHALL HAVE TYPE "H" C & G PER S.D.D. 3.08 ANI NOSES PER S.D.D. 3.13. ALL OTHER C & G SHALL BE TYPE "A" UNLESS OTHERWISE NOTED.

ISLAND INTERIORS SHALL BE OF SOD WHERE THE BACK TO BACURB DIMENSION IS GREATER THAN 6'.

UNDERDRAINS SHALL BE INSTALLED, PER STANDARD DETAIL DR. FOR 75'ON EACH SIDE OF THE LOW POINT, OR TO THE NEAR HIGH POINT. ALL UNDERDRAIN SHALL BE WRAPPED.

ALL GUTTERS SHALL DRAIN WITH A MINIMUM GRADES OF 0.59 STORM SEWER INLETS.

PAVEMENT CROSS SLOPES SHALL BE 2%, TERRACES SHALL SLOPE AT A 4% GRADE TOWARD THE GUTTER, SHOULDERS SHALL HAV 4% CROSS SLOPE AND CROSS SLOPES FORMING DITCHES SHALL EXCEED 4.00:1 UNLESS OTHERWISE INDICATED.

THE CROSS SLOPE OF SIDEWALKS AND BARRIER FREE SIDEWAL RAMPS SHALL BE 2%. THE LONGITUDINAL GRADE OF BARRIER FREE SIDEWALK CURB RAMPS SHALL NOT EXCEED 8.33%. ALL S RAMPS SHALL BE CONSTRUCTED ACCORDING TO S.D.D. 3.03. AT OTHER LOCATIONS THE LONGITUDINAL GRADE OF SIDEWALKS NOT EXCEED 5.0 % OR THE ADJACENT STREET GRADE WHICHI IS GREATER NOR BE LESS THAN 0.5% AND SHALL DRAIN TOW. STORM SEWER INLETS. A 2 FOOT WIDE CONSRETE FLUME SHAL INSTALLED BETWEEN THE SIDEWALK AND THE BACK OF CURB SIDEWALK LOW POINTS WHICH CANNOT OTHERWISE BE DRAIN TO THE GUTTER. SIDE SLOPES WITHIN TEN FEET OF A PUBL SIDEWALK SHALL NOT EXCEED 4.00:1. THE DESIGN OF SIDEWALK ELEVATIONS AND GRADES IS NOT INCLUDED IN THIS PLAN. ALL SIDEWALK AND SIDEWALK RAMP ELEVATIONS AND GRADES SHA BE FIELD VERIFIED AND SET TO COMPLY WITH THE CITY OF STANDARD SPECIFICATIONS AND THE A.D.A. GUIDELINES.

OBTAIN A PRINT OUT OF THE ALIGNMENT FROM THE CITY EN PRIOR TO STAKING THIS PROJECT.

CURB STATION AND OFFSETS SHALL BE TO THE FACE OF CURI OTHERWISE INDICATED. CURB ELEVATIONS SHALL BE TO THE T CURB (OR EXTENDED TOP OF CURB FOR DRIVEWAYS OR RAMPS OTHERWISE INDICATED.

POWER POLES AND OTHER OBSTRUCTIONS SHALL BE MOVED TO PROVIDE 2 FEET MINIMUM OF CLEAR DISTANCE FROM ANY FA CURB OR EDGE OF SIDEWALK.

ANY INFORMATION SHOWN ON THIS PLAN, WHICH IS NOT PART PROJECT, IS PRELIMINARY AND NOT FOR CONSTRUCTION.
