

# **LATE NIGHT VENDING**

## **General Guidelines**

**Please see the Late Night Vending Map in the Maps section at the bottom of this web page.**

### **The Four Late Night Vending Areas -**

All sites will be assigned on the 700 block of State Street and the 400 block of N. Frances Street. The first-come, first-served system will still pertain to Johnson and Broom Streets.

(NOTE: No public electricity is available on Johnson Street. One outlet is available on Broom Street.)

### **The 400 Block of N. Frances Street -**

There will be a maximum of two hot dog pushcarts on the 400 block of N. Frances Street, with sites assigned by seniority. No large carts may operate on that block.

### **The 700 Block of State Street -**

All interested large cart operators will be assigned sites on the 700 block of State Street. Mall/Concourse Food Vendors will have first refusal to retain their daytime site during Late Night Vending. Mall/Concourse Food Vendors will be required to leave the 700 block of State Street by 8 p.m. seven days a week, so licensed Late Night Vendors may arrive at 9 p.m. or afterwards.

Remaining sites on the 700 block of State Street will then be assigned by seniority for Late Night Vending, based on the first day the vendor purchased a basic Street Vendor License. Mall/Concourse Food Vendors who do not wish to retain their daytime site, but who want another site on the 700 block of State Street for Late Night Vending, will also be assigned sites according to seniority.

### **Licensing for Late Night Vending -**

Fees are:

Large Carts: \$350.00 per year

Pushcarts: \$125.00 per year

Mall/Concourse Food Vendors must purchase this additional license in order to participate in Late Night Vending. Please see the Application Materials box on this page for links to the license applications.

The basic **Street Vendor License** will still be required for each person who functions as a street vendor.

**Site Orientation Appointment -**

Once sites have been assigned – or beforehand as needed - the Street Vending Coordinator will meet *during the day* by appointment at the two areas requiring assigned Late Night Vending sites. These meetings will allow vendors to ask any questions, to make sure they know which site is theirs, and to plan set-up and arrival times in advance of occupying them.

**Use of Electricity -**

Any vendors using public electricity will be required to fill out the **Application for Electrical Use** and pay the appropriate fee in advance.

**Parking Restrictions -**

Parking of personal or tow vehicles will not be permitted on the 700 block of State Street during Late Night Vending except for cart placement and supply delivery. Normal parking regulations pertain to all vendor vehicles and are subject to enforcement.
