Enclosed is a copy of a lobbying complaint, together with attachments, filed against you and others related to lobbying for the Edgewater Hotel development. Ms. Konkel's complaint alleges that, although you and others have registered and made filings under the Madison Lobbying Ordinance, Sec. 2.40, MGO, that your filings are woefully incomplete and may be misleading.


The complaint alleges that you, Amy Supple, Hank Gempeler, Mary Carpenter, David Manfredi, and Mark Sardegna all failed to comply with the ordinance. I am copying those individuals with this letter, but have not made a complete copy of all the attachments, since Landmark X is the principal involved.

The complaint and the attachments do appear to show violations of the Madison lobbying ordinance. I request that you either correct those violations and make a complete filing under the ordinance, or provide me with information as to why these activities are not subject to the Madison lobbying ordinance.

This is your opportunity to provide us with any additional information related to the complaint. Do you disagree with any of the allegations? Is there other information you wish to provide?

In either event, I ask that you respond to this letter within fifteen days. At that time, our office will determine whether additional action will be taken.
