



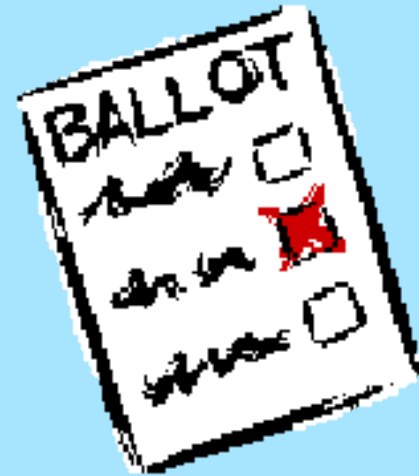
Election Official Training for new poll workers

Facilitating the Right to Vote

Election Officials enhance representative democracy by ensuring the integrity of the electoral process.

To ensure elections are:

- **Open**
- **Fair**
- **Impartial**
- **Trusted**

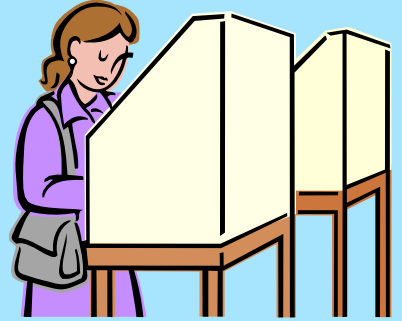


Ensure that the vote of every elector counts!

Election Officials must act in an impartial and professional manner

- Treat all voters with respect. Do not make comments about the voters.
- Treat your fellow Election Officials professionally and with respect.
- Do not allow candidates or politics to be discussed at the polling place.
- Do not permit campaign literature in the polling place.

Voting Procedures



- Voter states name and address.
- If voter is registered at current address, issue a voter slip.
 - Voter slips and poll books are color coordinated with ballots.
- Write voter slip number on poll lists.
Reconcile voter numbers throughout day.
- Voter hands voter slip to Election Official issuing the ballots.

Ballots

- Election Officials write Ward number on ballot.
- Ballots must be initialed by two Election Officials
- Instruct voter on marking the ballot.
- Hand voter an initialed ballot inserted in a secrecy sleeve, and a marking pen.
- Officials should be no closer than 10 feet away from tabulator and booths.

Supplemental Poll List

- Voters who registered within 20 days of Election are listed on Supplemental Poll List.
- If a voter does not appear on the Original Poll List, check the Supplemental Poll List.
- Voters who register at the polls are added to the Election Day Registration List.
- Reverse Directory helps identify misspelled names.

- Mailing Address is not necessary.

- Utility Bill
- Tax Bill
- Lease
- Wisconsin Driver's License/DOT-issued ID
- University ID (if on certified housing list)
- Bank Statement
- Paycheck
- Any Government Check or Document

- If an applicant is unable to provide acceptable proof of residence, their application can be corroborated by a City of Madison resident who provides acceptable proof of residence and signs Section 12. The corroborating witness does not need to be a registered voter.
- If an individual cannot provide proof of residence or prove residency through the use of a corroborator, they cannot register to vote and therefore cannot vote.

The following items
are not acceptable forms
of proof of residence:

- Business card
- Magazine subscription
- Expired driver's license
- Expired state ID card
- Out-of-state driver's license
- Piece of mail addressed to the voter

Provisional Voting

used in only two situations

- First-time voters who registered by mail and failed to provide proof of residence (this is indicated on poll list).
- Election Day registrants who have a current and valid Wisconsin driver's license but are unable or unwilling to provide driver's license number on form.

Presidential Ballot

- Only used by voters who moved to Wisconsin less than 10 days before the Election.
- May not be used by truckers driving through town.



Replacement Ballots

- A second ballot is issued to voters who say they made a mistake.
- Voter partially tears original ballot and places it in Discarded Ballot Envelope.
- A voter can be issued a total of three ballots.
- Voter does not get a new voter slip number.
- Record 2nd ballot (and 3rd ballot) on poll list.

Ballot Returned to the Voter



- The tabulator may return a ballot to the voter due to voting errors.
- A message indicating why ballot was returned will print on tabulator.
- Voter removes ballot from tabulator.
- Election Official discreetly reads printout message to voter.
- Election Official shall not look at a voted ballot unless requested by voter.

Processing Absentee Ballots

- Check ward number on envelope.
- Envelope must be signed and witnessed.
- Announce voter's name. Find voter on the Poll List or Supplemental Poll List.
- Issue a voter slip number. Record voter slip number and an "A" on poll list and on envelope.
- Carefully open envelope.
- Feed ballot through Tabulator.
