Each item on the consent agenda will be read aloud and if there are no objections by committee members, alders, staff, or citizens registered to speak on the item, the item will be approved with any recommended action as stated on the consent agenda. If you still wish to speak, or if you would like the ALRC not to take action on your item this evening, please inform the clerk.

If you are here to testify on an agenda item, and would like to make sure you speak, check the box “wishes to speak.”

#### **Why is a consent agenda used?**

The consent agenda is used by the ALRC to save meeting time and to help ensure that meetings focus on substantive topics that are worth discussion. Through the “bundling” process, the entire set of routine agenda items can be voted on in one action versus taking the time to vote on each individual item.
