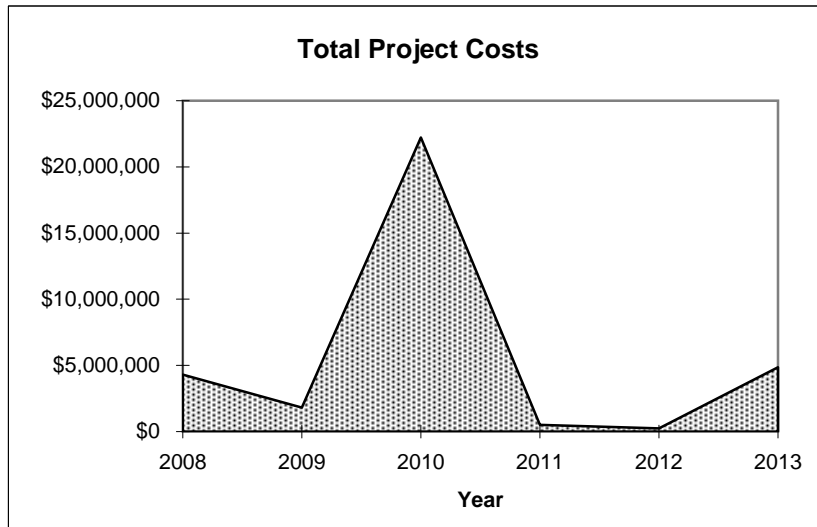

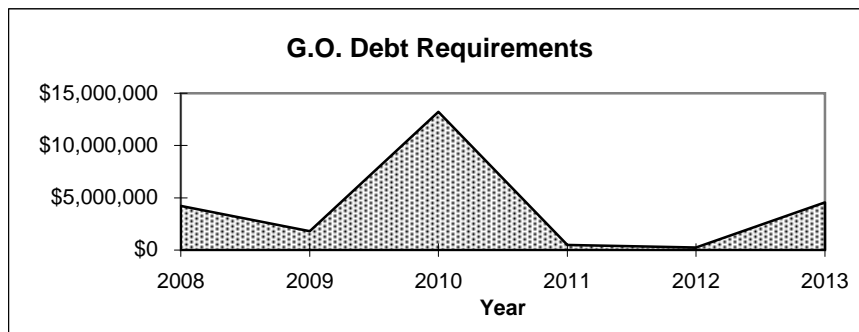

2007 for planning and design. Other funding is from private contributions.
