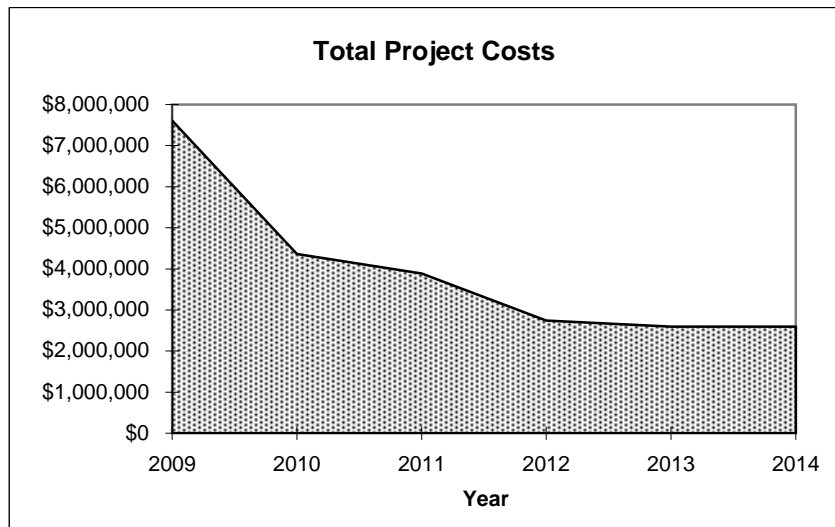

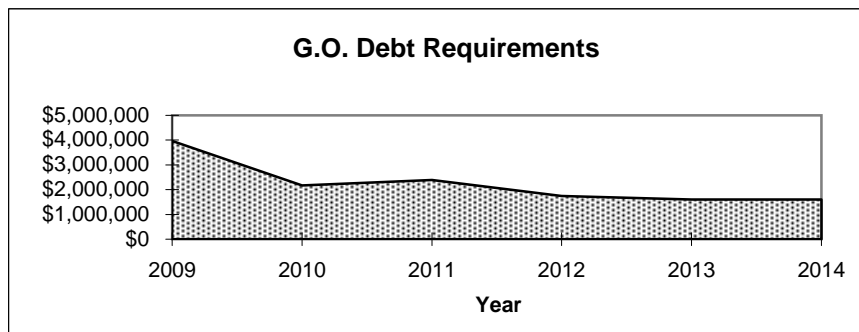

Assessable Trees

Project No. 1 Acct. No. 810533

GO \$ 0 Plant Assessable Trees in the terrace areas along new streets. Trees are planted by the City,
Other 220,000 and property owners are assessed for the total plantings costs.

Olbrich Botanical Gardens

Project No. 2 Acct. No. 810396

GO \$ 37,000 Replace heating, ventilation, and air conditioning controls.

Conservation

Project No. 3 Acct. No. 810401

GO \$ 75,000 This program provides funding (\$50,000) for environmental enhancement in the City's 14
Other 0 Conservation parks, which are designed to preserve biologically diverse native ecosystems.
\$ 75,000 Removal of exotic botanical species, restoration efforts, and the provision of safe year around
access are all functions which are made possible with this funding. Some restoration is also
done in wooded and meadow areas of general parkland. This is a long-term reinvestment in
the City's green infrastructure, which promotes sustainability and lowers future expenses.
Heating the garage (\$25,000) will facilitate another work area for staff to use without
returning to their home location, resulting in savings of time and fuel.

Park Equipment

Project No. 4 Acct. No. 810609

GO \$ 150,000 Purchase new equipment to replace outdated, worn equipment. Goodman Maintenance
Other 0 Facility requires a scissors lift to maintain high ceiling structure and fixtures (\$12,000). Forest
\$ 150,000 Hill is in need of Zero Turn Mowers that are required due to the tight turning areas (\$64,500).
Park Maintenance requires Mower Decks used for cutting and mulching, cabs that are
necessary for wet and colder weather, and mowers that are used for leaf mulching (\$20,000).
Olbrich Botanical Gardens needs a Lift (cherry picker) to perform overhead maintenance and
site preparation (\$8,500), and a new pickup for primary use in moving work materials and
supplies (\$20,000). Olbrich Garden currently does not have a vehicle that is legal to drive on
public roadways. A new Ski Trail Groomer will replace inoperable equipment and has the
newest technology to assist in grooming of snow and trails (\$25,000).

Parks Facility Improvements

Project No. 5 Acct. No. 810397

GO \$ 150,000 Park Facility Improvements is an annual program to maintain and improve existing park
Other 0 buildings and facilities. Projects are prioritized and addressed by need. Efforts in 2009 may
\$ 150,000 include: Electric Gates at the Goodman Maintenance Facility (\$20,000); Replacement of
Skating Rink Poles and Fixtures at Warner (\$30,000); Roof and Door Replacement
(\$30,000); Lighting and Electrical Systems (\$15,000); Building Mechanical Systems
(\$30,000); Fencing (\$10,000); and Resurfacing Floor at the WPCRC (\$15,000).

Parkland Acquisition

Project No. 6 Acct. No. 810398

GO \$ 0 This program provides funding to meet the costs of appraisals, research, negotiations and
Other 0 related real estate charges for parkland acquisition.

Park LandscapingProject No. **7** Acct. No. 810399

GO \$ 200,000 The 2009 Park Landscaping Program continues to provide new and replacement
 Other 0 landscaping to a variety of Madison's park areas. Efforts in 2009 may include: Meadow
\$ 200,000 Plantings (\$50,000), Trail and Continued Landscaping/Restoration Improvements for
 Starkweather Creek (\$10,000), Continued Historical Landscape Restoration for Yahara
 Parkway (\$10,000), General Streets Terrace Tree Replacements (\$80,000), and General
 Landscaping (\$50,000).

Parks Matching FundProject No. **8** Acct. No. 810400

GO \$ 75,000 This program is promoting responsibility and volunteerism. Utilizing private contributions and
 Other 75,000 matching them with City funds, improvements specified by donors and approved by the Park
\$ 150,000 Commission are made possible.

Neighborhood Park ImprovementsProject No. **9** Acct. No. 810402

GO \$ 50,000 This program provides new and used replacement facilities to keep parks up to a comparable
 Other 0 standard City-wide. Projects for 2009 include turf renovation and the Thut Park Phase II
\$ 50,000 Development project, which may be completed to the extent that funding is available.

Parks PavingProject No. **10** Acct. No. 810403

GO \$ 395,000 This is the eighth year of a major multi-year program to repair and replace deteriorated paved
 Other 0 areas throughout the parks system. Anticipated work for 2009 includes: Repave Goodman
\$ 395,000 Maintenance Area Parking (\$110,000), General Pavement Repair (\$30,000), Tennis Court
 Recolor and Crack Repair (\$35,000), Accessible Improvements (\$20,000), and Repave
 Parking and Access (\$50,000). G.O. debt includes \$150,000 reauthorized from 2008.

Development Fee ProjectsProject No. **11** Acct. No. 810437

GO \$ 700,000 Ordinance 20.08 provides that all new residential units provide funding for land acquisition
 Other 0 and park development. For 2009, funding authorization of \$700,000 is provided for Phases II
\$ 700,000 and III for Door Creek Park, a drinking fountain (bubbler) in North Star Park and tennis courts
 at Richmond Hill Park.

Specific Park ImprovementsProject No. **12** Acct. No. 810405

GO \$ 280,000 2009 represents both a continuance of familiar initiatives plus several initiatives for Specific
 Other 0 Parks improvements. The projects are as follows: Boat Launch Dredging (\$20,000),
\$ 280,000 Reservations Shelter Repairs (\$45,000), MMSD Sewer Charges (\$15,000), and General
 Parks Playground Safety Surface and Improvements (\$200,000).

Odana Golf Course Clubhouse StudyProject No. **13** Acct. No. 0

GO \$ 0 Funding in 2010 is for a study to determine if the Odana Golf Course clubhouse should be
 Other 0 renovated or replaced. Potential funding of \$1,000,000 in 2011 includes \$500,000 of General
\$ 0 Obligation Debt and \$500,000 to be raised via user fees, private donations, or Golf Enterprise
 reserves.

Breese Stevens ProjectProject No. **14** Acct. No. 810565

GO \$ 300,000 Breese Stevens Project Phase II is a program to improve existing buildings and facilities.
 Other 145,000 Other funding consists of \$100,000 of County grant funding reauthorized from 2008, and
\$ 445,000 \$45,000 of other donations.

Tenney ShelterProject No. **15** Acct. No. 810617

GO \$ 500,000 Replacement of the Tenney Park Shelter. Other funding is to be derived from private
 Other 700,000 donations. It is anticipated that additional public and private funding will be required for
\$ 1,200,000 shoreline and parking improvements.

Street Tree Inventory for EABProject No. **16** Acct. No. 810628

GO \$ 160,000 Implement a response plan that will identify the location of ash and other trees in the City of
 Other 0 Madison. This inventory will assist in the effectiveness and efficiency of addressing the
\$ 160,000 Emerald Ash Borer (EAB) infestation.

Equipment for Pruning BacklogProject No. **17** Acct. No. 0

GO \$ 0 Purchase of equipment to reduce the cycle of pruning trees from the current fifteen year cycle
 Other 0 to a ten year cycle. No funding is included in the Capital Improvement Program.

Brittingham Picnic ShelterProject No. **18** Acct. No. 0

GO \$ 0 Remodel existing shelter to enclose shelter area that will allow additional use well into the
 Other 0 colder season. Updated design in this facility will result in an expanded use of an existing
\$ 0 Park facility. No funding is included in the Capital Improvement Program. Improvements are
 not necessary at this time.

James Madison ParkProject No. **19** Acct. No. 0

GO \$ 100,000 This project provides funding for improvements per the report of the James Madison Park Ad
 Other 0 Hoc Committee. This report made recommendations on the sales of property and park
\$ 100,000 improvements. Other funding in 2010 is to be derived from land sales. G.O. debt includes
 \$100,000 reauthorized from 2008.

Warner Park StadiumProject No. **20** Acct. No. 810588

GO \$ 800,000 This project contains reauthorized funding for the Warner Park Stadium Project. Other
 Other 1,500,000 funding of \$1,500,000 is from the private sector.

Lisa Link Peace ParkProject No. **21** Acct. No. 810320

GO \$ 0 This project contains reauthorized funding for Lisa Link Peace Park. Other funding of
 Other 1,000,000 \$1,000,000 consists of \$650,000 of cash from TID #32, and \$350,000 of private contributions.
