- 1) Pre-application notice and community discussion
- 2) Informational presentation at the Urban Design Commission
- 3) Applicant files formal applications for review
- 4) City agencies review project plans and provide comments to Plan Commission
- 5) Urban Design Commission holds public hearing regarding the development and makes a recommendation on the design of the site and buildings to the Plan Commission
- 6) Plan Commission holds public hearing for the Amended PD(GDP-SIP), and if standards are met, approves project subject to conditions
- 7) The Common Council holds a public hearing on the Amended PD(GDP-SIP)
- 8) City agencies review final plans for conformance with conditions of approval
- 9) Permits issued and construction may begin
