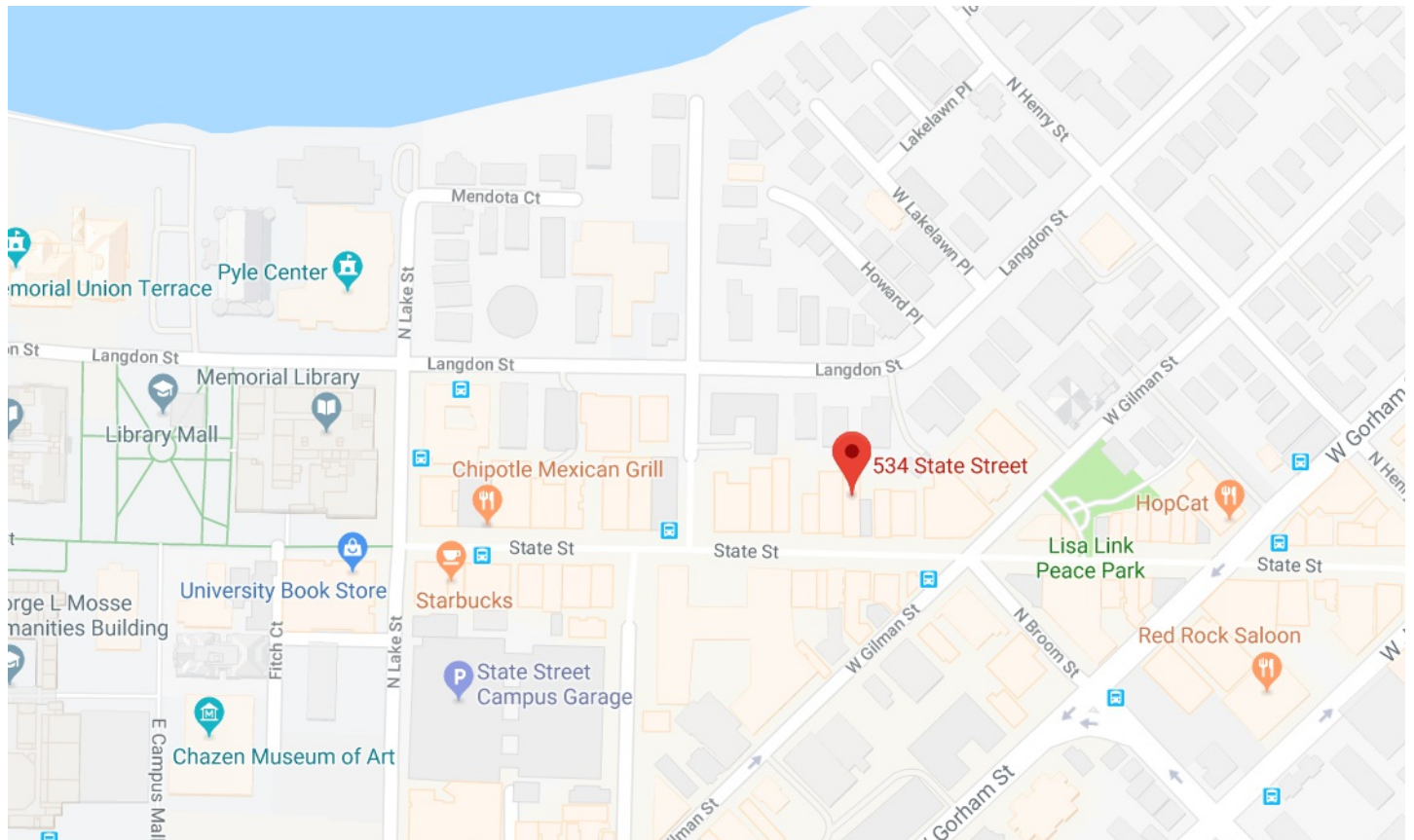

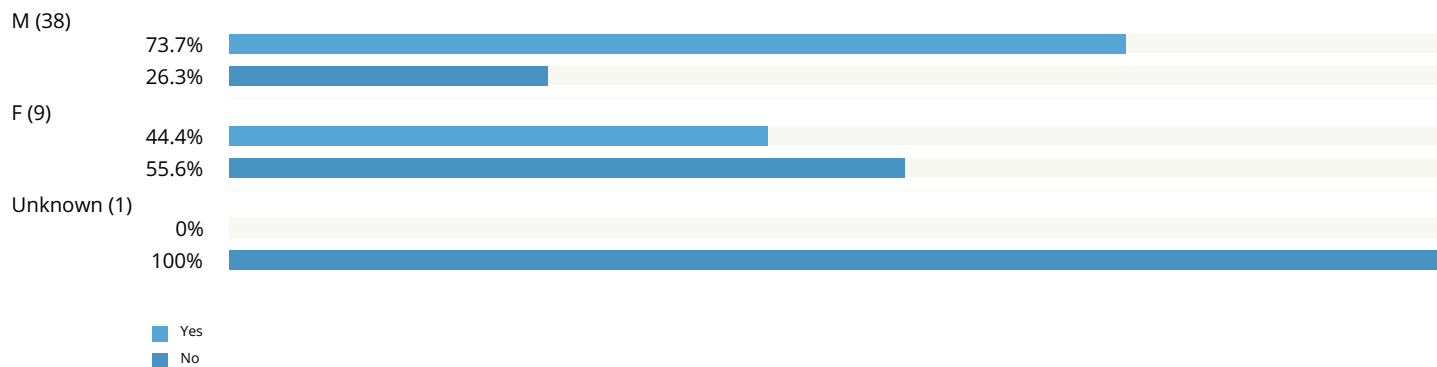

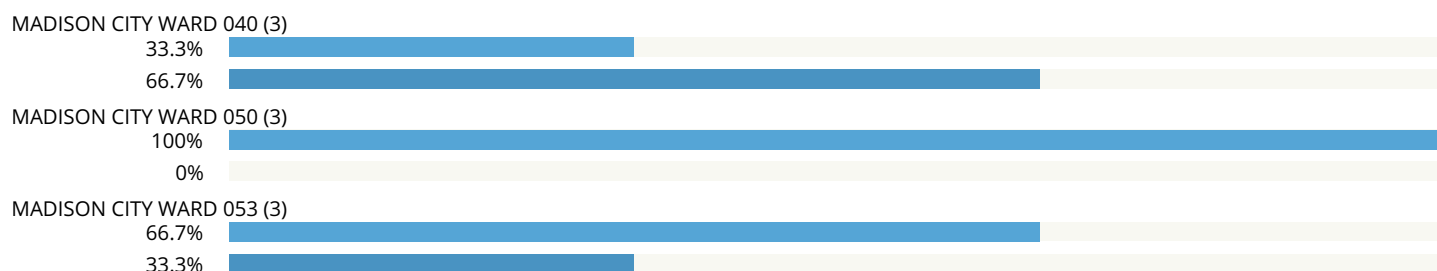

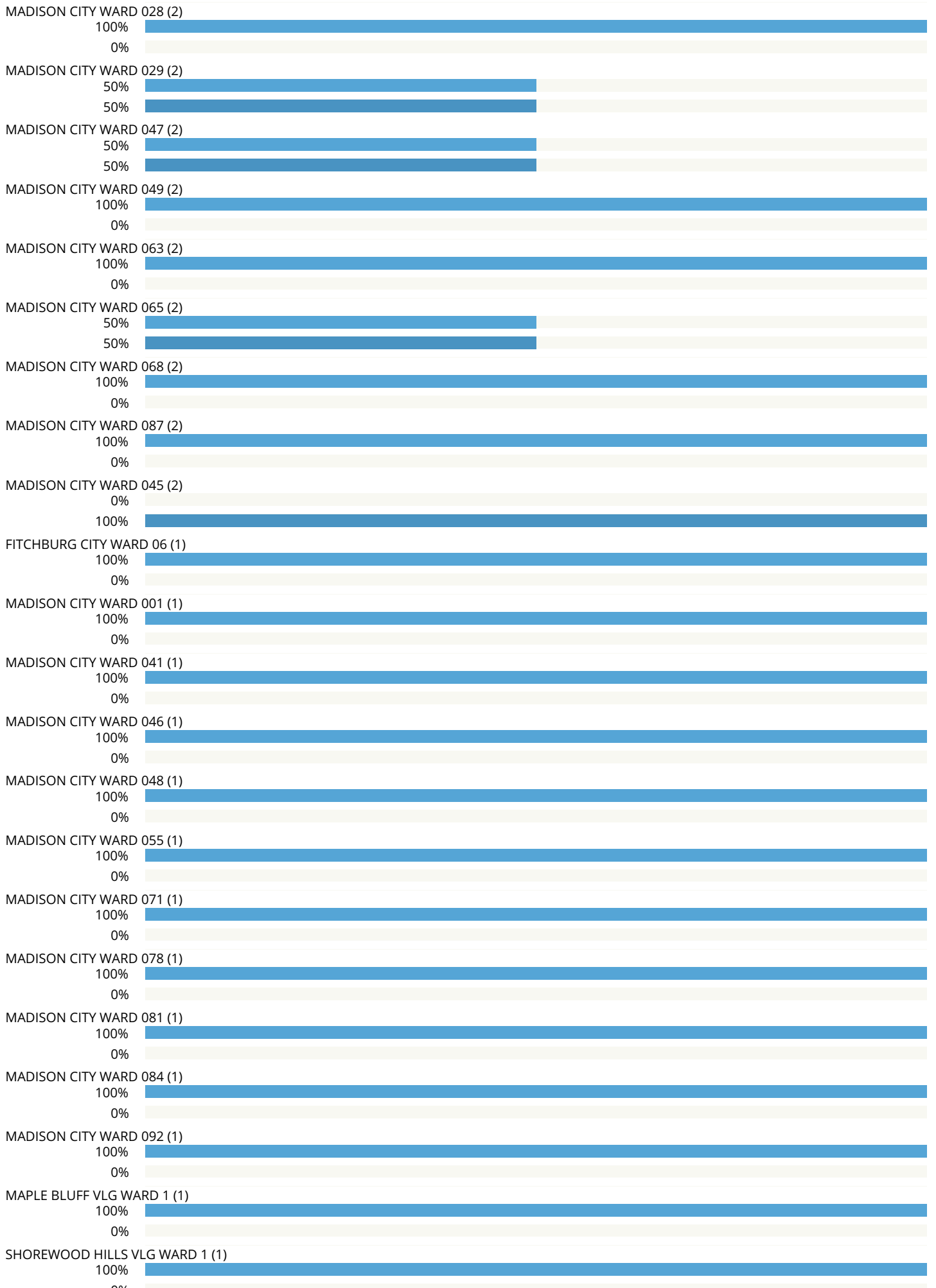


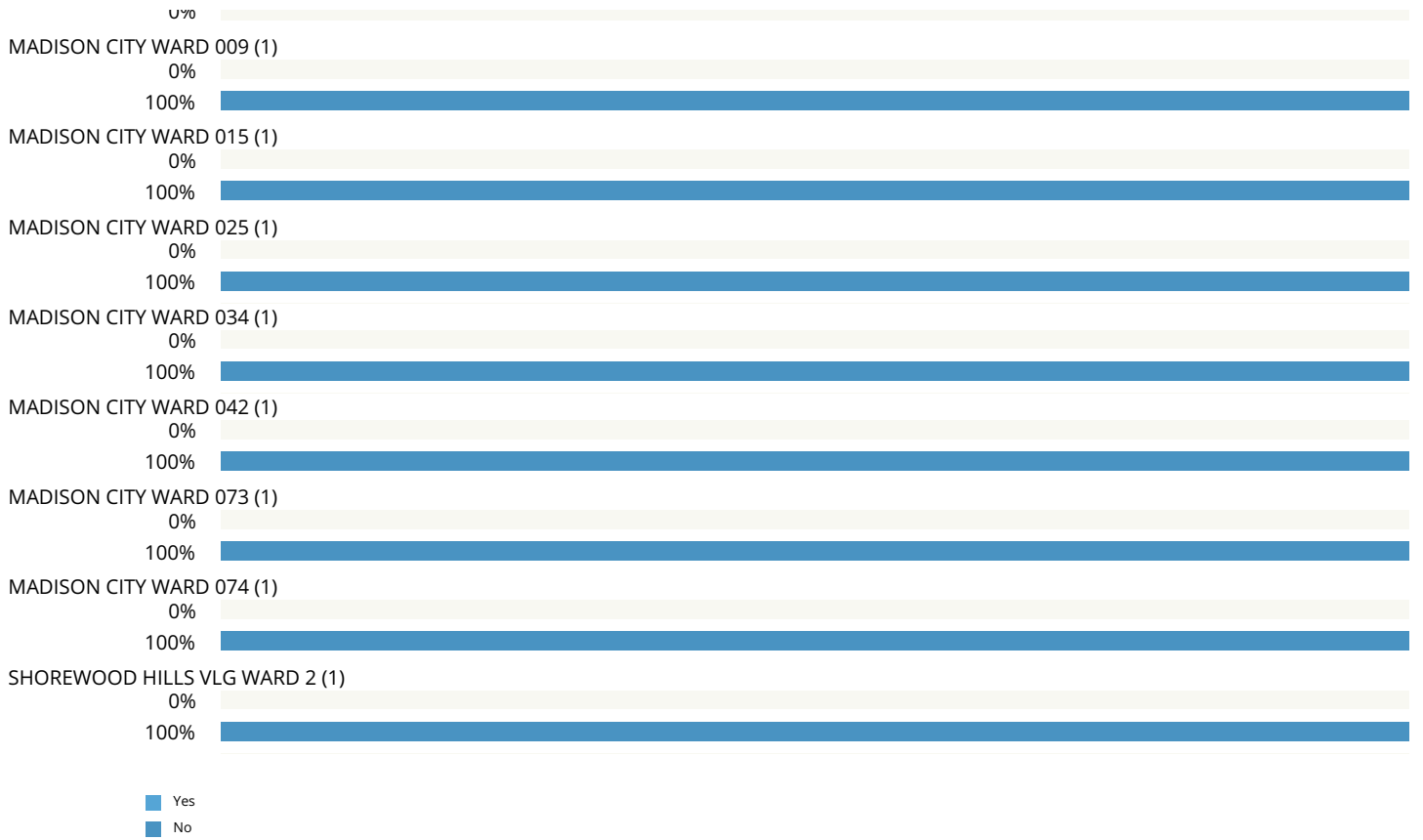
Voters_Gender Breakdown
