



Scope - City Utility Work

- Replace water mains and services
- Replace sanitary sewer, and laterals
- > 5600, 5604, 5608 Joylynne have private backyard main (not City maintained). This will stay in service. However we will also install new laterals off main in street for potential future connection.
- Extend storm sewer

Forestry

- Estimated tree removals in project limits 3-4 trees (2 of them are preemptive ash removals, one is volunteer).
- Ash trees planned for removal on this project would be removed regardless of project, City's Emerald Ash Borer response plan.
- Please contact Marla Eddy from forestry directly w/ tree related ?s
- Shrubs in Right-of-Way will be removed as needed to install street + sewer lats.
- When project is complete, Forestry will evaluate terraces for potential tree planting spots. (New trees typically planted the next spring.)



Scope – Street work

- Install curb and gutter on Glenview/Joylynne, install stone base, replace pavement, replace drive aprons.
- 32' street width
- Resurface Woodlawn (Existing curb stays, repave).

Terrace Rain Gardens

Assessment Policy & Costs

ltem	Property Owner Share	City Share
Curb and Gutter*	100%	0%
Pavement*	Costs of 4 ft.	Remaining 20'
Intersect Curb & Pvmt	0%	100%
Storm Sewer Main	0%	100%
Priv Storm Connects	100% (if any)	0%
Sanitary Sewer Main	0%	100%
Sanitary Laterals	25%	75%
Water Main	0%	100%

^{*} Curb, & pavement assessed per linear ft. of frontage



Assessment Policy

- Assessments can be paid in lump sum or typically over 8 years with 3% interest
- Alder can request 15 year payback
- Qualified loans available dependent on income
- Final assessments will be mailed in the summer of 2019, following the project completion



Assessment Costs

- Approximate property owner costs (this example, 85 FT frontage) for items
 - Curb & pavement approximately \$50 per ft frontage = \$4250
 - Drive Apron approx \$900 each
 - Sewer lateral replacement approx \$1600 each
 - For 85 ft frontage ballpark \$6750

Frontages vary 70–122 ft



Tentative Schedule

- Mail estimated assessments 3/9/2018
- ▶ BPW Hearing 3/21/2018
- CC Hearing 4/10/2018
- Advertise for Bids on 4/19/18
- Construction beginning early July 2018.



Construction - Terraces

Whole terrace/Right-of-way will get disturbed. Remove any plantings, raised beds, structures, stone landscaping, retaining walls, pavers, railings, etc. that you wish to save from the terrace prior to construction. Contractor will not replace/reinstall these items.



Construction

- Parking removed for project duration
- Road closed during project, local traffic only
- Residential driveways closed up to 20 days, Contractor will notify you in advance of driveway closures.
- Typically ~2 planned water shut-offs (up to 8 hours but usually about 4 hours) contractor will notify ahead of time. Occasionally emergency shut-offs if old main breaks.

- Driveway forms (please read + fill out + return to us to express your preference!)
- Informational letter prior to start of work (save! Will have inspector's contact info + Contractor info)
- Finalized assessment/bill about a year after work is done
