**1. Proposed NR 151 Revisions – Jim Bertolacini**

Jim gave a presentation on the proposed NR151 revisions. If approved by the DNR Board, public hearings could be held later in 2008 at the earliest. Anticipated earliest promulgation would be in 2009. The DNR NR151 Rule Revision website is here: <http://dnr.wi.gov/runoff/rules/nr151/rulerevision.htm>, and a copy of Jim's powerpoint can be found here:

Highlights of proposed revisions include:

- A new buffer standard and Phosphorus Index for ag land
- A construction site TSS performance standard of less than or equal to 5 tons per acre per year (instead of 80% reduction)
- Post-construction controls for redevelopment requiring 50% reduction of TSS (Total Suspended Solids) on internal roads and parking lots
- Wetland setbacks extended to 75 feet for more wetland types.

## **2. Summary of MS4 Modeling/Treatment Devices Utilized – Eric Rortvedt**

Eric provided a spreadsheet of what each municipality reported for their current TSS controls. Some may have over-estimated their removal efficiencies if an early version of SLAMM was used (prior to 9.2), while some of the towns may be underestimated if they rerun with the latest version (9.3) which takes into account grassed swales. The spreadsheet is included, but DON'T CITE OR QUOTE IT ☺

## **3. Update on MAMSWaP Annual Report Reviews – Laura Bub**

Laura has received all the annual reports and has begun reviewing them. Written comments will be provided to each municipality in the next 4-8 weeks.

## **4. Update on Re-application of MAMSWaP Permit Coverage – Jim/Eric**

Each municipality should send a letter to Eric that they intend to continue their involvement with the MAMSWaP group, using “official” letterhead in the next few months. A review of the current agreement will also take place shortly.

## **5. Information & Education Update**

Updated maps will be sent to each municipality shortly

The recently-formed Yahara Lakes Legacy Partnership was created to coordinate the activities of three complementary initiatives.

- 1) The Yahara CLEAN Memorandum of Understanding to assess existing nutrient and sediment loading to the Yahara lakes and determine actions required to decrease the loading and address bacterial outbreaks at beaches to improve water quality
- 2) A City of Madison budget amendment providing "funding to initiate a planning process to pull together stakeholders and community members to establish clear and achievable goals and an implementation plan for cleaning the lakes,"
- 3) The Yahara Lakes Legacy Project, in which Gathering Waters Conservancy and Clean Wisconsin—two nonprofit organizations with funding from the Madison Community Foundation— will be documenting historical lake rehabilitation efforts and "develop a common vision for restoring and maintaining a healthy, sustainable [Yahara lakes] watershed."
