6. Relevant geographic market area and subindustries

- Important before begin availability telephone interviews
 - Relevant geographic market area identifies geography for availability interviews
 - Subindustries identifies types of firms for availability interviews and work type definitions to be in "what type of work do you do" question in interviews
- Important before begin marketplace analyses, including in-depth interviews
 - Relevant geographic market area identifies study area and types of firms to be examined
- Relevant geographic market area: Madison Metropolitan Area contracting marketplace (Columbia, Dane and Iowa counties)
- Subindustries (see next page)





7. Overview of availability analysis

- Collect information on firms available for different types of prime contracts and subcontracts through telephone interviews
- Then determine subset of firms that fit each contract/subcontract
- Divides number of MBE/WBEs available by total firms available
 - \rightarrow 19 MBE/WBEs \div 55 total firms = 35% MBE/WBE availability for subcontract
- Then weight results by \$ involved to calculate total availability by racial/ethnic/gender group



Prime contracts and subcontracts come in many types and sizes



8. Availability telephone interviews

- Develop list of hundreds of business establishments in relevant geographic area that might perform public works-related work
- Customer Research International (CRI) will conduct interviews by telephone
- Conducted with firm owners and managers
- Open with ... "Hello. My name is [interviewer name]. We are calling on behalf
 of the City of Madison. This is not a sales call. The City is compiling a list of
 companies interested in working on a wide range of City public works
 construction contracts."
- Initially screen for whether do any work related to public works projects
- Also initially screen for whether "a business"



8(b). Examples - draft questions in availability telephone interviews

- "Does your firm do any work related to City public works contracts? This includes any construction, trucking and materials supply.
- Public works contracts include construction and repair of public buildings, streets and bridges, water and sewer facilities, and parks and recreation facilities]
- "What types of work does your firm perform related to public works contracts?" [list]
- "Thinking about work in the past seven years in the Madison area, has your company submitted a bid or a price quote for any part of a contract for a government agency?"
- "Were those bids or price quotes to work as a prime contractor, a subcontractor, a trucker/hauler, or as a supplier?"
- "In rough dollar terms, what was the largest contract or subcontract your company was awarded in during the past seven years?"
- "What was the largest contract or subcontract that your company bid on or submitted quotes for during the past seven years?"



8(c). Examples - draft questions in availability telephone interviews

- "My next questions are about the ownership of the business. A business is defined as woman-owned if more than half — that is, 51 percent or more — of the ownership and control is by women. By this definition, is your firm a woman-owned business?"
- "A business is defined as minority-owned if more than half that is, 51 percent or more of the ownership and control is African American, Asian, Hispanic or Native American. By this definition, is your firm a minority-owned business?"
 - "Would you say that the minority group ownership is mostly African American, Asian-Pacific American, Subcontinent Asian American, Hispanic American, or Native American?"




9. In-depth interviews with business owners, trade associations, others

- Many of the business owners will be identified for interviews from the telephone availability interviews
 - (last question in availability interview asks if they would be willing to participate in a follow-up interview)
- Trade associations will include major construction industry groups and minority and female business groups
- Lauber Consulting and the Davis Group will conduct the interviews
