**DOWNTOWN PLAN
Recreation, Culture and Entertainment Session Results**

On June 24, 2008 members of the community met in the Overture Center to share ideas regarding Downtown “Recreation, Culture and Entertainment”. The meeting attendees formed three groups; each group was asked to answer the following three questions:

- 1) What make Downtown an attractive location for recreational, cultural and entertainment activities?
- 2) What opportunities exist to support and expand recreational, cultural and entertainment activities in Downtown?
- 3) How can your big ideas about “Recreation, Culture and Entertainment” advance the goal of sustainability?

Below are the groups’ answers for each of the three questions. These comments are taken from flip-chart paper used by the groups as well as comment cards that were filled out individually. The answers are grouped into broad categories. An asterisk denotes comment card comments. Additionally, the groups wrote and drew some of their ideas on maps. Those ideas can be found on the summary maps which are available through the Downtown Plan website.
