Meeting Notes:

- Conceptboard will be available to review or add comments following the meeting.
- Children's Memorial project team discussed with Compassionate Friends about modifying the memorial to use the pedestrian bridges to allow for future expansion.
- No redflags on proposed uses within PR zoning.
 - No setback for accessory buildings (shelters, restrooms, etc.), parking lots, etc, 3' from OHW.
 Setbacks only apply to principal structures.
 - o 30' front yard and sideyard of 30' from adjacent property lines.
- Discuss sidewalk access from Vilas Ave. to park/multi-use trail with RRG.
- Review wetland boundary at Northern Parking lot and limits of Stormwater treatment. May need to alter Stormwater treatment location or method confirm with CoM Stormwater and DNR.
- Question for Sean/TE: is there a preferred proposed section for 2-way bike combined w/ ped-only?
 - Currently shown as 12' MUP with 6' Ped. (Sean minimum 10' with 2' buffer and 6' path. delineated by striping)
- Check in with Edgewood regarding their plans for boardwalks / other shoreline features

From Planning:

- RESJI analysis on Vilas Park Drive closure. Planning is concerned with the possibility of reducing
 accessibility for those with limited mobility and less convenient access in general. Look at "woonerf" or
 other means for slow movement of vehicles.
- Include narrative on future use of 2203 Edgewood Drive (this is a TR-C2 zoned property with wetland designation) so the plan isn't silent of any proposed use for the lot
- Include narrative on connecting Edgewood Drive to Wingra Park via pedestrian path system which
 would result in a quicker, easier route around Lake Wingra. Note Engineering was planning to
 condemn the driveways behind 1054, 1050, 938 Woodrow Street to make this pedestrian connection
 during the Monroe Street reconstruction; however, the state legislature changed the law limiting the
 authority of the city to do so.
- Vilas Mounds are a local landmark (in addition to being protected by the Wisconsin Burial Law). Any
 changes there will need a CoA in addition to a Request to Disturb Permit from the Wisconsin Historical
 Society. Whatever you work out with the tribes, we will likely concur with their wishes for how to best
 respect a site sacred to their people and showing proper respect to their ancestors who are buried
 there.
- Should plan go to Plan Commission for Review?
