Any and all applications beyond the fifteen agenda items will be scheduled for the next regularly scheduled meeting. Staff will inform the applicant as soon as possible if their case will be postponed.

You are required to register and report your lobbying. Please consult the City Clerk's Office for more information. Failure to comply with the lobbying ordinance may result in fines.
