Recently you requested information pertaining to demolition of 7 properties located on Cypress Way and W. Badger Road. The specific properties are:

2405, 2409 & 2413 Cypress Way

826, 830, 834 & 838 W. Badger Road

Over the past several years, a number of these properties have been the source of numerous calls for police service. Some of these buildings have also been the source of significant criminal and unlawful activity, particular drug dealing and prostitution. When these buildings were occupied, "No Trespassing" signs were posted on most of these buildings authorizing Madison police officers to take immediate enforcement action against persons who would regularly enter these properties or loiter around these properties for unlawful and illegal purposes. Now that many of these buildings are vacant, the remain a constant security risk as we routinely must check these properties for illegal entry by those who may wish to use the unoccupied buildings to conduct unlawful activities.

It is my recommendation as commanding officer of the South Police District these buildings be demolished as soon as possible so that long term redevelopment can proceed.
