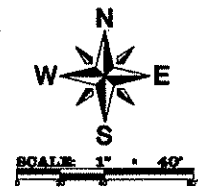
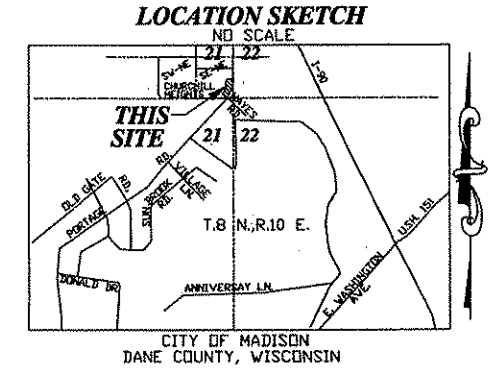
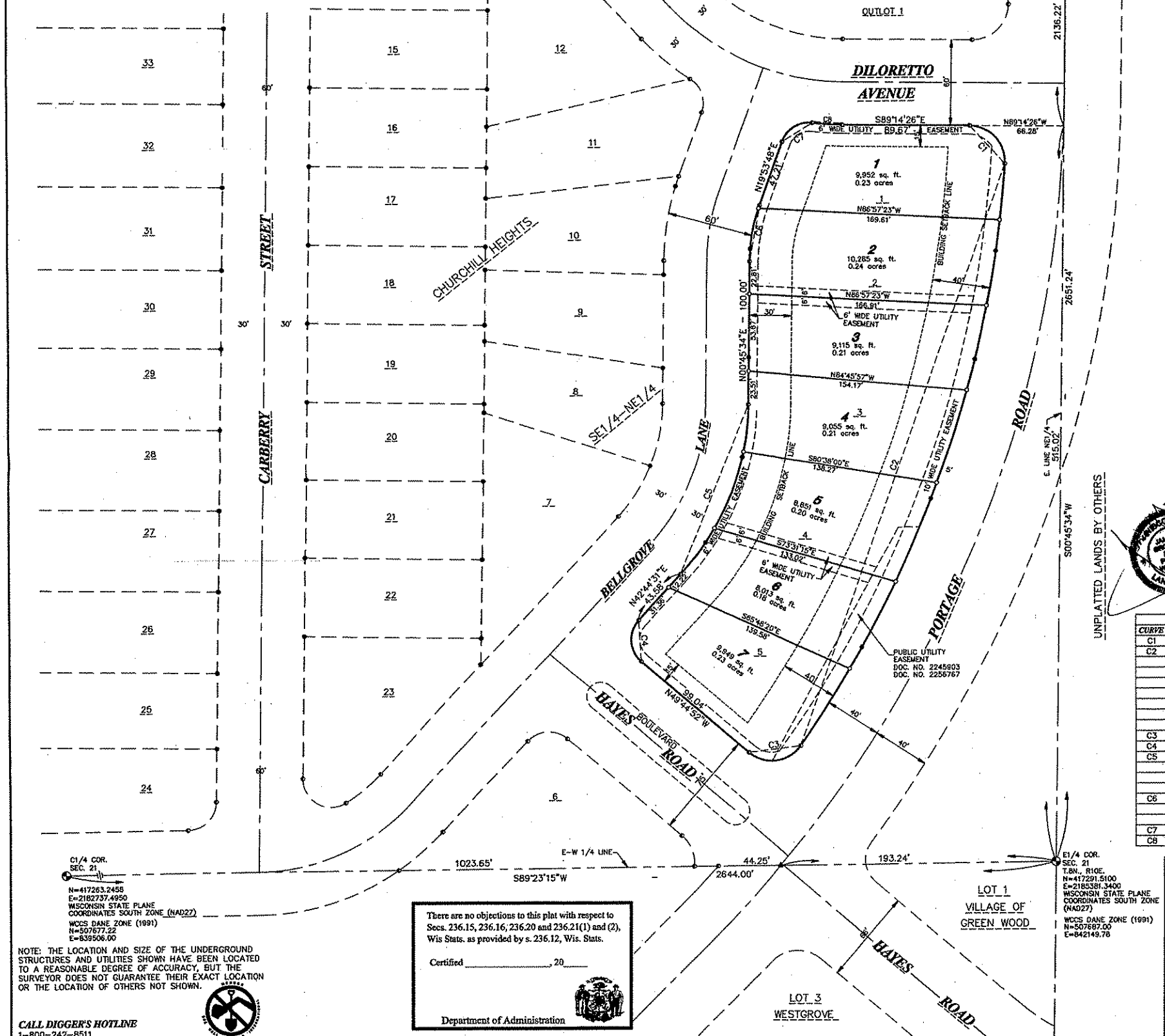


Churchill Heights Replat

SURVEYOR'S CERTIFICATE

I, JAMES R. GROTHMAN, Registered Land Surveyor, do hereby certify that in full compliance with the Provisions of Chapter 236 of the Wisconsin State Statutes and the City of Madison Subdivision Ordinance and under the direction of Blayde K. Elert of Churchill Homes, LLC, I have surveyed, monumented, mapped and divided the plat of the Churchill Heights Replat, that such plat correctly represents all exterior boundaries of the land surveyed and subdivision thereof, being Lots 1, 2, 3, 4 and 5, Churchill Heights located in the Southeast Quarter of the Northeast Quarter of Section 21, Town 8 North, Range 10 East, City of Madison, Dane County, Wisconsin, described as follows:

 thence South 00°45'34" West along the east line of the Northeast Quarter of said Section 21, 2,136.22 feet;
 thence North 89°14'27" West, 66.28 feet to a point on the right-of-way line of Dileotto Avenue and the point of beginning;
 thence Southeasterly along the westerly right-of-way line of Portage Road along a 25.00 foot radius curve to the right having a central angle of 93°18'38" and whose long chord bears South 42°36'07" East, 38.35 feet;
 thence Southwesterly along the westerly right-of-way line of Portage Road along a 810.00 foot radius curve to the right having a central angle of 30°50'02" and whose long chord bears South 19°30'13" West, 432.03 feet;
 thence Southwesterly along said westerly right-of-way line of Portage Road along a 25.00 foot radius curve to the right having a central angle of 95°16'54" and whose long chord bears South 82°36'41" West, 38.95 feet;
 thence North 49°44'52" West along the northeasterly right-of-way line of Hayes Road, 99.04 feet;
