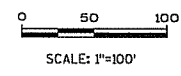

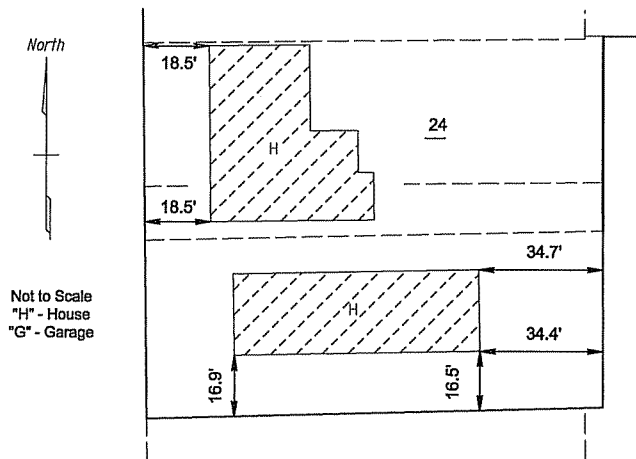
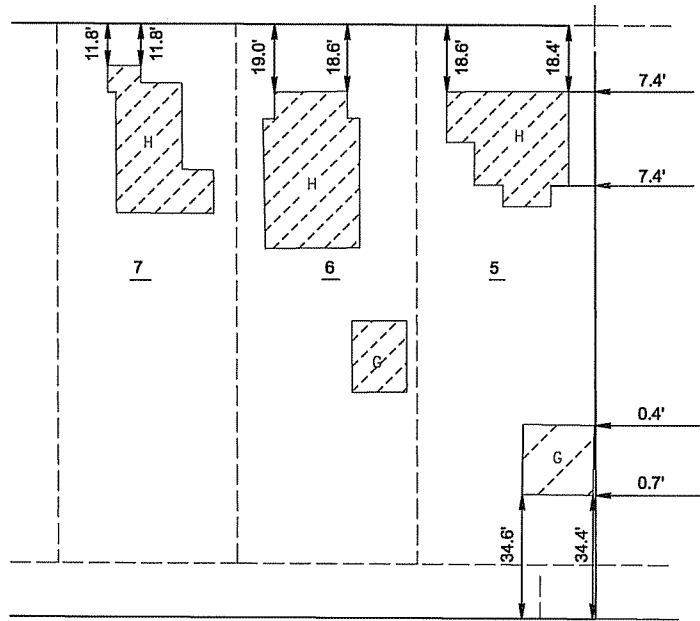
**Building Location Detail**
