Dear Ms. Thiele,

I am writing to lend my full support to Patrick McCaughey's request to the Zoning Board of Appeals regarding 801 Erin Street (702 West Shore Drive). I have studied the floor plan and elevations for the new structure and find Mr. McCaughey's request for three variances to the code TR-C3 entirely reasonable in terms of both function and aesthetics.

Having lived at 814 West Shore Drive since 1981, I have observed many changes and am delighted to see such a handsome addition to our street. I especially appreciate the reduction of the massing of the building by the pushing of the attic area back from the front sidewalk. In addition, a garage with ample storage space means less clutter of bicycles, garden tools, etc. in the yard. Furthermore, as someone fortunate enough to have a prime view of the capitol from out our front windows, I find Mr. McCaughey's request for bay windows at the level of the first floor entirely reasonable.

I urge that the ZBA will vote in favor of all three variances.
