SECTION B: INSTRUCTIONS TO BIDDERS

The City of Madison Standard Specifications for Public Works Construction - 2012 Edition, as supplemented and amended from time to time, forms a part of these contract documents as if attached hereto.

These standard specifications are available on the City of Madison Public Works website at www.cityofmadison.com/Business/PW/specs.cfm or by contacting City Engineering Division, Room 115, City-County Building, 210 Martin Luther King Jr. Blvd., Madison, WI 53703.

The Contractor shall review these Specifications prior to preparation of proposals for the work to be done under this contract, with specific attention to Article 102 "BIDDING REQUIREMENTS AND CONDITIONS" and Article 103 "AWARD AND EXECUTION OF THE CONTRACT." For the convenience of the bidder, below are highlights of three subsections of the specifications.

Section 102.1: Pre-Qualification of Bidders

In accordance with Wisconsin State Statutes 66.0901 (2) and (3), all bidders must submit to the Board of Public Works proof of responsibility on forms furnished by the City. The City requires that all bidders be qualified on a biennial basis.

Bidders must present satisfactory evidence that they have been regularly engaged in the type of work specified herein and they are fully prepared with necessary capital, materials, machinery and supervisory personnel to conduct the work to be contracted for to the satisfaction of the City. All bidders must be prequalified by the Board of Public Works for the type of construction on which they are bidding prior to the opening of the bid.

In accordance with Section 39.02(9)(a)l. of the Madison General Ordinances, all bidders shall submit in writing to the Affirmative Action Division Manager of the City of Madison, a Certificate of Compliance or an Affirmative Action Plan at the same time or prior to the submission of the proof of responsibility forms. The bidder shall be disqualified if the bidder fails to or refuses to, prior to opening of the bid, submit a Certificate of compliance, Affirmative Action Plan or Affirmative Action Data Update, as applicable, as defined by Section 39.02 of the Madison General Ordinances (entitled Affirmative Action) and as required by Section 102.11 of the Standard Specifications.

Section 102.4: Proposals

No bid will be accepted that does not contain an adequate or reasonable price for each and every item named in the Schedule of Unit Prices.

A lump sum bid for the work in accordance with the plans and specifications is required. The lump sum bid musts be the same as the total amounts bid for the various items and it shall be inserted in the space provided.

All papers bound with or attached to the proposal form are considered a part thereof and must not be detached or altered when the proposal is submitted. The plans, specifications and other documents designated in the proposal form will be considered a part of the proposal whether attached or not.

A proposal submitted by an individual shall be signed by the bidder or by a duly authorized agent. A proposal submitted by a partnership shall be signed by a member/partner or by a duly authorized agent thereof. A proposal submitted by a corporation shall be signed by an authorized officer or duly authorized registered agent of such corporation, and the proposal shall show the name of the State under the laws of

which such corporation was chartered. The required signatures shall in all cases appear in the space provided therefore on the proposal.

Each proposal shall be placed, together with the proposal guaranty, in a sealed envelope, so marked as to indicate name of project, the contract number or option to which it applies, and the name and address of the Contractor. Proposals will be received at the place and until the hour on the date designated in the advertisement. When sent by mail, the sealed proposal marked as indicated above shall be enclosed in an additional envelope. Proposals sent by mail, submitted in person or otherwise delivered must be in the hands of the official conducting the letting by the hour on the date designated in the advertisement. Proposals received after the date designated will be returned to the bidder unopened.

The Bidder shall execute form ERD-7777 (R.9/03), a part of these proposal pages and submit same with the bidder's proposal, if applicable. REFER TO PROPOSAL SECTION.

Section 102.5: Bid Deposit (Proposal Guaranty)

No proposal shall be considered unless either (i) it is accompanied by a bid deposit of the character and amount described in the Advertisement for Bids or (ii) a biennial bid bond in an amount and form acceptable to the City of Madison has been previously submitted.

Bid deposits of unsuccessful bidders shall be returned following the award of the contract by the Common Council. Bid deposit of the successful bidders shall be returned within forty-eight (48) hours following execution of the contract and bond as required.

SECTION D: SPECIAL PROVISIONS

BLAIR STREET SANITARY SEWER REPAIR 2012 CONTRACT NO. 6938

It is the intent of these Special Provisions to set forth the final contractual intent as to the matter involved and shall prevail over the Standard Specifications and plans whenever in conflict therewith. In order that comparisons between the Special Provisions can be readily made, the numbering system for the Special Provisions is equivalent to that of the Specifications.

Whenever in these Specifications the term "Standard Specifications" appears, it shall be taken to refer to the City of Madison Standard Specifications for Public Works Construction and Supplements thereto.

SECTION 102.10: MINIMUM RATE OF WAGE SCALE

For this project, payment of prevailing wages (white sheet) is not required if either: a single trade accounts for 85% or more of the total labor costs of the project and the bid is less than \$48,000; or no single trade accounts for 85% or more of the total labor costs of the project and the bid is less than \$100,000. For bids not meeting either of these conditions, prevailing wages shall be required.

If required, the wages and benefits paid on the contract shall not be less than those specified in the Prevailing Wage Determination included with these contract documents for the following types of work:

	Building and Heavy Construction

All bidders are notified that all labor employed on City contracts must be paid in accordance with the minimum rate of wage scale included in the Contract Documents.

For the information of the employees working on the project, a copy of the wage scale included in the contract documents and the provisions of Section 66.0903(8) of the Wisconsin Statutes shall be kept posted by the employer and in at least one conspicuous and easily accessible place at the site of the project.

The Contractor shall keep weekly payroll records setting forth the name, address, telephone number, classification, wage rate and fringe benefit package of each employee who worked on such City project and all other projects the employee worked in the same period, and the Contractor must keep records of the individual time each employee worked on the project and for each day of the project. Such records shall also set forth the total number of hours of overtime credited to each such employee for each day and week and the amount of overtime pay received in that week. Such records shall, in addition, set forth the full weekly wages earned by each such employee and the actual hourly wage paid to that employee. The Contractor shall submit payroll records to the Engineer every week for those periods when work is being done on the project. Said submittal shall be within twenty-one (21) calendar days of the end of the Contractor's weekly pay period.

The Contractor shall ensure that employees shall be paid unconditionally and shall receive the full amounts accrued at the time of payment, computed at rates not less than those stated in the City of Madison "Minimum Rate of Wage Scale" and that each employee's rate shall be determined by the work that is done within the trade or occupation classification which should be properly assigned to such employee. Questions regarding an employee's classification or rate of pay within that classification, shall

be resolved by the practice that predominates in the industry and on which the trade or occupation rate/classification is based. Therefore, rate of pay, classification and work jurisdiction disputes shall be resolved by relying upon practices established by collective bargaining agreements and guidelines used in such determinations by appropriate recognized trade unions operating within the City of Madison.

The Contractor shall agree that the normal rate of wage paid to the Contractor's employees on other projects shall not be reduced or otherwise diminished as a result of the requirement to pay no less than the minimum rate of wage scale on a City project. Mulcting of employees on City projects by contractors, such as by kickbacks or other such devices, is prohibited.

These contract provisions shall apply to all work performed on the contract by the Contractor with its own organization and with assistance of laborers under its immediate superintendency and to all work performed by piecework or by subcontract. No laborer, worker, or mechanic shall be employed directly upon the site of the work except on a wage basis, but this shall not be construed to prohibit the rental of equipment from individuals.

In the event of a refusal by the Contractor to submit payroll records as required by the contract, the City of Madison shall have the option to cancel this contract and request the Surety to perform or to relet the balance of the work for bids, and in that event, to charge the Contractor for any loss which the City may incur thereby.

SECTION 102.12: BEST VALUE CONTRACTING

This Contract shall be considered a Best Value Contract if the Contractor's bid is equal to or greater than \$51,500 for a single trade contract; or equal to or greater than \$251,000 for a multi-trade contract pursuant to MGO 33.07(7).

ARTICLE 102.3 <u>EQUAL BENEFITS REQUIREMENT</u> (SEC. 39.07, MGO)

This provision applies to contracts executed by the City on July 1, 2012 or later, unless exempt by Sec. 39.07 of the Madison General Ordinances (MGO).

For the duration of this Contract, the Contractor agrees to offer and provide benefits to employees with domestic partners that are equal to the benefits offered and provided to married employees with spouses, and to comply with all provisions of Sec. 39.07, MGO. If a benefit would be available to the spouse of a married employee, or to the employee based on his or her status as a spouse, the benefit shall also be made available to a domestic partner of an employee, or to the employee based on his or her status as a domestic partner. "Benefits" include any plan, program or policy provided or offered to employees as part of the employer's total compensation package, including but not limited to, bereavement leave, family medical leave, sick leave, health insurance or other health benefits, dental insurance or other dental benefits, disability insurance, life insurance, membership or membership discounts, moving expenses, pension and retirement benefits, and travel benefits.

<u>Cash Equivalent</u>. If after making a reasonable effort to provide an equal benefit for a domestic partner of an employee, the Contractor is unable to provide the benefit, the Contractor shall provide the employee with the cash equivalent of the benefit.

<u>Proof of Domestic Partner Status</u>. The Contractor may require an employee to provide proof of domestic partnership status as a prerequisite to providing the equal benefits. Any such requirement of proof shall comply with Sec. 39.07(4), MGO.

Notice Posting, Compliance. The Contractor shall post a notice informing all employees of the equal benefit requirements of this Contract, the complaint procedure, and agrees to produce records upon request of the City, as required by Sec. 39.07, MGO.

<u>Subcontractors</u>. Contractor shall require all subcontractors, the value of whose work exceeds the single-trade minimum set forth in Sec 33.07(7)(b)5., MGO, to provide equal benefits in compliance with Sec. 39.07, MGO.

See Section 39.07 MGO for exemptions from this requirement. Exemptions from this requirement include a Contractor whose employees are under a collective bargaining agreement that was in effect prior to July 1, 2012, however, the Contractor must agree to propose to the applicable collective bargaining unit(s) that an equal benefit requirement consistent with this ordinance be incorporated into the next collective bargaining agreement or in the existing agreement upon amendment, extension or other modification that occurs after July 1, 2012.

ARTICLE 103 AWARD AND EXECUTION OF THE CONTRACT

The Contractor shall execute signing of this contract prior to August 7, 2012. No exceptions or extensions to the above date will be permitted.

ARTICLE 104 SCOPE OF WORK

The work under this contract shall include installation sanitary sewer point repair 8' north of railroad tracks on N. Blair Street. City Maintenance crews found that the City sewer was collapsed while doing routine maintenance cleaning of the sewer. The sewer appears to be currently operating at half capacity. The estimated location of the repair is marked with a box and X in green paint.

Due to the repair being located in a high traffic area, this utility repair work will need to be completed during the weekends only.

The Contractor shall view the site prior to bidding to become familiar with the existing conditions. It will be the responsibility of the Contractor to work with the utilities located in the right of way to resolve conflicts during the construction process.

SECTION 105.1: <u>AUTHORITY OF THE ENGINEER</u>

The Engineer shall resolve all questions which arise as to the quality and acceptability of materials furnished, work performed, manner of performance, rate of progress of the work, interpretation of the plans and Specifications, acceptable fulfillment of the contract, compensation, and disputes and mutual rights between Contractors under the Specifications. The Engineer shall determine the amount and quantity of work performed and materials furnished.

All decisions of the Engineer shall, when so requested, be rendered in writing. They shall be final and conclusive in all matters unless within ten (10) days after such decision the Contractor applies in writing to the Board of Public Works for a review of such decision.

Any change proposed by a Contractor in SBE subcontractors, vendors or suppliers from those SBEs indicated on the SBE Compliance Report must be approved by the Engineer and the City's Manager of the Affirmative Action Division (hereafter, AAD). When requested, such decision shall be rendered in writing. Such decisions shall be final and conclusive in all matters unless within ten (10) days after such decision the Contractor or the affected SBE applies in writing to the Board of Public Works for a review of such decision.

In the event the Engineer and the AAD disagree over the proper decision to be made regarding an SBE, the Mayor shall appoint a third person to resolve the disagreement, within 30 days of appointment. The decision thus rendered may be reviewed by the Board of Public Works upon request of the Contractor or the affected SBE as set forth in Sections 105.1 and 105.2 of the City's standard specifications.

ARTICLE 105.12 COOPERATION BY THE CONTRACTOR

The City is not required to obtain a railroad permit from the Wisconsin Southern Railroad but requests that the Contractor adheres to all requirements set forth by the railroad as if the a permit was necessary to complete the work including but not limited to providing notice to railroad, providing evidence of railroad insurance and all compensation necessary to have a Wisconsin & Southern Railroad flag person present during construction.

SECTION 107.14 WEAPONS PROHIBITION

Contractor shall prohibit, and shall require its subcontractors to prohibit, its employees from carrying weapons, including concealed weapons, in the course of performance of work under this Contract, other than while at the Contractor's or subcontractor's own business premises. This requirement shall apply to vehicles used at any City work site and vehicles used to perform any work under this Contract, except vehicles that are an employee's "own motor vehicle" pursuant to Wis. Stat. sec. 175.60(15m).

ARTICLE 107.7 MAINTENANCE OF TRAFFIC

All signing and barricading shall conform to Part VI of the Federal Highways Administrations "Manual on Uniform Traffic Control Devices" (MUTCD), the State of Wisconsin Standard Facilities Development Manual (including Chapter 16 – Standard Detail Drawings) and the City of Madison Standards for sidewalk and bikeway closures.

A traffic control plan is provided in the plan set. The traffic control plan is a schematic representation of the traffic control. It shall not be considered to scale. The contractor shall not use the traffic control plan to represent quantity of drums. Drums shall be spaced per M.U.T.C.D. The contractor shall maintain all lanes shown on the traffic control plan except as noted below. Accomplish the construction sequence, including the associated traffic control as detailed in the traffic control section of the plans, and as described in this traffic article. Unless detailed in the plans, do not begin or continue any work that closes traffic lanes outside the allowed time periods specified in this article. Submit all traffic control change requests to the construction engineer at least 3 working days prior to an actual traffic control change. A request does not constitute approval.

Traffic Control shall be measured as a lump sum. Payment for the Traffic Control is full compensation for constructing, assembling, hauling, erecting, re-erecting, maintaining, restoring, and removing non permanent traffic signs, drums, barricades, and similar control devices, including arrow boards, for providing, placing, and maintaining work zone. Maintaining shall include replacing damaged or stolen traffic control devices. Traffic control to install temporary markings shall be included in the Traffic Control Lump Sum Bid Item. Contractor shall supply all necessary mounting hardware and supports for signing. This shall also include covering and uncovering any conflicting overhead signs during the project. Contractor shall display all signing so as to be easily viewed by all users. Contractor shall mount traffic control on posts or existing poles or drive posts whenever possible. Existing poles may be used with approval of Construction Engineer. This project is located in a high traffic control theft area. Contractor shall inspect traffic control daily to insure all traffic control remains in place during the project.

Traffic Control measures and Temporary Pavement Markings will need to be installed and removed each weekend.

The traffic control plan may need to be altered as conditions change in the field or as unexpected conditions occur. This shall include relocating existing traffic control or providing additional traffic control. This should be considered incidental to providing traffic control for the project.

Contractor shall at all times have an appropriately equipped flagger at any location where construction equipment or trucks are leaving the jobsite and entering the normal traffic flow.

All vehicular travel lanes shall be maintained at a minimum width of 10 feet or 12 feet if lane is adjacent to curb. Contractor shall maintain turning radii where right or left turns are allowed per the traffic control plan. Turning radii at a minimum shall be adequate for a WB-50 size semi to make the turn and larger vehicles where necessary as determined by the construction engineer.

Maintain Access to all properties along Blair Street, Williamson Street, and Wilson Street at all times.

Maintain sidewalk at all times on both sides of Williamson Street, Wilson Street, and Blair Street.

Construction equipment and materials are not to be stored within the street right-of-way that is open to traffic during non-working hours.

The Contractor shall not remove traffic signs. For removal or replacement of traffic and parking signs, contact the City of Madison Traffic Engineering Field Operations, 1120 Sayle Street, 266-4767, 8:00 a.m. to 4:00 p.m., a minimum of 2 working days in advance of when any existing signs need to be removed. This service is provided free of charge. If the contractor removes the signs, the contractor will be billed for the reinstallation of, and any damage to, the signing equipment. The contractor shall notify The City of Madison Traffic Engineering Field Operations, 1120 Sayle Street, 266-4767 upon completion of final landscaping to have permanent signs reinstalled. The contractor shall expect a minimum of seven working days to have permanent signs reinstalled. The contractor shall leave in place all necessary traffic control until given notice by the construction engineer that permanent signing is in place and temporary traffic control may be removed.

ARTICLE 107.12 <u>RAILROAD - HIGHWAY GRADE SEPARATIONS AND APPROACHES,</u> NEW RAILROAD CROSSINGS, AND OPERATION ON RAILROAD RIGHT- OF WAY

The company representative who may be consulted by Bidders and Contractors with regard to railroad requirements is Ben Meighan at (608) 243-9129 x 201. Notice must be given to Ben Meighan at least 72 hours prior to working within twenty feet (20') of the Railroad Tracks. When doing so, the contractor's employees and equipment must first have authorization of Wisconsin and Southern Railroad. Any time that work is being done within twenty feet (20') of the track, a Wisconsin and Southern Railroad flag person must be present. It shall be the responsibility of the Contractor to compensate the Railroad for the flag person.

BID ITEM 10790 - RAILROAD INSURANCE

The Contractor shall provide special third party protection insurance for, and in behalf of, Wisconsin and Southern Railroad Company.

The Contractor shall provide special third party protection insurance for, and in behalf of, the Wisconsin and Southern Railroad Company.

The amount of insurance to be provided shall be limited to a combined single limit amount of Two Million Dollars (\$2,000,000) per occurrence for Bodily Injury Liability, Property Damage Liability, and Physical Damage to Property, with Six Million Dollars (\$6,000,000) aggregate for the term of the policy with respect to Bodily Injury, Liability, Property Damage Liability and Physical Damage to Property.

ARTICLE 108.2 PERMITS

The following permits have been applied for:

1. City of Madison Erosion Control & Stormwater Management Permit

It shall be the responsibility of the Contractor to obtain the permits listed below, if required, and to pay all applicable charges and fees associated with these permits.

All permit costs shall be considered incidental to the various Mobilization bid items for the Contract.

The Contractor shall meet the conditions of all permits and must keep a copy of each individual permit on site at all times throughout construction.

The Contractor shall meet the conditions of the permits involving including properly installing and maintaining the erosion control measures as directed by the Construction Engineer or his designees. The work will be paid for under the appropriate contract bid items or, if appropriate items are not included in the contract, they shall be paid for as Extra Work.

The City's obtaining of these permits is not intended to be exhaustive of all permits that may be required to be obtained by the Contractor for construction of this project. It shall be the responsibility of the Contractor to identify and obtain any other permits needed for construction.

ARTICLE 109.2 PROSECUTION OF WORK

The Contractor shall begin work on or before <u>August 18, 2012</u>. The total time for completion of the contract shall be <u>FIVE (5) CALENDAR DAYS</u>. Work shall follow Section 107.7 Maintenance of Traffic herein these specifications unless approved by the Engineer.

Due to the location of the sewer repair having high traffic impacts, all work shall be completed on the weekends (Friday 7:00 P.M. to Monday 6:00 AM). A weekend as defined by these special provisions shall be equal to 2.5 calendar days. Contractors are allowed to work during the evenings but will not be allowed drive sheeting after 10:00 pm. After the first weekend, the disturbed portion of the road shall have a temporary asphalt patch (Utility Trench Patch-TYPE III).

Work shall begin only after the start work letter is received.

The fixed, agreed upon, daily liquidated damages for failure to complete all work within the contract shall be computed in accordance with the special provisions.

Calendars Days will not be charged for the installation of the type 2 dewatering wells provided that they are installed at a time that is acceptable to the City Traffic Engineer. The Dewatering system: pumps and hosing will not be allowed in the pavement area unless they are inside the work zone during allowable contract work hours.

In the event of inclement weather, final concrete paving be shall be completed on a weekend agreeable with the Traffic Engineer. Work on football weekends will not be allowed.

ARTICLE 109.9 LIQUIDATED DAMAGES

A Liquidated Damage Penalty (maximum \$11,000/day) will be assessed to the contractor for closure of the streets outside of the weekend time period called for in the contract-(Friday 7:00 PM to Monday 6:00 AM). The Liquidated Damage Penalties will be enforced for work that is completed during the following time periods:

ARTICLE 203.2 DISPOSING OF MATERIALS

The Contractor shall comply with Section 203.2 of the City of Madison Standard Specifications for Public Works Construction with regard to salvaging castings.

ARTICLE 210 <u>EROSION CONTROL</u>

The standards specifications for Erosion Control are supplemented as follows. The Contractor shall be responsible for final stabilizing (seeding/matting/sodding/...as called for in the contract) the disturbed terrace area within 10 calendar days after the pouring of adjacent curb and gutter, unless alternate phasing is approved by the Construction Engineer. This specification shall be interpreted by the Contractor to require multiple trips to the job site by the landscaping subcontractor and the Contractor shall plan for that to occur.

ARTICLE 301 CONCRETE AND CONCRETE MATERIALS

HIGH EARLY STRENGTH CONCRETE

This special provision describes high early strength concrete in accordance with the requirements of the standard specifications and as hereinafter provided.

High early strength concrete shall be used for Utility Trench Patch Type I on Blair Street which is to be re-opened to traffic to traffic for weekday traffic in accordance with the Traffic Control plan.

All concrete used on City of Madison Public Works projects shall comply with the following subsections of Article 501, "Concrete" of the latest edition of the Standard Specifications for Highway and Structure Construction of the State of Wisconsin, Department of Transportation, Division of Highways:

501.2 Materials

501.3 Construction

ARTICLE 501 SEWER AND SEWER STRUCTURES GENERAL

SANITARY SEWER GENERAL

The Sanitary Sewer Designer for this project is Mark Moder, Phone: 261-9250, mmoder@cityofmadison.com.

This project consists of a sanitary sewer point repair anticipated to be approximately 10' of 8" sanitary sewer main. Sanitary sewer pipe work shall include installing new AWWA C900 DR 18 pipe at the sizes and locations that are specified on the plan set and in accordance with the Standard Specifications.

It is advised that the Contractor visit the site prior to bidding to determine the type of trench protection that will be necessary for the sanitary sewer main installation.

Tunneling is expected to be required at the existing utility crossings. Any utility tunneling required shall be considered incidental to the pipe being installed.

BID ITEM 50202 – TYPE II DEWATERING

It is advised that the Contractor visit the site prior to bidding to determine the type of trench protection and dewatering that will be necessary for the sanitary sewer main installation. It is anticipated that with the high groundwater table, that dewatering will be necessary with Point wells. Placing a pump in the trench will be considered Type 1 Dewatering which is considered incidental to the pipe installation.

If petroleum products (odor or positive testing) are detected while dewatering the excavation trench, the water shall be discharged to the City's 24" diameter sanitary sewer (see SAS 5249-015 or SAS 5249-011 on plan set).

If pumping is expected to last beyond the contract work period called for in these specifications, dewatering wells will not be allowed in pavement area. If dewatering equipment (pumps/ hoses) is in the Street pavement area during the time periods beyond the 2 weekend contract work period, liquidated penalties in accordance with Article 109.9 will be assessed to the contractor.

BID ITEM 50801 – UTILITY LINE OPENING (ULO)

The work under this item shall be completed in accordance with Article 508 of the Standard Specifications for Public Works Construction. It is the discretion of the contractor to locate utilities by either a trench excavation or by a pothole technique. However, the contractor shall not be compensated more than once for multiple utilities located within a maximum distance of five (5) feet long.

BID ITEM 90030 - SANITARY SEWER POINT REPAIR

DESCRIPTION

City Maintenance crews found that the City's 8" diameter Cast Iron sewer was collapsed while doing routine maintenance cleaning of the sewer. The sewer appears to be currently operating at half capacity. It is not known what may have caused the caused the collapse. According to our site survey, there does not appear to be any utility crossings of the City sewer. Work under this bid item shall include removal of the obstruction causing the sewer collapse which may include an old manhole and replacing collapsed 8" diameter Cast Iron pipe with a AWWA C900 DR 18 or Ductile Iron Water Pipe (ANSI/AWWA C151/A21.51- Latest Revison). Inside diameters pipe sizes need to match size. It is anticipated that the repair length will be 10' long but it will be the responsibility of the Contractor to connect to a solid

unbroken pipe. The existing cast iron pipe shall be sawcut and Compression Couplings Fernco (payable under BID ITEM 50357) shall be installed to connect the existing cast iron pipe to the new pipe. If ductile iron pipe is to be used for the point repair, Solid Sleeves in accordance with Article 702.8 of the City of Madison Standard Specification will be require. Solid Sleeves will be paid for as compression couplings. All sewer repair work shall be completed in conformance of Article 501.6 of the City of Madison Standard Specifications for Public Works Construction- 2012 edition.

Due to the close proximity to the railroad tracks (break located 8' away according to TV data), it is anticipated that the contractor will need to install earth retention measures to prevent undermining of the railroad tracks and provide a safe work area. Soil retention- shoring and/ or tight sheeting, shall be paid for separately(BID ITEM 90032- TEMPORARY SHORING).

METHOD OF MEASUREMENT

SANITARY SEWER POINT REPAIR shall be measured by the Lump Sum including removal of obstruction(s) causing the collapse, removal of all broken sanitary sewer pipe and including the installation of select fill.

BASIS OF PAYMENT

SANITARY SEWER POINT REPAIR shall be measured as described above and shall be paid for at the contract price which shall be full compensation for all work, materials, labor and incidentals required to complete the work set forth in the description.

BID ITEM 90031 - EXCAVATION AND HAULING OF PETROLEUM CONTAMINATED SOIL

DESCRIPTION

This work shall conform with the requirements of the City of Madison's Standard Specifications for Public Works Contracts, pertinent parts of the Wisconsin Administration Code (Department of Natural Resources Environmental Investigation and Remediation of Environmental Contamination, Chapters NR 700-736), as shown on the plans, and as supplemented herein.

The potential exists for excavation of petroleum-contaminated soil in conjunction to the sanitary sewer point repair. If during the course of the project, contaminated soils are encountered, the Contractor shall terminate excavation activities in the area and notify the Project Engineer.

This work shall consist of excavating, loading and hauling petroleum-contaminated soil to the nearest City of Madison approved BioSite treatment facility operated by Waste Management of Wisconsin and furnishing, hauling and placing clean select fill in the excavated areas where contaminated soils were removed. The closest Waste Management BioSite facility is the Madison Prairie Landfill. This facility is located approximately 11 miles from the project limits. The City of Madison will pay the disposal fee at the Madison Prairie Landfill.

Per NR 718.07 a solid waste collection and transportation service-operating license is required under NR 502.06 whenever excavated contaminated soils are transported

The role of the City of Madison will be limited to determining the location and limits of contaminated soil to be excavated based on soil analytical results from field investigations, visual observations, and field screening of soil that is excavated. The City of Madison will be responsible for identifying contaminated soils to be hauled to the treatment/disposal facility. The Contractor shall manage the soil in accordance with the terms and conditions specified herein.

The Contractor shall notify the Project Engineer three (3) calendar days prior to commencement of excavation activities in suspected contaminated areas. The Contractor will coordinate with the City of Madison to ensure that the City of Madison is present prior to and during excavation of contaminated soils.

HEALTH AND SAFETY REQUIREMENTS

The City of Madison's Standard Specifications for Public Works Contracts is supplemented with the following:

Soil contaminated with gasoline, diesel fuel, fuel oil, or other petroleum related products may be encountered during excavation activities. The Contractor shall prepare a site specific Health and Safety Plan complying with the Occupational Safety and Health Administration (OSHA) standard for Hazardous Waste Operation and Emergency Response (HAZWOPER), 29 CFR 1910.120.

All site workers taking part in remediation activities or who will have the reasonable probability of exposure of safety or health hazards associated with the hazardous material shall have completed Health and Safety training that meets OSHA requirements. A site specific Health and Safety Plan, and written verification by the Contractor that workers will have completed up to date OSHA training will be submitted to the Project Engineer prior to the start of remediation work.

The Contractor shall be responsible for the development, delineation and enforcement of the health and safety exclusion zones for each contaminated site location pursuant to 29 CFR 1910.120.

CONSTRUCTION METHODS

The City of Madison's Standard Specifications for Public Works Contracts is supplemented with the following:

Excavated soil shall be periodically examined by the City of Madison. The Contractor shall assist the City of Madison in collecting soil samples using excavation equipment. Soil samples shall be collected by the City of Madison from the bucket of the excavation equipment.

The ends of the sanitary sewer trench shall have bentonite clay dams installed.

Soils designated by the City of Madison as contaminated shall be hauled directly to the disposal facility. The Contractor is responsible for providing and placing suitable fill material required to bring the excavation to the elevation of the finished grade. Furnishing, hauling and placing the fill material shall be incidental to Bid Item 90031 Excavation and Hauling of Petroleum Contaminated Soil.

METHOD OF MEASUREMENT

Excavation and Hauling of Petroleum Contaminated Soil will be measured by the ton of excavated material in accordance with the City's Standard Specifications. All weights to be determined at the Madison Prairie Landfill scale.

BASIS OF PAYMENT

Excavation and Hauling of Petroleum Contaminated Soil, measured as provided above, will be paid for at the contract unit price per ton, which price shall be payment in full for excavating and hauling of contaminated soil; bentonite clay dams; temporary stockpiling if necessary; furnishing, hauling and placement of select fill in the excavation; and furnishing all labor, tools, equipment, and incidentals necessary to complete the work.

BID ITEM 90032 – TEMPORARY SHORING

DESCRIPTION

This work shall consist of providing and removing (as needed to bring site back to finish grade and as described below) temporary shoring at the approximate locations shown on the drawings and in accordance with the contractor's shoring design.

SHORING DESIGN

The limits of the required temporary shoring are to be determined by the Contractor but shall be sufficient to complete the point repair as shown on the contract drawings. The Contractor shall be responsible for providing a shoring design for each required temporary shoring. The adequacy of each shoring design shall be verified by a professional engineer registered in the State of Wisconsin, experienced in the design of shoring systems, and knowledgeable of the specific site conditions and requirements for this project. One copy of each shoring design (drawings and calculations) shall be signed and sealed by the same professional engineer verifying the design, and shall be submitted to the project engineer for documentation.

Shoring system shall be designed to support lateral earth pressure and groundwater pressure as appropriate for the shoring system installed. The surcharge effects of live load from the active railroad

operations be accounted for in the shoring system design. Approximately 200 rail cars travel this rail daily.

The lateral deflection at any location in the shoring system and at any time during construction shall not exceed ¼" as measured at the top of the shoring system. The engineer will monitor deflection by shooting coordinates and elevations of points along the shoring walls and the railroad tracks prior to and at intervals during construction.

The shoring system design shall be sufficient to meet the above deflection criteria until point the repair is complete.

CONSTRUCTION METHODS

Construction or installation of temporary shoring at a required location shall be done in accordance with the design developed for the location.

METHOD OF MEASUREMENT

Temporary Shoring will be measured by the Lump Sum for all shoring installed on the project with the limitations shown on the drawings..

BASIS OF PAYMENT

Temporary Shoring, measured as provided above, will be paid for at the contract unit price, which price shall be full compensation for providing the design of the shoring system; for furnishing and hauling materials to each location; for installing or constructing the shoring; for maintenance as needed; for removal of the shoring when required by the design; for backfilling upon completion of the need for the shoring; and for all labor, tools, equipment and incidentals needed to complete the work in accordance with the contract.

Temporary Shoring not required by the plans and installed for the convenience of the contractor's operations shall be considered incidental to work under the contract and will not be measured and paid for under this item.

1.	Scope of Work. The Contractor shall, perform the construction, execution and completion of the following listed complete work or improvement in full compliance with the Plans, Specifications, Standard Specifications, Supplemental Specifications, Special Provisions and contract; perform all items of work covered or stipulated in the proposal; perform all altered or extra work; and shall furnish, unless otherwise provided in the contract, all materials, implements, machinery, equipment, tools, supplies, transportation, and labor necessary to the prosecution and completion of the work or improvements:

2.	Completion Date/Contract Time. Construction work must begin within seven (7) calendar days after the date appearing on mailed written notice to do so shall have been sent to the Contractor and shall be carried on at a rate so as to secure full completion <u>SEE SPECIAL PROVISIONS</u> , the rate of progress and the time of completion being essential conditions of this Agreement.
3.	Contract Price. The City shall pay to the Contractor at the times, in the manner and on the conditions set forth in said specifications, the sum of(\$) Dollars being the amount bid by such Contractor and which was awarded to him/her as provided by law.
4.	Wage Rates for Employees of Public Works Contractors
	General and Authorization. The Contractor shall compensate its employees at the prevailing wage rate in accordance with section 66.0903, Wis. Stats., DWD 290 of the Wisconsin Administrative Code and as hereinafter provided.
	"Public Works" shall include building or work involving the erection, construction, remodeling, repairing or demolition of buildings, parking lots, highways, streets, bridges, sidewalks, street lighting, traffic signals, sanitary sewers, water mains and appurtenances, storm sewers, and the grading and landscaping of public lands.
	"Building or work" includes construction activity as distinguished from manufacturing, furnishing of materials, or servicing and maintenance work, except for the delivery of mineral aggregate such as sand, gravel, bituminous asphaltic concrete or stone which is incorporated into the work under contract with the City by depositing the material directly in final place from transporting vehicle.

"Erection, construction, remodeling, repairing" means all types of work done on a particular building or work at the site thereof in the construction or development of the project, including without limitation, erecting, construction, remodeling, repairing, altering, painting, and decorating, the transporting of materials and supplies to or from the building or work done by the employees of the Contractor, Subcontractor, or Agent thereof, and the manufacturing or furnishing of materials, articles, supplies or equipment on the site of the building or work, by persons employed by the Contractor, Subcontractor, or Agent thereof.

"Employees working on the project" means laborers, workers, and mechanics employed directly upon the site of work.

"Laborers, Workers, and Mechanics" include preapprentices, helpers, trainees, learners and properly registered and indentured apprentices but exclude clerical, supervisory, and other personnel not performing manual labor.

Establishment of Wage Rates. The Department of Public Works shall periodically obtain a current schedule of prevailing wage rates from DWD. The schedule shall be used to establish the City of Madison Prevailing Wage Rate Schedule for Public Works Construction (prevailing wage rate). The Department of Public Works may include known increases to the prevailing wage rate which can be documented and are to occur on a future specific date. The prevailing wage rate shall be included in public works contracts subsequently negotiated or solicited by the City. Except for known increases contained within the schedule, the prevailing wage rate shall not change during the contract. The approved wage rate is attached hereto.

Workforce Profile. The Contractor shall, at the time of signature of the contract, notify the City Engineer in writing of the names and classifications of all the employees of the Contractor, Subcontractors, and Agents proposed for the work. In the alternative, the Contractor shall submit in writing the classifications of all the employees of the Contractor, Subcontractors and Agents and the total number of hours estimated in each classification for the work. This workforce profile(s) shall be reviewed by the City Engineer who may, within ten (10) days, object to the workforce profile(s) as not being reflective of that which would be required for the work. The Contractor may request that the workforce profile, or a portion of the workforce profile, be submitted after the signature of the contract but at least ten (10) days prior to the work commencing. Any costs or time loss resulting from modifications to the workforce profile as a result of the City Engineer's objections shall be the responsibility of the Contractor.

Payrolls and Records. The Contractor shall keep weekly payroll records setting forth the name, address, telephone number, classification, wage rate and fringe benefit package of all the employees who work on the contract, including the employees of the Contractor's subcontractors and agents. Such weekly payroll records must include the required information for all City contracts and all other contracts on which the employee worked during the week in which the employee worked on the contract. The Contractor shall also keep records of the individual time each employee worked on the project and for each day of the project. Such records shall also set forth the total number of hours of overtime credited to each such employee for each day and week and the amount of overtime pay received in that week. The records shall set forth the full weekly wages earned by each employee and the actual hourly wage paid to the employee.

The Contractor shall submit the weekly payroll records, including the records of the Contractor's subcontractors and agents, to the City Engineer for every week that work is being done on the contract. The submittal shall be within twenty-one (21) calendar days of the end of the Contractor's weekly pay period.

Employees shall receive the full amounts accrued at the time of the payment, computed at rates not less than those stated in the prevailing wage rate and each employee's rate shall be determined by the work that is done within the trade or occupation classification which should be properly assigned to the employee.

An employee's classification shall not be changed to a classification of a lesser rate during the contract. If, during the term of the contract, an employee works in a higher pay classification than the one which was previously properly assigned to the employee, then that employee shall be considered to be in the higher pay classification for the balance of the contract, receive the appropriate higher rate of pay, and she/he shall not receive a lesser rate during the balance of the contract. For purposes of clarification, it is noted that there is a distinct difference between working in a different classification with higher pay and doing work within a classification that has varying rates of pay which are determined by the type of work that is done within the classification. For example, the classification "Operating Engineer" provides for different rates of pay for various classes of work and the Employer shall compensate an employee classified as an "Operating Engineer" based on the highest class of work that is done in one day. Therefore, an "Operating Engineer's" rate may vary on a day to day basis depending on the type of work that is done, but it will never be less than the base rate of an "Operating Engineer". Also, as a matter of clarification, it is recognized that an employee may work in a higher paying classification merely by chance and without prior intention, calculation or design. If such is the case and the performance of the work is truly incidental and the occurrence is infrequent, inconsequential and does not serve to undermine the single classification principle herein, then it may not be required that the employee be considered to be in the higher pay classification and receive the higher rate of pay for the duration of the contract. However, the Contractor is not precluded or prevented from paying the higher rate for the limited time that an employee performs work that is outside of the employee's proper classification.

Questions regarding an employee's classification, rate of pay or rate of pay within a classification, shall be resolved by reference to the established practice that predominates in the industry and on which the trade or occupation rate/classification is based. Rate of pay and classification disputes shall be resolved by relying upon practices established by collective bargaining agreements and guidelines used in such determination by appropriate recognized trade unions operating within the City of Madison.

The Contractor, its Subcontractors and Agents shall submit to interrogation regarding compliance with the provisions of this ordinance.

Mulcting of the employees by the Contractor, Subcontractor, and Agents on Public Works contracts, such as by kickbacks or other devices, is prohibited. The normal rate of wage of the employees of the Contractor, Subcontractor, and Agents shall not be reduced or otherwise diminished as a result of payment of the prevailing wage rate on a public works contract.

Hourly contributions. Hourly contributions shall be determined in accordance with the prevailing wage rate and with DWD. 290.01(10), Wis. Admin. Code.

Apprentices and Subjourneypersons. Apprentices and subjourneypersons performing work on the project shall be compensated in accordance with the prevailing wage rate and with DWD 290.02, and 290.025, respectively, Wis. Admin. Code.

Straight Time Wages. The Contractor may pay straight time wages as determined by the prevailing wage rate and DWD 290.04, Wis, Admin. Code.

Overtime Wages. The Contractor shall pay overtime wages as required by the prevailing wage rate and DWD 290.05, Wis, Admin. Code.

Posting of Wage Rates and Hours. A clearly legible copy of the prevailing wage rate, together with the provisions of Sec. 66.0903(10)(a) and (11)(a), Wis. Stats., shall be kept posted in at least one conspicuous and easily accessible place at the project site by the Contractor and such notice shall remain posted during the full time any laborers, workers or mechanics are employed on the contract.

Evidence of Compliance by Contractor. Upon completion of the contract, the Contractor shall file with the Department of Public Works an affidavit stating:

- a. That the Contractor has complied fully with the provisions and requirements of Sec. 66.0903(3), Wis. Stats., and Chapter DWD 290, Wis. Admin. Code; the Contractor has received evidence of compliance from each of the agents and subcontractors; and the names and addresses of all of the subcontractors and agents who worked on the contract.
- b. That full and accurate records have been kept, which clearly indicate the name and trade or occupation of every laborer, worker or mechanic employed by the Contractor in connection with work on the project. The records shall show the number of hours worked by each employee and the actual wages paid therefor; where these records will be kept and the name, address and telephone number of the person who will be responsible for keeping them. The records shall be retained and made available for a period of at least three (3) years following the completion of the project of public works and shall not be removed without prior notification to the municipality.

Evidence of Compliance by Agent and Subcontractor. Each agent and subcontractor shall file with the Contractor, upon completion of their portion of the work on the contract an affidavit stating that all the provisions of Sec. 66.0903(3), Wis. Stats., have been fully complied with and that full and accurate records have been kept, which clearly indicate the name and trade or occupation of every laborer, worker or mechanic employed by the Contractor in connection with work on the project. 5. **Affirmative Action.** In the performance of the services under this Agreement the Contractor agrees not to discriminate against any employee or applicant because of race, religion, marital status, age, color, sex, disability, national origin or ancestry, income level or source of income, arrest record or conviction record, less than honorable discharge, physical appearance, sexual orientation, political beliefs, or student status. If the contract is still in effect, or if the City enters into a new agreement with the Contractor, within one year after the date on which the form was required to be provided, the Contractor will provide updated workforce information using a second form, also to be furnished by the City. The second form will be submitted to the City Affirmative Action Division no later than one year after the date on which the first form was required to be provided.

The Contractor further agrees that, for at least twelve (12) months after the effective date of this contract, it will notify the City Affirmative Action Division of each of its job openings at facilities in Dane County for which applicants not already employees of the Contractor are to be considered. The notice will include a job description, classification, qualifications and application procedures and deadlines. The Contractor agrees to interview and consider candidates referred by the Affirmative Action Division if the candidate meets the minimum qualification standards established by the Contractor, and if the referral is timely. A referral is timely if it is received by the Contractor on or before the date started in the notice.

Articles of Agreement Article I

Such action shall include, but not be limited to, the following: employment, upgrading, demotion or transfer, recruitment or recruitment advertising, layoff or termination, rates of pay or other forms of compensation and selection for training including apprenticeship insofar as it is within the control of the Contractor. The Contractor agrees to post in conspicuous places available to employees and applicants notices to be provided by the City setting out the provisions of the nondiscrimination clauses in this contract.

The Contractor shall send to each labor union or representative of workers with which it has a collective bargaining agreement or other contract or understanding a notice to be provided by the City advising the labor union or worker's representative of the Contractor's equal employment opportunity and affirmative action commitments. Such notices shall be posted in conspicuous places available to employees and applicants for employment.

Article V

The Contractor agrees that it will comply with all provisions of the Affirmative Action Ordinance of the City of Madison, including the contract compliance requirements. The Contractor agrees to submit the model affirmative action plan for public works contractors in a form approved by the Director of Affirmative Action.

Article VI

Article VII

In the event of the Contractor's or subcontractor's failure to comply with the Equal Employment Opportunity and Affirmative Action Provisions of this contract or Section 39.03 and 39.02 of the Madison General Ordinances, it is agreed that the City at its option may do any or all of the following:

- 1. Cancel, terminate or suspend this Contract in whole or in part.
- 2. Declare the Contractor ineligible for further City contracts until the Affirmative Action requirements are met.
- 3. Recover on behalf of the City from the prime Contractor 0.5 percent of the contract award price for each week that such party fails or refuses to comply, in the nature of liquidated damages, but not to exceed a total of five percent (5%) of the contract price, or five thousand dollars (\$5,000), whichever is less. Under public works contracts, if a subcontractor is in noncompliance, the City may recover liquidated damages from the prime Contractor in the manner described above. The preceding sentence shall not be construed to prohibit a prime Contractor from recovering the amount of such damage from the non-complying subcontractor.

Article VIII

The Contractor shall include the above provisions of this contract in every subcontract so that such provisions will be binding upon each subcontractor. The Contractor shall allow the maximum feasible opportunity to small business enterprises to compete for any subcontracts entered into pursuant to this contract.
