STANDARD SPECIFICATIONS

The City of Madison's Standard Specifications for Public Works Construction - 2014 Edition, as supplemented and amended from time to time, forms a part of these contract documents as if attached hereto.

These standard specifications are available on the City of Madison Public Works website, www.cityofmadison.com/Business/PW/specs.cfm.

The Contractor shall review these Specifications prior to preparation of proposals for the work to be done under this contract, with specific attention to Article 102, "BIDDING REQUIREMENTS AND CONDITIONS" and Article 103, "AWARD AND EXECUTION OF THE CONTRACT." For the convenience of the bidder, below are highlights of three subsections of the specifications.

SECTION 102.1: PRE-QUALIFICATION OF BIDDERS

In accordance with Wisconsin State Statutes 66.0901 (2) and (3), all bidders must submit to the Board of Public Works proof of responsibility on forms furnished by the City. The City requires that all bidders be qualified on a biennial basis.

Bidders must present satisfactory evidence that they have been regularly engaged in the type of work specified herein and they are fully prepared with necessary capital, materials, machinery and supervisory personnel to conduct the work to be contracted for to the satisfaction of the City. All bidders must be pre-

qualified by the Board of Public Works for the type of construction on which they are bidding prior to the opening of the bid.

In accordance with Section 39.02(9)(a)l. of the General Ordinances, all bidders shall submit in writing to the Affirmative Action Division Manager of the City of Madison, a Certificate of Compliance or an Affirmative Action Plan at the same time or prior to the submission of the proof of responsibility forms.

The bidder shall be disqualified if the bidder fails to or refuses to, prior to opening of the bid, submit a Certificate of compliance, Affirmative Action Plan or Affirmative Action Data Update, as applicable, as defined by Section 39.02 of the General Ordinances (entitled Affirmative Action) and as required by Section 102.11 of the Standard Specifications.

SECTION 102.4 PROPOSAL

No bid will be accepted that does not contain an adequate or reasonable price for each and every item named in the Schedule of Unit Prices.

A lump sum bid for the work in accordance with the plans and specifications is required. The lump sum bid must be the same as the total amounts bid for the various items and it shall be inserted in the space provided.

All papers bound with or attached to the proposal form are considered a part thereof and must not be detached or altered when the proposal is submitted. The plans, specifications and other documents designated in the proposal form will be considered a part of the proposal whether attached or not.

A proposal submitted by an individual shall be signed by the bidder or by a duly authorized agent. A proposal submitted by a partnership shall be signed by a member/partner or by a duly authorized agent thereof. A proposal submitted by a corporation shall be signed by an authorized officer or duly authorized registered agent of such corporation, and the proposal shall show the name of the State under the laws of which such corporation was chartered. The required signatures shall in all cases appear in the space provided thereof on the proposal.

Each proposal shall be placed, together with the proposal guaranty, in a sealed envelope, so marked as to indicate name of project, the contract number or option to which it applies, and the name and address of the Contractor or submitted electronically through Bid Express (www.bidexpress.com). Proposals will be accepted at the location, the time and the date designated in the advertisement. Proposals received after the time and date designated will be returned to the bidder unopened.

The Bidder shall execute the Disclosure of Ownership form. REFER TO SECTION F.

SECTION 102.5: BID DEPOSIT (PROPOSAL GUARANTY)

All bids, sealed or electronic, must be accompanied with a Bid Bond equal to at least 5% of the bid or a Certificate of Annual/Biennial Bid Bond or certified check, payable to the City Treasurer. Bid deposit of the successful bidders shall be returned within forty-eight (48) hours following execution of the contract and bond as required.

Instructions to Bidders City of Madison SBE Program Information

2 Small Business Enterprise (SBE) Program Information

2.1 Policy and Goal

The City of Madison reaffirms its policy of nondiscrimination in the conduct of City business by maintaining a procurement process which remains open to all who have the potential and ability to sell goods and services to the City. It is the policy of the City of Madison to allow Small Business Enterprises (SBE) maximum feasible opportunity to participate in City of Madison contracting. The bidder acknowledges that its bid has been submitted in accordance with the SBE program and is for the public's protection and welfare.

Please refer to the "ADVERTISEMENT FOR BIDS" for the goal for the utilization of SBEs on this project. SBEs may participate as subcontractors, vendors and/or suppliers, which provide a commercially useful function. The dollar value for SBE suppliers or 'materials only' vendors shall be discounted to 60% for purposes of meeting SBE goals.

A bidder which achieves or exceeds the SBE goal will be in compliance with the SBE requirements of this project. In the event that the bidder is unable to achieve the SBE goal, the bidder must demonstrate that a good faith effort to do so was made. Failure to either achieve the goal or demonstrate a good faith effort to do so will be grounds for the bidder being deemed a non-responsible contractor ineligible for award of this contract.

A bidder may count towards its attainment of the SBE goal only those expenditures to SBEs that perform a commercially useful function. For purposes of evaluating a bidder's responsiveness to the attainment of the SBE goal, the contract participation by an SBE is based on the percentage of the total base bid proposed by the Contractor. The total base bid price is inclusive of all addenda.

Work performed by an SBE firm in a particular transaction can be counted toward the goal only if it involves a commercially useful function. That is, in light of industry practices and other relevant considerations, does the SBE firm have a necessary and useful role in the transaction, of a kind for which there is a market outside the context of the SBE Program, or is the firm's role a superfluous step added in an attempt to obtain credit towards goals? If, in the judgment of the Affirmative Action Division, the SBE firm will not perform a commercially useful function in the transaction, no credit towards goals will be awarded.

The question of whether a firm is performing a commercially useful function is completely separate from the question of whether the firm is an eligible SBE. A firm is eligible if it meets the definitional criteria and ownership and control requirements, as set forth in the City of Madison's SBE Program.

If the City of Madison determines that the SBE firm is performing a commercially useful function, then the City of Madison must then decide what that function is. If the commercially useful function is that of an SBE vendor / supplier that regularly transacts business with the respective product, then the City of Madison will count 60% of the value of the product supplied toward SBE goals.

To be counted, the SBE vendor / supplier must be engaged in selling the product in question to the public. This is important in distinguishing an SBE vendor / supplier, which has a regular trade with a variety of customers, from a firm which performs supplier-like functions on an ad hoc basis or for only one or two contractors with whom it has a special relationship.

A supplier of bulk goods may qualify as an eligible SBE vendor / supplier if it either maintains an inventory or owns or operates distribution equipment. With respect to the distribution equipment; e.g., a fleet of trucks, the term "operates" is intended to cover a situation in which the supplier leases the equipment on a regular basis for its entire business. It is not intended to cover a situation in which the firm simply provides drivers for trucks owned or leased by another party; e.g., a prime contractor, or leases such a party's trucks on an ad hoc basis for a specific job.

If the commercially useful function being performed is not that of a qualified SBE vendor / supplier, but rather that of delivery of products, obtaining bonding or insurance, procurement of personnel, acting as a broker or manufacturer's representative in the procurement of supplies, facilities, or materials, etc., only the fees or commissions will apply towards the goal.

For example, a business that simply transfers title of a product from manufacturer to ultimate purchaser; e. g., a sales representative who re-invoices a steel product from the steel company to the Contractor, or a firm that puts a product into a container for delivery would not be considered a qualified SBE vendor / supplier. The Contractor would not receive credit based on a percentage of the cost of the product for working with such firms.

Concerning the use of services that help the Contractor obtain needed supplies, personnel, materials or equipment to perform a contract: only the fee received by the service provider will be counted toward the goal. For example, use of a SBE sales representative or distributor for a steel company, if performing a commercially useful function at all, would entitle the Contractor receiving the steel to count only the fee paid to the representative or distributor toward the goal. This provision would also govern fees for professional and other services obtained expressly and solely to perform work relating to a specific contract.

Concerning transportation or delivery services: if an SBE trucking company picks up a product from a manufacturer or a qualified vendor / supplier and delivers the product to the Contractor, the commercially useful function it is performing is not that of a supplier, but simply that of a transporter of goods. Unless the trucking company is itself the manufacturer or a qualified vendor / supplier in the product, credit cannot be given based on a percentage of the cost of the product. Rather, credit would be allowed for the cost of the transportation service.

The City is aware that the rule's language does not explicitly mention every kind of business that may contribute work on this project. In administering these programs, the City would, on a case-by-case basis, determine the appropriate counting formula to apply in a particular situation.

2.2 Contract Compliance

2.3 Certification of SBE by City of Madison

The Affirmative Action Division maintains a directory of SBEs which are currently certified as such by the City of Madison. Contact the Contract Compliance Officer as indicated in Section 2.2 to receive a copy of the SBE Directory or you may access the SBE Directory online at www.cityofmadison.com/dcr/aaTBDDir.cfm.

All contractors, subcontractors, vendors and suppliers seeking SBE status must complete and submit the **Targeted Business Certification Application** to the City of Madison Affirmative Action Division by the time and date established for receipt of bids. A copy of the Targeted Business Certification Application is available by contacting the Contract Compliance Officer at the address and telephone indicated in Section 2.2 or you may access the Targeted Business Certification Application online at www.cityofmadison.com/dcr/aaTBDDir.cfm. Submittal of the Targeted Business Certification Application by the time specified does not guarantee that the applicant will be certified as a SBE eligible to be utilized towards meeting the SBE goal for this project.

2.4 Small Business Enterprise Compliance Report

2.4.1 Good Faith Efforts

Bidders shall take all necessary affirmative steps to assure that SBEs are utilized when possible and that the established SBE goal for this project is achieved. A contractor who self performs a portion of the work, and is pre-qualified to perform that category of work, may subcontract that portion of the work, but shall not be required to do so. When a bidder is unable to achieve the established SBE goal, the bidder must demonstrate that a good faith effort to do so was made. Such a good faith effort should include the following:

- 2.4.1.1 Attendance at the pre-bid meeting.
- 2.4.1.2 Using the City of Madison's directory of certified SBEs to identify SBEs from which to solicit bids.
- 2.4.1.3 Assuring that SBEs are solicited whenever they are potential sources.
- 2.4.1.4 Referring prospective SBEs to the City of Madison Affirmative Action Division for certification.
- 2.4.1.5 Dividing total project requirements into smaller tasks and/or quantities, where economically feasible, to permit maximum feasible SBE participation.
- 2.4.1.6 Establishing delivery schedules, where requirements permit, which will encourage participation by SBEs.
- 2.4.1.7 Providing SBEs with specific information regarding the work to be performed.
- 2.4.1.8 Contacting SBEs in advance of the deadline to allow such businesses sufficient time to prepare a bid.
- 2.4.1.9 Utilizing the bid of a qualified and competent SBE when the bid of such a business is deemed reasonable (i.e. 5% above the lowest bidder), although not necessarily low.
- 2.4.1.10 Contacting SBEs which submit a bid, to inquire about the details of the bid and confirm that the scope of the work was interpreted as intended.

2.4.2 Reporting SBE Utilization and Good Faith Efforts

The Small Business Enterprise Compliance Report is to be submitted by the bidder with the bid: This report is due by the specified bid closing time and date. Bids submitted without a completed SBE Compliance Report as outlined below

shall be deemed non-responsible and the bidder ineligible for award of this contract.

2.4.2.1 If the Bidder meets or exceeds the goal established for SBE utilization, the Small Business Enterprise Compliance Report shall consist of the following:

2.4.2.1.1 **Cover Page**, Page C-6; and

2.4.2.1.2 **Summary Sheet**, C-7.

2.4.2.2 If the bidder does not meet the goal established for SBE utilization, the Small Business Enterprise Compliance Report shall consist of the following:

2.4.2.2.1 **Cover Page**, Page C-6;

2.4.2.2.2 **Summary Sheet**, C-7; and

2.4.2.2.3 **SBE Contact Report**, C-8 and C-9. (A separate Contact Report must be completed for each applicable SBE which is not utilized.)

2.5 Appeal Procedure

A bidder which does not achieve the established goal and is deemed non-responsible for failure to demonstrate a good faith effort to achieve such goal and subsequently denied eligibility for award of contract may, within 72 hours of receiving such notification, appeal that decision to a special appeals committee composed of three (3) members of the Affirmative Action Commission, three (3) members of the Board of Public Works and a seventh member appointed by the Mayor. All appeals must be made in writing to the City Engineer and received within 72 hours of City of Madison's notice. Postmark not applicable.

2.6 SBE Requirements After Award of the Contract

The successful bidder shall identify SBE subcontractors, suppliers and vendors on the subcontractor list in accordance with the specifications. The Contractor shall submit a detailed explanation of any variances between the listing of SBE subcontractors, vendors and/or suppliers on the subcontractor list and the Contractor's SBE Compliance Report for SBE participation.

No change in SBE subcontractors, vendors and/or suppliers from those SBEs indicated in the SBE Compliance Report will be allowed without prior approval from the Engineer and the Affirmative Action Division. The contractor shall submit in writing to the City of Madison Affirmative Action Division a request to change any SBE citing specific reasons which necessitate such a change. The Affirmative Action Division will use a general test of reasonableness in approving or rejecting the contractor's request for change. If the request is approved, the Contractor will make every effort to utilize another SBE if available.

The City will monitor the project to ensure that the actual percentage commitment to SBE firms is carried out.

2.7 SBE Definition and Eligibility Guidelines

A Small Business Enterprise is a business concern awarded certification by the City of Madison. For the purposes of this program a Small Business Enterprise is defined as:

- A. An independent business operated under a single management. The business may not be a subsidiary of any other business and the stock or ownership may not be held by any individual or any business operating in the same or a similar field. In determining whether an entity qualifies as a SBE, the City shall consider all factors relevant to being an independent business including, but not limited to, the date the business was established, adequacy of its resources for the work in which it proposes to involve itself, the degree to which financial, equipment leasing and other relationships exist with other ineligible firms in the same or similar lines of work. SBE owner(s) shall enjoy the customary incidents of ownership and shall share in the risks and profits commensurate with their enjoyment interests, as demonstrated by an examination of the substance rather than form or arrangements that may be reflected in its ownership documents.
- B. A business that has averaged no more than \$4.0 million in annual gross receipts over the prior three year period and the principal owner(s) do not have a personal net worth in excess of \$1.32 million.

Firm and/or individuals that submit fraudulent documents/testimony may be barred from doing business with the City and/or forfeit existing contracts.

SBE certification is valid for one (1) year unless revoked.

SECTION D: SPECIAL PROVISIONS

EASTMORLAND PARK GREENWAY CONTRACT NO. 7369

It is the intent of these Special Provisions to set forth the final contractual intent as to the matter involved and shall prevail over the Standard Specifications and plans whenever in conflict therewith. In order that comparisons between the Special Provisions can be readily made, the numbering system for the Special Provisions is equivalent to that of the Specifications.

Whenever in these Specifications the term "Standard Specifications" appears, it shall be taken to refer to the City of Madison Standard Specifications for Public Works Construction and Supplements thereto.

SECTION 102.10: PREVAILING WAGE

For this project, payment of prevailing wages (white sheet) shall be required unless the box indicating prevailing wages are not required is checked below.

Prevailing wages shall not be required when this box is checked.

If prevailing wages (white sheets) are required, the wages and benefits paid on the contract shall not be less than those specified in the Prevailing Wage Determination included with these contract documents for the following types of work:

- Building or Heavy Construction
- Sewer, Water, or Tunnel Construction
- Local Street or Miscellaneous Paving Construction
- Residential or Agricultural Construction

When multiple boxes are checked, worker's wages may vary according to the type and area of work performed. It is the responsibility of the Contractor to determine and apply the appropriate wage rate for the specific work assigned.

SECTION 102.12: BEST VALUE CONTRACTING

This Contract shall be considered a Best Value Contract if the Contractor's bid is equal to or greater than \$54,000 for a single trade contract; or equal to or greater than \$264,500 for a multi-trade contract pursuant to MGO 33.07(7).

ARTICLE 103: AWARD AND EXECUTION OF THE CONTRACT

The Contractor shall execute the signing of the contract completely prior to September 1, 2014. No exceptions or extensions to the above date will be permitted.

ARTICLE 104: SCOPE OF WORK

This contract consists of removing an existing concrete cunette within Eastmorland Park and Woodman's Detention Pond and replacing it with a new concrete cunette of similar size. This contract also includes regrading the detention area of Woodman's Detention Pond to provide positive drainage to the cunette.

The Contractor shall view the site prior to bidding to become familiar with the existing conditions. It will be the responsibility of the Contractor to work with the utilities located in the right of way to resolve conflicts during the construction process.

SECTION 105.1: AUTHORITY OF THE ENGINEER

The Engineer shall resolve all questions which arise as to the quality and acceptability of materials furnished, work performed, manner of performance, rate of progress of the work, interpretation of the plans and Specifications, acceptable fulfillment of the contract, compensation, and disputes and mutual rights between Contractors under the Specifications. The Engineer shall determine the amount and quantity of work performed and materials furnished.

All decisions of the Engineer shall, when so requested, be rendered in writing. They shall be final and conclusive in all matters unless within ten (10) days after such decision the Contractor applies in writing to the Board of Public Works for a review of such decision.

Any change proposed by a Contractor in SBE subcontractors, vendors or suppliers from those SBEs indicated on the SBE Compliance Report must be approved by the Engineer and the City's Manager of the Affirmative Action Division (hereafter, AAD). When requested, such decision shall be rendered in writing. Such decisions shall be final and conclusive in all matters unless within ten (10) days after such decision the Contractor or the affected SBE applies in writing to the Board of Public Works for a review of such decision.

In the event the Engineer and the AAD disagree over the proper decision to be made regarding an SBE, the Mayor shall appoint a third person to resolve the disagreement, within 30 days of appointment. The decision thus rendered may be reviewed by the Board of Public Works upon request of the Contractor or the affected SBE as set forth in Sections 105.1 and 105.2 of the City's standard specifications.

SECTION 105.12: COOPERATION BY THE CONTRACTOR

The Contractor shall coordinate all activities within Eastmorland Park with the Parks Division. This includes work, site access, and laydown areas. The Contractor may contact Kay Rutledge at (608) 266-4714. Ms. Rutledge shall review all finish work within Eastmorland Park prior to the Contractor demobilizing from the site.

SECTION 107.7: MAINTENANCE OF TRAFFIC

All traffic control shall conform to Part VI of the Federal Highways Administration's "Manual on Uniform Traffic Control Devices" (MUTCD), the State of Wisconsin Standard Facilities Development Manual (including Chapter 16 – Standard Detail Drawings) and the City of Madison Standards for Sidewalk and Bikeway closures.

The Contractor shall submit an acceptable, complete Traffic Control Plan, including all necessary phases and any required sidewalk or bike route closures, to the office of the City Traffic Engineer, attention Tom Mohr, at 215 Martin Luther King Jr. Blvd. Suite 100, Madison, WI 53703, a minimum of five (5) working days prior to the pre-construction meeting. The Traffic Control Plan shall address all requirements of this section of the Special Provisions. The Contractor shall not start work on this project until the Traffic Engineering Division has approved a traffic control plan and traffic control devices have been installed in accordance with the approved plan. Failure of the Contractor to obtain an approved Traffic Control Plan, as specified above, may prevent the Contractor from starting work and shall be considered a delay of the project, caused by the Contractor.

The Contractor will be responsible for installing and maintaining traffic control in accordance with the traffic control plan and as directed by the City Traffic Engineer. The Contractor shall install and maintain modifications or additions to the traffic control, as directed by the City Traffic Engineer, at no cost to the City.

The Contractor shall access the site from Buckingham Lane and/or Milwaukee Street. The Contractor will not be permitted to use the bike path for site access.

The Contractor shall not block driveways on Buckingham Lane at any time during the project. The Contractor may intermittently close the sidewalk on the southbound side of Milwaukee Street for site

access. All closures shall be appropriately noticed and marked. All travel lanes of Milwaukee Street shall stay open to traffic at all times. Care should be taken to keep the travel lanes and bike lane of Milwaukee Street clear and free of debris.

No construction equipment or materials shall be stored in the roadway or street right-of-way that is open to traffic during non-working hours. Construction equipment and materials are not to be stored within the street right-of-way that is outside the project limits as shown on the approved plan.

SECTION 107.8: NOTIFICATION WHEN CLOSING STREET

The Contractor shall not remove traffic signs. For removal or replacement of traffic and parking signs, contact the City of Madison Traffic Engineering Field Operations, 1120 Sayle Street, 266-4767, 8:00 a.m. to 4:00 p.m., a minimum of twenty-four (24) hours in advance of when any existing signs need to be removed. This service is provided free of charge. If the Contractor removes the signs, the Contractor will be billed for the reinstallation of, and any damage to, the signing equipment.

SECTION 107.13: TREE PROTECTION SPECIFICATIONS

The Contractor is advised to review Section 107.13 of the Standard Specifications for tree protection. Note that Sections 107.13(b) Curb Excavation and Installation, 107.13(c) Sidewalk Excavation and Installation, are not applicable to this project. Other sections are applicable except as provided below.

Only trees marked for removal on the plans shall be removed. It is the intent of this project to save as many trees as possible; therefore, there are trees within the grading limits. It is recognized that grading operations and root cutting may need to occur within 5 feet of these trees in order to complete the work, but it should be minimized and care must be taken in these areas. The Contractor is permitted to slightly alter planned grades in order to minimize tree impacts.

Roots shall be cut cleanly by using a saw, axe, lopping shears, chain saw, stump grinder, or other means which will produce a clean cut. Exposed roots shall be covered as soon as excavation is complete. The Contractor shall not rip or pull roots out towards the trunk of a tree while excavating with a backhoe. The use of a backhoe to cut roots is NOT acceptable.

With regard to Section 107.13(f), pruning to accommodate construction equipment invading the tree crown may be done by the Contractor, with advance permission from the Construction Engineer. No pruning will be performed by City Forestry. All pruning shall be done according to ANSI A300 tree pruning specifications. The Contractor shall not prune the group of trees immediately adjacent to the play equipment off Buckingham Lane.

With regard to Section 107.14(g), no equipment or materials will be allowed to be parked on, or piled on areas within 5 feet of a tree. Construction traffic within 5 feet of a tree will be allowed only where necessary to complete grading operations, as described above, at the discretion of the Construction Engineer.

Where noted on the plan set, trees shall be protected. The Contractor shall mark these trees, or place temporary fencing between the work area and tree. Temporary fencing shall be paid separately under Bid Item 90001.

SECTION 108.2: PERMITS

The following permits have been applied for:

1. WI-DNR WRAPP Water Resources Application for Project Permit, formerly known as a Notice of Intent NOI) for construction site erosion control
2. City of Madison Erosion Control and Stormwater Management Permit – received

It shall be the responsibility of the Contractor to obtain the permits listed below, if required, and to pay all applicable charges and fees associated with these permits.

1. Wisconsin DNR Dewatering

All permit costs shall be considered incidental to the various Mobilization bid items for the Contract. The Contractor shall meet the conditions of all permits and must keep a copy of each individual permit on site at all times throughout construction.

The Contractor shall meet the conditions of the permits involving including properly installing and maintaining the erosion control measures shown on the plans, specified in these Special Provisions, or as directed by the Construction Engineer or his designees. This work will be paid for under the appropriate bid items, or if appropriate items are not included in the contract, they shall be paid for as Extra Work.

The City's obtaining these permits is not intended to be exhaustive of all permits that may be required to be obtained by the Contractor for construction of this project. It shall be the responsibility of the Contractor to identify and obtain any other permits needed for construction.

SECTION 109.2: PROSECUTION OF WORK

The Contractor shall begin work on or before **September 15, 2014**. The contract completion date shall be **November 30, 2014**. This completion date accounts for normal weather conditions.

Work shall begin only after the start work letter is received. The Contractor shall limit workdays from 7:00 am to 7:00 pm, unless approved by the Engineer in writing.

BID ITEM 10911 - MOBILIZATION

DESCRIPTION

This item shall include all work necessary to mobilize and de-mobilize all equipment, personnel, materials, and incidentals to and from the site for the duration of work.

This bid item shall include all work, materials, equipment, and incidentals necessary to provide site access for the duration of the project, with the exception of Construction Entrances and repair of the asphalt park path (NOT bike path), which shall be paid under the appropriate bid items. The Contractor is permitted to access the site from Buckingham Lane or Milwaukee Street. Any access roads, swamp matting, curb cutting, or other access methods shall be constructed and removed as part of this bid item. All disturbance due to site access, unless otherwise noted, shall be repaired as part of this bid item, including replacing damaged curb and sidewalk, finish grading, topsoiling, seeding, and placing erosion control matting in any areas outside of the grading limits as shown on the plan set.

The Contractor shall be aware that the Woodman's Detention Pond is subject to regular flooding, and at times, ground conditions may not support vehicles. Access routes from Milwaukee Street will likely require soil reinforcement of some sort.

Mobilization will only be paid once.

METHOD OF MEASUREMENT

Mobilization shall be paid as a Lump Sum for all work described above and in Section 109.14 of the Standard Specifications.

BASIS OF PAYMENT

Mobilization shall be measured as described above which shall be full compensation for all work, materials, and incidentals to complete the work as described above.

BID ITEM 20201 - EXCAVATION CUT

DESCRIPTION

Excavation Cut shall include all excavation from within the limits shown on the plans and cross sections. The Contractor shall be responsible for determining a suitable off-site disposal location for excess excavated materials or material that is deemed unusable as fill on site, for hauling unsuitable material from the site, and for placement at the disposal site.

This bid item includes excavation required to construct the new concrete channel, shaping and grading the banks adjacent to the channel, and grading the detention basin. This bid item does not include removal of the existing concrete; that work shall be paid under the appropriate bid item.

Suitable materials may be reused as fill within the project limits. The work involved with placement of suitable fill obtained on site through excavation cut shall be considered subsidiary to work pertaining to excavation cut. Stockpiling these fill materials and final grading shall be considered incidental to this bid item and shall not be compensated separately.

Any excavation directed by the Engineer beyond the limits shown on the plans shall be measured in the field and paid for as Excavation Cut.

Estimated Excavation and fill quantities are as follows:

Excavation	2345 cy
Fill	1836 cy

No bulking/expansion or shrink factors were used when determining earthworks quantities for this project. No adjustments have been made to above quantities for topsoil. In cut sections or at-grade sections, if over-excavation is required to place adequate topsoil thickness, over-excavation shall be considered to be incidental to Bid Item 20221 – Topsoil.

METHOD OF MEASUREMENT

Excavation Cut within the limits shown on the plans and cross sections will be paid for based on the "plan quantity" as shown in the contract without measurement thereof, plus actual undercut quantities measured in the field. The plan quantity was computed by average end area based on cross sections. No changes to this quantity shall be approved unless there are modifications to the plan that result in significant (>10%) change in quantity up or down.

BASIS OF PAYMENT

Excavation Cut shall be paid for at the contract price for work as described and measured above which shall be full compensation for all labor, tools, equipment, and incidentals necessary to complete this item of work.

BID ITEM 20202 - FILL BORROW

DESCRIPTION

This item shall only be used in the event that materials resulting from excavation cut are insufficient or unacceptable and fill borrow is required. This item includes placement of fill material at the locations as directed by the Construction Engineer. Materials used for fill shall meet the requirements of the Standard

Specifications Section 202.2(a) Fill, with the additional requirement that fill material shall be a clayey material, as approved by the Construction Engineer.

It is not anticipated that this bid item will be necessary. The City reserves the right to eliminate this bid item at no cost to the City.

METHOD OF MEASUREMENT

Fill Borrow will be measured by the Cubic Yard of fill, in place, imported to the site.

BASIS OF PAYMENT

Fill Borrow shall be paid at the contract price for work as described and measured above, which shall be full compensation for all material, labor, tools, equipment and incidentals necessary to complete this item of work.

BID ITEM 20221 - TOPSOIL

DESCRIPTION

Work under this item shall include placement of topsoil within the seeding limits shown on the drawings or as directed by the Engineer in the field, in accordance with Section 202 of the Standard Specifications. Topsoil shall be placed four (4) inches thick per the Standard Specifications. Topsoil materials and placement shall be in accordance with Article 202 – Fill.

Topsoil salvaged on-site that meets the specifications may be reused. In some areas the existing topsoil thickness may be adequate and no additional topsoil may be required, however scarifying of the existing or in place topsoil shall be completed prior to seeding and shall be considered incidental to this bid item.

Stripping and stockpiling of topsoil for reuse on the site shall be considered incidental to this bid item. Stockpiles shall be protected with silt fence, or silt sock, to prevent erosion of the stockpile. It is anticipated that sufficient quantities of topsoil are present on site.

METHOD OF MEASUREMENT

Topsoil within the limits shown on the plans shall be paid for based on the "plan quantity" as shown in the contract without measurement thereof. The plan quantity was computed by measuring the grading limits, outside of the cunette. No changes to this quantity shall be approved unless there are modifications to the plan that result in significant (>10%) change in quantity up or down.

BASIS OF PAYMENT

Topsoil shall be paid at the contract price for work as described and measured above, which shall be full compensation for all labor, tools, equipment, and incidentals necessary to complete this item of work, including segregating, stockpiling, and preparing salvaged topsoil, furnishing topsoil from off-site as needed, placing, grading and raking finished surfaces.

BID ITEM 20233 – HEAVY RIPRAP FILTER FABRIC, TYPE HR

DESCRIPTION

This item shall include furnishing and placing Heavy Riprap Filter Fabric at all locations required for the project. Heavy Riprap Filter Fabric material and placement shall be as described in Section 202 of the Standard Specifications. Fabric shall conform to requirements for Geotextile Fabric Type HR contained in the latest edition of the Standard Specifications for Highway and Structure Construction for the State of Wisconsin, Department of Transportation. Fabric shall be synthetic, non-woven needle punched fabric

that is resistant to chemicals and mildew, stable under freeze-thaw cycles, does not shrink or expand under wet conditions, and that does not unravel during use.

Placement of filter fabric shall conform to manufacturer's requirements to assure a continuous layer unbroken by rips, tears, punctures, or other physical damage from placement of the fabric or placement of materials over the fabric.

METHOD OF MEASUREMENT

Heavy Riprap Filter Fabric shall be measured by the Square Yard, according to the yardage provided in each roll. The total yardage shall be measured by multiplying the number of complete rolls used by the yardage of each roll. The last roll, if partially used, shall be paid, but the remainder of the roll shall be delivered by the Contractor to the Engineering Service Building on Emil Street.

The quantity on the proposal page includes a 10% allowance for overlap and waste.

BID ITEM 20401 - CLEARING

DESCRIPTION

Work under this item shall include removal of trees indicated on the plans for removal, or as marked in the field. Tree sizes noted on the plans are approximate. Trees to be removed were marked in the field with a dot of pink paint. Any questions or concerns about the removal of particular trees shall be brought promptly to the attention of the Engineer. Clearing shall be as described in the Standard Specifications except as noted below.

All clearing shall be done by sawing trees near the ground line. Under no circumstances is the Contractor permitted to pull trees from the ground or use methods which will significantly disturb existing root systems. Grubbing shall be paid separately under Bid Item 20403.

This bid item shall also include root cutting necessary to remove or install the concrete cunette. Roots greater than 2 inches shall be measured by the inch diameter at the cut. Cutting roots smaller than 2 inches shall be considered incidental to Excavation Cut. All root cutting shall be completed in accordance with the Article 107.13 of the Standard Specifications.

The Contractor shall remove all cut material from the site.

METHOD OF MEASUREMENT

Clearing will be measured per Inch Diameter, as set forth in the Standard Specifications.

BASIS OF PAYMENT

The contract unit price for Clearing per inch diameter shall be payment in full for furnishing all labor and equipment for all clearing actually performed, and for the handling and disposal of all debris resulting from clearing and grubbing.

BID ITEM 20403 - GRUBBING

DESCRIPTION

Work under this item shall include grubbing stumps, following removal of trees indicated on the plans for removal. Tree sizes noted on the plans are approximate. Fill required to backfill holes where stumps are removed shall be considered incidental to this bid item. The Contractor shall remove all grubbed material from the site.

METHOD OF MEASUREMENT

Grubbing will be measured per Inch Diameter, as set forth in the Standard Specifications.

BASIS OF PAYMENT

The contract unit price for Grubbing per inch diameter shall be payment in full for furnishing all labor and equipment for all grubbing activities performed, and for the handling and disposal of all debris resulting from clearing and grubbing.

BID ITEM 20701 – TERRACE SEEDING

DESCRIPTION

Work under this item shall include all labor, equipment, materials and incidentals necessary to seed the swale to be regraded in Eastmorland Park, as shown on the plan set. Work shall be completed in accordance with Article 207 of the Standard Specifications. Sun Terrace Seed Mix shall be used. The graded, topsoiled, and seeded areas shall be covered with Class I, Urban Type B erosion control matting, which shall be paid separately.

This seed shall contain a cover crop in accordance with Article 207.3(b) of the Standard Specifications. Cover crops, fertilizer, and polymer shall be applied per the Standard Specifications and are incidental to this bid item.

METHOD OF MEASUREMENT

Terrace Seeding within the limits shown on the plans shall be paid for based on the "plan quantity" as shown in the contract without measurement thereof. The plan quantity was computed by measuring the grading limits associated with the swale in Eastmorland Park. No changes to this quantity shall be approved unless there are modifications to the plan that result in significant (>10%) change in quantity up or down.

BASIS OF PAYMENT

Terrace Seeding shall be measured as described above and shall be paid for at the contract unit price, which shall be full compensation for provision, storing, placement, and fertilization of the seed mix.

BID ITEM 20705 – DETENTION BASIN SEEDING

DESCRIPTION

Work under this item shall include all labor, equipment, materials and incidentals necessary to seed the Woodman's Detention Basin after grading activities. Work shall be completed in accordance with Article 207 of the Standard Specifications. Erosion control matting will not be used in this area. Instead straw or hay mulch shall be placed in accordance with Article 207.2 (c) of the Standard Specifications. Provision and placement of mulch shall be considered incidental to this bid item.

This seed shall contain a cover crop in accordance with Article 207.3(b) of the Standard Specifications. Cover crops, fertilizer, and polymer shall be applied per the Standard Specifications and are incidental to this bid item.

METHOD OF MEASUREMENT

Detention Basin Seeding within the limits shown on the plans shall be paid for based on the "plan quantity" as shown in the contract without measurement thereof. The plan quantity was computed by measuring the grading limits outside of the cunette. No changes to this quantity shall be approved unless there are modifications to the plan that result in significant (>10%) change in quantity up or down.

BASIS OF PAYMENT

Detention Basin Seeding shall be measured as described above and shall be paid for at the contract unit price, which shall be full compensation for provision, storing, placement, and fertilization of the seed mix.

BID ITEM 20706 – TALL GRASS PRAIRIE SEEDING

DESCRIPTION

Work under this item shall include all labor, equipment, materials and incidentals necessary to seed the graded slopes adjacent to the concrete cunette, with the exception of the detention basin area. Work shall be completed in accordance with Article 207 of the Standard Specifications. The graded, topsoiled, and seeded areas shall be covered with Class I, Urban Type B erosion control matting, which shall be paid separately.

This seed shall contain a cover crop in accordance with Article 207.3(b) of the Standard Specifications. Cover crops, fertilizer, and polymer shall be applied per the Standard Specifications and are incidental to this bid item.

METHOD OF MEASUREMENT

Tall Grass Prairie Seeding within the limits shown on the plans shall be paid for based on the "plan quantity" as shown in the contract without measurement thereof. The plan quantity was computed by measuring the grading limits outside of the cunette. No changes to this quantity shall be approved unless there are modifications to the plan that result in significant (>10%) change in quantity up or down.

BASIS OF PAYMENT

Tall Grass Prairie Seeding shall be measured as described above and shall be paid for at the contract unit price, which shall be full compensation for provision, storing, placement, and fertilization of the seed mix.

BID ITEM 21046 – EROSION MATTING, CLASS I, URBAN TYPE B

DESCRIPTION

Work under this bid item shall include all labor, equipment, materials, and incidentals necessary to provide and install Erosion Control Matting, Class I, Urban Type B in accordance with the Standard Specifications.

METHOD OF MEASUREMENT

Erosion Matting, Class I, Urban Type B within the limits shown on the plans shall be paid for based on the "plan quantity" as shown in the contract without measurement thereof. The plan quantity was computed by measuring the grading limits outside of the cunette, and subtracting the grading area within the detention basin. No changes to this quantity shall be approved unless there are modifications to the plan that result in significant (>10%) change in quantity up or down.

BASIS OF PAYMENT

Erosion Matting, Class I, Urban Type B shall be measured as described above and shall be paid for at the contract unit price, which shall be full compensation for provision and installation of storm sewer pipe to the line and grade specified in the plan set.

BID ITEM 40201 – HMA PAVEMENT TYPE E-0.3

DESCRIPTION

Work under this bid item shall include provision and installation of asphalt pavement should the park path at the end of Buckingham Lane be damaged during construction activities. All asphalt paving shall occur in accordance with Part 4 of the Standard Specifications.

The City reserves the right to eliminate this bid item at no cost to the City.

BID ITEM 40311 – PULVERIZE AND SHAPE

DESCRIPTION

Work under this bid item shall include pulverize and shaping the park path at the end of Buckingham Lane, should it be damaged during construction activities. All pulverizing and shaping shall occur in accordance with Part 4 of the Standard Specifications.

The City reserves the right to eliminate this bid item at no cost to the City.

BID ITEM 40321 – UNDERCUT

DESCRIPTION

Work under this bid item shall include all work necessary to excavate to a suitable foundation in the unlined section of the channel, approximate Stations 8+75 – 13+25. It is assumed that a suitable foundation exists beneath the lined portion of the channel. All work shall be completed, measured, and paid in accordance with Article 403.4 of the Standard Specifications. Areas of undercut shall be backfilled with Clear Stone, which shall be paid under that bid item.

The City reserves the right to eliminate this bid item at no cost to the City.

BID ITEM 50411 – 12 INCH RCP STORM SEWER PIPE

DESCRIPTION

Work under this item shall include all labor, equipment, materials and incidentals necessary to install 12-inch RCP storm sewer pipe as shown on the plans and in accordance with Article 5 of the Standard Specifications. The Contractor may propose an alternative pipe material, provided that water tight field bends and connections to the concrete apron endwalls can be achieved. The Contractor shall request permission from the Engineer prior to bidding or installing an alternate pipe material. Any additional couplings or fittings required to provide non-concrete pipe shall be considered incidental to this bid item.

METHOD OF MEASUREMENT

12-Inch RCP Storm Sewer Pipe shall be measured by the Linear Foot of concrete pipe, or approved alternate, installed in the field.

BASIS OF PAYMENT

12-Inch RCP Storm Sewer Pipe shall be measured as described above and shall be paid for at the contract unit price, which shall be full compensation for provision and installation of storm sewer pipe to the line and grade specified in the plan set.

BID ITEM 90001 - TEMPORARY FENCING

DESCRIPTION

This item includes installation of temporary construction fencing at the locations shown on the drawing, or as directed by the Construction Engineer. The intent of this item is to delineate the area to which contractor shall confine his or her operations, to protect trees, and to direct the public away from construction areas. Minor relocation of fencing may be required as the work progresses. No extra payment shall be made for temporarily opening and re-closing the fence, or minor relocation of the fencing as needed to perform the work. Temporary fencing shall be installed at the direction of the Construction Engineer.

Construction fencing shall be International Orange color, high-density polyethylene mesh conforming to the following:

- Mesh opening: 1 inch min to 3 inch max
- Height: 4 feet
- Ultimate tensile strength: Avg 3000 lb per 4' width (ASTM D638)

Posts shall be conventional metal "T" or "U" shaped posts. Fencing shall be installed according to the manufacturer's recommendations.

METHOD OF MEASUREMENT

Temporary Fencing shall be measured by the Linear Foot of fence provided, installed, maintained, and removed during project activities.

BASIS OF PAYMENT

Cost for Temporary Fencing shall be paid for according to the contract unit price. Price shall include payment for providing and installing temporary fence and appurtenances, maintenance of fencing as required, creating and closing temporary openings as needed, and removal of fencing and appurtenances, including furnishing all labor, tools, equipment, and incidentals necessary to perform the work.

BID ITEM 90002 - CHAIN LINK FENCE

DESCRIPTION

This bid item shall include all work, materials, labor, and incidentals required to install new chain link fence at the upstream outfall, as shown on the plan set. The chain link fence shall be installed in accordance with the detail shown on Sheet D-1.

The Contractor shall minimize the time between the removal of the existing fence and the installation of the new fence. If possible, the fence shall be removed and replaced during the same working day. The Contractor shall remove and replace the fence within two working days.

When the outfall is not protected by a fence, the Contractor shall barricade between the bike path and the concrete headwall, as well as place signs indicating a drop-off and/or fall hazard.

The Contractor shall locate the fence posts so as not to damage the existing storm box or 36-inch storm pipe.

METHOD OF MEASUREMENT

Chain Link Fence shall be measured by the Linear Foot of fence installed in the field.

BASIS OF PAYMENT

Chain Link Fence shall be measured as described above and shall be paid for at the contract unit price, which shall be considered full compensation for furnishing, hauling, stockpiling as needed, and placing the material, including all equipment, tools, labor and incidentals necessary to complete the work as set forth in the description.

BID ITEM 90030 – STORM CONTROL

DESCRIPTION

Work under this item shall include all work, materials, equipment, and incidentals required to control wet and dry weather flow in the channel where the work is to be completed. The Contractor should expect that low flows could be present during dry weather; however, the channel can be expected to fill rapidly during rain events. The project area shall be expected to flood regularly; the Woodman's Detention Pond retains water and will remain wet for an extended period after rain events.

The Contractor shall take all necessary steps to protect the new structures and channels from damage during construction and to accommodate the existing flows during construction.

This item includes all storm control necessary for all aspects of the Construction. This item is not for control of groundwater.

METHOD OF MEASUREMENT

Storm Control shall be measured as a single Lump Sum for all storm control necessary throughout construction.

BASIS OF PAYMENT

Storm Control will be paid for at the contract sum price, which shall be full compensation for all work as provided in the description.

BID ITEM 90031 – TEMPORARY DITCH CHECK

DESCRIPTION

Work under this item shall include installation of Temporary Ditch Checks for erosion control as shown on and described in the Erosion Control Plans, as required for erosion control and at locations as approved or as directed by the Construction Engineer. Riprap, filter fabric, and clear stone required to construct the ditch checks shall be paid separately as bid items 90033, 20233, 20217, respectively.

METHOD OF MEASUREMENT

Temporary Ditch Check shall be measured by Each complete unit installed, maintained, and removed in the field.

BASIS OF PAYMENT

Temporary Ditch Check shall be measured as described above and shall be paid for at the contract price which shall be full compensation for all work, equipment, labor, and incidentals required to complete the work as set forth in the description and for maintenance of the Temporary Ditch Check as needed.

BID ITEM 90032 - REMOVE EXISTING CUNETTE

DESCRIPTION

Work under this item shall include removal of the existing cunette within Eastmorland Park and Woodman's Detention Pond, the limits of which are shown the plan set. The existing concrete cunette has an estimated thickness of 8 inches and may include reinforcing material. This item shall also include all required sawcutting of the existing cunette at the 36-inch apron endwall and at the upstream concrete structure (cunette and retaining walls).

Work shall include removal of the cunette, stockpiling as needed, hauling away of the concrete, and disposal of the concrete. Contractor shall be responsible for determining a suitable off-site disposal location.

The Contractor shall phase concrete removal with construction of the new concrete cunette, so as not to leave unprotected sections of the channel. Concrete removal shall occur in conjunction with the placement of new concrete or aggregate base course.

METHOD OF MEASUREMENT

Remove Existing Cunette shall be paid by the Square Yard of concrete removed.

BASIS OF PAYMENT

Remove Existing Cunette shall be measured as described above and shall be paid for at the contract unit price, which shall be considered full compensation for sawcutting, removing, stockpiling as needed, hauling, and disposal of the material, including all equipment, tools, labor and incidentals necessary to complete the work as set forth in the description.

BID ITEM 90033- MEDIUM RIPRAP – GLACIAL FIELD STONE

DESCRIPTION

Work under this bid item shall include furnishing and installing Medium Riprap in accordance with Section 202 of the Standard Specifications, except that the riprap shall meet the requirements for Medium Riprap cited in Section 606 of the latest edition of the Standard Specifications for Highway and Structure Construction by the State of Wisconsin Department of Transportation, and riprap shall consist of durable, non-sedimentary, field stone that is resistant to freeze-thaw degradation. Limestone riprap will not be accepted. Riprap shall be placed a minimum of 2-ft thick, measured perpendicular to the lines and grades shown on the drawings. The Contractor shall limit channel disturbance to that which can be restored in a day.

Riprap shall be placed on filter fabric, paid separately as Item 20233 (Riprap Filter Fabric, Type HR).

METHOD OF MEASUREMENT

Medium Riprap shall be measured by the Ton in place. All tickets shall be presented to the City representative on the project within twenty-four (24) hours after delivery of the materials to the project.

BASIS OF PAYMENT

Medium Riprap shall be measured as described above and shall be paid for at the contract unit price, which shall be considered full compensation for furnishing, hauling, stockpiling as needed, and placing the material, including all equipment, tools, labor and incidentals necessary to complete the work as set forth in the description.

BID ITEM 90034 – 7-INCH CONCRETE CUNETTE

Work under this bid item shall include construction of the 7-inch thick concrete cunette as shown in the plan set. This work shall include supplying, forming, and pouring concrete as detailed on the plans.

Concrete and concrete materials shall comply with Article 404 of the Standard Specifications (Article 415 & 416 "Concrete Pavement" of the latest edition of the Standard Specifications for Highway and Structure Construction of the State of Wisconsin, Department of Transportation). Concrete shall be DOT Grade A-FA, and shall be **fiber-reinforced with macrosynthetic fiber at a rate 5 lb/cubic yard**. Macrosynthetic fiber shall meet ACI 360. Contractor shall use fiber product as recommended by the manufacturer. Macrosynthetic fiber shall be Forta Ferro Macro Fiber or Matrix HPS 950 Fiber, or Engineer-approved equal.

The concrete design mix and proposed fiber-reinforcement and shall be submitted to the Engineer for approval at least 10 days prior to pouring of concrete. Construction of the concrete shall comply with Article 304 of the Standard Specifications.

This item shall include transverse contraction joints on 20-ft centers, and supplying and installing epoxy-coated dowel bars at joints per Standard Detail 3.11. Dowels shall be required at joints across the bottom of the cunette, but not within the side slopes. This item shall also include sealing of all joints with Sonolastic NP-1 gun-grade caulk or an Engineer-approved equal. Joint sealer shall be applied according to the manufacturer's specifications, and in accordance with Section 303.2(d) of the Standard Specifications.

This bid item shall also include the construction of flumes as shown in the plan set, and the widening of the cunette at the outfall, which is necessary to connect to the existing structure.

Base course for the cunette shall be paid separately as Bid Items 40101 Crushed Stone Aggregate Base Course, Gradation No. 1 and 40102 Crushed Stone Aggregate Base Course, Gradation No. 2.

METHOD OF MEASUREMENT

7-inch Concrete Cunette, as described above and as detailed in the plans, will be measured in place by the linear foot along the station line for completed and accepted work.

BASIS OF PAYMENT

7-Inch Concrete Cunette shall be measured as described above and shall be paid for at the contract price per Linear Foot installed including placing, finishing, and curing the concrete and for furnishing and installing all dowel bars and reinforcement, and for all labor, tools, materials, equipment, and incidentals necessary to complete the work.

BID ITEM 90035 – INTERMITTENT CUTOFF WALLS

DESCRIPTION

Work under this item shall include construction of a new intermittent concrete cutoff walls at the locations shown, or as directed by the Construction Engineer according to the detail on Sheet D-1.

This item shall include required excavation, and furnishing and installing concrete and reinforcement as shown on the detail. Base course below the foundation shall be paid separately.

METHOD OF MEASUREMENT

Intermittent Cutoff Walls shall be measured as a complete unit as installed in the field.

BASIS OF PAYMENT

Intermittent Cutoff Walls shall be measured as described above and shall be paid for at the contract price which shall be full compensation for all work, equipment, labor, and incidentals required to complete the work as set forth in the description.

BID ITEM 90036 - FIELD BEND

DESCRIPTION

Where shown on the drawings, the Contractor shall provide a 12" field bend. The field-poured bend shall be reinforced with welded wire fabric and shall utilize fiber reinforced concrete in the concrete collar itself. The interior or the joint shall be finished smooth to match the interior of adjoining surfaces.

METHOD OF MEASUREMENT

Field Bend shall be measured by Each complete bend installed in the field. Individual or multiple precast bend sections that are assembled to provide the total angle required will be measured for payment as a single precast bend.

BASIS OF PAYMENT

Field Bend shall be paid for according to the unit price bid. Price bid shall include all materials, labor and equipment necessary for a complete installation as specified in the description.

BID ITEM 90037 – 8-INCH PLASTIC DRAIN TILE

DESCRIPTION

Work under this bid item shall include all labor, materials, equipment, and incidentals necessary to install 8-inch plastic drain tile as shown on the plan set and depicted on Sheet D-1. The pipe shall meet the specifications described in Article 201.4(a) of the Standard Specifications, but shall be 8-inch diameter pipe. The tile shall be wrapped with non-woven filter fabric.

The drain tile shall be placed in bedding of 0.5-inch (or larger) clear stone. The bedding material may be graded, so long as it has been washed of fines. The bedding material shall be separated from native soil by a non-woven filter fabric that complies with Article 201.4(b). Bedding material and non-woven filter fabric shall be considered incidental to this bid item.

All fittings, couplings, and incidentals necessary to place pipe shall be considered incidental to this bid item. The pipe shall be placed in an alignment that minimizes impact to tree roots.

METHOD OF MEASUREMENT

8-Inch Plastic Drain Tile shall be measured by Linear Foot installed in the field and shall include all fittings, bends, bedding material, and filter fabric necessary for the installation.

BASIS OF PAYMENT

8-Inch Plastic Pipe shall be paid for according to the unit price bid. Price bid shall include all materials, labor and equipment necessary for a complete installation as specified in the description.

BID ITEM 90038 – CONCRETE WASTE MANAGEMENT

GENERAL

This work consists of containment, collection, storage and proper disposal of concrete wastes generated by sawcutting or grinding of existing concrete, or waste run-off generated during construction of new concrete. Concrete wastes typically are strongly alkaline and may contain other contaminants and are particularly harmful if allowed to enter streams, lakes wetlands or other water bodies through the storm sewer system.

The Contractor is alerted that there are local, state and federal regulations governing the handling and disposal of hazardous materials and this Special Provision in no way relieves the Contractor of any responsibility to comply with such regulations. The intent is to provide more specific guidelines for management of concrete wastes on this project and provide a basis of payment for work associated with specific management measures properly implemented.

MATERIALS

The Contractor may choose appropriate materials to suit their methods of waste management with the following minimum requirements. Pre-fabricated washout containers shall be in sound condition and watertight. They shall be of sturdy materials and designed to provide a minimum of 6 inches of freeboard based on the volume of liquid wastes to be generated between clean-outs. Structures shall be lined with a waterproof plastic sheeting of minimum 10-mil thickness that has no holes or tears. Above grade structures shall have a double layer lining.

Redirecting of flow with sand bags and/or silt sock within the cunette may be required to prevent concrete waste or runoff from entering the storm sewer system.

NOTE: a geotextile sediment trap by itself is not acceptable as the leachate continues to be highly alkaline and contain dissolved contaminants.

CONSTRUCTION METHODS

If conditions are such that debris and slurry from sawcutting and grinding operations will remain on concrete and not run off into the storm sewer system, they may be allowed to dry in place and be cleaned from the concrete by sweeping or vacuum equipment. Such wastes shall not be allowed to remain on pavements beyond the end of a day's work.

Sand bags or other devices shall be used to contain the slurry from cutting or grinding to prevent its entry into storm sewer system. Slurry may be pumped to an approved containment structure for on-site storage.

On-site containment structures shall be emptied on a periodic basis, such that they do not exceed their design capacity, including required freeboard. Contractor shall remove contaminated liquids from the site, using trucks fitted with watertight gaskets to prevent leakage, or other similar methods. Wastes shall be properly disposed of off-site, in accordance with applicable laws and regulations.

METHOD OF MEASUREMENT

Work under this Section will be measured as a Lump Sum, for all measures and devices used to contain and dispose of concrete wastes throughout the duration of the project, that are acceptably installed, maintained and removed.

BASIS OF PAYMENT

Concrete Waste Management shall be paid for according to the unit price bid. Price bid shall include all materials, labor and equipment necessary for a complete installation as specified in the description.

SECTION H: AGREEMENT

THIS AGREEMENT made this 3d day of September in the year Two Thousand and Fourteen between DRAX, INC. hereinafter called the Contractor, and the City of Madison, Wisconsin, hereinafter called the City.

WHEREAS, the Common Council of the said City of Madison under the provisions of a resolution adopted SEPTEMBER 2, 2014, and by virtue of authority vested in the said Council, has awarded to the Contractor the work of performing certain construction.

NOW, THEREFORE, the Contractor and the City, for the consideration hereinafter named, agree as follows:

1. **Scope of Work.** The Contractor shall, perform the construction, execution and completion of the following listed complete work or improvement in full compliance with the Plans, Specifications, Standard Specifications, Supplemental Specifications, Special Provisions and contract; perform all items of work covered or stipulated in the proposal; perform all altered or extra work; and shall furnish, unless otherwise provided in the contract, all materials, implements, machinery, equipment, tools, supplies, transportation, and labor necessary to the prosecution and completion of the work or improvements:

EASTMORLAND PARK GREENWAY CONTRACT NO. 7369

2. **Completion Date/Contract Time.** Construction work must begin within seven (7) calendar days after the date appearing on mailed written notice to do so shall have been sent to the Contractor and shall be carried on at a rate so as to secure full completion SEE SPECIAL PROVISIONS, the rate of progress and the time of completion being essential conditions of this Agreement.
3. **Contract Price.** The City shall pay to the Contractor at the times, in the manner and on the conditions set forth in said specifications, the sum of THREE HUNDRED THIRTY-SEVEN THOUSAND NINE HUNDRED THIRTY-ONE (\$337,931.00) Dollars being the amount bid by such Contractor and which was awarded to him/her as provided by law.
4. **Wage Rates for Employees of Public Works Contractors**

General and Authorization. The Contractor shall compensate its employees at the prevailing wage rate in accordance with section 66.0903, Wis. Stats., DWD 290 of the Wisconsin Administrative Code and as hereinafter provided unless otherwise noted in Section D: Special Provisions, Subsection 102.10 – Minimum Rate of Wage Scale.

"Public Works" shall include building or work involving the erection, construction, remodeling, repairing or demolition of buildings, parking lots, highways, streets, bridges, sidewalks, street lighting, traffic signals, sanitary sewers, water mains and appurtenances, storm sewers, and the grading and landscaping of public lands.

"Building or work" includes construction activity as distinguished from manufacturing, furnishing of materials, or servicing and maintenance work, except for the delivery of mineral aggregate such as sand, gravel, bituminous asphaltic concrete or stone which is incorporated into the work under contract with the City by depositing the material directly in final place from transporting vehicle.

"Erection, construction, remodeling, repairing" means all types of work done on a particular building or work at the site thereof in the construction or development of the project, including without limitation, erecting, construction, remodeling, repairing, altering, painting, and decorating, the transporting of materials and supplies to or from the building or work done by the employees of the Contractor, Subcontractor, or Agent thereof, and the manufacturing or furnishing of

materials, articles, supplies or equipment on the site of the building or work, by persons employed by the Contractor, Subcontractor, or Agent thereof.

"Employees working on the project" means laborers, workers, and mechanics employed directly upon the site of work.

"Laborers, Workers, and Mechanics" include pre-apprentices, helpers, trainees, learners and properly registered and indentured apprentices but exclude clerical, supervisory, and other personnel not performing manual labor.

Establishment of Wage Rates. The Department of Public Works shall periodically obtain a current schedule of prevailing wage rates from DWD. The schedule shall be used to establish the City of Madison Prevailing Wage Rate Schedule for Public Works Construction (prevailing wage rate). The Department of Public Works may include known increases to the prevailing wage rate which can be documented and are to occur on a future specific date. The prevailing wage rate shall be included in public works contracts subsequently negotiated or solicited by the City. Except for known increases contained within the schedule, the prevailing wage rate shall not change during the contract. The approved wage rate is attached hereto.

Workforce Profile. The Contractor shall, at the time of signature of the contract, notify the City Engineer in writing of the names and classifications of all the employees of the Contractor, Subcontractors, and Agents proposed for the work. In the alternative, the Contractor shall submit in writing the classifications of all the employees of the Contractor, Subcontractors and Agents and the total number of hours estimated in each classification for the work. This workforce profile(s) shall be reviewed by the City Engineer who may, within ten (10) days, object to the workforce profile(s) as not being reflective of that which would be required for the work. The Contractor may request that the workforce profile, or a portion of the workforce profile, be submitted after the signature of the contract but at least ten (10) days prior to the work commencing. Any costs or time loss resulting from modifications to the workforce profile as a result of the City Engineer's objections shall be the responsibility of the Contractor.

Payrolls and Records. The Contractor shall keep weekly payroll records setting forth the name, address, telephone number, classification, wage rate and fringe benefit package of all the employees who work on the contract, including the employees of the Contractor's subcontractors and agents. Such weekly payroll records must include the required information for all City contracts and all other contracts on which the employee worked during the week in which the employee worked on the contract. The Contractor shall also keep records of the individual time each employee worked on the project and for each day of the project. Such records shall also set forth the total number of hours of overtime credited to each such employee for each day and week and the amount of overtime pay received in that week. The records shall set forth the full weekly wages earned by each employee and the actual hourly wage paid to the employee.

The Contractor shall submit the weekly payroll records, including the records of the Contractor's subcontractors and agents, to the City Engineer for every week that work is being done on the contract. The submittal shall be within twenty-one (21) calendar days of the end of the Contractor's weekly pay period.

Employees shall receive the full amounts accrued at the time of the payment, computed at rates not less than those stated in the prevailing wage rate and each employee's rate shall be determined by the work that is done within the trade or occupation classification which should be properly assigned to the employee.

An employee's classification shall not be changed to a classification of a lesser rate during the contract. If, during the term of the contract, an employee works in a higher pay classification than the one which was previously properly assigned to the employee, then that employee shall be considered to be in the higher pay classification for the balance of the contract, receive the appropriate higher rate of pay, and she/he shall not receive a lesser rate during the balance of the

contract. For purposes of clarification, it is noted that there is a distinct difference between working in a different classification with higher pay and doing work within a classification that has varying rates of pay which are determined by the type of work that is done within the classification. For example, the classification "Operating Engineer" provides for different rates of pay for various classes of work and the Employer shall compensate an employee classified as an "Operating Engineer" based on the highest class of work that is done in one day. Therefore, an "Operating Engineer's" rate may vary on a day to day basis depending on the type of work that is done, but it will never be less than the base rate of an "Operating Engineer". Also, as a matter of clarification, it is recognized that an employee may work in a higher paying classification merely by chance and without prior intention, calculation or design. If such is the case and the performance of the work is truly incidental and the occurrence is infrequent, inconsequential and does not serve to undermine the single classification principle herein, then it may not be required that the employee be considered to be in the higher pay classification and receive the higher rate of pay for the duration of the contract. However, the Contractor is not precluded or prevented from paying the higher rate for the limited time that an employee performs work that is outside of the employee's proper classification.

Questions regarding an employee's classification, rate of pay or rate of pay within a classification, shall be resolved by reference to the established practice that predominates in the industry and on which the trade or occupation rate/classification is based. Rate of pay and classification disputes shall be resolved by relying upon practices established by collective bargaining agreements and guidelines used in such determination by appropriate recognized trade unions operating within the City of Madison.

The Contractor, its Subcontractors and Agents shall submit to interrogation regarding compliance with the provisions of this ordinance.

Mulcting of the employees by the Contractor, Subcontractor, and Agents on Public Works contracts, such as by kickbacks or other devices, is prohibited. The normal rate of wage of the employees of the Contractor, Subcontractor, and Agents shall not be reduced or otherwise diminished as a result of payment of the prevailing wage rate on a public works contract.

Hourly contributions. Hourly contributions shall be determined in accordance with the prevailing wage rate and with DWD. 290.01(10), Wis. Admin. Code.

Apprentices and Subjourney persons. Apprentices and sub journeypersons performing work on the project shall be compensated in accordance with the prevailing wage rate and with DWD 290.02, and 290.025, respectively, Wis. Admin. Code.

Straight Time Wages. The Contractor may pay straight time wages as determined by the prevailing wage rate and DWD 290.04, Wis. Admin. Code.

Overtime Wages. The Contractor shall pay overtime wages as required by the prevailing wage rate and DWD 290.05, Wis. Admin. Code.

Posting of Wage Rates and Hours. A clearly legible copy of the prevailing wage rate, together with the provisions of Sec. 66.0903(10)(a) and (11)(a), Wis. Stats., shall be kept posted in at least one conspicuous and easily accessible place at the project site by the Contractor and such notice shall remain posted during the full time any laborers, workers or mechanics are employed on the contract.

Evidence of Compliance by Contractor. Upon completion of the contract, the Contractor shall file with the Department of Public Works an affidavit stating:

- a. That the Contractor has complied fully with the provisions and requirements of Sec. 66.0903(3), Wis. Stats., and Chapter DWD 290, Wis. Admin. Code; the Contractor has received evidence of compliance from each of the agents and subcontractors; and the

names and addresses of all of the subcontractors and agents who worked on the contract.

- b. That full and accurate records have been kept, which clearly indicate the name and trade or occupation of every laborer, worker or mechanic employed by the Contractor in connection with work on the project. The records shall show the number of hours worked by each employee and the actual wages paid therefore; where these records will be kept and the name, address and telephone number of the person who will be responsible for keeping them. The records shall be retained and made available for a period of at least three (3) years following the completion of the project of public works and shall not be removed without prior notification to the municipality.

Evidence of Compliance by Agent and Subcontractor. Each agent and subcontractor shall file with the Contractor, upon completion of their portion of the work on the contract an affidavit stating that all the provisions of Sec. 66.0903(3), Wis. Stats., have been fully complied with and that full and accurate records have been kept, which clearly indicate the name and trade or occupation of every laborer, worker or mechanic employed by the Contractor in connection with work on the project. The records shall show the number of hours worked by each employee and the actual wages paid therefore; where these records shall be kept and the name, address and telephone number of the person who shall be responsible for keeping them. The records shall be retained and made available for a period of at least three (3) years following the completion of the project of public works and shall not be removed without prior notification to the municipality.

Failure to Comply with the Prevailing Wage Rate. If the Contractor fails to comply with the prevailing wage rate, she/he shall be in default on the contract.

5. **Affirmative Action.** In the performance of the services under this Agreement the Contractor agrees not to discriminate against any employee or applicant because of race, religion, marital status, age, color, sex, disability, national origin or ancestry, income level or source of income, arrest record or conviction record, less than honorable discharge, physical appearance, sexual orientation, gender identity, political beliefs, or student status. The Contractor further agrees not to discriminate against any subcontractor or person who offers to subcontract on this contract because of race, religion, color, age, disability, sex, sexual orientation, gender identity or national origin.

The Contractor agrees that within thirty (30) days after the effective date of this agreement, the Contractor will provide to the City Affirmative Action Division certain workforce utilization statistics, using a form to be furnished by the City.

If the contract is still in effect, or if the City enters into a new agreement with the Contractor, within one year after the date on which the form was required to be provided, the Contractor will provide updated workforce information using a second form, also to be furnished by the City. The second form will be submitted to the City Affirmative Action Division no later than one year after the date on which the first form was required to be provided.

The Contractor further agrees that, for at least twelve (12) months after the effective date of this contract, it will notify the City Affirmative Action Division of each of its job openings at facilities in Dane County for which applicants not already employees of the Contractor are to be considered. The notice will include a job description, classification, qualifications and application procedures and deadlines. The Contractor agrees to interview and consider candidates referred by the Affirmative Action Division if the candidate meets the minimum qualification standards established by the Contractor, and if the referral is timely. A referral is timely if it is received by the Contractor on or before the date started in the notice.

Articles of Agreement

Article I

The Contractor shall take affirmative action in accordance with the provisions of this contract to insure that applicants are employed, and that employees are treated during employment without regard to race, religion, color, age, marital status, disability, sex, sexual orientation, gender identity or national origin and that the employer shall provide harassment free work environment for the realization of the potential of each employee. Such action shall include, but not be limited to, the following: employment, upgrading, demotion or transfer, recruitment or recruitment advertising, layoff or termination, rates of pay or other forms of compensation and selection for training including apprenticeship insofar as it is within the control of the Contractor. The Contractor agrees to post in conspicuous places available to employees and applicants notices to be provided by the City setting out the provisions of the nondiscrimination clauses in this contract.

Article II

The Contractor shall in all solicitations or advertisements for employees placed by or on behalf of the Contractors state that all qualified or qualifiable applicants will be employed without regard to race, religion, color, age, marital status, disability, sex, sexual orientation, gender identity or national origin.

Article III

The Contractor shall send to each labor union or representative of workers with which it has a collective bargaining agreement or other contract or understanding a notice to be provided by the City advising the labor union or worker's representative of the Contractor's equal employment opportunity and affirmative action commitments. Such notices shall be posted in conspicuous places available to employees and applicants for employment.

Article V

The Contractor agrees that it will comply with all provisions of the Affirmative Action Ordinance of the City of Madison, including the contract compliance requirements. The Contractor agrees to submit the model affirmative action plan for public works contractors in a form approved by the Affirmative Action Division Manager.

Article VI

The Contractor will maintain records as required by Section 39.02(9)(f) of the Madison General Ordinances and will provide the City Affirmative Action Division with access to such records and to persons who have relevant and necessary information, as provided in Section 39.02(9)(f). The City agrees to keep all such records confidential, except to the extent that public inspection is required by law.

Article VII

In the event of the Contractor's or subcontractor's failure to comply with the Equal Employment Opportunity and Affirmative Action Provisions of this contract or Section 39.03 and 39.02 of the Madison General Ordinances, it is agreed that the City at its option may do any or all of the following:

1. Cancel, terminate or suspend this Contract in whole or in part.
2. Declare the Contractor ineligible for further City contracts until the Affirmative Action requirements are met.

3. Recover on behalf of the City from the prime Contractor 0.5 percent of the contract award price for each week that such party fails or refuses to comply, in the nature of liquidated damages, but not to exceed a total of five percent (5%) of the contract price, or five thousand dollars (\$5,000), whichever is less. Under public works contracts, if a subcontractor is in noncompliance, the City may recover liquidated damages from the prime Contractor in the manner described above. The preceding sentence shall not be construed to prohibit a prime Contractor from recovering the amount of such damage from the non-complying subcontractor.

Article VIII

The Contractor shall include the above provisions of this contract in every subcontract so that such provisions will be binding upon each subcontractor. The Contractor shall take such action with respect to any subcontractor as necessary to enforce such provisions, including sanctions provided for noncompliance.

Article IX

The Contractor shall allow the maximum feasible opportunity to small business enterprises to compete for any subcontracts entered into pursuant to this contract. (In federally funded contracts the terms "DBE, MBE and WBE" shall be substituted for the term "small business" in this Article.)

s. 66.0903 (10) RECORDS; INSPECTION; ENFORCEMENT.

(a) Each contractor, subcontractor, or contractor's or subcontractor's agent performing work on a project of public works that is subject to this section shall keep full and accurate records clearly indicating the name and trade or occupation of every person performing the work described in sub. (4) and an accurate record of the number of hours worked by each of those persons and the actual wages paid for the hours worked.

s. 66.0903 (11) LIABILITY AND PENALTIES.

- (a) 1. Any contractor, subcontractor, or contractor's or subcontractor's agent who fails to pay the prevailing wage rate determined by the department under sub. (3) or who pays less than 1.5 times the hourly basic rate of pay for all hours worked in excess of the prevailing hours of labor is liable to any affected employee in the amount of his or her unpaid wages or his or her unpaid overtime compensation and in an additional amount as liquidated damages as provided under subd. 2., 3., whichever is applicable.
2. If the department determines upon inspection under sub. (10) (b) or (c) that a contractor, subcontractor, or contractor's or subcontractor's agent has failed to pay the prevailing wage rate determined by the department under sub. (3) or has paid less than 1.5 times the hourly basic rate of pay for all hours worked in excess of the prevailing hours of labor, the department shall order the contractor to pay to any affected employee the amount of his or her unpaid wages or his or her unpaid overtime compensation and an additional amount equal to 100 percent of the amount of those unpaid wages or that unpaid overtime compensation as liquidated damages within a period specified by the department in the order.
3. In addition to or in lieu of recovering the liability specified in subd. 1. as provided in subd. 2., any employee for and in behalf of that employee and other employees similarly situated may commence an action to recover that liability in any court of competent jurisdiction. If the court finds that a contractor, subcontractor, or contractor's or subcontractor's agent has failed to pay the prevailing wage rate determined by the department under sub. (3) or has paid less than 1.5 times the hourly basic rate of pay for all hours worked in excess of the prevailing hours of labor, the court shall order the contractor, subcontractor, or agent to pay to any affected employee the amount of his or her unpaid wages or his or her unpaid overtime compensation and an additional amount equal to 100 percent of the amount of those unpaid wages or that unpaid overtime compensation as liquidated damages.
5. No employee may be a party plaintiff to an action under subd. 3. unless the employee consents in writing to become a party and the consent is filed in the court in which the action is brought. Notwithstanding s. 814.04 (1), the court shall, in addition to any judgment awarded to the plaintiff, allow reasonable attorney fees and costs to be paid by the defendant.
