Notes to Bidders:

1. This bid consists of a **BASE BID** and and **ALTERNATE BID ITEM #1, BULK DIRT STORAGE BUILDING.**
2. Provide a unit price for all bid items.
3. Provide a total bid for each item.
4. Provide a **SUBTOTAL** of all the **BASE BID** items.
5. Provide a **GRAND TOTAL** of the **BASE BID** plus **ALTERNATE BID ITEM #1.**

The contract shall be awarded to the lowest bidding contractor in the following manner:

1. Prior to bid opening the City will establish a **Construction Budget Dollar Value (CBDV)** for the overall project.
2. The City will award the contract based on the **Grand Total of the Base Bid plus Alternate Bid Item #1** if lower than the **CBDV.**
3. If the **Grand Total** exceeds the **CBDV** the City will award the contract based on the **Sub-Total of the Base Bid Items only.**

The City shall have the right to proceed or not proceed with any alternate regardless of how the bid was awarded.

The City shall have the right to reject all bids regardless of the value of the bids submitted.
