Ability to Search a Display List First

When performing a search in Legislative Files, the search results now display in a list format so you can select the record you want to view from a list. This new feature is automatically enabled and is controlled via the Search Results Threshold located in **Tools > Local Settings**.



New Functionality for Legistar Navigation Arrows

The search results navigation arrows now stay hidden until a search actually occurs. The arrows then display at the top of the form for ease of access if more than one record is found.

Customizable Tab Order on Legislative Files Screen

You now have the ability to set the order of your tabs on Legistar's Legislative Files screen; this allows you greater ease of access and navigation with your workflow. You can set the tab order in Administration > System Settings > Legislative Files > Legislative Files Tab Order.

Edit Export Options per Meeting

You can now change the default values of an export for each meeting. This allows you to customize the export settings for each meeting. The Export Options are accessible on the Agenda screen through **Tools > Edit Export Options**.

Auto Export Checkbox for Meeting Bodies

You can now select the **Auto Export checkbox** to determine which meeting bodies are automatically exported to MediaManager. Select this checkbox in **Administration > Government Bodies > Bodies**.

Legistar Agenda Packet Attachment and Cover Page Names

When you click the Agenda Packet button, the Cover Page is now named with the name of the report, and the attachment name is now pulled from the attachment name field.
