ADDENDUM NO. 1 NORTH ST, HOARD ST AND COMMERCIAL AVE RECONSTRUCTION 2014 **CONTRACT NO. 7248**

Revise and amend the contract document(s) for the above project as stated in this addendum, otherwise, the original document shall remain in effect.

SECTION D: SPECIAL PROVISIONS

Add the following item:

BID ITEM 90073 – PROTECT AT&T DUCT PACKAGE

DESCRIPTION

There is an existing underground AT&T duct package on North st running from E Washington Ave to Commercial Ave. This duct package is shown on the plan set and is labeled as "FO". It consists of two four duct packages approx twelve inches per side. This duct package is composed of clay tile installed in the 1920's. There are AT&T access structures along this line of similar age.

Work under this bid item includes all work, materials, equipment, time, and incidentals required to support and protect the AT&T duct package and access structures throughout construction. It is anticipated that due to the depth of the duct package and the depth of the proposed sanitary sewer, this duct package will require additional protection/support during installation of the sanitary sewer main from E. Johnson St to Commercial Ave.

The Contractor shall work with AT&T to determine a method of providing and removing (as needed to bring site back to finish grade and as described below) temporary support, protection, and/or shoring.

The contractor shall contact AT&T prior to starting work, review the project, and install any requested protection or support requested by AT&T. Contact information for AT&T is listed below.

METHOD OF MEASUREMENT

Protect AT&T Duct Package will be measured by the Lump Sum for all support and protection installed on the project.

BASIS OF PAYMENT

Protection measured as provided above, will be paid for at the contract price, which price shall be full compensation for providing the design of the protection system; for furnishing and hauling materials to each location; for installing or constructing the protection measures; for maintenance as needed; for removal when required; and for all labor, tools, equipment and incidentals needed to complete the work in accordance with the contract.
