## SECTION 105.12 COOPERATION BY THE CONTRACTOR

Add the following paragraph:

The Railroad property is not to be used for this project. In the event the RR property is needed for construction purposes, a Temporary Authorization permit is required through the Wisconsin Department of Transportation. All work on the Railroad Right of Way will also require Railroad protective insurance and flag protection through the Wisconsin Southern Railroad.

### SECTION 108.2 PERMITS

#### Add the following paragraph:

The Railroad property is not to be used for this project. In the event the RR property is needed for construction purposes, a Temporary Authorization permit is required through the Wisconsin Department of Transportation. All work on the Railroad Right of Way will also require Railroad protective insurance and flag protection through the Wisconsin Southern Railroad.

BID ITEM 70009 - HORIZONTAL DIRECTIONAL DRILL 2" HDPE PIPE & FITTINGS Add the following underlined sentence to the last paragraph under the City of Madison Storm Sewer subheading:

<u>A minimum 3' of horizontal clearance and 2' of vertical clearance shall be required on all storm pipes and structures.</u>

### **BID ITEM 90007 - PICNIC TABLES**

### Delete the 4<sup>th</sup> paragraph of Bid Item 90007 and replace with the following:

This bid item includes all work, materials, labor and incidentals necessary to coordinate delivery of the picnic tables with the manufacturer; deliver the picnic tables to the construction site; and install the picnic tables in accordance with plans and manufacturer's instructions.

### STANDARD SPECIFICATIONS

The City of Madison's Standard Specifications for Public Works Construction - 2018 Edition, as supplemented and amended from time to time, forms a part of these contract documents as if attached hereto.

These standard specifications are available on the City of Madison Public Works website, www.cityofmadison.com/Business/PW/specs.cfm.

The Contractor shall review these Specifications prior to preparation of proposals for the work to be done under this contract, with specific attention to Article 102, "BIDDING REQUIREMENTS AND CONDITIONS" and Article 103, "AWARD AND EXECUTION OF THE CONTRACT." For the convenience of the bidder, below are highlights of three subsections of the specifications.

#### SECTION 102.1: PRE-QUALIFICATION OF BIDDERS

In accordance with Wisconsin State Statutes 66.0901 (2) and (3), all bidders must submit to the Board of Public Works proof of responsibility on forms furnished by the City. The City requires that all bidders be qualified on a biennial basis.

Bidders must present satisfactory evidence that they have been regularly engaged in the type of work specified herein and they are fully prepared with necessary capital, materials, machinery and supervisory personnel to conduct the work to be contracted for to the satisfaction of the City. All bidders must be prequalified by the Board of Public Works for the type of construction on which they are bidding prior to the opening of the bid.
