3. If no responsible bidder submits a base bid plus alternate one (1) plus alternate two (2) that is below the Construction Budget Dollar Value, the City will award the contract based on the base bid plus alternate one (1).
4. If no responsible bidder submits a base bid plus alternate one (1) that is below the Construction Budget Dollar Value, the City will award the contract based on the base bid only.
5. The City shall have the right to proceed or not proceed with alternate one (1), alternate (2), or alternate (3) regardless of how the bid was awarded. The City shall have the right to reject all bids regardless of the value of the bids submitted.
