1. **GENERAL QUESTIONS/ANSWERS and CLARIFICATIONS**

Q1. If any old landfill material has to be removed during excavation does it have to go to the Dane County Landfill?

A1. Section 104.1 states “Any old landfill material shall be removed and properly disposed of at the Dane County Landfill.”. However the contractor may choose to take it to any other registered landfill operation but must be able to provide disposal records.
