**CONTRACT NO. 9318, PROJECT NO. 14023
OLIN WASTE TRANSFER DROP-OFF**

1. **SECTION D - SPECIAL PROVISIONS:**

- a. Modify Section 104.1 LANDS FOR WORK, last bulleted sub paragraph to read as follows:
 - o Some of the work for this project is on landfill that was not remediated. The Contractor may run into varying depths of old landfill during excavation. Any old landfill material shall be removed and properly disposed of at the Dane County Landfill, **or other legally licensed landfill.**
- b. Add the following bid item description to the Section D, Special Provisions and utilize the updated proposal page which reflects this additional bid item.

BID ITEM 20101.5 – EXCAVATION CUT – SOLID WASTE REMOVAL

DESCRIPTION

BID ITEM 20101.5 shall be for the following work:

- Removal and proper disposal of any excavation material deemed by the inspector to contain solid waste.
- Material shall be properly disposed of in a legally licensed landfill.
- This bid item includes all equipment, trucking, and disposal fees required for the proper removal and disposal of excavated solid waste materials.
- This shall include any solid waste materials that may be located within the electrical trench, Bid Item 50226.

METHOD OF MEASUREMENT

BID ITEM 20101.5 shall be measured as TONS for the complete unit of work described above. Contractor shall retain all tipping tickets indicating entrance and exit weights and landfill name and location.

BASIS OF PAYMENT

BID ITEM 20101.5 shall be paid at the contract unit price for all labor, materials, equipment, and incidentals, including tipping fees.
