SECTION B: INSTRUCTIONS TO BIDDERS

The City of Madison Standard Specifications for Public Works Construction - 2012 Edition, as supplemented and amended from time to time, forms a part of these contract documents as if attached hereto.

These standard specifications are available on the City of Madison Public Works website at www.cityofmadison.com/Business/PW/specs.cfm or by contacting City Engineering Division, Room 115, City-County Building, 210 Martin Luther King Jr. Blvd., Madison, WI 53703.

The Contractor shall review these Specifications prior to preparation of proposals for the work to be done under this contract, with specific attention to Article 102 "BIDDING REQUIREMENTS AND CONDITIONS" and Article 103 "AWARD AND EXECUTION OF THE CONTRACT." For the convenience of the bidder, below are highlights of three subsections of the specifications.

Section 102.1: Pre-Qualification of Bidders

In accordance with Wisconsin State Statutes 66.0901 (2) and (3), all bidders must submit to the Board of Public Works proof of responsibility on forms furnished by the City. The City requires that all bidders be qualified on a biennial basis.

Bidders must present satisfactory evidence that they have been regularly engaged in the type of work specified herein and they are fully prepared with necessary capital, materials, machinery and supervisory personnel to conduct the work to be contracted for to the satisfaction of the City. All bidders must be prequalified by the Board of Public Works for the type of construction on which they are bidding prior to the opening of the bid.

In accordance with Section 39.02(9)(a)l. of the Madison General Ordinances, all bidders shall submit in writing to the Affirmative Action Division Manager of the City of Madison, a Certificate of Compliance or an Affirmative Action Plan at the same time or prior to the submission of the proof of responsibility forms. The bidder shall be disqualified if the bidder fails to or refuses to, prior to opening of the bid, submit a Certificate of compliance, Affirmative Action Plan or Affirmative Action Data Update, as applicable, as defined by Section 39.02 of the Madison General Ordinances (entitled Affirmative Action) and as required by Section 102.11 of the Standard Specifications.

Section 102.4: Proposals

No bid will be accepted that does not contain an adequate or reasonable price for each and every item named in the Schedule of Unit Prices.

A lump sum bid for the work in accordance with the plans and specifications is required. The lump sum bid musts be the same as the total amounts bid for the various items and it shall be inserted in the space provided.

All papers bound with or attached to the proposal form are considered a part thereof and must not be detached or altered when the proposal is submitted. The plans, specifications and other documents designated in the proposal form will be considered a part of the proposal whether attached or not.

A proposal submitted by an individual shall be signed by the bidder or by a duly authorized agent. A proposal submitted by a partnership shall be signed by a member/partner or by a duly authorized agent thereof. A proposal submitted by a corporation shall be signed by an authorized officer or duly authorized registered agent of such corporation, and the proposal shall show the name of the State under the laws of

which such corporation was chartered. The required signatures shall in all cases appear in the space provided therefore on the proposal.

Each proposal shall be placed, together with the proposal guaranty, in a sealed envelope, so marked as to indicate name of project, the contract number or option to which it applies, and the name and address of the Contractor. Proposals will be received at the place and until the hour on the date designated in the advertisement. When sent by mail, the sealed proposal marked as indicated above shall be enclosed in an additional envelope. Proposals sent by mail, submitted in person or otherwise delivered must be in the hands of the official conducting the letting by the hour on the date designated in the advertisement. Proposals received after the date designated will be returned to the bidder unopened.

The Bidder shall execute form ERD-7777 (R.9/03), a part of these proposal pages and submit same with the bidder's proposal, if applicable. REFER TO PROPOSAL SECTION.

Section 102.5: Bid Deposit (Proposal Guaranty)

No proposal shall be considered unless either (i) it is accompanied by a bid deposit of the character and amount described in the Advertisement for Bids or (ii) a biennial bid bond in an amount and form acceptable to the City of Madison has been previously submitted.

Bid deposits of unsuccessful bidders shall be returned following the award of the contract by the Common Council. Bid deposit of the successful bidders shall be returned within forty-eight (48) hours following execution of the contract and bond as required.

Instructions to Bidders City of Madison SBE Program Information

2 Small Business Enterprise (SBE) Program Information

2.1 Policy and Goal

The City of Madison reaffirms its policy of nondiscrimination in the conduct of City business by maintaining a procurement process which remains open to all who have the potential and ability to sell goods and services to the City. It is the policy of the City of Madison to allow Small Business Enterprises (SBE) maximum feasible opportunity to participate in City of Madison contracting. The bidder acknowledges that its bid has been submitted in accordance with the SBE program and is for the public's protection and welfare.

Please refer to the "ADVERTISEMENT FOR BIDS" for the goal for the utilization of SBEs on this project. SBEs may participate as subcontractors, vendors and/or suppliers, which provide a commercially useful function. The dollar value for SBE suppliers or 'materials only' vendors shall be discounted to 60% for purposes of meeting SBE goals.

A bidder which achieves or exceeds the SBE goal will be in compliance with the SBE requirements of this project. In the event that the bidder is unable to achieve the SBE goal, the bidder must demonstrate that a good faith effort to do so was made. Failure to either achieve the goal or demonstrate a good faith effort to do so will be grounds for the bidder being deemed a non-responsible contractor ineligible for award of this contract.

A bidder may count towards its attainment of the SBE goal only those expenditures to SBEs that perform a commer—cially useful function. For purposes of evaluating a bidder's responsiveness to the attainment of the SBE goal, the contract participation by an SBE is based on the percentage of the total base bid proposed by the Contractor. The total base bid price is inclusive of all addenda.

Work performed by an SBE firm in a particular transaction can be counted toward the goal only if it involves a commercially useful function. That is, in light of industry practices and other relevant considerations, does the SBE firm have a necessary and useful role in the transaction, of a kind for which there is a market outside the context of the SBE Program, or is the firm's role a superfluous step added in an attempt to obtain credit towards goals? If, in the judgment of the Affirmative Action Division, the SBE firm will not perform a commercially useful function in the transaction, no credit towards goals will be awarded.

The question of whether a firm is performing a commercially useful function is completely separate from the question of whether the firm is an eligible SBE. A firm is eligible if it meets the definitional criteria and ownership and control requirements, as set forth in the City of Madison's SBE Program.

If the City of Madison determines that the SBE firm is performing a commercially useful function, then the City of Madison must then decide what that function is. If the

commercially useful function is that of an SBE vendor / supplier that regularly transacts business with the respective product, then the City of Madison will count 60% of the value of the product supplied toward SBE goals.

To be counted, the SBE vendor / supplier must be engaged in selling the product in question to the public. This is important in distinguishing an SBE vendor / supplier, which has a regular trade with a variety of customers, from a firm which performs supplier-like functions on an <u>ad hoc</u> basis or for only one or two contractors with whom it has a special relationship.

A supplier of bulk goods may qualify as an eligible SBE vendor / supplier if it either maintains an inventory or owns or operates distribution equipment. With respect to the distribution equipment; e.g., a fleet of trucks, the term "operates" is intended to cover a situation in which the supplier leases the equipment on a regular basis for its entire business. It is not intended to cover a situation in which the firm simply provides drivers for trucks owned or leased by another party; e.g., a prime contractor, or leases such a party's trucks on an <u>ad hoc</u> basis for a specific job.

If the commercially useful function being performed is not that of a qualified SBE vendor / supplier, but rather that of delivery of products, obtaining bonding or insurance, procurement of personnel, acting as a broker or manufacturer's representative in the procurement of supplies, facilities, or materials, etc., only the fees or commissions will apply towards the goal.

For example, a business that simply transfers title of a product from manufacturer to ultimate purchaser; e. g., a sales representative who re-invoices a steel product from the steel company to the Contractor, or a firm that puts a product into a container for delivery would not be considered a qualified SBE vendor / supplier. The Contractor would not receive credit based on a percentage of the cost of the product for working with such firms.

Concerning the use of services that help the Contractor obtain needed supplies, personnel, materials or equipment to perform a contract: only the fee received by the service provider will be counted toward the goal. For example, use of a SBE sales representative or distributor for a steel company, if performing a commercially useful function at all, would entitle the Contractor receiving the steel to count only the fee paid to the representative or distributor toward the goal. This provision would also govern fees for professional and other services obtained expressly and solely to perform work relating to a specific contract.

Concerning transportation or delivery services: if an SBE trucking company picks up a product from a manufacturer or a qualified vendor / supplier and delivers the product to the Contractor, the commercially useful function it is performing is not that of a supplier, but simply that of a transporter of goods. Unless the trucking company is itself the manufacturer or a qualified vendor / supplier in the product, credit cannot be given based on a percentage of the cost of the product. Rather, credit would be allowed for the cost of the transportation service.

The City is aware that the rule's language does not explicitly mention every kind of business that may contribute work on this project. In administering these programs, the City would, on a case-by-case basis, determine the appropriate counting formula to apply in a particular situation.

2.2 Contract Compliance

2.3 Certification of SBE by City of Madison

The Affirmative Action Division maintains a directory of SBEs which are currently certified as such by the City of Madison. Contact the Contract Compliance Officer as indicated in Section 2.2 to receive a copy of the SBE Directory or you may access the SBE Directory online at www.cityofmadison.com/dcr/aaTBDir.cfm.

All contractors, subcontractors, vendors and suppliers seeking SBE status must complete and submit the Targeted Business Certification Application to the City of Madison Affirmative Action Division by the time and date established for receipt of bids. A copy of the Targeted Business Certification Application is available by contacting the Contract Compliance Officer at the address and telephone indicated in Section 2.2 or you may Certification Application access the **Targeted** Business online www.cityofmadison.com/dcr/aaTBDir.cfm. Submittal of the Targeted Business Certification Application by the time specified does not guarantee that the applicant will be certified as a SBE eligible to be utilized towards meeting the SBE goal for this project.

2.4 Small Business Enterprise Compliance Report

2.4.1 Good Faith Efforts

Bidders shall take all necessary affirmative steps to assure that SBEs are utilized when possible and that the established SBE goal for this project is achieved. A contractor who self performs a portion of the work, and is pre-qualified to perform that category of work, may subcontract that portion of the work, but shall not be required to do so. When a bidder is unable to achieve the established SBE goal, the bidder must demonstrate that a good faith effort to do so was made. Such a good faith effort should include the following:

- 2.4.1.1 Attendance at the pre-bid meeting.
- 2.4.1.2 Using the City of Madison's directory of certified SBEs to identify SBEs from which to solicit bids.
- 2.4.1.3 Assuring that SBEs are solicited whenever they are potential sources.
- 2.4.1.4 Referring prospective SBEs to the City of Madison Affirmative Action Division for certification.
- 2.4.1.5 Dividing total project requirements into smaller tasks and/or quantities, where economically feasible, to permit maximum feasible SBE participation.
- 2.4.1.6 Establishing delivery schedules, where requirements permit, which will encourage participation by SBEs.
- 2.4.1.7 Providing SBEs with specific information regarding the work to be performed.
- 2.4.1.8 Contacting SBEs in advance of the deadline to allow such businesses sufficient time to prepare a bid.

- 2.4.1.9 Utilizing the bid of a qualified and competent SBE when the bid of such a business is deemed reasonable (i.e. 5% above the lowest bidder), although not necessarily low.
- 2.4.1.10 Contacting SBEs which submit a bid, to inquire about the details of the bid and confirm that the scope of the work was interpreted as intended.

2.4.2 Reporting SBE Utilization and Good Faith Efforts

The Small Business Enterprise Compliance Report is to be submitted by the bidder in a separate sealed envelope marked: "ENVELOPE 2 - SBE COMPLIANCE REPORT." This report is due by the specified bid closing time and date. Bids submitted without a completed SBE Compliance Report as outlined below shall be deemed non-responsible and the bidder ineligible for award of this contract.

- 2.4.2.1 If the Bidder <u>meets or exceeds</u> the goal established for SBE utilization, the Small Business Enterprise Compliance Report shall consist of the following:
 - 2.4.2.1.1 **Cover Page,** Page C-7; and
 - 2.4.2.1.2 Summary Sheet, C-8.
- 2.4.2.2 If the bidder <u>does not meet</u> the goal established for SBE utilization, the Small Business Enterprise Compliance Report shall consist of the following:
 - 2.4.2.2.1 **Cover Page**, Page C-7;
 - 2.4.2.2.2 **Summary Sheet,** C-8; and
 - 2.4.2.2.3 **SBE Contact Report,** C-9 and C-10. (A <u>separate</u> Contact Report must be completed for <u>each applicable</u> SBE which is <u>not</u> utilized.)

2.5 Appeal Procedure

A bidder which does not achieve the established goal and is deemed <u>non-responsible</u> for failure to demonstrate a good faith effort to achieve such goal and subsequently denied eligibility for award of contract may, within 72 hours of receiving such notification, appeal that decision to a special appeals committee composed of three (3) members of the Affirmative Action Commission, three (3) members of the Board of Public Works and a seventh member appointed by the Mayor. All appeals must be made in writing to the City Engineer and <u>received</u> within 72 hours of City of Madison's notice. Postmark not applicable.

2.6 SBE Requirements After Award of the Contract

The successful bidder shall identify SBE subcontractors, suppliers and vendors on the subcontractor list in accordance with the specifications. The Contractor shall submit a detailed explanation of any variances between the listing of SBE subcontractors, vendors and/or suppliers on the subcontractor list and the Contractor's SBE Compliance Report for SBE participation.

No change in SBE subcontractors, vendors and/or suppliers from those SBEs indicated in the SBE Compliance Report will be allowed without prior approval from the Engineer and the Affirmative Action Division. The contractor shall submit in writing to the City of Madison Affirmative Action Division a request to change any SBE citing specific reasons which necessitate such a change. The Affirmative Action Division will use a general test of reasonableness in approving or rejecting the contractor's request for change. If the request is approved, the Contractor will make every effort to utilize another SBE if available.

The City will monitor the project to ensure that the actual percentage commitment to SBE firms is carried out.

2.7 SBE Definition and Eligibility Guidelines

A Small Business Enterprise is a business concern awarded certification by the City of Madison. For the purposes of this program a Small Business Enterprise is defined as:

- A. An independent business operated under a single management. The business may not be a subsidiary of any other business and the stock or ownership may not be held by any individual or any business operating in the same or a similar field. In determining whether an entity qualifies as a SBE, the City shall consider all factors relevant to being an independent business including, but not limited to, the date the business was established, adequacy of its resources for the work in which it proposes to involve itself, the degree to which financial, equipment leasing and other relationships exist with other ineligible firms in the same or similar lines of work. SBE owner(s) shall enjoy the customary incidents of ownership and shall share in the risks and profits commensurate with their enjoyment interests, as demonstrated by an examination of the substance rather than form or arrangements that may be reflected in its ownership documents.
- B. A business with annual gross receipts of less than \$750,000 when averaged over the past three year period;

Firm and/or individuals that submit fraudulent documents/testimony may be barred from doing business with the City and/or forfeit existing contracts.

SBE certification is valid for one (1) year unless revoked.

SECTION D: SPECIAL PROVISIONS

WEST GORHAM STREET, N. HENRY STREET & N. FRANCES STREET ASSESSMENT DISTRICT - 2012 CONTRACT NO. 6785

It is the intent of these Special Provisions to set forth the final contractual intent as to the matter involved and shall prevail over the Standard Specifications and plans whenever in conflict therewith. In order that comparisons between the Special Provisions can be readily made, the numbering system for the Special Provisions is equivalent to that of the Specifications.

Whenever in these Specifications the term "Standard Specifications" appears, it shall be taken to refer to the City of Madison Standard Specifications for Public Works Construction and Supplements thereto.

SECTION 102.10: MINIMUM RATE OF WAGE SCALE

For this project, payment of prevailing wages (white sheet) is not required if either: a single trade accounts for 85% or more of the total labor costs of the project and the bid is less than \$48,000; or no single trade accounts for 85% or more of the total labor costs of the project and the bid is less than \$100,000. For bids not meeting either of these conditions, prevailing wages shall be required.

If required, the wages and benefits paid on the contract shall not be less than those specified in the Prevailing Wage Determination included with these contract documents for the following types of work:

	Building and Heavy Construction
	Sewer, Water, and Tunnel Construction
\boxtimes	Local Street and Miscellaneous Paving Operations
	Residential and Agricultural Construction

All bidders are notified that all labor employed on City contracts must be paid in accordance with the minimum rate of wage scale included in the Contract Documents.

For the information of the employees working on the project, a copy of the wage scale included in the contract documents and the provisions of Section 66.0903(8) of the Wisconsin Statutes shall be kept posted by the employer and in at least one conspicuous and easily accessible place at the site of the project.

The Contractor shall keep weekly payroll records setting forth the name, address, telephone number, classification, wage rate and fringe benefit package of each employee who worked on such City project and all other projects the employee worked in the same period, and the Contractor must keep records of the individual time each employee worked on the project and for each day of the project. Such records shall also set forth the total number of hours of overtime credited to each such employee for each day and week and the amount of overtime pay received in that week. Such records shall, in addition, set forth the full weekly wages earned by each such employee and the actual hourly wage paid to that employee. The Contractor shall submit payroll records to the Engineer every week for those periods when work is being done on the project. Said submittal shall be within twenty-one (21) calendar days of the end of the Contractor's weekly pay period.

The Contractor shall ensure that employees shall be paid unconditionally and shall receive the full amounts accrued at the time of payment, computed at rates not less than those stated in the City of Madison "Minimum Rate of Wage Scale" and that each employee's rate shall be determined by the work that is done within the trade or occupation classification which should be properly assigned to such

employee. Questions regarding an employee's classification or rate of pay within that classification, shall be resolved by the practice that predominates in the industry and on which the trade or occupation rate/classification is based. Therefore, rate of pay, classification and work jurisdiction disputes shall be resolved by relying upon practices established by collective bargaining agreements and guidelines used in such determinations by appropriate recognized trade unions operating within the City of Madison.

The Contractor shall agree that the normal rate of wage paid to the Contractor's employees on other projects shall not be reduced or otherwise diminished as a result of the requirement to pay no less than the minimum rate of wage scale on a City project. Mulcting of employees on City projects by Contractors, such as by kickbacks or other such devices, is prohibited.

These contract provisions shall apply to all work performed on the contract by the Contractor with its own organization and with assistance of laborers under its immediate superintendency and to all work performed by piecework or by subcontract. No laborer, worker, or mechanic shall be employed directly upon the site of the work except on a wage basis, but this shall not be construed to prohibit the rental of equipment from individuals.

In the event of a refusal by the Contractor to submit payroll records as required by the contract, the City of Madison shall have the option to cancel this contract and request the Surety to perform or to relet the balance of the work for bids, and in that event, to charge the Contractor for any loss which the City may incur thereby.

SECTION 102.12 BEST VALUE CONTRACTING

This Contract shall be considered a Best Value Contract if the Contractor's bid is equal to or greater than \$51,500 for a single trade contract; or equal to or greater than \$251,000 for a multi-trade contract pursuant to MGO 33.07(7).

ARTICLE 104 SCOPE OF WORK

The work under this contract shall include installation of storm and sanitary sewer systems, water main, curb and gutter, concrete terrace, base preparation, asphalt pavement, drive aprons, sidewalk and street lighting.

The project includes the reconstruction of approximately 450 ft of roadway including underground utilities and 1,800 ft of sidewalk and terrace improvements including tree grates and pedestrian lighting.

The project limits for the work are:

W Gorham Street: from State Street to N Henry Street (sidewalk and terrace)

N Henry Street: from State Street to W Gorham Street (reconstruction)

N Frances St: from University Avenue to State Street cul-de-sac (sidewalk and terrace)

N Frances St: from Langdon Street to State Street cul-de-sac (reconstruction)

Also included is the spot replacement of specialty sidewalk on the 400 block of North Lake Street and 500 block of State Street.

The Contractor shall view the site prior to bidding to become familiar with the existing conditions. It will be the responsibility of the Contractor to work with the utilities located in the right of way to resolve conflicts during the construction process.

SECTION 104.6 DECREASED AND DELETED ITEMS

The electrical quantities include estimates for work that may or may not be required. If actual quantities are less than estimated, or if items are deleted from the contractor's work, the decreased quantities or deleted items shall not constitute the basis for a claim for damages for anticipated profits for the work dispensed with.

SECTION 105.1 <u>AUTHORITY OF THE ENGINEER</u>

The Engineer shall resolve all questions which arise as to the quality and acceptability of materials furnished, work performed, manner of performance, rate of progress of the work, interpretation of the plans and Specifications, acceptable fulfillment of the contract, compensation, and disputes and mutual rights between Contractors under the Specifications. The Engineer shall determine the amount and quantity of work performed and materials furnished.

All decisions of the Engineer shall, when so requested, be rendered in writing. They shall be final and conclusive in all matters unless within ten (10) days after such decision the Contractor applies in writing to the Board of Public Works for a review of such decision.

Any change proposed by a Contractor in SBE subcontractors, vendors or suppliers from those SBEs indicated on the SBE Compliance Report must be approved by the Engineer and the City's Manager of the Affirmative Action Division (hereafter, AAD). When requested, such decision shall be rendered in writing. Such decisions shall be final and conclusive in all matters unless within ten (10) days after such decision the Contractor or the affected SBE applies in writing to the Board of Public Works for a review of such decision.

In the event the Engineer and the AAD disagree over the proper decision to be made regarding an SBE, the Mayor shall appoint a third person to resolve the disagreement, within 30 days of appointment. The decision thus rendered may be reviewed by the Board of Public Works upon request of the Contractor or the affected SBE as set forth in Sections 105.1 and 105.2 of the City's standard specifications.

SECTION 105.12 COOPERATION BY THE CONTRACTOR

The City of Madison has contracted work that will be undertaken by others in the same time frame and the same area as the proposed project, specifically City of Madison contract #6577, on North Frances Street (Langdon Street to Lake Mendota). It shall be the Contractor's responsibility to verify this information and any subsequent changes in the scheduling of the work by others and to make corrections in his/her construction timetable as required.

As part of this contract, repair of "C1 Structural Concrete" shall be completed on the 500 block of State Street and "C1 Concrete" shall be installed on the 400 block of Lake Street. Work on the 500 block of State Street will be in coordination with MG&E gas service replacement. MG&E gas contact, Don McClain, at (608) 252-5618 shall be contacted with any questions on the schedule of MG&E's work. The contractor shall replace the structural concrete removed by MG&E during their service replacement. Details of structural concrete section replacement can be seen in the construction detail drawings. Work on the 400 block of Lake Street will be the removal of a concrete patch in the sidewalk terrace and replacement with "C1 concrete". For both locations, concrete waste management practices shall apply.

MG&E Electric – Mark Bohm (608-252-4730)

MG&E electric work shall be completed with this project. The Contractor shall coordinate their work to allow access to the utility company to install new facilities and resolve any conflicts that may arise. Known work will take place at electrical vault locations to adjust manhole and hatch elevations.

Overhead to Underground Utility Conversion

Charter Communications - Jon Marschke (608) 274-3822 ext. 6734

MG&E and Charter Communications will be burying overhead utility service lines on N Frances St (University Ave to State St cul-de-sac). This work includes one utility pole removal and street trenching near 408 N Frances Street. The Contractor shall review the extents of the utility work with the utility companies and schedule the utility work into their construction schedule. Any additional time shall be agreed upon between the Contractor and the Engineer before work begins.

The Contractor shall use care around existing trees, plantings, fences, walls, steps and driveways that are indicated on the plans to remain. Damage to these items during construction shall be repaired or replaced at the Contractor's expense. No trees, other than those shown on the plan to be removed, shall be cut without the approval of the Engineer and the City Forester; the abutting property owners shall be notified in accordance with the City's Administrative Procedure Memorandum No. 6-2.

The Contractor shall maintain access for mail delivery and garbage/recycling pickup for all properties in the project area.

No utility work, utility disruption or sidewalk construction can commence in front of an entrance without notifying the business a minimum of 48 hours in advance. Utilities or entrances shall not be shut down during the business open times unless approved by the business and the Engineer. For any replacement of the main line sidewalk directly in front of a business, bridges shall be provided to enter all building entryways. Sidewalk closures with five feet of a businesses' entrance providing lunch service shall be prohibited between the hours of 11:00am and 1:00pm. Contractor shall coordinate utility lateral work with Businesses to provide access at all times, and perform work in businesses' desired time frames as much as possible. Specifically, water lateral reconnections shall be coordinated with all business to minimize interruption.

Contractor shall install and maintain up to 4 "Business Open" signs on the project. Signage will be provided to contractor. Contractor may need to support with plywood, post, etc. Along with the business open signs, businesses shall be allowed to place business signs within the project limits. Sign placement shall be coordinated to place signs in a location of visibility.

As part of the North Frances Street (Langdon Street to south cul-de-sac) project, the contractor shall obtain and bag parking meters on Langdon Street per the maintenance of traffic specifications to provide a drop off and pick up location for the Campus Inn hotel at 601 Langdon Street during construction. Access to the two parking lots shall be maintained at all times.

Bus stops shall be maintained at all times as directed by the Engineer. When work is being performed adjacent to existing bus stops, a bus stop loading area shall be provided next to the adjacent travel lane. The contractor shall provide an accessible area for bus riders to board the bus. Madison Metro contact: Tim Sobota (608) 261-4289.

All staging and construction equipment must be stored within project limits

The Contractor shall hold weekly progress meetings with the Engineer, affected utilities, contractor on adjacent project and interested area businesses and residents. The progress meetings are intended to give updates regarding the progression of work and timing of various traffic control stages.

Maxwell Street Days are from 6:00 AM July 20, 2012 to 9:00 PM July 22, 2012. The Contractor shall not work on these days and shall remove all equipment; barricades and other items that will impede the

free flow of pedestrians during Maxwell Street Days (on West Gorham Street). The entire Street Right of Way shall be made available for Maxwell Street Days. The Contractor shall fill between the remaining concrete terrace and new curb with crushed stone to provide a walkable surface to access the street. Contractor shall limit excavation behind the existing curb to minimize fill needed. Crushed stone for fill will be paid under the corresponding bid item and shall be reused on the job. The Contractor shall leave existing tree grates, if any, in place until after Maxwell Street Days. The Contractor shall transition all surfaces to blend, including street areas for safe pedestrian movements. If the area is under construction, the Contractor shall present a plan of what W. Gorham Street will look like 10 days prior to the event to the Engineer.

The contractor shall avoid work around the following events/dates (addition to the above):

SECTION 107.7 <u>MAINTENANCE OF TRAFFIC</u>

All traffic control shall conform to Part VI of the Federal Highways Administrations "Manual on Uniform Traffic Control Devices" (MUTCD), the State of Wisconsin Standard Facilities Development Manual (including Chapter 16 – Standard Detail Drawings) and the City of Madison Standards for sidewalk and bikeway closures.

The Contractor shall submit an acceptable, complete Traffic Control Plan, including all necessary phases and any required sidewalk or bike route closures, to the office of the City Traffic Engineer, at 215 Martin Luther King, Jr. Blvd, Suite 100, Madison, WI 53703, a minimum of five (5) working days, prior to the pre-construction meeting. The Traffic Control Plan shall address all requirements of this section of the Special Provisions. The contractor shall not start work on this project until the Traffic Engineering Division has approved a traffic control plan and traffic control devices have been installed, in accordance with the approved plan. Failure of the Contractor to obtain approval of a Traffic Control Plan, as specified above, may prevent the Contractor from starting work and shall be considered a delay of the project, caused by the Contractor.

The Contractor will be responsible for installing and maintaining traffic control in accordance with the Traffic Control Plan and as directed by the City Traffic Engineer. The Contractor shall install and maintain modifications or additions to the traffic control, as directed by the City Traffic Engineer, at no cost to the City.

300 block of N Henry St may be closed to through traffic within the project limits for the duration of the project. Local and emergency vehicle access to all properties shall be maintained at all times. Pedestrian traffic to all properties shall be maintained at all times.

No work shall encroach into or impact traffic lanes on Johnson St during peak traffic hours (7:00 AM - 9:00 AM and 3:00 PM - 6:00 PM, weekdays) and on days with special events.

When 300 block of N Henry St is closed, a 50-foot loading zone shall be maintained on south side of 200 block of W Gorham St at all times. The zone shall be signed as TRUCK LOADING ZONE.

When parking on 300 block of N Henry St is removed, the following alternate parking signs shall be provided to direct traffic to State Street Capitol Parking Garage:

- North side of eastbound Johnson St before State St: "HENRY ST ALTERNATE PARKING" sign with straight arrow
- South side of eastbound Johnson St before Henry St: "HENRY ST ALTERNATE PARKING" sign with straight arrow
- South end of 300 block of N Henry St, on type III barricade: "HENRY ST ALTERNATE PARKING" sign with right arrow

500 block of N Frances St may be closed to through traffic within the project limits for the duration of the project. Local and emergency vehicle access to all properties shall be maintained at all times. Pedestrian traffic to all properties shall be maintained at all times.

Langdon St shall remain open to two lanes of traffic, one lane for each direction, at all times during construction. The sidewalk shall remain open at all times on both sides of Langdon St. When necessary for construction at the Frances-Langdon intersection, Langdon St may be reduced to one lane of traffic during off peak hours (peak hours are defined as 7:00 AM - 9:00 AM and 3:00 PM - 6:00 PM, weekdays) provided that properly equipped and trained flag persons are present and proper signage is in place in accordance with MUTCD.

When 500 block of N Frances St is closed, a 50-foot loading zone shall be maintained on north side of 200 block of Langdon St (near Frances St) at all times. The zone shall be signed as PASSENGER LOADING ZONE.

400 block of N Frances St shall remain open to two lanes of traffic, one lane for each direction, at all times during construction. Local and emergency vehicle access to all properties shall be maintained at all times. The sidewalk shall remain open at all times on both sides of the street. The total parking lane closure time shall be limited to a maximum of three (3) weeks.

No work shall encroach into or impact traffic lanes on University Ave during peak traffic hours (7:00 AM - 9:00 AM and 3:00 PM - 6:00 PM, weekdays) and on days with special events.

When parking lanes on 400 block of N Frances St are closed, a 50-foot loading zone shall be maintained at south end of the block and another 50-foot loading zone at the north end of the block at all times. The zones shall be signed as FREIGHT LOADING ZONE.

At least two lanes of traffic shall be maintained on W Gorham St during peak traffic hours (7:00 AM – 9:00 AM and 3:00 PM – 6:00 PM, weekdays) and for days with special events. At least one lane of traffic shall be maintained on W Gorham St during non-peak traffic hours. Local and emergency vehicle access to all properties shall be maintained at all times. The sidewalk shall remain open at all times on both sides of the street. The total lane closure time shall be limited to a maximum of three (3) weeks.

When the south parking lane on 200 block of W Gorham St is closed, a 50-foot loading zone shall be maintained at south side of the street at all times. The zones shall be signed as TRUCK LOADING ZONE.

The contractor shall post and maintain business open signs as required.

The contractor shall call Parking Utility Maintenance Supervisor (Dan Valenza, 266-4744), a minimum of seven (7) days in advance of when any existing parking facilities need to be removed.

The contractor shall call Parking Utility (John Villarreal, 267-8756), a minimum of three (3) days in advance of when any parking meter hoods are needed.

The work areas shall be backfilled, plated, or protected by traffic control devices during non-working hours. If steel plates are used, the Contractor shall notify the City of Madison Streets Division, 266-4681, 1 working day prior to placement of the plates.

The Contractor shall provide ADA/Handicap Accessible pedestrian access at all intersections within the construction area at all times. Sidewalks shall be maintained on at least one side of the street at all times unless otherwise required.

The Contractor may remove parking within the project limits as indicated on the Traffic Control Plan. The Contractor shall be responsible for posting and maintaining NO PARKING signs in accordance with City of Madison Police Department's "Guidelines for Temporary No Parking Restrictions for Construction or Special Events".

No construction equipment or materials shall be stored in the roadway or street right-of-way that is open to traffic during non-working hours. Construction equipment and materials are not to be stored within the street right-of-way that is outside the project limits as shown on the approved plan.

Contact Yang Tao, Traffic Engineering Division, 266-4815, with any questions concerning these traffic control specifications.

SECTION 107.8 NOTIFICATION WHEN STREET CLOSING

The Contractor shall not remove traffic signs. For removal or replacement of traffic and parking signs, contact the City of Madison Traffic Engineering Field Operations, 1120 Sayle Street, 266-4767, 8:00 a.m. to 4:00 p.m., a minimum of twenty-four (24) hours in advance of when any existing signs need to be removed. This service is provided free of charge. If the Contractor removes the signs, the Contractor will be billed for the reinstallation of, and any damage to, the signing equipment.

SECTION 107.10 OPENING OF SECTION OF HIGHWAY TO TRAFFIC

Upon completion of all concrete work, final surface course of pavement, landscaping, topsoil, seed or sod, the City Construction Engineer shall certify that it is complete and shall contact the City of Madison Traffic Operations Section, 266-4767. The City of Madison Traffic Engineer shall have seven (7) working days to complete the signing and marking so that the street is ready to open to traffic. The Contractor shall leave all barricades in place until such time that the permanent pavement marking and signing has been installed by the City. The City shall notify the Contractor when the final pavement marking and signing is complete and the Contractor shall remove all temporary construction signs and barricades within 24 hours of the notification.

SECTION 109.2 PROSECUTION OF WORK

The Contractor shall begin work on or before <u>MAY 21, 2012</u>. The total time of completion of the contract shall be <u>SEVENTY-FIVE (75) CALENDAR DAYS</u>.

Work on North Henry Street shall be completed by **JUNE 15, 2012**.

Work on West Gorham Street and North Frances Street (University Avenue to State Street cul-de-sac) shall be limited to <u>TWENTY-ONE (21) CONSECUTIVE CALENDAR DAYS</u> for each separate block of work following Section 107.7 Maintenance of Traffic herein these specifications unless approved by the Engineer.

Work on North Frances Street (Langdon Street to State Street cul-de-sac) shall start on or after <u>JUNE 4</u>, <u>2012</u> and shall be completed within <u>THIRTY-FIVE (35) CALENDAR DAYS</u>.

Daily work hours on North Frances Street (Langdon Street to State Street cul-de-sac) and North Frances Street (University Avenue to State Street cul-de-sac) shall begin no earlier than 8:00 A.M.

Work shall begin only after the start work letter is received.

SECTION 203.2 <u>DISPOSING OF MATERIALS</u>

The Contractor shall comply with Section 203.2 of the City of Madison Standard Specifications for Public Works Construction with regard to salvaging castings.

BID ITEM 20323 - REMOVE CONCRETE SIDEWALK AND DRIVE

Removal of brick pavers in areas where they will not be reset, specifically on N Frances Street (University Ave to State Street cul-de-sac) and in areas of new tree grates and pedestrian lighting in front of 601 Langdon Street shall be paid under this item. All work associated with removal, salvaging and replacement of brick pavers will be paid under a separate bid item.

BID ITEM 20336 - PIPE PLUGS

Structures and pipes called out for removal and/or abandonment shall have the existing pipes plugged at the structure or at the pipe ends, as noted in the plans, and shall be paid for under this bid item. This includes plugs necessary to abandon sanitary sewer laterals. All work under this item shall comply with Article 203 of the Standard Specifications.

ARTICLE 301 CONCRETE AND CONCRETE MATERIALS

HIGH EARLY STRENGTH CONCRETE

This special provision describes the use of high early strength concrete in accordance with the requirements of the standard specifications and as hereinafter provided.

High early strength concrete (on curb, driveway & sidewalks) shall be used to meet the established contract schedule and maintain access to commercial drives within the project limits. All use of high early strength concrete shall be incidental to the specific bid item.

All concrete used on City of Madison Public Works projects shall comply with the following subsections of Article 501, "Concrete" of the latest edition of the Standard Specifications for Highway and Structure Construction of the State of Wisconsin, Department of Transportation, Division of Highways:

501.2 Materials

501.3 Construction

ARTICLE 501 STORM SEWER STRUCTURES

501.1 Description

STORM SEWER GENERAL

The storm sewer designer for this project is Corey Stelljes. He may be contacted by phone at (608) 266-9721 or by email at cstelljes@cityofmadison.com.

Reconnection of existing pipes at new structures, or new pipes at new structures, shall be considered to be part of the work required to construct the new structure or to construct the new sewer pipe and shall not be rewarded with additional compensation. However, if the structure being removed is larger than the new structure, thus requiring additional pipe, the new pipe shall be paid under the appropriate bid item and the connection of the old pipe to the new pipe shall be accomplished with a concrete collar.

Where a new structure is to be constructed at an existing pipe, it is expected that the contractor shall saw cut the existing pipe in the required location to accommodate the placement of the new structure. If the contractor for his/her convenience deems it more suitable to remove the existing pipe to a full joint, the additional pipe and concrete collar required to reconnect to the new structure shall be the contractor's responsibility and shall not be compensated.

Connection of new pipes to existing structures shall be accommodated with a Storm Sewer Tap – Bid Item 50792.

If there are structures where the pipe walls are to be poured into the structure roof or both the pipe walls and the structure casting are to be poured in the structure roof, the Contractor shall not be provided additional compensation for complying with the structure requirements detailed on the storm sewer chart and plans.

Precast structures are only allowed where field poured structures are not specifically called for, and no precast structures are allowed until ULO's are completed and approval of the design engineer has been received.

SANITARY SEWER GENERAL

THE SANITARY SEWER DESIGNER FOR THIS PROJECT IS COREY STELLJES (608) 266-9721.

Sanitary sewer pipe work shall include installing approximately 161 feet of new 10" PVC and 9 sanitary laterals.

All new sanitary sewer access structures shall include Neenah R-1550 castings with the new City of Madison casting detail (see S.D.D. 5.7.16) of the City of Madison Standard Specifications for Public Works Construction 2012 ed. All new sewer main connections may be factory cored and shall be included in the structure. All existing main connections shall be field cored to

accommodate existing conditions and shall be compensated under BID ITEM 50791 SANITARY SEWER TAP. All sewer main and/or laterals not slated for replacement that are damaged during the installation of a structure shall be replaced by the Contractor and shall be considered incidental to the project. All benches and flowlines shall have a smooth trowel finish.

It is advised that the Contractor visit the site prior to bidding to determine the type of trench protection that will be necessary for the sanitary sewer main installation.

BID ITEM 50353 - SANITARY SEWER LATERAL

All work associated with this bid item shall comply with Article 503 of the Standard Specifications. Any terrace restoration (topsoil, seed and mulch) required to restore the grassy areas where disturbed for lateral construction, shall be considered incidental to SANITARY SEWER LATERAL.

The sewer lateral at 201 W Gorham St has been located and surveyed prior to design. Laterals that were located are marked on the plan set as "LAT LOCATED". All other laterals were located from City records. Per the City of Madison Standard Specifications for sanitary sewer lateral construction on street reconstruction projects, Contractors are encouraged to begin installation of sanitary lateral pipe at the proposed sewer main. If the Contractor starts excavation for the lateral at the property line, it shall be at the Contractor's risk. No Utility Line Openings (ULOs) will be granted for the inability to locate the sanitary lateral at the property line. Any extra sidewalk removal caused by looking for an existing sanitary lateral at the property line will not be compensated to the Contractor. Contractors are encouraged to have a locator device on-site if they intend to start laying lateral pipe at the property line to minimize the amount of extra sidewalk removal. Each sanitary lateral shall have a maximum of 4 sidewalk squares and 20' of curb and gutter removed and replaced. No additional compensation shall be awarded beyond this amount for the replacement of a sewer lateral.

BID ITEM 50390 SEWER ELECTRONIC MARKERS

With regard to the City of Madison Standard Specifications for Public Works Construction 2012 Edition Section 503.3(c), each sanitary lateral shall have a minimum of two (2) electronic markers with the City providing the Contractor with the required number of electronic markers. For sanitary laterals, which only include the installation of a wye, a marker ball shall be installed directly above the wye connection to the main.

BID ITEM 50903 – FURNISH AND INSTALL CIPP TO REHABILITATE 10" VP SAN

Work under this item shall include lining existing 10" VP sanitary sewer on N Henry St from Ex SAS #4950-032 to SAS#2 with Cured-in-Place Pipe (CIPP). Work shall be in accordance with Article 509 of the Standard Specifications. Files (mpg) of the CCTV inspection of the existing storm sewer are available for review by the Contractor at ftp://ftp.cityofmadison.com/, in the folder called Henry Sanitary. To access the ftp site, use Username "cityftp" and password "2upload!".

After you have accessed the site, find the directory called "Henry Sanitary." Copy the video files onto your hard drive, and you may view the videos. If you have problems, the videos will be available on DVD's or CD's upon request.

Any additional spot repairs of damaged sections of pipe (either shown on the TV report above, or incurred prior to or during construction) required to successfully line the pipe shall be considered incidental to this bid item. Cleaning of the pipe as needed to complete the lining shall be considered incidental to this bid item. Contractor is encouraged to complete pipe lining at the start of the project to avoid damage to the existing VPs during construction activities.

METHOD OF MEASUREMENT

Furnish and Install CIPP to rehabilitate 10" VP San shall be measured as complete when each completed unit is installed in the field.

BASIS OF PAYMENT

Furnish and Install CIPP to rehabilitate 10" VP san shall be measured as described above and shall be paid for at the contract price which shall be full compensation for all work, materials, labor, and incidentals required to complete the work as set forth in the description.

SECTION 601 ELECTRICAL, GENERAL REQUIREMENTS

The existing signal and lighting poles, conduits, handholes, and manholes not scheduled for removal or abandonment shall be protected during construction. If the contractor believes that damage to such facilities is unavoidable, the contractor shall not damage or remove any facilities until the City Traffic Engineering electrical inspector has reviewed and approved such actions. Any damage or removal of City electrical conduit, wire, fiber, or structures, without the specific approval by the City Traffic Engineering electrical inspector shall be promptly repaired or replaced by and at the expense of the contractor. The City may elect to do repair work with City crews. The cost for any repair work done by the City will be billed to the contractor.

Any damage or removal of City street lighting facilities shall be repaired or replaced within 24 hours, but any resulting street light outage resulting from such damage or removal shall be confined to as few numbers of street lights as possible. The streetlight circuits shall remain operational each and every night. If any street light outage continues beyond 24 hours, the City shall have the right to make temporary or permanent repairs, with the full cost of such work, including engineering time, billed to the general contractor.

The City of Madison Traffic Engineering Division will remove existing and install new lighting poles as necessary and install wire for new street light operation. The contractor shall fully cooperate with the City in staging the work so that existing lights remain operational until the new lights on the opposite side of the road are operational.

Unless a manhole (utility access structure) or handhole is specifically designated for removal, it shall be saved. Not all fiberoptic, signal and lighting structures and conduit are being removed or abandoned in the project area. The contractor shall consult with the Traffic Engineering Electrical Inspector before removing or damaging any existing facilities.

SECTION 601.10 MATERIALS FURNISHED BY THE CITY OF MADISON

The following electrical materials will be furnished to the Contractor at the Traffic Operations Shop, 1120 Sayle Street. The Contractor shall notify the Traffic Operations Shop (Dennis Rowe at 266-9034) twenty four (24) hours prior to picking up any materials. Complete quantities of an item shall be picked up on one appointment unless Dennis Rowe agrees to a partial quantity disbursement.

3/4" x 24" Anchor Bolts: 76 1" x 40" anchor bolts: 16

Steel Base for Multi-Space Parking Meters: 4

SECTION 602.4(b) ELECTRICAL CONDUIT

Item 60241, Gopher Raceway, shall include any and all work associated with determining locations of existing utilities, such as underground locates. Item 60241 shall include raceways created by pushing, gophering or boring. The measured quantity will only include distances installed directly underneath curb and gutter, roadway, and sidewalk sections that are not removed or constructed with this project. Minor alterations in conduit location may be made by the City Traffic Engineering Electrical Inspector to avoid gopher installation.

Where curb and gutter is being replaced, the new conduit to be installed parallel to the curb and gutter shall be placed according to the Typical Conduit Installation detail shown on the plan sheet. When existing utilities preclude placing conduit as shown in the detail, the conduit shall be placed under the curb or as close to the curb as possible.

When curb and gutter is not being replaced, the new conduit to be installed parallel to the curb and gutter shall be placed in the roadway, three feet from the edge of gutter, and as approved by the City Traffic Engineering Electrical Inspector.

Conduit depth within five feet of entering or leaving any handhole shall be 40 inches.

SECTION 604 BASES FOR STREET LIGHTING UNITS

The bid items for LB-3 and LB-3 Modified bases shall include cutting existing conduit and wire, pulling back and saving existing wire, and extending existing conduit and wire into each new base where streetlight conduit and/or wire already exists. Existing street light conductors shall be saved and reused. Any existing wire that is damaged or removed by the contractor when it could have been reused shall be replaced by the contractor at no expense to the City. All work associated with installing conduit connection between existing conduit and new base, saving and reusing existing wire or removing existing wire from conduit is incidental to the bid items for LB-3 and LB-3 Modified bases.

ARTICLE 607 ELECTRICAL HANDHOLES

The contractor shall furnish Type I and V handholes conforming to this section and the Standard Detail Drawings. Electrical Handhole, Type I shall be gray colored polymer concrete construction. Box dimensions for Type I shall be 19" wide X 32" long X 24" deep and come with a cover rated to withstand 15,000 lbs over a 10" square with a minimum test load of 22,568 lbs. Electrical Handhole, Type V, shall be gray colored polymer concrete construction. Box dimensions shall be 26" wide by 38" long by 24" deep. The box and cover shall be rated at 15,000 lbs over a 10" square with a minimum test load of 22,568 lbs.

SECTION 701 PROVISIONS FOR WATER INSTALLATION AND ABANDONMENT

The project consists of work in two locations. The first location is North Frances Street between State and Langdon Streets. This portion of the project consists of furnishing and installing 8-inch ductile iron water main on North Frances Street from the cul de sac just north of State Street to the intersection with Langdon Street. The second location is North Henry Street between State and Gorham Streets. This portion of the work consists of abandoning the existing 4-inch cast iron water main and re-connecting all service laterals off the 4-in main onto the existing 12-in ductile iron main. Both locations will include the abandonment of old main including water valves and hydrants.

Once the new systems have passed the pressure and water quality tests, cut off, extend as necessary, and reconnect the existing water service laterals to the new water mains unless the service is to be abandoned. All services that may require relocation due to conflicts with trees or any other issue must authorized and the new location approved in advance by the Water Utility inspector. Any broken curb stops, buried curb boxes or otherwise dysfunctional service components must be approved for adjustment, removal and/or replacement by the Water Utility inspector in advance of any work being performed.

Water Shut-Off Notification

Notify all affected users of water shut-offs per the Standard Specifications. Coordinate planned outages with all building representatives and businesses and ensure all owners and tenants of affected properties are properly noticed. Work with businesses to find mutually agreeable timeframes for water shut offs. The contractor is responsible for ensuring ALL affected customers are properly noticed. No premium or extra compensation shall be paid for work performed outside of normal working hours to make such accommodations.

Coordinate all outages affecting the Campus Inn at 601 Langdon Street with General Manager Bill Wellman at (608) 257-4391.

Coordinate all outages affecting The Towers at 502 North Frances Street with Area Manager Peter Feltman at (608) 257-0701.

Coordinate all outages affecting Vientiane Palace at 151 West Gorham Street with owner Lee Madden at (608) 345-3998.

Special Service Notes

156 West Johnson: The 1-inch service to 156 West Johnson Street shall be abandoned and the curb stop removed per section 704.31 of the Standard Specifications. A new 1-inch copper service shall be installed to replace the abandoned service. The new service shall be tapped off the existing 12-in water main as shown on the plans. Place the curb stop 8 feet off the property line and lay the service such that there is a minimum 5 feet clearance from proposed tree grates.

151 West Gorham: The existing 2-inch lateral serving 151 West Gorham Street shall be abandoned from the 4-inch main to and including the curb stop. Replace the lateral with a new 6-inch service. Cap the 6-inch service 8 feet off the property line with a MJ cap tapped with a 2-inch corporation stop. Re-connect the existing service to the new 2-inch corporation stop. The existing curb stop shall be removed and incidental to the installation of the 6-inch service. The 6-inch service shall be paid per Bid Item 70002: Furnish and Install 6-inch Pipe & Fittings. The tapped cap, stop, 2-inch copper, all other required fittings and the reconnection to the existing 2-inch service shall be paid per Bid Item 90160.

302 State Street: The existing 3/4" lateral to 302 State Street is not in service. DO NOT re-connect the service. DO NOT abandon the curb stop due to its location in the recently hardscaped State Street Mall Area.

265 Langdon Street: The proposed 4-inch lateral serving 265 Langdon Street must be installed and in service before the storm sewer work between Stations 10+00 and 10+90 on Frances Street may occur.

Protection of Existing Water Utility System

Take all necessary precautions to protect the existing Madison Water Utility system and ensure its proper functioning during construction. Note that some of the existing water main dates back to the 1800's.

Special Bid Items

Bid Item # 90160: Furnish & Install 6" MJ Cap W/ 2" Corp & Reconnect To Ex. Service. The work under this bid item includes the following items regarding the service at 151 West Gorham Street

- Installing a 6-inch MJ cap tapped with a 2-inch corporation stop on the proposed 6-inch service.
- Reconnecting the existing service to the new corporation stop.
- Furnishing the tapped cap, corporation stop, 2-inch copper and all other fittings required to make a proper connection to the existing service.

View the sites prior to bidding and become familiar with existing conditions and utilities.

SECTION 702 **MATERIALS**

Furnish all materials, labor and equipment necessary to complete this project except the tapping sleeves, tapping valves and tapping valve boxes. Water Utility will furnish the tapping sleeves, tapping valves, tapping valve boxes, and the crew to perform the taps.

Section 702.2 Valves and Valve Boxes

The AFC Series 2500 is an acceptable gate valve model for this project.

CONSTRUCTION METHODS SECTION 703

Perform all work in accordance with these provisions and the City of Madison Standard Specifications. Keep all valves accessible and functioning throughout the duration of the work or directed otherwise by the Water Utility representative.

All water main and ductile iron service pipe that cannot be disinfected per Standard Specification section 704.14(c) shall be hand disinfected by a method acceptable to the Water Utility inspector.

BID ITEM 90001 – TEMPORARY SIDEWALK ACCESS

DESCRIPTION

This special provision describes maintaining accessible sidewalk within the construction zone. Maintaining accessible sidewalks consists of maintaining a sidewalk and/or crosswalk on existing pavement, new pavement, or temporary surface material.

MATERIALS

Furnish a hard temporary surface material consisting of asphaltic surface, any grade of concrete, skid resistant steel plating, or alternative material as approved by the Engineer. Gravel or base course material is not acceptable.

CONSTRUCTION

Install, maintain, move, and remove temporary surface material at Temporary Sidewalk Access locations as shown on the plans and as directed by the Engineer. Level and compact the surface prior to placing temporary surface material. The temporary crosswalk shall have a minimum clear width of 4 feet; be located outside the immediate work area, as approved by the Engineer; and meet the requirements of the current Americans with Disabilities Act Accessibility Guidelines (ADAAG). Reconstruct or relay Temporary Sidewalk Access when disturbed by construction operations or utility trenches.

MEASUREMENT

The department will measure Temporary Sidewalk Access by the lump sum completed and accepted by the Engineer.

PAYMENT

This item, measured as provided above, will be paid for at the contract unit price lump sum which is full compensation for furnishing, loading, hauling material; for preparing the foundation; for furnishing, placing, maintaining, and removing temporary surface material; for reconstructing or relaying the temporary surface material; and for furnishing all labor, tools, equipment, and incidentals necessary to complete the work.

BID ITEM 90002 – FENCE SAFETY

DESCRIPTION

This special provision describes constructing a plastic fence between the construction zone and all sidewalk, or as directed by the Engineer and as hereinafter provided. Fence shall extend to the ground to be detectable by cane for the blind.

MATERIALS

Provide notched conventional metal "T" or "U" shaped fence posts. Provide fence fabric meeting the following requirements.

Color: International orange (UV stabilized)

Roll Height: 4 feet

Mesh opening: 1 inch min to 3-inch max

Resin/construction: High density polyethylene diamond mesh

Service temperature: -60° F to 200° F (ASTM D648)

Tensile Yield: Avg. 2000 lb per 4 ft. width (ASTM D638) Ultimate tensile strength: Avg. 3000 lb per 4 ft. width (ASTM D638)

Elongation at break (%): Greater than 100% (ASTM D638)
Chemical resistance: Inert to most chemicals and acids

CONSTRUCTION

Drive posts into the ground 12 to 18 inches or use other Engineer approved method to secure posts. Space posts at 7 feet.

Use a minimum of three wire ties to secure the fence at each post. Weave tension wire through the top row of strands to provide a top stringer that prevents sagging. Overlap two rolls at a post and secure with wire ties.

METHOD OF MEASUREMENT

City Engineering will measure Fence Safety by the linear foot along the base of the fence, center to center of posts. Fence moved or removed and replaced for construction activities will not be measured and paid again.

BASIS OF PAYMENT

Payment is full compensation for furnishing and installing fence and posts; maintaining the fence and posts in satisfactory condition; removing and disposing of fence and posts at project completion; and for furnishing all labor, tools, equipment and incidentals necessary to complete the work.

BID ITEM 90003 - C1 CONCRETE SIDEWALK 7-INCH

DESCRIPTION

This work shall be in accordance with the requirements of Part 3 of the Standard Specifications, except as herein after amended.

MATERIALS

The concrete mix design shall be as follows per cubic yard:

CONSTRUCTION

Placing and Finishing Concrete. Conform to Part 3 of the Standard Specifications for the concrete. The Engineer will check and approve the foundation, forms and reinforcement if required, before placing the concrete. Place the concrete on a moist foundation, deposit it to the required depth, and consolidate sufficiently to bring the mortar to the surface, then strike-off and finish to a true and even surface. Before mortar sets, spray the surface with water and brush or lightly broom the surface to expose the aggregate. Before performing the final surface finish, check the sidewalk surface with a 10-foot straightedge, and correct all areas that vary ¼-inch from the testing edge by adding or removing concrete while the concrete is still plastic.

C1 Concrete Sidewalk 7-Inch shall be doweled into all existing and new concrete with #6 epoxy coated tie bars. All tie bars shall be in accordance with Standard Detais 3.10 and 3.11 of the City of Madison Standard Specifications

All C1 Concrete Sidewalk 7-Inch shall include 2 inches crushed stone base foundation incidental if needed.

The Contractor shall follow concrete waste management specifications herein these specifications.

Interface between C1 Concrete Sidewalk 7-Inch and 7" Concrete Sidewalk & Drive shall have foam expansion joint and caulk seal incidental.

METHOD OF MEASUREMENT

C1 Concrete Sidewalk 7-Inch shall be measured by the square foot installed and accepted.

BASIS OF PAYMENT

C1 Concrete Sidewalk 7-Inch, measured as stated above, is full compensation for providing all materials, including concrete, bar steel reinforcement HS, joint fillers, joint sealers, and expansion joints; for excavating and preparing the foundation; backfilling and disposing of surplus material; for placing, finishing, protecting, and curing; and restoring the work site. However, if the contract provides a bid item for excavation, then the department will pay for work required and performed in construction concrete sidewalks as specified in the contract.

BID ITEM 90004 - C1 CONCRETE STRUCTURAL SLAB 7-INCH

DESCRIPTION

This work shall be in accordance with the requirements of Part 3 of the Standard Specifications, except as herein after amended.

MATERIALS

The concrete mix design shall be the same as the bid item "C1 Concrete Sidewalk 7-Inch".

CONSTRUCTION

Placing and Finishing Concrete. The Placing and Finishing Concrete shall be the same as the bid item "C1 Concrete Sidewalk 7-Inch".

Reinforcement. Epoxy Coated Bar Steel Reinforcement is required and shall be placed as specified in the plans.

METHOD OF MEASUREMENT

C1 Structural Slab 7-Inch shall be measured by the square foot installed and accepted.

BASIS OF PAYMENT

C1 Structural Slab 7-Inch, measured as stated above, is full compensation for providing all materials, including concrete, bar steel reinforcement HS, joint fillers, joint sealers, and expansion joints; for excavating and preparing the foundation; backfilling and disposing of surplus material; for placing, finishing, protecting, and curing; and restoring the work site. However, if the contract provides a bid item for excavation, then the department will pay for work required and performed in construction concrete sidewalks as specified in the contract.

BID ITEM 90005 - CONCRETE SIDEWALK TEST POUR

Description

This work shall be in accordance with the requirements of Part 3 of the Standard Specifications, except as hereinafter amended. The test pours shall be completed by the Contractor to demonstrate the techniques and quality of workmanship required to produce the desired finished product. The test pour area shall be 10-foot by 10-foot.

Materials

The concrete mix design shall be the same as the bid item "C1 Concrete Sidewalk 7-Inch".

Construction

The test pour shall be done at a location within the City of Madison Metropolitan area. Location shall be verified with the Engineer. The Contractor will give the Engineer a minimum 48-hour notice prior to the test pour. The test pours shall be completed on separate days. The construction of the test pour area shall follow the techniques as described in the bid item "C1 Concrete Sidewalk 7-Inch," including different tooling techniques as directed by the Engineer.

Method of Measurement

Concrete Sidewalk Test Pour shall be measured by the unit each.

Basis of Payment

Concrete Sidewalk Test Pour, measure as provided above, shall be paid at the contact unit price for work as described above.

BID ITEM 90006 - CARDBOARD VOID FORMS

DESCRIPTION

The work shall consist of furnishing and installing cardboard void forms to create a temporary support for the placement of structural concrete slabs over expansive soils in accordance with Section 602 of the State of Wisconsin Standard Specifications, the plan details, and as herein provided.

MATERIALS

Cardboard Void Form shall be four inches thick with a minimum work load strength of 1000 psf. The composition of the material shall be corrugated paper material with a moisture resistant exterior, and having an interior fabrication of a uniform, cellular configuration, composed of non-wax impregnated components. Cardboard Void Form shall be Sure Void Products, Inc, Void Forms International, LTD, or approved equal.

CONSTRUCTION

Prepare ground surface on an even plane. Install Cardboard Void Form in accordance with manufacturer's recommendations. Protect forms from moisture before concrete placement. Tape joints to prevent water absorption. Protect forms from puncture and other damage during concrete placement.

METHOD OF MEASUREMENT

The department will measure Cardboard Void Forms in square feet of surface area acceptably completed.

BASIS OF PAYMENT

Cardboard Void Forms, measured as provided above, will be paid for at the contract unit, which price shall be payment in full for furnishing all materials, labor, tools, equipment and incidentals necessary to complete this item of work.

BID ITEM 90007 – REMOVE BENCH

DESCRIPTION

This special provision describes removing benches in accordance with the pertinent provisions of Article 203 of the standard specifications and as hereinafter provided.

The existing bench on North Frances Street (University Avenue to State Strreet cul-de-sac) shall be carefully removed and delivered to the City of Madison Parks Division. The Contractor shall notify Laura Bauer, City of Madison, (608) 266-6031 to schedule delivery.

All other material shall be removed from the right-of-way and disposed of by the Contractor.

METHOD OF MEASUREMENT

Remove Bench shall be measured by the unit each removed.

BASIS OF PAYMENT

Remove Bench, measured as provided above, shall be paid at the contract unit price for work as described above.

BID ITEM 90008 – INSTALL BENCH

DESCRIPTION

This work shall consist of installing City of Madison furnished benches in locations as shown on the plans and as herein provided.

The City of Madison Parks Division shall deliver benches for installation. The Contractor shall notify Laura Bauer, City of Madison, (608) 266-6031 or Tom Skaife, City of Madison, (608) 225-4849 to schedule delivery.

All material to securely attach the benches shall be provided by the Contractor. Contact the above contacts for questions on securing the benches.

METHOD OF MEASUREMENT

Install Bench shall be measured by the unit each removed.

BASIS OF PAYMENT

Install Bench, measured as provided above, shall be paid at the contract unit price for work as described above.

BID ITEM 90009 - DECOMPOSED GRANITE

DESCRIPTION

This bid item is to provide decomposed granite for the tree openings where the trees are too large for tree grates. Provide uniform 4" depth to surface of tree opening. Full 4" depth may not be possible at all locations due to tree roots. Do not damage tree roots for installation of Decomposed Granite.

MATERIALS

Decomposed Granite to be orange/red in color. Contractor shall submit sample to Engineer prior to ordering or installing.

METHOD OF MEASUREMENT

Decomposed Granite shall be measured by square foot of installed material.

BASIS OF PAYMENT

This item, measured as provided above, will be paid for at the contract unit price per square foot, which price shall be payment in full for furnishing, installing stone, and for furnishing all labor, tools, equipment, and incidentals necessary to complete this item of work.

BID ITEM 900010 - REMOVE AND SALVAGE BRICK PAVERS

DESCRIPTION

The Contractor shall remove and salvage the terrace pavers as needed at the locations shown on the plans, specifically in the North Frances Street terrace of the Campus Inn, 601 Langdon Street. The limits of this work shall be as necessary to replace the adjacent curb and gutter, sidewalk, driveway apron, underground utilities and terrace improvements. The approximate limits of this work are shown on the plans, but additional work may be necessary as directed by the Engineer. The Contractor will be required to salvage and palletize pavers. The bid item will be full compensation for all work necessary including any incidental items to remove and salvage the pavers for future use. MEASUREMENT

Remove and Salvage Brick Pavers shall be measured by the square foot.

BASIS OF PAYMENT

Payment for this work, as measured above, shall be full compensation at the contract unit price for all work, materials, equipment, and incidentals required to complete the work.

BID ITEM 900011 - RESET BRICK PAVERS

DESCRIPTION

The Contractor shall reset the terrace pavers as needed at the locations shown on the plans, specifically in the North Frances Street terrace of the Campus Inn, 601 Langdon Street. The limits of this work shall be

as necessary to reinstall pavers within the terrace around the terrace improvements (lighting and tree grates). The limits of the work shall be such that there will not be any tripping hazards within the area of the pavers and such that there are not any low spots within this area that prevent the terrace from draining properly. The approximate limits of this work are shown on the plans, but additional work may be necessary as directed by the Engineer. The Contractor will be required to saw the pavers to match into the curb, sidewalk, driveway apron and around improvements. The bid item will be full compensation for all work necessary including any incidental items to reset the pavers to match the existing pattern around the terrace improvements.

MEASUREMENT

Reset Brick Pavers shall be measured by the square foot.

BASIS OF PAYMENT

Payment for this work, as measured above, shall be full compensation at the contract unit price for all work, materials, equipment, and incidentals required to complete the work.

BID ITEM 90012 - UNDISTRIBUTED SHEET MEMBRANE WATERPROOFING

DESCRIPTION

This special provision describes preparing the surface, furnishing and installing a primer, waterproofing membrane, and hot rubberized sealer or mastic, or both, on the vault roof to be overlaid with a minimum of one-inch granular material and concrete.

MATERIALS

Provide a material in the waterproofing system that is specifically designed for use with vault roofs. The membrane shall consist of a cold-applied, self-adhering membrane incorporating a heat resistant woven or non-woven fabric or fiberglass reinforcing laminated in between layers of polymer modified bitumen or SBS modified rubberized asphalt. The membrane shall have a release film, polyester or polyethylene on the down side and may have a thin spun bonded open weave polyester fabric on the up side. Provide a composite sheet membrane with the following properties:

Provide rubberized asphalt compound containing not more than 15% inorganic residue or filler material.

Provide primer, mastic and/or hot rubberized asphalt sealer conforming to the specified properties required by the manufacturer of the waterproofing membrane.

MATERIALS CERTIFICATION

Prior to membrane approval for initial submittals and/or upon reformulation of membrane material compounds, submit to the Engineer a notarized certification by an independent test laboratory stating that the materials conform to the requirements of these specifications. The certification shall include or have attached specific results of tests performed on the material supplied. The Engineer may at his option require samples of any material for testing. Prior approval membranes will be provisionally accepted by manufacturer's certification on their company letterhead, but may be subject to control and/or approval by subsequent testing.

CONSTRUCTION

Application Methods

Apply materials in strict accordance with the manufacturer's instructions. In order to install the waterproofing membrane, the vault roof temperature shall be a minimum of 45° F and rising. Before applying the system, become acquainted with the materials specified and their handling characteristics and become thoroughly familiar with the construction procedures recommended by the manufacturer. Furnish a copy of the recommended procedures to the Engineer. To establish procedures for maintaining optimum working conditions and to coordinate work related to adjacent construction, a pre-installation conference with a manufacturer's representative shall be held prior to starting construction. To provide quality assurance that the membrane has been properly installed, a manufacturer's representative familiar with membrane installation procedures shall be present during placement of the membrane.

After sidewalk removal operations, remove by sweeping, compressed air blasting, or by other satisfactory means any foreign material remaining on the vault roof. The roof shall be clean, dry and free from mud, dirt, sand, oil or grease and any other contaminants prior to application of the primer. No vehicles or equipment will be permitted on the roof after surface preparation except those necessary for the installation of the waterproofing membrane. The Engineer will inspect the roof prior to the application of the primer. Do not begin application of either the primer or membrane until after the Engineer grants approval.

To coat all surfaces of the roof and walls that will be covered with the membrane, apply primer uniformly as recommended by the manufacturer. Use roller, brush or spray to apply primer to the surfaces. If spraying is used, an approved method of protecting the environment is required.

Allow the primer to dry until tack free (approximately forty-five minutes) before applying the membrane. Apply primer only to an area that will be covered with the membrane within the same calendar day. If the surface of the roof becomes contaminated, clean and reprime the area.

Apply primer on the walls and expansion joints to the limits of the adjacent concrete pours. Take care to ensure that all corners are coated with primer.

After the primer has dried to a tack free condition, apply one layer of membrane to the roof starting on the low side edge.

To form a bond with the primed roof, remove the release film from the membrane on the tacky side while the membrane is rolled face down. Apply the membrane by hand methods or by using mechanical applicators. Overlap a minimum of 2.5 inches at the edges of each strip and overlap the membrane in such a manner to provide a shingling effect toward the low side of the roof cross section. Overlap a minimum of 5 inches at the ends of each strip of membrane and overlap the membrane in such a manner to provide a shingling effect toward the lower side of the roof profile. Roll the entire membrane surface with a rubber tire roller to ensure firm and uniform contact with the primed surface. Use special care to ensure that the membrane is uniformly adhered to the concrete. The entire membrane shall be free of wrinkles, air bubbles, and other placement defects. In the event bubbles or blisters do form under the membrane, puncture the bubbles or blisters with a sharp pointed instrument such as an awl and press the membrane firmly into contact with the roof. Repair any membrane punctures, tears, holes, and misaligned or inadequate seams with a patch of waterproofing membrane sized as required to ensure water tightness. Apply membrane flashing to expansion joints and cut, fit and seal the membrane flashing with mastic or by heat sealing.

Cover the corners of walls and all other perimeter edges with narrow strips (flashing strips of approximately 12 inches), hot rubberized sealer, or mastic in accordance with manufacturer guidelines. As an additional method of ensuring a watertight bond, all terminating edges, transverse overlaps and longitudinal overlaps may be heated with a propane torch to soften the top mat and fuse the surfaces together.

The applicator foreman or lead worker shall be certified by the manufacturer of the waterproofing membrane as approved applicators, and shall be present during all applications.

OVERLAYING THE MEMBRANE WITH CONCRETE

Construct the concrete according to scheduling requirements elsewhere in the contract. Cover all exposed membrane with the specified granular material and concrete mix within five (5) days after installation. Chemical solvents, gasoline, diesel fuel, mineral spirits, etc. shall not be spilled or leaked onto the membrane. Prior to covering the membrane with granular material and concrete, clean and dry the membrane of mud, dirt, oil, grease, or any other contaminants, and dry the membrane. Patch contaminated areas as required by the Engineer.

METHOD OF MEASUREMENT

Sheet Membrane Waterproofing, installed in accordance with the contract and accepted will be measured, in area by the square feet.

BASIS OF PAYMENT

Sheet membrane waterproofing, measured as provided above, shall be paid at the contract unit price. Payment is full compensation for furnishing and placing the primer, membrane, mastic, and hot rubberized

asphalt sealer; preparing the surface; and for furnishing all labor, tools, materials, equipment, and incidentals necessary to complete the contract work.

BID ITEM 90013 - UNDISTRIBUTED ABANDON VAULT

DESCRIPTION

The work shall consist of removing the vault roof, removing part of the outer walls and cracking the existing vault floor.

MATERIALS

Granular Backfill shall meet the requirements of Article 202 of the standard specifications.

METHOD OF MEASUREMENT

The department will measure Undistributed Abandon Vault in square feet of roof.

BASIS OF PAYMENT

Undistributed Abandon Vault measured as provided above, will be paid for at the contract price square feet, which price shall be payment in full for excavation of vault roof and vault walls, disposal of material and other debris, granular backfill, labor, material, equipment, and incidentals necessary to complete this item of work.

BID ITEM 90014 - UNDISTRIBUTED VAULT WALL

DESCRIPTION

The work shall consist of drilling in dowel bars and constructing a masonry wall.

MATERIALS

Clay brick, concrete brick, or concrete block masonry shall meet the requirements of Section 519 of the State of Wisconsin Standard Specifications. The new material shall match the existing foundation material. If the existing foundation is cast-in-place concrete, use concrete block or brick.

CONSTRUCTION

See construction details.

METHOD OF MEASUREMENT

The department will measure Undistributed Vault Wall in square feet of wall face.

BASIS OF PAYMENT

Undistributed Vault Wall shall be measured as provided above, will be paid for at the contract unit price square feet, which price shall be payment in full for construction of masonry wall, including ties to existing walls, waterproofing, labor, material, equipment, and incidentals necessary to complete this item of work.

BID ITEM 90030 - STORM CONTROL

DESCRIPTION

Work under this item shall include all work, materials, equipment, and incidentals required to control dry and wet weather flow in the storm sewer system during the reconstruction project. The Contractor shall take all necessary steps to protect the new and existing storm mains from damage during construction and to accommodate the existing flows during construction.

This item includes all storm control necessary for all aspects of the Construction. This item is not for control of groundwater.

METHOD OF MEASUREMENT

Storm Control shall be measured by the lump sum for all dewatering necessary throughout construction.

BASIS OF PAYMENT

Storm Control shall be paid for at the contract price, which shall be full compensation for all work as outlined in the description.

BID ITEM 90031 - PRIVATE STORM RECONNECT

DESCRIPTION

Work under this item shall include all work, materials, labor and incidentals necessary to connect existing private storm sewers to the new storm sewer main. Specifically, this item includes (at a minimum) the following: up to twenty five (25) feet of six (6) inch, ten (10) inch, or twelve (12) inch PVC pipe or RCP pipe (concrete pipe must be used under the roadway), compression couplings, or concrete collar to connect to the existing private system, and up to four (4) precast bends. The Contractor shall complete the following as part of this item:

- 1) Find the end of the existing system.
- 2) Remove the pipe to a point where it is covered by at least 6 inches of topsoil.
- Connect to the pipe with a bend directing the pipe underground to a depth where a second or third bend can be installed directing the lateral toward the new storm sewer structure/pipe.
- 4) The lateral shall then be connected to the new storm sewer structure
 - All storm lateral pipe under the roadway must be RCP

METHOD OF MEASUREMENT

Private Storm Sewer Lateral Reconnect shall be measured as complete when each completed unit is installed in the field.

BASIS OF PAYMENT

Private Storm Sewer Lateral Reconnect shall be measured as described above which shall be full compensation for all work, materials and incidentals to complete the work as described above.

BID ITEM 90032 - PRIVATE STORM RECONNECT AND PIPE REPAIR

DESCRIPTION

This item is intended for the work needed to remove structure RS-3, repair the existing storm pipe, reconnect the private storm sewer, and remove and replace the existing private storm sewer under the roadway.

Work under this item shall include all work, materials, labor and incidentals necessary to:

- Remove inlet casting and chimney from RS-3 (saddled inlet)
- Saw cut out section of existing 14"x23" HERCP storm sewer over which RS-3 is saddled or remove pipe to next joint
- Replace section of 14"x23" HERCP with new pipe
- Remove and replace private PVC storm sewer pipe under roadway with 8" AWWA C900 DR18 PVC pipe
 - o Includes approx 60' of pipe, backfill, bend, marker ball and all labor and incidentals necessary to complete the work
- Reconnect new private storm pipe to HERCP pipe
 - O Contractor shall field core the existing pipe and provide a Core-n-T, Core-n-Seal boot, or approved equal to connect the new pipe to the existing pipe as detailed in Standard Detail Drawing 5.7.31.

METHOD OF MEASUREMENT

Private Storm Reconnect and Pipe Repair shall be measured as complete when each completed unit is installed in the field.

BASIS OF PAYMENT

Private Storm Reconnect and Pipe Repair shall be measured as described above which shall be full compensation for all work, materials and incidentals to complete the work as described above.

BID ITEM 90120 - CONCRETE BASES LB-3 MODIFIED

DESCRIPTION

This work shall consist of constructing concrete foundations as shown on the plans, in accordance with the pertinent provisions of Section 604 of the Standard Specifications and as hereinafter provided.

CONSTRUCTION

The bases shall be placed with one side of the bolt square parallel to the centerline of the street.

The top of the concrete base must be 2-inch \pm 0.5 inch above the adjacent sidewalk/terrace and the bolt circle pattern must be centered to be within a tolerance of \pm 0.25 inch. If the base is not within this tolerance the base will be required to be removed and reinstalled at the Contractors expense.

The bid item for LB-3 Modified base shall include cutting existing conduit and wire, pulling back and saving existing wire, and extending existing conduit and wire into each new base where streetlight conduit and/or wire already exists. Existing street light conductors shall be saved and reused. Any

existing wire that is damaged or removed by the contractor when it could have been reused shall be replaced by the contractor at no expense to the City. All work associated with installing conduit connection between existing conduit and new base, saving and reusing existing wire or removing existing wire from conduit is incidental to the bid item for LB-3 Modified base

METHOD OF MEASUREMENT

Concrete Base LB-3 Modified will be measured as a unit complete in place.

BASIS OF PAYMENT

Concrete Base LB-3 Modified, measured as provided above, will be paid for at the contract unit price each, which price shall be payment in full for picking up City-furnished anchor bolts; for furnishing and installing all materials including conduit, bushings, caps and/or plugs, ground rod, copper grounding wire, bar steel reinforcement, and concrete masonry; for excavation, including hand-digging as required, backfill, and disposal of surplus materials; and for all labor, tools, equipment, and incidentals necessary to complete this item of work.

BID ITEM 90121 - TEMPORARY WOOD POLE

DESCRIPTION

Work under this item consists of installing City-furnished temporary wood poles for overhead lighting as required, and for the locations determined by the Traffic Engineering (TE) Inspector. The quantity to be installed will be determined as the project progresses.

CONSTRUCTION

Wood poles will be sized to provide a minimum thirty (30) foot above grade height and be of the size and weight normally used for power poles. The poles shall be set in dug or bored holes, and set with compacted backfill. The location of each pole will be determined by the TE Inspector. The depth of the hole shall be approximately five feet, but fully subject to the review and revision by the TE Inspector. The poles shall be installed within one week after notification, or as directed by the TE Inspector. When they are no longer needed, they shall be removed and returned to the City of Madison Traffic Engineering Shop, 1120 Sayle Street. The City will install and subsequently remove any temporary facilities from these poles.

METHOD OF MEASUREMENT

Temporary Wood Pole will be measured as a unit complete in place, and removed after their use is no longer needed.

BASIS OF PAYMENT

Temporary Wood Pole, measured as provided above, will be paid for at the contract unit price each, which price shall be payment in full for picking up City-furnished wood poles, installing poles, furnishing backfill as needed, disposal of surplus materials; and for all labor, tools, equipment, and incidentals necessary to complete this item of work.

BID ITEM 90122 - BASE FOR MULTI SPACE PARKING METERS

General.

This item consists of picking up and installing city provided steel bases for multi space parking meters in accordance with the standard specifications, these Special Provisions, and the detail shown on the plans.

Materials.

All requirements specified in Article 301 - Concrete and Concrete Materials, regarding mix design, highearly strength concrete, testing, materials, mixing, placing, curing, and protecting the concrete, shall apply to the concrete used in the construction of said concrete slab around said bases.

Construction Methods.

Where bases are to be installed within existing sidewalks or improved terraces, the Contractor shall remove and replace the entire stone of sidewalk or improved terrace affected by the installation unless otherwise specified or directed by the Engineer.

The general locations of the bases are shown on the plans. The exact locations and elevations shall be established in the field by the Parking Utility Maintenance Supervisor (Dan Valenza, 266-4744). Unless otherwise specified, bases shall be placed with one side parallel to the center line of the adjacent sidewalk and the center of the base shall be four (4) feet from the face of the curb. The elevations of the bases shall be as shown on the detail unless otherwise specified.

The city-furnished steel base shall be cast into the concrete sidewalk slab. The top of the steel base shall be level, with a minimum depth of two inches below the finished slab grade.


The contractor shall install conduit as shown in the plan. Conduit shall extend three inches above the top of the steel base plate.

Unless otherwise specified, all backfill shall be in accordance with the requirements of Section 503.2 of these Specifications.

Measurement and Payment.

This item shall be measured as units, complete in place and accepted in accordance with the contract.

This item, measured as provided above, will be paid for at the contract unit price for each base, which price shall be payment in full for picking up and installing the city provided steel plate in the concrete slab and placing the concrete slab; for excavation, backfill, and disposal of surplus materials; and for all labor, tools, equipment and incidentals necessary to complete these items of work.

Such weekly payroll records must include the required information for all City contracts and all other contracts on which the employee worked during the week in which the employee worked on the contract. The Contractor shall also keep records of the individual time each employee worked on the project and for each day of the project. Such records shall also set forth the total number of hours of overtime credited to each such employee for each day and week and the amount of overtime pay received in that week. The records shall set forth the full weekly wages earned by each employee and the actual hourly wage paid to the employee.

The Contractor shall submit the weekly payroll records, including the records of the Contractor's subcontractors and agents, to the City Engineer for every week that work is being done on the contract. The submittal shall be within twenty-one (21) calendar days of the end of the Contractor's weekly pay period.

Employees shall receive the full amounts accrued at the time of the payment, computed at rates not less than those stated in the prevailing wage rate and each employee's rate shall be determined by the work that is done within the trade or occupation classification which should be properly assigned to the employee.

An employee's classification shall not be changed to a classification of a lesser rate during the contract. If, during the term of the contract, an employee works in a higher pay classification than the one which was previously properly assigned to the employee, then that employee shall be considered to be in the higher pay classification for the balance of the contract, receive the appropriate higher rate of pay, and she/he shall not receive a lesser rate during the balance of the contract. For purposes of clarification, it is noted that there is a distinct difference between working in a different classification with higher pay and doing work within a classification that has varying rates of pay which are determined by the type of work that is done within the classification. For example, the classification "Operating Engineer" provides for different rates of pay for various classes of work and the Employer shall compensate an employee classified as an "Operating Engineer" based on the highest class of work that is done in one day. Therefore, an "Operating Engineer's" rate may vary on a day to day basis depending on the type of work that is done, but it will never be less than the base rate of an "Operating Engineer". Also, as a matter of clarification, it is recognized that an employee may work in a higher paying classification merely by chance and without prior intention, calculation or design. If such is the case and the performance of the work is truly incidental and the occurrence is infrequent, inconsequential and does not serve to undermine the single classification principle herein, then it may not be required that the employee be considered to be in the higher pay classification and receive the higher rate of pay for the duration of the contract. However, the Contractor is not precluded or prevented from paying the higher rate for the limited time that an employee performs work that is outside of the employee's proper classification.

Questions regarding an employee's classification, rate of pay or rate of pay within a classification, shall be resolved by reference to the established practice that predominates in the industry and on which the trade or occupation rate/classification is based. Rate of pay and classification disputes shall be resolved by relying upon practices established by collective bargaining agreements and guidelines used in such determination by appropriate recognized trade unions operating within the City of Madison.

The Contractor, its Subcontractors and Agents shall submit to interrogation regarding compliance with the provisions of this ordinance.

Mulcting of the employees by the Contractor, Subcontractor, and Agents on Public Works contracts, such as by kickbacks or other devices, is prohibited. The normal rate of wage of the employees of the Contractor, Subcontractor, and Agents shall not be reduced or otherwise diminished as a result of payment of the prevailing wage rate on a public works contract.

Hourly contributions. Hourly contributions shall be determined in accordance with the prevailing wage rate and with DWD. 290.01(10), Wis. Admin. Code.

Apprentices and Subjourneypersons. Apprentices and subjourneypersons performing work on the project shall be compensated in accordance with the prevailing wage rate and with DWD 290.02, and 290.025, respectively, Wis. Admin. Code.

Straight Time Wages. The Contractor may pay straight time wages as determined by the prevailing wage rate and DWD 290.04, Wis. Admin. Code.

Overtime Wages. The Contractor shall pay overtime wages as required by the prevailing wage rate and DWD 290.05, Wis. Admin. Code.

Posting of Wage Rates and Hours. A clearly legible copy of the prevailing wage rate, together with the provisions of Sec. 66.0903(10)(a) and (11)(a), Wis. Stats., shall be kept posted in at least one conspicuous and easily accessible place at the project site by the Contractor and such notice shall remain posted during the full time any laborers, workers or mechanics are employed on the contract.

Evidence of Compliance by Contractor. Upon completion of the contract, the Contractor shall file with the Department of Public Works an affidavit stating:

- a. That the Contractor has complied fully with the provisions and requirements of Sec. 66.0903(3), Wis. Stats., and Chapter DWD 290, Wis. Admin. Code; the Contractor has received evidence of compliance from each of the agents and subcontractors; and the names and addresses of all of the subcontractors and agents who worked on the contract.
- b. That full and accurate records have been kept, which clearly indicate the name and trade or occupation of every laborer, worker or mechanic employed by the Contractor in connection with work on the project. The records shall show the number of hours worked by each employee and the actual wages paid therefor; where these records will be kept and the name, address and telephone number of the person who will be responsible for keeping them. The records shall be retained and made available for a period of at least three (3) years following the completion of the project of public works and shall not be removed without prior notification to the municipality.

Evidence of Compliance by Agent and Subcontractor. Each agent and subcontractor shall file with the Contractor, upon completion of their portion of the work on the contract an affidavit stating that all the provisions of Sec. 66.0903(3), Wis. Stats., have been fully complied with and that full and accurate records have been kept, which clearly indicate the name and trade or occupation of every laborer, worker or mechanic employed by the Contractor in connection with work on the project. The records shall show the number of hours worked by each employee and the actual wages paid therefor; where these records shall be kept and the name, address and telephone number of the person who shall be responsible for keeping them. The records shall be retained and made available for a period of at least three (3) years following the completion of the project of public works and shall not be removed without prior notification to the municipality.

Failure to Comply with the Prevailing Wage Rate. If the Contractor fails to comply with the prevailing wage rate, she/he shall be in default on the contract.

5. **Affirmative Action.** In the performance of the services under this Agreement the Contractor agrees not to discriminate against any employee or applicant because of race, religion, marital status, age, color, sex, disability, national origin or ancestry, income level or source of income, arrest record or conviction record, less than honorable discharge, physical appearance, sexual orientation, political beliefs, or student status. The Contractor further agrees not to discriminate against any subcontractor or person who offers to subcontract on this contract because of race, religion, color, age, disability, sex or national origin.

The Contractor agrees that within thirty (30) days after the effective date of this agreement, the Contractor will provide to the City Affirmative Action Division certain workforce utilization statistics, using a form to be furnished by the City.

If the contract is still in effect, or if the City enters into a new agreement with the Contractor, within one year after the date on which the form was required to be provided, the Contractor will provide updated workforce information using a second form, also to be furnished by the City. The second form will be submitted to the City Affirmative Action Division no later than one year after the date on which the first form was required to be provided.

The Contractor further agrees that, for at least twelve (12) months after the effective date of this contract, it will notify the City Affirmative Action Division of each of its job openings at facilities in Dane County for which applicants not already employees of the Contractor are to be considered. The notice will include a job description, classification, qualifications and application procedures and deadlines. The Contractor agrees to interview and consider candidates referred by the Affirmative Action Division if the candidate meets the minimum qualification standards established by the Contractor, and if the referral is timely. A referral is timely if it is received by the Contractor on or before the date started in the notice.

Articles of Agreement Article I

The Contractor shall take affirmative action in accordance with the provisions of this contract to insure that applicants are employed, and that employees are treated during employment without regard to race, religion, color, age, marital status, disability, sex or national original and that the employer shall provide harassment free work environment for the realization of the potential of each employee. Such action shall include, but not be limited to, the following: employment, upgrading, demotion or transfer, recruitment or recruitment advertising, layoff or termination, rates of pay or other forms of compensation and selection for training including apprenticeship insofar as it is within the control of the Contractor. The Contractor agrees to post in conspicuous places available to employees and applicants notices to be provided by the City setting out the provisions of the nondiscrimination clauses in this contract.

Article II

The Contractor shall in all solicitations or advertisements for employees placed by or on behalf of the Contractors state that all qualified or qualifiable applicants will be employed without regard to race, religion, color, age, marital status, disability, sex or national origin.

Article III

The Contractor shall send to each labor union or representative of workers with which it has a collective bargaining agreement or other contract or understanding a notice to be provided by the City advising the labor union or worker's representative of the Contractor's equal employment opportunity and affirmative action commitments. Such notices shall be posted in conspicuous places available to employees and applicants for employment.

Article V

The Contractor agrees that it will comply with all provisions of the Affirmative Action Ordinance of the City of Madison, including the contract compliance requirements. The Contractor agrees to submit the model affirmative action plan for public works contractors in a form approved by the Director of Affirmative Action.

Article VI

The Contractor will maintain records as required by Section 39.02(9)(f) of the Madison General Ordinances and will provide the City Affirmative Action Division with access to such records and to persons who have relevant and necessary information, as provided in Section 39.02(9)(f). The City agrees to keep all such records confidential, except to the extent that public inspection is required by law.

Article VII

In the event of the Contractor's or subcontractor's failure to comply with the Equal Employment Opportunity and Affirmative Action Provisions of this contract or Section 39.03 and 39.02 of the Madison General Ordinances, it is agreed that the City at its option may do any or all of the following:

- 1. Cancel, terminate or suspend this Contract in whole or in part.
- 2. Declare the Contractor ineligible for further City contracts until the Affirmative Action requirements are met.
- 3. Recover on behalf of the City from the prime Contractor 0.5 percent of the contract award price for each week that such party fails or refuses to comply, in the nature of liquidated damages, but not to exceed a total of five percent (5%) of the contract price, or five thousand dollars (\$5,000), whichever is less. Under public works contracts, if a subcontractor is in noncompliance, the City may recover liquidated damages from the prime Contractor in the manner described above. The preceding sentence shall not be construed to prohibit a prime Contractor from recovering the amount of such damage from the non-complying subcontractor.

Article VIII

The Contractor shall include the above provisions of this contract in every subcontract so that such provisions will be binding upon each subcontractor. The Contractor shall take such action with respect to any subcontractor as necessary to enforce such provisions, including sanctions provided for noncompliance.

Article IX

The Contractor shall allow the maximum feasible opportunity to small business enterprises to compete for any subcontracts entered into pursuant to this contract.

- 3. In addition to or in lieu of recovering the liability specified in subd. 1. as provided in subd. 2., any employee for and in behalf of that employee and other employees similarly situated may commence an action to recover that liability in any court of competent jurisdiction. If the court finds that a contractor, subcontractor, or contractor's or subcontractor's agent has failed to pay the prevailing wage rate determined by the department under sub. (3) or has paid less than 1.5 times the hourly basic rate of pay for all hours worked in excess of the prevailing hours of labor, the court shall order the contractor, subcontractor, or agent to pay to any affected employee the amount of his or her unpaid wages or his or her unpaid overtime compensation and an additional amount equal to 100 percent of the amount of those unpaid wages or that unpaid overtime compensation as liquidated damages. 5. No employee may be a party plaintiff to an action under subd. 3. unless the employee consents in writing to become a party and the court shall, in addition to any

Notwithstanding s. 814.04 (1), the court shall, in addition to any judgment awarded to the plaintiff, allow reasonable attorney fees and costs to be paid by the defendant.
