#### **SECTION B: INSTRUCTIONS TO BIDDERS**

The City of Madison Standard Specifications for Public Works Construction - 2012 Edition, as supplemented and amended from time to time, forms a part of these contract documents as if attached hereto.

These standard specifications are available on the City of Madison Public Works website at <a href="https://www.cityofmadison.com/Business/PW/specs.cfm">www.cityofmadison.com/Business/PW/specs.cfm</a> or by contacting City Engineering Division, Room 115, City-County Building, 210 Martin Luther King Jr. Blvd., Madison, WI 53703.

The Contractor shall review these Specifications prior to preparation of proposals for the work to be done under this contract, with specific attention to Article 102 "BIDDING REQUIREMENTS AND CONDITIONS" and Article 103 "AWARD AND EXECUTION OF THE CONTRACT." For the convenience of the bidder, below are highlights of three subsections of the specifications.

#### Section 102.1: Pre-Qualification of Bidders

In accordance with Wisconsin State Statutes 66.0901 (2) and (3), all bidders must submit to the Board of Public Works proof of responsibility on forms furnished by the City. The City requires that all bidders be qualified on a biennial basis.

Bidders must present satisfactory evidence that they have been regularly engaged in the type of work specified herein and they are fully prepared with necessary capital, materials, machinery and supervisory personnel to conduct the work to be contracted for to the satisfaction of the City. All bidders must be prequalified by the Board of Public Works for the type of construction on which they are bidding prior to the opening of the bid.

In accordance with Section 39.02(9)(a)l. of the Madison General Ordinances, all bidders shall submit in writing to the Affirmative Action Division Manager of the City of Madison, a Certificate of Compliance or an Affirmative Action Plan at the same time or prior to the submission of the proof of responsibility forms. The bidder shall be disqualified if the bidder fails to or refuses to, prior to opening of the bid, submit a Certificate of compliance, Affirmative Action Plan or Affirmative Action Data Update, as applicable, as defined by Section 39.02 of the Madison General Ordinances (entitled Affirmative Action) and as required by Section 102.11 of the Standard Specifications.

#### Section 102.4: Proposals

No bid will be accepted that does not contain an adequate or reasonable price for each and every item named in the Schedule of Unit Prices.

A lump sum bid for the work in accordance with the plans and specifications is required. The lump sum bid musts be the same as the total amounts bid for the various items and it shall be inserted in the space provided.

All papers bound with or attached to the proposal form are considered a part thereof and must not be detached or altered when the proposal is submitted. The plans, specifications and other documents designated in the proposal form will be considered a part of the proposal whether attached or not.

A proposal submitted by an individual shall be signed by the bidder or by a duly authorized agent. A proposal submitted by a partnership shall be signed by a member/partner or by a duly authorized agent thereof. A proposal submitted by a corporation shall be signed by an authorized officer or duly authorized registered agent of such corporation, and the proposal shall show the name of the State under the laws of

which such corporation was chartered. The required signatures shall in all cases appear in the space provided therefore on the proposal.

Each proposal shall be placed, together with the proposal guaranty, in a sealed envelope, so marked as to indicate name of project, the contract number or option to which it applies, and the name and address of the Contractor. Proposals will be received at the place and until the hour on the date designated in the advertisement. When sent by mail, the sealed proposal marked as indicated above shall be enclosed in an additional envelope. Proposals sent by mail, submitted in person or otherwise delivered must be in the hands of the official conducting the letting by the hour on the date designated in the advertisement. Proposals received after the date designated will be returned to the bidder unopened.

The Bidder shall execute form ERD-7777 (R.9/03), a part of these proposal pages and submit same with the bidder's proposal, if applicable. REFER TO PROPOSAL SECTION.

## Section 102.5: Bid Deposit (Proposal Guaranty)

No proposal shall be considered unless either (i) it is accompanied by a bid deposit of the character and amount described in the Advertisement for Bids or (ii) a biennial bid bond in an amount and form acceptable to the City of Madison has been previously submitted.

Bid deposits of unsuccessful bidders shall be returned following the award of the contract by the Common Council. Bid deposit of the successful bidders shall be returned within forty-eight (48) hours following execution of the contract and bond as required.

# Instructions to Bidders City of Madison SBE Program Information

## 2 Small Business Enterprise (SBE) Program Information

#### 2.1 Policy and Goal

The City of Madison reaffirms its policy of nondiscrimination in the conduct of City business by maintaining a procurement process which remains open to all who have the potential and ability to sell goods and services to the City. It is the policy of the City of Madison to allow Small Business Enterprises (SBE) maximum feasible opportunity to participate in City of Madison contracting. The bidder acknowledges that its bid has been submitted in accordance with the SBE program and is for the public's protection and welfare.

Please refer to the "ADVERTISEMENT FOR BIDS" for the goal for the utilization of SBEs on this project. SBEs may participate as subcontractors, vendors and/or suppliers, which provide a commercially useful function. The dollar value for SBE suppliers or 'materials only' vendors shall be discounted to 60% for purposes of meeting SBE goals.

A bidder which achieves or exceeds the SBE goal will be in compliance with the SBE requirements of this project. In the event that the bidder is unable to achieve the SBE goal, the bidder must demonstrate that a good faith effort to do so was made. Failure to either achieve the goal or demonstrate a good faith effort to do so will be grounds for the bidder being deemed a non-responsible contractor ineligible for award of this contract.

A bidder may count towards its attainment of the SBE goal only those expenditures to SBEs that perform a commer—cially useful function. For purposes of evaluating a bidder's responsiveness to the attainment of the SBE goal, the contract participation by an SBE is based on the percentage of the total base bid proposed by the Contractor. The total base bid price is inclusive of all addenda.

Work performed by an SBE firm in a particular transaction can be counted toward the goal only if it involves a commercially useful function. That is, in light of industry practices and other relevant considerations, does the SBE firm have a necessary and useful role in the transaction, of a kind for which there is a market outside the context of the SBE Program, or is the firm's role a superfluous step added in an attempt to obtain credit towards goals? If, in the judgment of the Affirmative Action Division, the SBE firm will not perform a commercially useful function in the transaction, no credit towards goals will be awarded.

The question of whether a firm is performing a commercially useful function is completely separate from the question of whether the firm is an eligible SBE. A firm is eligible if it meets the definitional criteria and ownership and control requirements, as set forth in the City of Madison's SBE Program.

If the City of Madison determines that the SBE firm is performing a commercially useful function, then the City of Madison must then decide what that function is. If the

commercially useful function is that of an SBE vendor / supplier that regularly transacts business with the respective product, then the City of Madison will count 60% of the value of the product supplied toward SBE goals.

To be counted, the SBE vendor / supplier must be engaged in selling the product in question to the public. This is important in distinguishing an SBE vendor / supplier, which has a regular trade with a variety of customers, from a firm which performs supplier-like functions on an <u>ad hoc</u> basis or for only one or two contractors with whom it has a special relationship.

A supplier of bulk goods may qualify as an eligible SBE vendor / supplier if it either maintains an inventory or owns or operates distribution equipment. With respect to the distribution equipment; e.g., a fleet of trucks, the term "operates" is intended to cover a situation in which the supplier leases the equipment on a regular basis for its entire business. It is not intended to cover a situation in which the firm simply provides drivers for trucks owned or leased by another party; e.g., a prime contractor, or leases such a party's trucks on an ad hoc basis for a specific job.

If the commercially useful function being performed is not that of a qualified SBE vendor / supplier, but rather that of delivery of products, obtaining bonding or insurance, procurement of personnel, acting as a broker or manufacturer's representative in the procurement of supplies, facilities, or materials, etc., only the fees or commissions will apply towards the goal.

For example, a business that simply transfers title of a product from manufacturer to ultimate purchaser; e. g., a sales representative who re-invoices a steel product from the steel company to the Contractor, or a firm that puts a product into a container for delivery would not be considered a qualified SBE vendor / supplier. The Contractor would not receive credit based on a percentage of the cost of the product for working with such firms.

Concerning the use of services that help the Contractor obtain needed supplies, personnel, materials or equipment to perform a contract: only the fee received by the service provider will be counted toward the goal. For example, use of a SBE sales representative or distributor for a steel company, if performing a commercially useful function at all, would entitle the Contractor receiving the steel to count only the fee paid to the representative or distributor toward the goal. This provision would also govern fees for professional and other services obtained expressly and solely to perform work relating to a specific contract.

Concerning transportation or delivery services: if an SBE trucking company picks up a product from a manufacturer or a qualified vendor / supplier and delivers the product to the Contractor, the commercially useful function it is performing is not that of a supplier, but simply that of a transporter of goods. Unless the trucking company is itself the manufacturer or a qualified vendor / supplier in the product, credit cannot be given based on a percentage of the cost of the product. Rather, credit would be allowed for the cost of the transportation service.

The City is aware that the rule's language does not explicitly mention every kind of business that may contribute work on this project. In administering these programs, the City would, on a case-by-case basis, determine the appropriate counting formula to apply in a particular situation.

#### 2.3 Certification of SBE by City of Madison

The Affirmative Action Division maintains a directory of SBEs which are currently certified as such by the City of Madison. Contact the Contract Compliance Officer as indicated in Section 2.2 to receive a copy of the SBE Directory or you may access the SBE Directory online at www.cityofmadison.com/dcr/aaTBDir.cfm.

All contractors, subcontractors, vendors and suppliers seeking SBE status must complete and submit the **Targeted Business Certification Application** to the City of Madison Affirmative Action Division by the time and date established for receipt of bids. A copy of the Targeted Business Certification Application is available by contacting the Contract Compliance Officer at the address and telephone indicated in Section 2.2 or you may access the Targeted Business Certification Application online at <a href="https://www.cityofmadison.com/dcr/aaTBDir.cfm">www.cityofmadison.com/dcr/aaTBDir.cfm</a>. Submittal of the Targeted Business Certification Application by the time specified does not guarantee that the applicant will be certified as a SBE eligible to be utilized towards meeting the SBE goal for this project.

#### 2.4 Small Business Enterprise Compliance Report

#### 2.4.1 Good Faith Efforts

Bidders shall take all necessary affirmative steps to assure that SBEs are utilized when possible and that the established SBE goal for this project is achieved. A contractor who self performs a portion of the work, and is pre-qualified to perform that category of work, may subcontract that portion of the work, but shall not be required to do so. When a bidder is unable to achieve the established SBE goal, the bidder must demonstrate that a good faith effort to do so was made. Such a good faith effort should include the following:

- 2.4.1.1 Attendance at the pre-bid meeting.
- 2.4.1.2 Using the City of Madison's directory of certified SBEs to identify SBEs from which to solicit bids.
- 2.4.1.3 Assuring that SBEs are solicited whenever they are potential sources.
- 2.4.1.4 Referring prospective SBEs to the City of Madison Affirmative Action Division for certification.
- 2.4.1.5 Dividing total project requirements into smaller tasks and/or quantities, where economically feasible, to permit maximum feasible SBE participation.
- 2.4.1.6 Establishing delivery schedules, where requirements permit, which will encourage participation by SBEs.
- 2.4.1.7 Providing SBEs with specific information regarding the work to be performed.
- 2.4.1.8 Contacting SBEs in advance of the deadline to allow such businesses sufficient time to prepare a bid.

- 2.4.1.9 Utilizing the bid of a qualified and competent SBE when the bid of such a business is deemed reasonable (i.e. 5% above the lowest bidder), although not necessarily low.
- 2.4.1.10 Contacting SBEs which submit a bid, to inquire about the details of the bid and confirm that the scope of the work was interpreted as intended.

## 2.4.2 Reporting SBE Utilization and Good Faith Efforts

The Small Business Enterprise Compliance Report is to be submitted by the bidder in a separate sealed envelope marked: "ENVELOPE 2 - SBE COMPLIANCE REPORT." This report is due by the specified bid closing time and date. Bids submitted without a completed SBE Compliance Report as outlined below shall be deemed non-responsible and the bidder ineligible for award of this contract.

- 2.4.2.1 If the Bidder <u>meets or exceeds</u> the goal established for SBE utilization, the Small Business Enterprise Compliance Report shall consist of the following:
  - 2.4.2.1.1 **Cover Page**, Page C-7; and
  - 2.4.2.1.2 **Summary Sheet,** C-8.
- 2.4.2.2 If the bidder <u>does not meet</u> the goal established for SBE utilization, the Small Business Enterprise Compliance Report shall consist of the following:
  - 2.4.2.2.1 **Cover Page**, Page C-7;
  - 2.4.2.2.2 **Summary Sheet,** C-8; and
  - 2.4.2.2.3 **SBE Contact Report,** C-9 and C-10. (A <u>separate</u> Contact Report must be completed for <u>each applicable</u> SBE which is not utilized.)

## 2.5 Appeal Procedure

A bidder which does not achieve the established goal and is deemed <u>non-responsible</u> for failure to demonstrate a good faith effort to achieve such goal and subsequently denied eligibility for award of contract may, within 72 hours of receiving such notification, appeal that decision to a special appeals committee composed of three (3) members of the Affirmative Action Commission, three (3) members of the Board of Public Works and a seventh member appointed by the Mayor. All appeals must be made in writing to the City Engineer and <u>received</u> within 72 hours of City of Madison's notice. Postmark not applicable.

#### 2.6 SBE Requirements After Award of the Contract

The successful bidder shall identify SBE subcontractors, suppliers and vendors on the subcontractor list in accordance with the specifications. The Contractor shall submit a detailed explanation of any variances between the listing of SBE subcontractors, vendors and/or suppliers on the subcontractor list and the Contractor's SBE Compliance Report for SBE participation.

No change in SBE subcontractors, vendors and/or suppliers from those SBEs indicated in the SBE Compliance Report will be allowed without prior approval from the Engineer and the Affirmative Action Division. The contractor shall submit in writing to the City of Madison Affirmative Action Division a request to change any SBE citing specific reasons which necessitate such a change. The Affirmative Action Division will use a general test of reasonableness in approving or rejecting the contractor's request for change. If the request is approved, the Contractor will make every effort to utilize another SBE if available.

The City will monitor the project to ensure that the actual percentage commitment to SBE firms is carried out.

#### 2.7 SBE Definition and Eligibility Guidelines

A Small Business Enterprise is a business concern awarded certification by the City of Madison. For the purposes of this program a Small Business Enterprise is defined as:

- A. An independent business operated under a single management. The business may not be a subsidiary of any other business and the stock or ownership may not be held by any individual or any business operating in the same or a similar field. In determining whether an entity qualifies as a SBE, the City shall consider all factors relevant to being an independent business including, but not limited to, the date the business was established, adequacy of its resources for the work in which it proposes to involve itself, the degree to which financial, equipment leasing and other relationships exist with other ineligible firms in the same or similar lines of work. SBE owner(s) shall enjoy the customary incidents of ownership and shall share in the risks and profits commensurate with their enjoyment interests, as demonstrated by an examination of the substance rather than form or arrangements that may be reflected in its ownership documents.
- B. A business with annual gross receipts of less than \$750,000 when averaged over the past three year period;

Firm and/or individuals that submit fraudulent documents/testimony may be barred from doing business with the City and/or forfeit existing contracts.

SBE certification is valid for one (1) year unless revoked.

## **SECTION D: SPECIAL PROVISIONS**

## ARBORETUM POND 3 - IMPROVEMENTS PHASE 2 CONTRACT NO. 6855

It is the intent of these Special Provisions to set forth the final contractual intent as to the matter involved and shall prevail over the Standard Specifications and plans whenever in conflict therewith. In order that comparisons between the Special Provisions can be readily made, the numbering system for the Special Provisions is equivalent to that of the Specifications.

Whenever in these Specifications the term "Standard Specifications" appears, it shall be taken to refer to the City of Madison Standard Specifications for Public Works Construction and Supplements thereto.

## SECTION 102.10: MINIMUM RATE OF WAGE SCALE

For this project, payment of prevailing wages (white sheet) is not required if either: a single trade accounts for 85% or more of the total labor costs of the project and the bid is less than \$48,000; or no single trade accounts for 85% or more of the total labor costs of the project and the bid is less than \$100,000. For bids not meeting either of these conditions, prevailing wages shall be required.

If required, the wages and benefits paid on the contract shall not be less than those specified in the Prevailing Wage Determination included with these contract documents for the following types of work:

Building and Heavy Construction
Sewer, Water, and Tunnel Construction
Local Street and Miscellaneous Paving Operations
Residential and Agricultural Construction

All bidders are notified that all labor employed on City contracts must be paid in accordance with the minimum rate of wage scale included in the Contract Documents.

For the information of the employees working on the project, a copy of the wage scale included in the contract documents and the provisions of Section 66.0903(8) of the Wisconsin Statutes shall be kept posted by the employer and in at least one conspicuous and easily accessible place at the site of the project.

The Contractor shall keep weekly payroll records setting forth the name, address, telephone number, classification, wage rate and fringe benefit package of each employee who worked on such City project and all other projects the employee worked in the same period, and the Contractor must keep records of the individual time each employee worked on the project and for each day of the project. Such records shall also set forth the total number of hours of overtime credited to each such employee for each day and week and the amount of overtime pay received in that week. Such records shall, in addition, set forth the full weekly wages earned by each such employee and the actual hourly wage paid to that employee. The Contractor shall submit payroll records to the Engineer every week for those periods when work is being done on

the project. Said submittal shall be within twenty-one (21) calendar days of the end of the Contractor's weekly pay period.

The Contractor shall ensure that employees shall be paid unconditionally and shall receive the full amounts accrued at the time of payment, computed at rates not less than those stated in the City of Madison "Minimum Rate of Wage Scale" and that each employee's rate shall be determined by the work that is done within the trade or occupation classification which should be properly assigned to such employee. Questions regarding an employee's classification or rate of pay within that classification, shall be resolved by the practice that predominates in the industry and on which the trade or occupation rate/classification is based. Therefore, rate of pay, classification and work jurisdiction disputes shall be resolved by relying upon practices established by collective bargaining agreements and guidelines used in such determinations by appropriate recognized trade unions operating within the City of Madison.

The Contractor shall agree that the normal rate of wage paid to the Contractor's employees on other projects shall not be reduced or otherwise diminished as a result of the requirement to pay no less than the minimum rate of wage scale on a City project. Mulcting of employees on City projects by contractors, such as by kickbacks or other such devices, is prohibited.

These contract provisions shall apply to all work performed on the contract by the Contractor with its own organization and with assistance of laborers under its immediate superintendency and to all work performed by piecework or by subcontract. No laborer, worker, or mechanic shall be employed directly upon the site of the work except on a wage basis, but this shall not be construed to prohibit the rental of equipment from individuals.

In the event of a refusal by the Contractor to submit payroll records as required by the contract, the City of Madison shall have the option to cancel this contract and request the Surety to perform or to relet the balance of the work for bids, and in that event, to charge the Contractor for any loss which the City may incur thereby.

## SECTION 102.12: BEST VALUE CONTRACTING

This Contract shall be considered a Best Value Contract if the Contractor's bid is equal to or greater than \$51,500 for a single trade contract; or equal to or greater than \$251,000 for a multi-trade contract pursuant to MGO 33.07(7).

## ARTICLE 102.3 EQUAL BENEFITS REQUIREMENT (SEC. 39.07, MGO)

This provision applies to contracts executed by the City on July 1, 2012 or later, unless exempt by Sec. 39.07 of the Madison General Ordinances (MGO).

For the duration of this Contract, the Contractor agrees to offer and provide benefits to employees with domestic partners that are equal to the benefits offered and provided to married employees with spouses, and to comply with all provisions of Sec. 39.07, MGO. If a benefit would be available to the spouse of a married employee, or to the employee based on his or her status as a spouse, the benefit shall also be made available to a domestic partner of an employee, or to the employee based on his or her status as a domestic partner. "Benefits" include any plan, program or policy provided or offered to employees as part of the employer's total compensation

package, including but not limited to, bereavement leave, family medical leave, sick leave, health insurance or other health benefits, dental insurance or other dental benefits, disability insurance, life insurance, membership or membership discounts, moving expenses, pension and retirement benefits, and travel benefits.

<u>Cash Equivalent</u>. If after making a reasonable effort to provide an equal benefit for a domestic partner of an employee, the Contractor is unable to provide the benefit, the Contractor shall provide the employee with the cash equivalent of the benefit.

<u>Proof of Domestic Partner Status</u>. The Contractor may require an employee to provide proof of domestic partnership status as a prerequisite to providing the equal benefits. Any such requirement of proof shall comply with Sec. 39.07(4), MGO.

<u>Notice Posting, Compliance</u>. The Contractor shall post a notice informing all employees of the equal benefit requirements of this Contract, the complaint procedure, and agrees to produce records upon request of the City, as required by Sec. 39.07, MGO.

<u>Subcontractors</u>. Contractor shall require all subcontractors, the value of whose work exceeds the single-trade minimum set forth in Sec 33.07(7)(b)5., MGO, to provide equal benefits in compliance with Sec. 39.07, MGO.

See Section 39.07 MGO for exemptions from this requirement. Exemptions from this requirement include a Contractor whose employees are under a collective bargaining agreement that was in effect prior to July 1, 2012, however, the Contractor must agree to propose to the applicable collective bargaining unit(s) that an equal benefit requirement consistent with this ordinance be incorporated into the next collective bargaining agreement or in the existing agreement upon amendment, extension or other modification that occurs after July 1, 2012.

#### ARTICLE 104: SCOPE OF WORK

This contract includes pond improvements to the existing Arboretum Pond 3 located on both City and University of Wisconsin property. The project area is located off of the cul-de-sac of W. Badger Road and addressed to 1892 West Beltline Highway, Madison, WI.

Existing pond areas will be combined to create one overall pond and stormwater treatment system as shown on the plans. A new storm box will be installed to convey storm water flows from the existing storm box to the new pond to alleviate erosion issues due to the velocity of the water and the change in elevation in the existing greenway area. Where the existing storm box ends and the new storm box starts a large screen treatment structure is to be installed for the removal of sediments and debris from the storm water.

## SECTION 105.1: AUTHORITY OF THE ENGINEER

The Engineer shall resolve all questions which arise as to the quality and acceptability of materials furnished, work performed, manner of performance, rate of progress of the work, interpretation of the plans and Specifications, acceptable fulfillment of the contract, compensation, and disputes and mutual rights between Contractors under the Specifications. The Engineer shall determine the amount and quantity of work performed and materials furnished.

All decisions of the Engineer shall, when so requested, be rendered in writing. They shall be final and conclusive in all matters unless within ten (10) days after such decision the Contractor applies in writing to the Board of Public Works for a review of such decision.

Any change proposed by a Contractor in SBE subcontractors, vendors or suppliers from those SBEs indicated on the SBE Compliance Report must be approved by the Engineer and the City's Manager of the Affirmative Action Division (hereafter, AAD). When requested, such decision shall be rendered in writing. Such decisions shall be final and conclusive in all matters unless within ten (10) days after such decision the Contractor or the affected SBE applies in writing to the Board of Public Works for a review of such decision.

In the event the Engineer and the AAD disagree over the proper decision to be made regarding an SBE, the Mayor shall appoint a third person to resolve the disagreement, within 30 days of appointment. The decision thus rendered may be reviewed by the Board of Public Works upon request of the Contractor or the affected SBE as set forth in Sections 105.1 and 105.2 of the City's standard specifications.

## SECTION 105.12 COOPERATION OF THE CONTRACTOR

The City is not aware of any other existing utilities running through the site other than the water main and existing storm sewer already shown on the plans. Regardless, the Contractor shall perform a One Call through Diggers Hotline prior to beginning construction.

The work required to manage on site ground water and storm water shall be paid under Bid Item 50202, Type II Dewatering and Bid Item 90038, Storm Control. No extra time or monetary compensation shall be granted for these water control items. Any Type I Dewatering required for construction activities shall be considered incidental to the work being performed.

Access is intended to be taken off of the cul-de-sac at the east end of West Badger Road. No other site access location has been approved or provided. There is an existing access road here from previous work. It is recommended that the Contractor visit the site prior to bidding to become familiar with the access restraints and site conditions.

The City of Madison has obtained a Right-of-Entry agreement for working on University of Wisconsin property and a permanent easement is also being finalized. Cooperation between the Contractor and University of Wisconsin and UW Arboretum staff is expected for this project as the majority of the work will take place on University of Wisconsin owned property. ## SECTION 105.13: ORDER OF COMPLETION

The order of doing the work is subject to the review of the City. Prior to the Preconstruction Meeting, the Contractor shall submit to the City a detailed construction schedule showing the sequence and anticipated dates of all construction operations, as well as a Staging/Phasing Plan for approval by the City. The sequence of scheduled operations may be modified by the City to accommodate specific needs.

Contractor shall be diligent in reviewing weather forecasts to manage erosion control, construction schedule, and plans for stormwater control during the project.

## SECTION 107.14 WEAPONS PROHIBITION

Contractor shall prohibit, and shall require its subcontractors to prohibit, its employees from carrying weapons, including concealed weapons, in the course of performance of work under this Contract, other than while at the Contractor's or subcontractor's own business premises. This requirement shall apply to vehicles used at any City work site and vehicles used to perform any work under this Contract, except vehicles that are an employee's "own motor vehicle" pursuant to Wis. Stat. sec. 175.60(15m).

## SECTION 108.2 PERMITS

The City of Madison has submitted a WRAPP permit application to WDNR to request a permit to construct the proposed Arboretum Pond 3 Improvements. The permit shall be posted at a conspicuous location on the project site for at least five days prior to construction and remaining at least five days after construction.

The City of Madison has submitted a DNR Notice of Intent (NOI) to obtain coverage under the Construction Site General Permit No. WI-S067831-3 for construction site erosion control.

The Contractor shall meet the conditions of the permit by properly installing and maintaining the erosion control measures shown on the plans, specified in these Special Provisions, or as directed by the Construction Engineer or his designees. This work will be paid for under the appropriate contract bid items or, if appropriate items are not included in the contract, shall be paid for as Extra Work. A copy of the permit will be available at the City of Madison, Engineering Division office.

This permit covers trench dewatering to a maximum of 70 gallons/minute from the project provided appropriate control measures are in place. The City's obtaining this permit is not intended to be exhaustive of all permits that may be required to be obtained by the Contractor for construction of this project. It shall be the responsibility of the Contractor to identify and obtain any other permits needed for construction:

The Contractor shall be responsible for obtaining any permits required from the Wisconsin Department of Natural Resources for any dewatering systems chosen by the Contractor per the conditions described in Bid Item 50202.

#### Wetlands:

There are wetlands adjacent to the project site and are shown on the plans. Consultation with WDNR staff during the design process indicated that a Chapter 30 permit is not required for this project. Disturbance of the wetland areas within the proposed pond improvement areas is allowed as they are resultant from the failure of the existing pond system. Disturbance of wetland areas outside the work areas as shown on the plans will not be allowed and care must be taken to stay out of these areas during the construction process.

## SECTION 109.2 PROSECUTION OF THE WORK

The Contractor shall begin work on this project on or before OCTOBER 1, 2012. Work shall begin only after the start work letter is received. If it is desirable to begin work before the above-mentioned date, the Contractor shall establish a mutually acceptable date with the City Engineer (contact the Construction Engineer at 266-9091).

The time of completion will be computed in accordance with Section 109.7 of the Specifications starting with the latest start date or the date work actually begins whichever is sooner. The Contractor shall complete a minimum of 40% of the work by December 31, 2012. If it becomes necessary to partially or completely suspend construction operations for some portion of winter months and a request to this affect by the Contractor is approved by the City Engineer, the Contractor will resume operations at the earliest practical date in 2013 and diligently pursue the work to completion. It is understood here that all work shall be completed on the project by **JUNE 1**<sup>ST</sup>, **2013**.

If suspension of work is required and allowed, the Contractor shall have methods in place to safely pass stormwater runoff through the site, with minimal erosion and minimal damage to work already completed, prior to shut down for the winter. Clear stone berms, temporary sediment basins and use of polymer are all to be considered by the Contractor. If shutdown is requested an erosion control plan for shut down shall be submitted to the Construction Engineer for approval as part of the shutdown request. The Contractor shall be paid for two (2) mobilizations on this job – one (1) for the main mobilization at the commencement of work and one (1) in the spring of 2013 to complete the remaining items.

The Contractor shall limit the workdays from 7:00 a.m. to 7:00 p.m., unless approved by the Engineer in writing and no work shall be performed on holidays.

## ARTICLE 200 EARTHWORK (CUT/FILL)

The earthwork quantities for this job have been broken up into two types.

The excavation quantities for the pond have been calculated using two (2) digital terrain models (existing and proposed). Cut (in place quantities) and fill have been estimated from this model and unless there are significant changes to the plan the quantity in the contract shall be the final amount for payment. No shrinkage factor has been applied to the earthwork quantities.

Placement of fill: Excavated material shall be utilized on site during construction of the ponds. Excess cut on the project shall be categorized by the construction engineer and place in as topsoil stockpiles or as general fill stockpiles, or hauled off-site. The stockpiles shall be enclosed by the use of a silt fence paid under Bid Item 21021, Silt Fence. The Contractor shall be paid for excavation of the material and for three (3) different classes of fill.

The digital contour model for the project, in MicroStation DGN format, will be made available to the Contractor. The contractor assumes all responsibility for maintaining the integrity of the electronic data and all responsibility and liability for the use of the electronic data. The contractor shall satisfy himself as to the accuracy of the electronic data provided, shall cross-

check his calculations against the hard copy plans included in with the bid documents and shall quote the work accordingly based upon his calculations.

Fill placement shall be paid as one of the following classes and as determined by the construction engineer:

- 1. BID ITEM 20221 TOPSOIL topsoil being placed throughout the pond project shall be paid under this item. This includes 6" of topsoil placement on all areas above the normal water elevation of the pond as noted in the plan set.
- 2. BID ITEM 20202 FILL– Placement of fill for the project limits except for the sewer backfill shall be constructed from on-site material as approved by the Construction Engineer, and shall be placed in accord with the City of Madison Standard Specifications for Public Works Construction Section 202. The sewer backfill shall be constructed from on-site material but shall be paid for under the 5X8 Box Culvert, Bid Item 50501.
- 3. BID ITEM 90034 HAULING & OFF-SITE DISPOSAL this item shall remove excess material from the site and dispose of it at a location to be provided by the Contractor. Excess material consists of all material that is not used on site.

## ARTICLE 501 - SEWER AND SEWER STRUCTURES GENERAL

## BID ITEM 10750 - RESET MONUMNET

Work under this item shall include all costs associated preserving and if necessary resetting the existing monument(s) adjacent to the planned work in accordance with Section 107.2(a) of the City of Madison Standard Specifications for Public Works Construction 2012 Edition. ## **BID ITEM 10911 - MOBILIZATION**

#### **DESCRIPTION**

Work under this item shall include all costs associated with mobilization of the Contractor to the site. Parking of equipment and staging shall be allowed only within the disturbance area. In addition to Mobilization requirements in the City of Madison Standard Specifications for Public Works Construction, all equipment used on the project is to be cleaned to remove any soil and seeds prior to entering the site.

There are two (2) Mobilizations included in the contract, one will occur in the Fall of 2012 at the start of work and the second will be for resuming/completing work in the Spring of 2013.

#### METHOD OF MEASUREMENT

Mobilization shall be paid as a lump sum for all the work described above.

#### **BASIS OF PAYMENT**

Mobilization for sewer construction shall be measured as described above which shall be full payment for all work as described above.

## **BID ITEM 20101 - EXCAVATION CUT**

#### DESCRIPTION

Excavation Cut shall be the in place quantity of excavation cut with no adjustment for shrink or swell. Work under this item shall include excavation to the finish grades as represented by the contours on the plan set or as shown on the cross sections. Where clay liner and topsoil in the pond area is to be placed below the finish grades shown, the over excavation for the placement of clay liner and topsoil has been included in the excavation quantity.

The pond bottom shall be over-excavated twenty four (24) inches to allow for the installation of a compacted clay liner, as shown on the plans. The Contractor shall install the clay liner for the pond and to the maximum extent possible, on-site excavated clay shall be used to construct the clay liner. Clay excavated from the site shall receive moisture conditioning efforts by the Contractor as necessary to achieve an appropriate moisture level that will allow the Contractor to achieve the required level of compaction. All pond grading shall be completed in accordance with the grading plan and the Typical Pond/Berm Cross Section provided in the plan set. All fill material shall be placed and compacted in accordance with the Standard Specifications and in accordance with the recommendations outlined in the soils report completed for this project by CGC, Inc. A copy of that soils report is included following these special provisions.

All existing berms shall be removed to the toe of the outside slope prior to the construction of the berms as shown on the engineering drawings. Materials removed from the existing berms may be used in the construction of the new berms, if suitable for construction as per attached soils report.

Temporary stockpiling of topsoil quantities that is required for Bid Item 20221 – Topsoil shall be considered incidental to this bid item. The redistribution of the topsoil quantity shall be paid under Bid Item 20221 – Topsoil.

Placement of on-site fill shall be compensated for under Bid Item 20202 Fill. The excess material beyond that needed for construction of the pond shall be taken off-site and disposed of by the Contractor at a site provided by the Contractor under Bid Item 90032, Hauling & Off-Site Disposal.

The type of fill used for each of the above types of placement/use of excess cut shall be at the discretion of the City Engineering and the Contractor shall not be entitled to a specific type of excess cut to be hauled off-site and disposed of. Rather the Contractor shall haul off-site whatever material is not desired to be used by the Construction Engineer.

The quantity for Excavation Cut has been estimated from in place quantities and no adjustment shall be made to this quantity unless substantial changes to the plans occur during construction. If there are substantial changes in the pond grading, city crews shall survey the area, and the difference in Excavation Cut over/under the existing terrain shall be calculated on an in-place basis by the Design Engineer. The excavation cut quantity was determined from the difference of the proposed surface model and the existing surface model equal to 14,406 cubic yards. In addition, the additional 2 feet required for the clay liner has been added into the quantity for excavation cut equal to 4,392 cubic yards. Therefore the total volume to be excavated is 18,798 cubic yards.

The Contractor shall be responsible for separation of the excavation cut into the following classes of material and stockpiling:

Clay - for on-site use in construction clay liner in pond.

Granular material for on-site use

Topsoil - for use on-site

Excess topsoil, mineral or granular materials – to be hauled off-site and disposed of at a location provided by the Contractor.

The City of Madison shall have an inspector on site to assist in determining what classifies as topsoil and clay, and what material is suitable for placement in berms, for topsoil placement on site. The Contractor shall be responsible for excavation of this material in a manner so as to not contaminate each individual type of material.

#### METHOD OF MEASUREMENT

Excavation Cut will not be measured but shall be based on the plan quantity as estimated on the proposal, except as noted above for field changes and roadway undercut.

#### BASIS OF PAYMENT

Excavation cut shall be measured as above and paid for at the contract price, which shall be full compensation for all work laid out in the description.

## BID ITEM 20202 - FILL

#### DESCRIPTION

Work under this item shall include providing and placing fill, from excavated on-site clay or granular material and providing additional fill. This item includes all required movement and placement of the fill to the contours and elevations shown on the plan and cross sections. The fill shall be placed to meet the finish grades as shown on the plan set, as staked in the field, and as discussed in these special provisions.

Clay or granular material shall be stockpiled on site during construction operations and used as required to provide fill for the clay liner and placement shall be paid under this item. If additional clay is necessary the material shall be paid for under Bid Item 90033 – Import Clay Fill for Pond Liner. All redistribution of clay shall be paid for under this bid item. The stockpiling and placement shall be included in the price of FILL and the contractor shall not be compensated in any additional manner for completing this requirement.

The amount of fill has been estimated from the digital terrain model and does not include the use of a shrinkage factor. Unless substantial changes occur during construction, the quantity of fill to be paid shall be held constant and the estimated amount shall be the final amount for payment. The fill quantity was determined from the difference of the proposed surface model and the existing surface model equal to 2,957 cubic yards. In addition, the additional 2 feet required for the clay liner has been added into the quantity for fill equal to 4,392 cubic yards. Therefore the total volume to be filled on site is 7,349 cubic yards.

As the top of these berms have elevations which are generally higher or equal in elevation to the ground on which they are being constructed, the contractor shall first strip the topsoil from the base area of the berm. The berms shall then be constructed and compacted with a sheeps-foot roller (or similar equipment) and the clay for these berms shall be placed in 8" to 12" lifts.

## METHOD OF MEASUREMENT

Fill will not be measured but will be based on plan quantities as estimated from the plan set, except as noted above for substantial field changes. The quantity listed in the proposal is an in place quantity.

#### BASIS OF PAYMENT

Fill shall be measured as above and paid for at the contract price, per cubic yard, which shall be full compensation for all work laid out in the description.

## **BID ITEM 20217 - CLEAR STONE**

#### **DESCRIPTION**

Clear Stone shall meet the requirements for Gradation Number One (No. 1) of the Standard Specifications, commonly known as three-inch clear stone. The clear stone shall be utilized in Bid Item 21014 Construction Entrance, Bid Item 90042 Screen Treatment Structure, Bid Item 50501 8X5 RCP Box Culvert, and 5X10 Storm Structure Bid Item 9004.

#### METHOD OF MEASUREMENT

Clear Stone shall be measured by the ton in place.

#### BASIS OF PAYMENT

Clear Stone shall be paid at the contract price for work as described and measured above including all work, materials, labor, and incidentals.

## **BID ITEM 20221 – TOPSOIL**

#### DESCRIPTION

Topsoil shall include all work, materials, labor, and incidentals necessary to redistribute and fine grade six (6) inches of topsoil to the final elevations as noted on the grading plan in accord with the Standard Specifications to the limits of disturbance. The excavation and temporary stockpiling of the topsoil shall be compensated for under Bid Item 20101, Excavation Cut. The Contractor shall determine the quantity of on-site topsoil from stockpile sizes and redistribute the topsoil accordingly if it is anticipated that there will be less than 6" of topsoil available for the surface. All topsoil used for final restoration must originate on-site, no imported topsoil will be allowed on UW Arboretum Property.

#### METHOD OF MEASUREMENT

Topsoil will not be measured but will be based on plan quantity of topsoil. Unless substantial changes occur during construction, the quantity to be paid shall be held constant and the estimated amount shall be the final amount for payment. If there are substantial changes in the grading, city crews shall resurvey the area. Any areas outside the grading limits shown on the plans, which are disturbed, shall be restored by the Contractor but no measurement or payment shall be allowed for these areas. Topsoil shall be measured by the square yard.

## BASIS OF PAYMENT

Topsoil shall be paid at the contract price for work as described and measured above including all work, materials, labor and incidentals.

## BID ITEM 20229 – HEAVY RIP RAP

Work under Bid Item 20229 Heavy Rip Rap shall be in accordance with Article 212 of the Standard Specifications for Public Works Construction except sedimentary rock will not be allowed. All Heavy Rip Rap provided must be durable field stone.

## BID ITEM 20231 – EXTRA HEAVY RIP RAP

Work under Bid Item 20231 Extra Heavy Rip Rap shall be in accordance with Article 212 of the Standard Specifications for Public Works Construction except sedimentary rock will not be allowed. All Extra Heavy Rip Rap provided must be durable field stone.

## **BID ITEM 20705 DETENTION BASIN SEEDING**

## **DESCRIPTION**

Work under Bid Item 20705 Detention Basin Seeding shall include seeding, soil stabilizers (polymers), and cover crop in accordance with Section 207 of the Standard Specifications for Public Works Construction except as noted below.

The following seed mix is to be used in place of the City's Standard Wet Detention Basin Seed mix as noted on the drawings. Seeding rate: 9.53 lb/ac.

#### BASIS OF PAYMENT

Detention Basin Seeding shall be paid for at the contract price, which shall be full payment for all work, materials (including seed, cover crop, and soil stabilizer) and incidentals to complete the work in accordance with the description.

## BID ITEM 20706 NO-MOW WITH ANNUAL RYE SEEDING

#### **DESCRIPTION**

Work under Bid Item 20706 No-Mow With Annual Rye Seeding shall include seeding, soil stabilizers (polymers), and cover crop in accordance with Section 207 of the Standard Specifications for Public Works Construction except as noted below.

The following seed mix is to be used in place of the City's Standard No Mow Seed mix as noted on the drawings. Seeding rate: 8.00 lb/ac.

Included with this bid item is a cover crop of winter wheat that shall be applied to hold the soil while the native seeds become established. Winter wheat shall be applied at a rate of 20 lbs. per acre and per the requirements of Section 207 of the City of Madison Standard Specifications for Public Works Construction.

No mulch or fertilizer is to be used prior to or after the seeding. All restored areas will be protected with the appropriate erosion control matting as specified on the plans.

All seeding is to include a sixty (60) day watering period provided by the Contractor. No fertilizer is to be used during or after the seeding.

#### METHOD OF MEASUREMENT

No-Mow With Annual Rye Seeding shall be measured by the square yard, in place. Areas outside the pond grading limits shall not be measured for payment.

#### **BASIS OF PAYMENT**

No-Mow With Annual Rye Seeding shall be paid for at the contract price, which shall be full payment for all work, materials (including seed, cover crop, and soil stabilizer) and incidentals to complete the work in accordance with the description.

## BID ITEM 21083 – EROSION MATTING, CLASS III, TYPE C

Work under Bid Item 21083 Erosion Matting, Class III, Type C shall be in accordance with Section 210.2(c) of the Standard Specifications for Public Works Construction except the top cover matting shall be Class II, Type B per the TRM detail included on Sheets 5 and 7 of the plan set.

## BID ITEM 50419 – 42 INCH RCP STORM SEWER PIPE

#### DESCRIPTION

Work under this item shall include all necessary work, materials, and incidentals necessary to provide and install a 42" RCP Storm Sewer Pipe as indicated in the plan set. The pipe shall be in accordance with Section 504 of the Standard Specifications for Public Works Construction. The 48" pipe shall be backfilled with existing materials. Included with this bid item are concrete pipe joint ties for the entire length of pipe from the storm treatment structure to the 5x10 storm structure. The pipe length is approximately 21 feet long from edge of structure and there are twin pipes for a total length of 42 feet. See standard detail drawing 5.4.6 in the City of Madison Standard Specifications for Public Works for a detail drawing on joint ties.

#### METHOD OF MEASUREMENT

42 Inch RCP Storm Sewer Pipe shall be measured as linear foot as upon complete installation of the pipe in the field.

#### **BASIS OF PAYMENT**

42 Inch RCP Storm Sewer Pipe shall be measured as described above which shall be full compensation for all work, materials and incidentals to complete the work as explained in the description above.

## **BID ITEM 50501 - 5' X 8' BOX CULVERT**

#### **DESCRIPTION**

This item shall include all work and coordination necessary to provide and install the 5' x 8' box culvert as shown on the plan set, and as detailed here.

Trench excavation material shall be used to backfill the trench and to restore the top of the trench above the outside top of box. Granular material (3" CLEAR STONE) shall only be used to provide a bedding/base for the box as described below.

Any excavation and disposal of excess material (at an offsite location provided by the contractor) resulting from the box culvert installation is to be considered incidental to the box culvert installation and is not considered in the cut or fill quantities for the pond grading.

The Contractor shall be responsible for coordinating delivery of the box, unloading and other incidentals associated with the installation.

The contractor shall abide by the following guidelines when installing the box culverts:

- 1) The subgrade for the boxes shall have filter fabric (included with this bid item) placed on all exposed subgrade areas prior to placement of the bedding stone for the boxes.
- One (1) foot of three (3) inch clear stone shall then be placed on the geotextile as bedding stone. Three (3) inch clear stone for box culvert bedding is included in the price of box culvert installation.
- 3) Pipe backfill above the bedding stone shall utilize on site existing materials from the trench excavation and shall be included with this bid item.

#### METHOD OF MEASUREMENT

5'X8' Box Culvert shall be measured by the linear - foot for box culvert provided and installed.

#### BASIS OF PAYMENT

5'X8' Box Culvert shall be measured as stated above and shall be paid at the contract price which shall be full payment for all work as laid out in the description.

## BID ITEM 90030 REMOVE EXISTING OUTLET STRUCTURE

#### DESCRIPTION

The Contractor shall be responsible for removal and off-site disposal of the outlet structures indicated on the plans. All material shall be disposed of off-site at a location to be determined and provided by the Contractor.

#### METHOD OF MEASUREMENT

Remove Existing Outlet Structure shall be measured by each for the completed work.

#### BASIS OF PAYMENT

Remove Existing Outlet Structure shall be paid at the contract price for work as described and measured above included all work, materials, labor, hauling, placement at a disposal site and incidentals.

## BID ITEM 90031 REMOVE EXISTING GABION BASKET STRUCTURE

#### **DESCRIPTION**

The Contractor shall be responsible for removal and off-site disposal of the existing gabion structures indicated on the plans. All material shall be disposed of off-site at a location to be determined and provided by the Contractor.

## METHOD OF MEASUREMENT

Remove Existing Gabion Basket Structure shall be measured by lump sum for the completed work.

#### BASIS OF PAYMENT

Remove Existing Gabion Basket Structure shall be paid at the contract price for work as described and measured above included all work, materials, labor, hauling, placement at a disposal site and incidentals.

## **BID ITEM 90032 PROTECTIVE FENCING**

#### DESCRIPTION

Several existing trees in the vicinity of the construction must be protected from damage. The Contractor shall furnish, install and maintain protective fencing around said trees, as shown on the plans, and protect these trees. Fencing shall be construction grade orange mesh with a minimum height of four (4) feet. The Contractor shall properly install steel fence posts at a maximum interval of eight (8) feet and securely attach the fencing to these steel posts. The protective fencing shall be in place and approved by the Construction Engineer in coordination with UW/UW Arboretum staff prior to any land disturbance, brush removal, or tree removal activities. When directed by the construction engineer towards the end of the project the Contractor shall remove the fencing and fence posts and restore the area.

#### METHOD OF MEASUREMENT

Construction Fencing shall be measured by the Linear Foot.

#### BASIS OF PAYMENT

Construction Fencing shall be measured as described above which shall be full compensation for providing, placing, maintaining, and removing the fencing.

#### BID ITEM 90033 IMPORT CLAY FOR POND LINER

#### DESCRIPTION

If attempts to use the on-site excavated clay for the pond liner fail due to extreme moisture that moisture conditioning efforts cannot correct, or due to an insufficient volume of on-site excavated clay to complete the liner, the Contractor shall import clay for construction of the pond liner. Imported clay material shall be appropriate for the construction of the pond liner and shall be at a moisture content which allows the Contractor to place and achieve the specified level of compaction, minimum 90% (ASTM D1557). The Contractor shall provide truck tickets for all imported clay material and present said tickets to the construction engineer at the end of each work day.

This item includes all materials to provide 24" (finish depth) of clay over all excavated areas within the pond. The pond shall contain clay from the top of the pond berm to the lowest elevation of the pond. The clay lining shall be compacted to a reasonable level with suitable equipment such as "sheep's foot rollers" but no compaction tests will be required. The placement of clay liner shall be paid for under Bid Item 20202 – Fill.

If this item is used then hauling and off-site disposal of additional material from the site shall be included with this bid item.

#### METHOD OF MEASUREMENT

Clay lining placement shall be measured by the Cubic Yard as an in place quantity. This will be estimated by measuring the surface area over which the clay lining shall be placed and assuming a 24" depth.

#### BASIS OF PAYMENT

Clay lining placement shall be measured as discussed above which shall be full payment for all work as laid out in the description.

## BID ITEM 90034 - HAULING AND OFF-SITE DISPOSAL

## **DESCRIPTION**

This item includes all necessary work, equipment, labor, and incidentals required to load, from the project site, excess material (clay, topsoil, other onsite material) identified by the City Construction Inspector, remove the material, and haul the material to an off-site disposal site, to be provided by the contractor, and place the material at that site.

The type of fill used for all excavation placement/use of excess cut shall be at the discretion of the City Engineer and the Contractor shall not be entitled to a specific type of excess cut to be hauled off-site and disposed of. Rather the Contractor shall haul off-site whatever material is not desired to be used by the Construction Engineer.

The hauling and off-site disposal was determined from the difference of the proposed surface model and the existing surface model. The volume of material being excavated from the site is equal to 18,798 cubic yards and the volume of fill material is equal to 2,957 cubic yards. Therefore the total volume to be hauled off site is 15,841 cubic yards. In the event that off-site clay liner is needed due to the materials found on site then the additional hauling and off-site removal shall be paid for under the Import Clay Liner for Pond, Bid Item 90033.

#### METHOD OF MEASUREMENT

Hauling and Off-Site Disposal shall be measured by the cubic yard for the completed work as described above.

#### BASIS OF PAYMENT

Hauling and off-site disposal shall be measured as described above which shall be full payment for all work, materials, and incidentals required to complete the work in accordance with the description.

## BID ITEM 90035 POND OUTLET STRUCTURE OS-1

#### DESCRIPTION

This item includes all required construction to provide a fully functioning and operational outlet structure for the new pond facility including all piping, apron endwall and the cast-in-place structure. Construction shall be completed in accordance with the details provided in the plan set and the Standard Specifications.

This item includes include furnishing all materials necessary to perform the work, including castings; reinforcing; excavation; installation and removal of sheeting and bracing; removal of water from the excavation; disposal of surplus material from the excavation; backfilling the excavation and compaction of the backfill material; preparation of the foundation; construction of the structure, reconnection of all existing pipes, connection of new pipes, including connections; cleaning out the structure; restoring the site; and all other work incidental to the installation of the structure. Construction of this structure shall be in accord with Section 507 of the Madison Standard Specifications for Public Works Construction 2012 edition and any subsequent addendums.

#### METHOD OF MEASUREMENT

Pond Outlet Structure OS-1 shall be measured as lump sum complete.

#### BASIS OF PAYMENT

Pond Outlet Structure OS-1 shall be measured as above and paid at the contract price which shall be full compensation for all work, materials, and incidentals to complete the work as explained in the description above.

## BID ITEM 90036 EXCAVATE AND GRADE ENERGY DISSIPATER

#### DESCRIPTION

This item includes all required construction to provide an energy dissipater including all riprap, heavy riprap filter fabric and excavation and removal of excess material, and all other work incidental to the installation of the energy dissipater. Construction shall be completed in accordance with the details provided in the plan set and the Standard Specifications.

## METHOD OF MEASUREMENT

Excavate and Grade Energy Dissipater shall be measured as each is complete.

## **BASIS OF PAYMENT**

Excavate and Grade Energy Dissipator shall be measured as above and paid at the contract price which shall be full compensation for all work, materials, and incidentals to complete the work as explained in the description above.

## BID ITEM 90037 CHAIN LINK FENCE AND DUAL LEAF GATE

## DESCRIPTION

New chain link fence and the associated dual leaf gate as shown on the plans shall be six (6) feet in height and shall be constructed in accordance with the details provided in the plan set and the latest edition of the Standard Specifications for Highway and Structure Construction of the State of Wisconsin Department of Transportation.

This work shall be paid for at the unit prices for New 6' High Chain Link Fence and New 20' Wide Dual Leaf Gate which shall be considered full compensation for furnishing all required materials, installation, and all equipment, tools, labor and incidentals necessary to complete the work as specified.

Note that the chain link fence that will be installed on top of the structure wall for the Storm Treatment Structure shall not be included as part of Bid Item 90037 Chain Link Fence and Dual Leaf Gate. Rather it shall be included with and considered incidental to Bid Item 90039 Storm Treatment Structure.

## METHOD OF MEASUREMENT

Construction Fencing shall be measured by the Linear Foot.

## **BASIS OF PAYMENT**

Construction Fencing shall be measured as described above which shall be full compensation for providing, placing, maintaining, and removing the fencing.

## BID ITEM 90038 – STORM CONTROL

## **DESCRIPTION**

Work under this item shall include all work, materials, equipment, and incidentals required to control dry, backwater conditions and wet weather flow in the storm sewer system during the project. Further, depending on pond levels during construction of this project there can be backwater from the pond up the storm system.

The Contractor shall take all necessary steps to protect the new storm main and storm structures from damage during construction and to accommodate the existing flows during construction.

This item includes all storm control necessary for all aspects of the Construction. This item is not for control of groundwater.

## METHOD OF MEASUREMENT

Storm Control shall be measured by the lump sum for all that necessary throughout construction.

#### BASIS OF PAYMENT

Storm Control shall be paid for at the contract price, which shall be full compensation for all work as outlined in the description.

## BID ITEM 90039- SCREEN TREATMENT STRUCTURE

## **DESCRIPTION**

Work under this item shall include all necessary work, materials, and incidentals necessary to construct the treatment structure to the details and location identified in the plan set.

The dimensions of the treatment structure shall conform to those indicated on the detail sheets of 12, 13, 14, and 15 of the plan set. Included with this item are all materials for building the structure indicated on the detail sheet including: excavation cut, fill, concrete, rebar reinforcement, clear stone, heavy riprap filter fabric, chain link fence, fence gate, removal of existing box culvert, removal of box culvert endwall, saw cutting box culvert, 4" diameter PVC with wedge wire debris screen, coanda screen, and rubber belting. Construction of this structure shall be in accord with Section 507 of the Madison Standard Specifications for Public Works Construction 2012 Edition and to the details in the plan set.

The coanda screen shall be purchased and installed by the contractor. The Contractor shall be responsible for coordination of delivery, unloading, and installation of the screen. The Contractor shall install the screen according to manufacturer's specifications and guidance and shall be anchored to the concrete on twelve inch centers with 3/8" anchor bolts. The screen shall be of a wedge wire coanda screen with an opening of 0.5 mm, wire tilt of 7 degrees, and screen wire width of 1.5 mm. The screen shall be provided in 5 foot sections (horizontal) in which 7 will be installed on each side for a total of 14 sections. Each section shall be 6 feet long (vertical) with a 0.75 foot accelerator plate on top and a 5.25 foot length of screen. For

information regarding ordering the coanda screen please contact Bob Weir, Hydroscreen, at (303) 393-8298.

Additionally, a 4" PVC pipe shall be installed from the 6 foot wide debris chamber to the outlet. This 4" PVC shall consist of a wedge wire debris screen. For information regarding ordering the debris screen please contact Bob Weir, Hydroscreen, at (303) 393-8298.

Both 42" RCP pipes at the outlet of the structure shall be paid for under Bid Item 50419. All 8X5 box culverts shall be paid for under Bid Item 50501. The outlet transition from treatment structure to 5X8 box culvert shall be included in this item which shall include all necessary work, materials, and incidentals.

Dewatering Type I shall be incidental to the complete project and Dewatering Type II shall be paid for under Bid Item 50202. No concrete shall be installed in water nor shall water be allowed to rise over concrete if there is danger of flotation or of setting up unequal pressures in the concrete until the concrete has set at least set for 24 hours and any danger of flotation has been removed.

## METHOD OF MEASUREMENT

Screen Treatment Structure shall be measured as a completed unit upon complete construction of the structure in the field.

## **BASIS OF PAYMENT**

Screen Treatment Structure shall be measured as described above which shall be full compensation for all work, materials and incidentals to complete the work as explained in the description above.

## BID ITEM 90040 5X10 STORM STRUCTURE

## DESCRIPTION

Work under this item shall include construction of a 5'X10' Storm Structure. Twin castings shall be centered on the structure and contain the same distance between the edge of casting to outside wall and from edge of casting to edge of casting. The castings shall be Neenah R-1550-054 or equivalent.

This item includes all materials, incidentals, and labor required to complete the work. Construction of this structure shall be in accord with Section 507 of the Madison Standard Specifications for Public Works Construction 2012 edition and any subsequent addendums.

## METHOD OF MEASUREMENT

5X10 Storm Structure shall be measured as structure construction is complete.

## BASIS OF PAYMENT

5X10 Storm Structure shall be measured as above and paid at the contract price which shall be full compensation for all work, materials, and incidentals to complete the work as explained in the description above.

## **BID ITEM 90041 SAS ACCESS ROAD - PERMANENT**

## **DESCRIPTION**

SAS Access Road – Permanent shall include all incidentals, labor and equipment required to grade and install materials for the access road as shown on Sheet 4 and per the detail included on Sheet 6 of the plan set. The amount of No. 2 Crushed Stone required to provide the 10 inch thick stone base shall be measured and paid separately per Bid Item 40102. The 6 inches of top soil over the access road shall be measured and paid separately per Bid Item 20221.

## METHOD OF MEASUREMENT

SAS Access Road – Permanent shall be measured by lump sum for the completed work.

## **BASIS OF PAYMENT**

SAS Access Road – Permanent shall be paid at the contract price for work as described and measured above.

## RIGHT OF ENTRY

The Board of Regents of the University of Wisconsin System ("Owner"), being the owner of the property hereinafter described (the "Property"), in consideration of the sum of One Dollar (\$1.00), the receipt whereof is hereby acknowledged, grants and conveys to the City of Madison (the "City"), a Wisconsin municipal corporation located in Dane County, Wisconsin, its agents and contractors, a Right of Entry in the Property for the purpose of performing construction activities associated with the installation of a new public water main serving the area south of the West Beltline Highway, and retention pond intended to benefit the UW Arboretum storm water drainage needs; including the right of ingress and egress and the right to operate necessary equipment thereon for said construction activities.

This Right of Entry shall commence on July 1, 2012, and shall expire on the earlier of (a) the completion of the construction activities, or (b) execution of a Permanent Limited Easement for public storm water management and public water main purposes by the Owner.

Dear Mr. Troester:

CGC, Inc. has completed our geotechnical services for the above-referenced project. At your request, ten soil borings were drilled in the area of a proposed detention pond to be located in the Arboretum about 400 ft northeast of Home Concepts at 2134 W. Beltline Highway in Madison, WI. An inlet structure and box culvert are also planned east of Home Concepts that will discharge to the pond. The borings were performed on January 10, 2011. The borings were marked out in the field by CGC and Held Engineering personnel prior to drilling and are shown on a boring location plan provided to us (copy attached in Appendix A). Held Engineering surveyed both boring locations and ground surface elevations. The following paragraphs discuss our observations and provide opinions relative to pond construction.


## SUBSURFACE PROGRAM & OBSERVATIONS

The borings were drilled to depths selected by CGC utilizing the services of Badger State Drilling (under subcontract to CGC) using a track-mounted, rotary CME 750 ATV drill rig equipped with hollow-stem augers. Standard Penetration Test (SPT) drilling techniques (ASTM D1586) were used for the full exploration depth at the boring locations. This method consists of driving a 2-inch outside diameter split-barrel sampler using a 140-pound weight falling freely through a distance of 30 inches. The sampler is first seated 6 inches into the material to be sampled and then driven 12 inches. The number of blows required to drive the sampler the final 12 inches is recorded on the log of borings and is known as the Standard Penetration Resistance (commonly referred to as the N-value).

During the field exploration program, the driller visually classified the soils and prepared a field log. Water level observations were made within the borings during and shortly after drilling, which are shown on the bottom of each boring log. Note groundwater was encountered at a consistent depth of about 8 to 9 ft below the ground surface. Groundwater levels are anticipated

to fluctuate based on seasonal variations in precipitation, infiltration, nearby lake/stream stages, etc. Upon completion of drilling, the borings were backfilled to satisfy WDNR requirements and the soil samples delivered to our laboratory for visual classification and moisture content evaluation. The soils were visually classified by CGC and reviewed by a geotechnical engineer using the Unified Soil Classification System (USCS). The final logs prepared by the engineer and a description of the USCS are presented in Appendix A. Note the logs include moisture content information.

The attached soil conditions indicate that somewhat consistent soil conditions exist at the boring locations. In general, about 8 to 8.5-in. of topsoil mantles the site that is underlain by soft to stiff lean clay that ranges from about 2 to 12 ft thick. The clays are not present in B-2 and B-10, with a 2-ft layer of fill involving silt and/or clayey sand present instead. This fill is also present in B-9 sandwiched between the topsoil and clay. Very loose to medium dense granular soils (both sands and silts) underlie the clays and extend to the maximum depths explored. As an exception, the sands in B-2 and B-9 become dense to very dense where possible to probable sandstone was encountered below the granular soils.

Note that Borings 9 and 10 were drilled on the top of a divider berm that was constructed in the present basin area. Borings 3 to 7 were drilled on what appeared to be overburden materials dozed around the perimeter of the basin to create a berming effect, with Boring 8 drilled within the basin base soils. As such, some of the soils noted in B-3 to B-7 may actually be fill, with differentiation very difficult because soils used to create the berming effect are indigenous to the area. Borings 1 and 2 were drilled along the box culvert and inlet structure alignment. Please refer to the final logs included in Appendix A for additional information specific to a boring question.

## CONSTRUCTION CONSIDERATIONS

Construction details are in the process of being developed at the time of this report submittal. We offer the following regarding construction:

1. The soils observed in the borings (excluding topsoil - see below) are acceptable for berm construction; however, moisture conditioning will be necessary to lower water content values to acceptable levels to achieve compaction. For example, to achieve the recommended minimum compaction level for the clays of 90% of modified Proctor (ASTM D1557), the on-site clays will require being dried back to a moisture content in the range of about 15-17% or lower. Sands and silts will require lower moisture values estimated in the 12-15% range or less. As shown on the right side of the boring logs under the column labeled "W", the majority of the clay soils have moisture contents well above the estimated optimum values.

- 2. To limit lateral seepage through the berms, we recommend the inboard surface of the berm be lined with 18-in. of compacted clay. If the pond is to be a "wet pond", then the clay thickness should be increased to 24-in. thick and also be placed in the basin base. The clays should be placed in a minimum two lifts that are compacted to a minimum 90% (ASTM D1557). Other granular materials used to construct the remainder of the berm should also be compacted to 90% minimum. As an alternative to a liner constructed on the inboard berm face, a clay core could be constructed (with details to be provided if desired). In either case, on-site clays are acceptable for use after moisture conditioning, but must be segregated from granular soils during excavation.
- 3. We recommend exterior slopes for the berm be 2H:1V (horizontal to vertical) or flatter. Also, topsoil should be removed prior to berm construction, followed by disking of the exposed subgrade soils and compaction to achieve 90% densification. Some undercutting/replacement of the subgrade soils may be needed to achieve firm subgrade conditions on which to build.
- 4. We recommend the berms be over-built 6-in. in height to account for potential settlement of the underlying clays that exist along portions of the alignment (assuming berm is about 5 ft in height).
- 5. Excess topsoil (if any) can be used to flatten the outboard face of the berm if the exterior is to be mowed.
- 6. Regarding structure construction near B-2, we recommend the concrete base be founded at least 4 ft below final grade for frost protection. Adequate bedding should also be used between the structure base and firm medium dense sands anticipated in the area.
- 7. Adequate bedding should also be used below the box culvert. Some subgrade soils may require undercutting/breaker rock stabilization along the alignment based on B-1 data and actual observation of the subgrade during excavation. In addition, the use of a geotextile (e.g. Mirafi 500X or equivalent) may be necessary.





## RECOMMENDED COMPACTED FILL SPECIFICATIONS

## **General Fill Materials**

Proposed fill shall contain no vegetation, roots, topsoil, peat, ash, wood or any other non-soil material which by decomposition might cause settlement. Also, fill shall never be placed while frozen or on frozen surfaces. Rock, stone or broken concrete greater than 6 in. in the largest dimension shall not be placed within 10 ft of the building area. Fill used greater than 10 ft beyond the building limits shall not contain rock, boulders or concrete pieces greater than a 2 sq ft area and shall not be placed within the final 2 ft of finish subgrade or in designated utility construction areas. Fill containing rock, boulders or concrete pieces should include sufficient finer material to fill voids among the larger fragments.

## **Special Fill Materials**

In certain cases, special fill materials may be required for specific purposes, such as stabilizing subgrades, backfilling undercut excavations or filling behind retaining walls. For reference, WisDOT gradation specifications for various types of granular fill are attached in Table 1.

## **Placement Method**

The approved fill shall be placed, spread and leveled in layers generally not exceeding 10 in. in thickness before compaction. The fill shall be placed at moisture content capable of achieving the desired compaction level. For clay soils or granular soils containing an appreciable amount of cohesive fines, moisture conditioning will likely be required.

It is the Contractor's responsibility to provide all necessary compaction equipment and other grading equipment that may be required to attain the specified compaction. Hand-guided vibratory or tamping compactors will be required whenever fill is placed adjacent to walls, footings, columns or in confined areas.

## **Compaction Specifications**

Maximum dry density and optimum moisture content of the fill soil shall be determined in accordance with modified Proctor methods (ASTM D1557). The recommended field compaction as a percentage of the maximum dry density is shown in Table 2. Note that these compaction guidelines would generally not apply to coarse gravel/stone fill. Instead, a method specification would apply (e.g., compact in thin lifts with a vibratory compactor until no further consolidation is evident).

## **Testing Procedures**

Representative samples of proposed fill shall be submitted to CGC, Inc. for optimum moisture-maximum density determination (ASTM D1557) prior to the start of fill placement. The sample size should be approximately 50 lb.

CGC, Inc. shall be retained to perform field density tests to determine the level of compaction being achieved in the fill. The tests shall generally be conducted on each lift at the beginning of fill placement and at a frequency mutually agreed upon by the project team for the remainder of the project.

# APPENDIX C DOCUMENT QUALIFICATIONS

## I. GENERAL RECOMMENDATIONS/LIMITATIONS

CGC, Inc. should be provided the opportunity for a general review of the final design and specifications to confirm that earthwork and foundation requirements have been properly interpreted in the design and specifications. CGC should be retained to provide soil engineering services during excavation and subgrade preparation. This will allow us to observe that construction proceeds in compliance with the design concepts, specifications and recommendations, and also will allow design changes to be made in the event that subsurface conditions differ from those anticipated prior to the start of construction. CGC does not assume responsibility for compliance with the recommendations in this report unless we are retained to provide construction testing and observation services.

This report has been prepared in accordance with generally accepted soil and foundation engineering practices and no other warranties are expressed or implied. The opinions and recommendations submitted in this report are based on interpretation of the subsurface information revealed by the test borings indicated on the location plan. The report does not reflect potential variations in subsurface conditions between or beyond these borings. Therefore, variations in soil conditions can be expected between the boring locations and fluctuations of groundwater levels may occur with time. The nature and extent of the variations may not become evident until construction.

# II. IMPORTANT INFORMATION ABOUT YOUR GEOTECHNICAL ENGINEERING REPORT

Geotechnical engineers structure their services to meet the specific needs of their clients. A geotechnical engineering study conducted for a civil engineer may not fulfill the needs of a construction contractor or even another civil engineer. Because each geotechnical engineering study is unique, each geotechnical engineering report is unique, prepared solely for the client. No one except you should rely on your geotechnical engineering report without first conferring with the geotechnical engineer who prepared it. And no one - not even you - should apply the report for any purpose or project except the one originally contemplated.

Serious problems have occurred because those relying on a geotechnical engineering report did not read it all. Do not rely on an executive summary. Do not read selected elements only.

## A GEOTECHNICAL ENGINEERING REPORT IS BASED ON A UNIQUE SET OF PROJECT-SPECIFIC FACTORS

Geotechnical engineers consider a number of unique, project-specific factors when establishing the scope of a study. Typical factors include: the client's goals, objectives, and risk management preferences; the general nature of the structure involved, its size, and configuration; the location of the structure on the site; and other planned or existing site improvements, such as access roads, parking lots, and underground utilities. Unless the geotechnical engineer who conducted the study specifically indicates otherwise, do not rely on a geotechnical engineering report that was:

- not prepared for you,
- · not prepared for your project,
- not prepared for the specific site explored, or
- completed before important project changes were made.

Typical changes that can erode the reliability of an existing geotechnical report include those that affect:

- the function of the proposed structure, as when it's changed from a parking garage to an office building, or from a light industrial plant to a refrigerated warehouse,
- elevation, configuration, location, orientation, or weight of the proposed structure,
- · composition of the design team, or project ownership.

As a general rule, , always inform your geotechnical engineer of project changes - even minor ones - and request an assessment of their impact. CGC cannot accept responsibility or liability for problems that occur because our reports do not consider developments of which we were not Informed.

## SUBSURFACE CONDITIONS CAN CHANGE

A geotechnical engineering report is based on conditions that existed at the time the study was performed. Do not rely on a geotechnical engineering report whose adequacy may have been affected by: the passage of time; by man-made events, such as construction on or adjacent to the site; or by natural events, such as floods, earthquakes, or groundwater fluctuations. Always contact the geotechnical engineer before applying the report to determine if it is still reliable. A minor amount of additional testing or analysis could prevent major problems.

## MOST GEOTECHNICAL FINDINGS ARE PROFESSIONAL OPINION

Site exploration identifies subsurface conditions only at those points where surface tests are conducted or samples are taken. Geotechnical engineers review field and laboratory data and then apply their professional judgement to render an opinion about subsurface conditions throughout the site. Actual subsurface conditions may differ - sometimes significantly - from those indicated in your report. Retaining the geotechnical engineer who developed your report to provide construction observation is the most effective method of managing the risks associated with unanticipated conditions.

#### A REPORT'S RECOMMENDATIONS ARE NOT FINAL

Do not over-rely on the construction recommendations included in your report. Those recommendations are not final, because geotechnical engineers develop them principally from judgement and opinion, geotechnical engineers can finalize their recommendations only by observing actual subsurface conditions revealed during construction. CGC cannot assume responsibility or liability for the report's recommendations if we do not perform construction observation.

## A GEOTECHNICAL ENGINEERING REPORT IS SUBJECT TO MISINTERPRETATION

Other design team members' misinterpretation of geotechnical engineering reports has resulted in costly problems. Lower that risk by having your geotechnical engineer confer with appropriate members of the design team after submitting the report. Also retain your geotechnical engineer to review pertinent elements of the design team's plans and specifications. Contractors can also misinterpret a geotechnical engineering report. Reduce that risk by having CGC participate in prebid and preconstruction conferences, and by providing construction observation.

#### DO NOT REDRAW THE ENGINEER'S LOGS

Geotechnical engineers prepare final boring and testing logs based upon their interpretation of field logs and laboratory data. To prevent errors or omissions, the logs included in a geotechnical engineering report should never be redrawn for inclusion in architectural or other design drawings. Only photographic or electronic reproduction is acceptable, but recognize that separating logs from the report can elevate risk.

## GIVE CONTRACTORS A COMPLETE REPORT AND GUIDANCE

Some owners and design professionals mistakenly believe they can make contractors liable for unanticipated subsurface conditions by limiting what they provide for bid preparation. To help prevent costly problems, give contractors the complete geotechnical engineering report, but preface it with a clearly written letter of transmittal. In that letter, advise contractors that the report was not prepared for purposes of bid development and that the report's accuracy is limited; encourage them to confer with the geotechnical engineer who prepared the report (a modest fee may be required) and/or to conduct additional study to obtain the specific types of information they need or prefer. A prebid conference can also be Be sure contractors have sufficient time to perform additional study. Only then might you be in a position to give contractors the best information available to you, while requiring them to at least share some of the financial responsibilities stemming from unanticipated conditions.

## READ RESPONSIBILITY PROVISIONS CLOSELY

Some clients, design professionals, and contractors do not recognize that geotechnical engineering is far less exact than other engineering disciplines. This lack of understanding has created unrealistic expectations that have led to disappointments, claims, and disputes. To help reduce such risks, geotechnical engineers commonly include a variety of explanatory provisions in their reports. Sometimes

labeled "limitations," many of these provisions indicate where geotechnical engineer's responsibilities begin and end, to help others recognize their own responsibilities and risks. Read these provisions closely. Ask questions. Your geotechnical engineer should respond fully and frankly.

## GEOENVIRONMENTAL CONCERNS ARE NOT COVERED

The equipment, techniques, and personnel used to perform a geoenvironmental study differ significantly from those used to perform a geotechnical study. For that reason, a geotechnical engineering report does not usually relate any geoenvironmental findings, conclusions, or recommendations; e.g., about the likelihood of encountering underground storage tanks or regulated contaminants. Unanticipated environmental problems have led to numerous project failures. If you have not yet obtained your own geoenvironmental information, ask your geotechnical consultant for risk management guidance. Do not rely on an environmental report prepared for someone else.

## OBTAIN PROFESSIONAL ASSISTANCE TO DEAL WITH MOLD

Diverse strategies can be applied during building design, construction, operation, and maintenance to prevent significant amounts of mold from growing on indoor surfaces. To be effective, all such strategies should be devised for the express purpose of mold prevention, integrated into a comprehensive plan, and executed with diligent oversight by a professional mold prevention consultant. Because just a small amount of water or moisture can lead to the development of severe mold infestations, a number of mold prevention strategies focus on keeping building surfaces dry. While groundwater, water infiltration, and similar issues may have been addressed as part of the geotechnical engineering study whose findings are conveyed in this report, the geotechnical engineer in charge of this project is not a mold prevention consultant; none of the services performed in connection with the geotechnical engineer's study were designed or conducted for the purpose of mold prevention. Proper implementation of the recommendations conveyed in this report will not of itself be sufficient to prevent mold from growing in or on the structure involved.

2.	Completion Date/Contract Time. 	<b>General and Authorization.</b> The Contractor shall compensate its employees at the prevailing wage rate in accordance with section 66.0903, Wis. Stats., DWD 290 of the Wisconsin Administrative Code and as hereinafter provided.
	"Public Works" shall include building or work involving the erection, construction, remodeling, repairing or demolition of buildings, parking lots, highways, streets, bridges, sidewalks, street lighting, traffic signals, sanitary sewers, water mains and appurtenances, storm sewers, and the grading and landscaping of public lands.
	"Building or work" includes construction activity as distinguished from manufacturing, furnishing of materials, or servicing and maintenance work, except for the delivery of mineral aggregate such as sand, gravel, bituminous asphaltic concrete or stone which is incorporated into the work under contract with the City by depositing the material directly in final place from transporting vehicle.

"Erection, construction, remodeling, repairing" means all types of work done on a particular building or work at the site thereof in the construction or development of the project, including without limitation, erecting, construction, remodeling, repairing, altering, painting, and decorating, the transporting of materials and supplies to or from the building or work done by the employees of the Contractor, Subcontractor, or Agent thereof, and the manufacturing or furnishing of materials, articles, supplies or equipment on the site of the building or work, by persons employed by the Contractor, Subcontractor, or Agent thereof.

"Employees working on the project" means laborers, workers, and mechanics employed directly upon the site of work.

"Laborers, Workers, and Mechanics" include preapprentices, helpers, trainees, learners and properly registered and indentured apprentices but exclude clerical, supervisory, and other personnel not performing manual labor.

Establishment of Wage Rates. The Department of Public Works shall periodically obtain a current schedule of prevailing wage rates from DWD. The schedule shall be used to establish the City of Madison Prevailing Wage Rate Schedule for Public Works Construction (prevailing wage rate). The Department of Public Works may include known increases to the prevailing wage rate which can be documented and are to occur on a future specific date. The prevailing wage rate shall be included in public works contracts subsequently negotiated or solicited by the City. Except for known increases contained within the schedule, the prevailing wage rate shall not change during the contract. The approved wage rate is attached hereto.

Workforce Profile. The Contractor shall, at the time of signature of the contract, notify the City Engineer in writing of the names and classifications of all the employees of the Contractor, Subcontractors, and Agents proposed for the work. In the alternative, the Contractor shall submit in writing the classifications of all the employees of the Contractor, Subcontractors and Agents and the total number of hours estimated in each classification for the work. This workforce profile(s) shall be reviewed by the City Engineer who may, within ten (10) days, object to the workforce profile(s) as not being reflective of that which would be required for the work. The Contractor may request that the workforce profile, or a portion of the workforce profile, be submitted after the signature of the contract but at least ten (10) days prior to the work commencing. Any costs or time loss resulting from modifications to the workforce profile as a result of the City Engineer's objections shall be the responsibility of the Contractor.

Payrolls and Records. The Contractor shall keep weekly payroll records setting forth the name, address, telephone number, classification, wage rate and fringe benefit package of all the employees who work on the contract, including the employees of the Contractor's subcontractors and agents. Such weekly payroll records must include the required information for all City contracts and all other contracts on which the employee worked during the week in which the employee worked on the contract. The Contractor shall also keep records of the individual time each employee worked on the project and for each day of the project. Such records shall also set forth the total number of hours of overtime credited to each such employee for each day and week and the amount of overtime pay received in that week. The records shall set forth the full weekly wages earned by each employee and the actual hourly wage paid to the employee.

The Contractor shall submit the weekly payroll records, including the records of the Contractor's subcontractors and agents, to the City Engineer for every week that work is being done on the contract. The submittal shall be within twenty-one (21) calendar days of the end of the Contractor's weekly pay period.

Employees shall receive the full amounts accrued at the time of the payment, computed at rates not less than those stated in the prevailing wage rate and each employee's rate shall be determined by the work that is done within the trade or occupation classification which should be properly assigned to the employee.

An employee's classification shall not be changed to a classification of a lesser rate during the contract. If, during the term of the contract, an employee works in a higher pay classification than the one which was previously properly assigned to the employee, then that employee shall be considered to be in the higher pay classification for the balance of the contract, receive the appropriate higher rate of pay, and she/he shall not receive a lesser rate during the balance of the contract. For purposes of clarification, it is noted that there is a distinct difference between working in a different classification with higher pay and doing work within a classification that has varying rates of pay which are determined by the type of work that is done within the classification. For example, the classification "Operating Engineer" provides for different rates of pay for various classes of work and the Employer shall compensate an employee classified as an "Operating Engineer" based on the highest class of work that is done in one day. Therefore, an "Operating Engineer's" rate may vary on a day to day basis depending on the type of work that is done, but it will never be less than the base rate of an "Operating Engineer". Also, as a matter of clarification, it is recognized that an employee may work in a higher paying classification merely by chance and without prior intention, calculation or design. If such is the case and the performance of the work is truly incidental and the occurrence is infrequent, inconsequential and does not serve to undermine the single classification principle herein, then it may not be required that the employee be considered to be in the higher pay classification and receive the higher rate of pay for the duration of the contract. However, the Contractor is not precluded or prevented from paying the higher rate for the limited time that an employee performs work that is outside of the employee's proper classification.

Questions regarding an employee's classification, rate of pay or rate of pay within a classification, shall be resolved by reference to the established practice that predominates in the industry and on which the trade or occupation rate/classification is based. Rate of pay and classification disputes shall be resolved by relying upon practices established by collective bargaining agreements and guidelines used in such determination by appropriate recognized trade unions operating within the City of Madison.

The Contractor, its Subcontractors and Agents shall submit to interrogation regarding compliance with the provisions of this ordinance.

Mulcting of the employees by the Contractor, Subcontractor, and Agents on Public Works contracts, such as by kickbacks or other devices, is prohibited. The normal rate of wage of the employees of the Contractor, Subcontractor, and Agents shall not be reduced or otherwise diminished as a result of payment of the prevailing wage rate on a public works contract.

Hourly contributions. Hourly contributions shall be determined in accordance with the prevailing wage rate and with DWD. 290.01(10), Wis. Admin. Code.

**Apprentices and Subjourneypersons.** Apprentices and subjourneypersons performing work on the project shall be compensated in accordance with the prevailing wage rate and with DWD 290.02, and 290.025, respectively, Wis. Admin. Code.

**Straight Time Wages.** The Contractor may pay straight time wages as determined by the prevailing wage rate and DWD 290.04, Wis. Admin. Code.

**Overtime Wages.** The Contractor shall pay overtime wages as required by the prevailing wage rate and DWD 290.05, Wis. Admin. Code.

Posting of Wage Rates and Hours. A clearly legible copy of the prevailing wage rate, together with the provisions of Sec. 66.0903(10)(a) and (11)(a), Wis. Stats., shall be kept posted in at least one conspicuous and easily accessible place at the project site by the Contractor and such notice shall remain posted during the full time any laborers, workers or mechanics are employed on the contract.

**Evidence of Compliance by Contractor.** Upon completion of the contract, the Contractor shall file with the Department of Public Works an affidavit stating:

- a. That the Contractor has complied fully with the provisions and requirements of Sec. 66.0903(3), Wis. Stats., and Chapter DWD 290, Wis. Admin. Code; the Contractor has received evidence of compliance from each of the agents and subcontractors; and the names and addresses of all of the subcontractors and agents who worked on the contract.
- b. That full and accurate records have been kept, which clearly indicate the name and trade or occupation of every laborer, worker or mechanic employed by the Contractor in connection with work on the project. The records shall show the number of hours worked by each employee and the actual wages paid therefor; where these records will be kept and the name, address and telephone number of the person who will be responsible for keeping them. The records shall be retained and made available for a period of at least three (3) years following the completion of the project of public works and shall not be removed without prior notification to the municipality.

Evidence of Compliance by Agent and Subcontractor. Each agent and subcontractor shall file with the Contractor, upon completion of their portion of the work on the contract an affidavit stating that all the provisions of Sec. 66.0903(3), Wis. Stats., have been fully complied with and that full and accurate records have been kept, which clearly indicate the name and trade or occupation of every laborer, worker or mechanic employed by the Contractor in connection with work on the project. The records shall show the number of hours worked by each employee and the actual wages paid therefor; where these records shall be kept and the name, address and telephone number of the person who shall be responsible for keeping them. The records shall be retained and made available for a period of at least three (3) years following the completion of the project of public works and shall not be removed without prior notification to the municipality.

Failure to Comply with the Prevailing Wage Rate. If the Contractor fails to comply with the prevailing wage rate, she/he shall be in default on the contract.

5. **Affirmative Action.** In the performance of the services under this Agreement the Contractor agrees not to discriminate against any employee or applicant because of race, religion, marital status, age, color, sex, disability, national origin or ancestry, income level or source of income, arrest record or conviction record, less than honorable discharge, physical appearance, sexual orientation, political beliefs, or student status. The Contractor further agrees not to discriminate against any subcontractor or person who offers to subcontract on this contract because of race, religion, color, age, disability, sex or national origin.

The Contractor agrees that within thirty (30) days after the effective date of this agreement, the Contractor will provide to the City Affirmative Action Division certain workforce utilization statistics, using a form to be furnished by the City.

If the contract is still in effect, or if the City enters into a new agreement with the Contractor, within one year after the date on which the form was required to be provided, the Contractor will provide updated workforce information using a second form, also to be furnished by the City. The second form will be submitted to the City Affirmative Action Division no later than one year after the date on which the first form was required to be provided.

The Contractor further agrees that, for at least twelve (12) months after the effective date of this contract, it will notify the City Affirmative Action Division of each of its job openings at facilities in Dane County for which applicants not already employees of the Contractor are to be considered. The notice will include a job description, classification, qualifications and application procedures and deadlines. The Contractor agrees to interview and consider candidates referred by the Affirmative Action Division if the candidate meets the minimum qualification standards established by the Contractor, and if the referral is timely. A referral is timely if it is received by the Contractor on or before the date started in the notice.

## Articles of Agreement Article I

The Contractor shall take affirmative action in accordance with the provisions of this contract to insure that applicants are employed, and that employees are treated during employment without regard to race, religion, color, age, marital status, disability, sex or national original and that the employer shall provide harassment free work environment for the realization of the potential of each employee. Such action shall include, but not be limited to, the following: employment, upgrading, demotion or transfer, recruitment or recruitment advertising, layoff or termination, rates of pay or other forms of compensation and selection for training including apprenticeship insofar as it is within the control of the Contractor. The Contractor agrees to post in conspicuous places available to employees and applicants notices to be provided by the City setting out the provisions of the nondiscrimination clauses in this contract.

#### Article II

The Contractor shall in all solicitations or advertisements for employees placed by or on behalf of the Contractors state that all qualified or qualifiable applicants will be employed without regard to race, religion, color, age, marital status, disability, sex or national origin.

## Article III

The Contractor shall send to each labor union or representative of workers with which it has a collective bargaining agreement or other contract or understanding a notice to be provided by the City advising the labor union or worker's representative of the Contractor's equal employment opportunity and affirmative action commitments. Such notices shall be posted in conspicuous places available to employees and applicants for employment.

#### Article V

The Contractor agrees that it will comply with all provisions of the Affirmative Action Ordinance of the City of Madison, including the contract compliance requirements. The Contractor agrees to submit the model affirmative action plan for public works contractors in a form approved by the Director of Affirmative Action.

#### Article VI

The Contractor will maintain records as required by Section 39.02(9)(f) of the Madison General Ordinances and will provide the City Affirmative Action Division with access to such records and to persons who have relevant and necessary information, as provided in Section 39.02(9)(f). The City agrees to keep all such records confidential, except to the extent that public inspection is required by law.

## Article VII

In the event of the Contractor's or subcontractor's failure to comply with the Equal Employment Opportunity and Affirmative Action Provisions of this contract or Section 39.03 and 39.02 of the Madison General Ordinances, it is agreed that the City at its option may do any or all of the following:

- 1. Cancel, terminate or suspend this Contract in whole or in part.
- 2. Declare the Contractor ineligible for further City contracts until the Affirmative Action requirements are met.
- 3. Recover on behalf of the City from the prime Contractor 0.5 percent of the contract award price for each week that such party fails or refuses to comply, in the nature of liquidated damages, but not to exceed a total of five percent (5%) of the contract price, or five thousand dollars (\$5,000), whichever is less. Under public works contracts, if a subcontractor is in noncompliance, the City may recover liquidated damages from the prime Contractor in the manner described above. The preceding sentence shall not be construed to prohibit a prime Contractor from recovering the amount of such damage from the non-complying subcontractor.

## Article VIII

The Contractor shall include the above provisions of this contract in every subcontract so that such provisions will be binding upon each subcontractor. The Contractor shall take such action with respect to any subcontractor as necessary to enforce such provisions, including sanctions provided for noncompliance.

#### Article IX

The Contractor shall allow the maximum feasible opportunity to small business enterprises to compete for any subcontracts entered into pursuant to this contract.

  - 6. December 25.
  - 7. The day before if January 1, July 4 or December 25 falls on a Saturday.
  - 8. The day following if January 1, July 4 or December 25 falls on a Sunday.

## s. 66.0903 (10) RECORDS; INSPECTION; ENFORCEMENT.

(a) Each contractor, subcontractor, or contractor's or subcontractor's agent performing work on a project of public works that is subject to this section shall keep full and accurate records clearly indicating the name and trade or occupation of every person performing the work described in sub. (4) and an accurate record of the number of hours worked by each of those persons and the actual wages paid for the hours worked.

## s. 66.0903 (11) LIABILITY AND PENALTIES.

- (a) 1. Any contractor, subcontractor, or contractor's or subcontractor's agent who fails to pay the prevailing wage rate determined by the department under sub. (3) or who pays less than 1.5 times the hourly basic rate of pay for all hours worked in excess of the prevailing hours of labor is liable to any affected employee in the amount of his or her unpaid wages or his or her unpaid overtime compensation and in an additional amount as liquidated damages as provided under subd. 2., 3., whichever is applicable.
- 2. If the department determines upon inspection under sub. (10) (b) or (c) that a contractor, subcontractor, or contractor's or subcontractor's agent has failed to pay the prevailing wage rate determined by the department under sub. (3) or has paid less than 1.5 times the hourly basic rate of pay for all hours worked in excess of the prevailing hours of labor, the department shall order the contractor to pay to any affected employee the amount of his or her unpaid wages or his or her unpaid overtime compensation and an additional amount equal to 100 percent of the amount of those unpaid wages or that unpaid overtime compensation as liquidated damages within a period specified by the department in the order.
- 3. In addition to or in lieu of recovering the liability specified in subd. 1. as provided in subd. 2., any employee for and in behalf of that employee and other employees similarly situated may commence an action to recover that liability in any court of competent jurisdiction. If the court finds that a contractor, subcontractor, or contractor's or subcontractor's agent has failed to pay the prevailing wage rate determined by the department under sub. (3) or has paid less than 1.5 times the hourly basic rate of pay for all hours worked in excess of the prevailing hours of labor, the court shall order the contractor, subcontractor, or agent to pay to any affected employee the amount of his or her unpaid wages or his or her unpaid overtime compensation and an additional amount equal to 100 percent of the amount of those unpaid wages or that unpaid overtime compensation as liquidated damages.

  5. No employee may be a party plaintiff to an action under subd. 3. unless the employee consents in writing to become a party
- and the consent is filed in the court in which the action is brought. Notwithstanding s. 814.04 (1), the court shall, in addition to any judgment awarded to the plaintiff, allow reasonable attorney fees and costs to be paid by the defendant.

## BUILDING OR HEAVY CONSTRUCTION

Includes sheltered enclosures with walk-in access for the purpose of housing persons, employees, machinery, equipment or supplies and non-sheltered work such as canals, dams, dikes, reservoirs, storage tanks, etc. A sheltered enclosure need not be "habitable" in order to be considered a building. The installation of machinery and/or equipment, both above and below grade level, does not change a project's character as a building. On-site grading, utility work and landscaping are included within this definition. Residential buildings of four (4) stories or less, agricultural buildings, parking lots and driveways are NOT included within this definition.
