#### STANDARD SPECIFICATIONS

The City of Madison's Standard Specifications for Public Works Construction - 2015 Edition, as supplemented and amended from time to time, forms a part of these contract documents as if attached hereto.

These standard specifications are available on the City of Madison Public Works website, www.cityofmadison.com/Business/PW/specs.cfm.

The Contractor shall review these Specifications prior to preparation of proposals for the work to be done under this contract, with specific attention to Article 102, "BIDDING REQUIREMENTS AND CONDITIONS" and Article 103, "AWARD AND EXECUTION OF THE CONTRACT." For the convenience of the bidder, below are highlights of three subsections of the specifications.

#### SECTION 102.1: PRE-QUALIFICATION OF BIDDERS

In accordance with Wisconsin State Statutes 66.0901 (2) and (3), all bidders must submit to the Board of Public Works proof of responsibility on forms furnished by the City. The City requires that all bidders be qualified on a biennial basis.

Bidders must present satisfactory evidence that they have been regularly engaged in the type of work specified herein and they are fully prepared with necessary capital, materials, machinery and supervisory personnel to conduct the work to be contracted for to the satisfaction of the City. All bidders must be pre-

qualified by the Board of Public Works for the type of construction on which they are bidding prior to the opening of the bid.

In accordance with Section 39.02(9)(a)I. of the General Ordinances, all bidders shall submit in writing to the Affirmative Action Division Manager of the City of Madison, a Certificate of Compliance or an Affirmative Action Plan at the same time or prior to the submission of the proof of responsibility forms.

The bidder shall be disqualified if the bidder fails to or refuses to, prior to opening of the bid, submit a Certificate of compliance, Affirmative Action Plan or Affirmative Action Data Update, as applicable, as defined by Section 39.02 of the General Ordinances (entitled Affirmative Action) and as required by Section 102.11 of the Standard Specifications.

#### SECTION 102.4 PROPOSAL

No bid will be accepted that does not contain an adequate or reasonable price for each and every item named in the Schedule of Unit Prices.

A lump sum bid for the work in accordance with the plans and specifications is required. The lump sum bid must be the same as the total amounts bid for the various items and it shall be inserted in the space provided.

All papers bound with or attached to the proposal form are considered a part thereof and must not be detached or altered when the proposal is submitted. The plans, specifications and other documents designated in the proposal form will be considered a part of the proposal whether attached or not.

A proposal submitted by an individual shall be signed by the bidder or by a duly authorized agent. A proposal submitted by a partnership shall be signed by a member/partner or by a duly authorized agent thereof. A proposal submitted by a corporation shall be signed by an authorized officer or duly authorized registered agent of such corporation, and the proposal shall show the name of the State under the laws of which such corporation was chartered. The required signatures shall in all cases appear in the space provided thereof on the proposal.

Each proposal shall be placed, together with the proposal guaranty, in a sealed envelope, so marked as to indicate name of project, the contract number or option to which it applies, and the name and address of the Contractor or submitted electronically through Bid Express (<u>www.bidexpress.com</u>). Proposals will be accepted at the location, the time and the date designated in the advertisement. Proposals received after the time and date designated will be returned to the bidder unopened.

The Bidder shall execute the Disclosure of Ownership form. REFER TO SECTION F.

#### SECTION 102.5: BID DEPOSIT (PROPOSAL GUARANTY)

All bids, sealed or electronic, must be accompanied with a Bid Bond equal to at least 5% of the bid or a Certificate of Annual/Biennial Bid Bond or certified check, payable to the City Treasurer. Bid deposit of the successful bidders shall be returned within forty-eight (48) hours following execution of the contract and bond as required.

## Instructions to Bidders City of Madison SBE Program Information

#### 2 Small Business Enterprise (SBE) Program Information

#### 2.1 Policy and Goal

The City of Madison reaffirms its policy of nondiscrimination in the conduct of City business by maintaining a procurement process which remains open to all who have the potential and ability to sell goods and services to the City. It is the policy of the City of Madison to allow Small Business Enterprises (SBE) maximum feasible opportunity to participate in City of Madison contracting. The bidder acknowledges that its bid has been submitted in accordance with the SBE program and is for the public's protection and welfare.

Please refer to the "ADVERTISEMENT FOR BIDS" for the goal for the utilization of SBEs on this project. SBEs may participate as subcontractors, vendors and/or suppliers, which provide a commercially useful function. The dollar value for SBE suppliers or 'materials only' vendors shall be discounted to 60% for purposes of meeting SBE goals.

A bidder which achieves or exceeds the SBE goal will be in compliance with the SBE requirements of this project. In the event that the bidder is unable to achieve the SBE goal, the bidder must demonstrate that a good faith effort to do so was made. Failure to either achieve the goal or demonstrate a good faith effort to do so will be grounds for the bidder being deemed a non-responsible contractor ineligible for award of this contract.

A bidder may count towards its attainment of the SBE goal only those expenditures to SBEs that perform a commercially useful function. For purposes of evaluating a bidder's responsiveness to the attainment of the SBE goal, the contract participation by an SBE is based on the percentage of the total base bid proposed by the Contractor. The total base bid price is inclusive of all addenda.

Work performed by an SBE firm in a particular transaction can be counted toward the goal only if it involves a commercially useful function. That is, in light of industry practices and other relevant considerations, does the SBE firm have a necessary and useful role in the transaction, of a kind for which there is a market outside the context of the SBE Program, or is the firm's role a superfluous step added in an attempt to obtain credit towards goals? If, in the judgment of the Affirmative Action Division, the SBE firm will not perform a commercially useful function in the transaction, no credit towards goals will be awarded.

The question of whether a firm is performing a commercially useful function is completely separate from the question of whether the firm is an eligible SBE. A firm is eligible if it meets the definitional criteria and ownership and control requirements, as set forth in the City of Madison's SBE Program.

If the City of Madison determines that the SBE firm is performing a commercially useful function, then the City of Madison must then decide what that function is. If the commercially useful function is that of an SBE vendor / supplier that regularly transacts business with the respective product, then the City of Madison will count 60% of the value of the product supplied toward SBE goals.

To be counted, the SBE vendor / supplier must be engaged in selling the product in question to the public. This is important in distinguishing an SBE vendor / supplier, which has a regular trade with a variety of customers, from a firm which performs supplier-like functions on an <u>ad hoc</u> basis or for only one or two contractors with whom it has a special relationship.

A supplier of bulk goods may qualify as an eligible SBE vendor / supplier if it either maintains an inventory or owns or operates distribution equipment. With respect to the distribution equipment; e.g., a fleet of trucks, the term "operates" is intended to cover a situation in which the supplier leases the equipment on a regular basis for its entire business. It is not intended to cover a situation in which the firm simply provides drivers for trucks owned or leased by another party; e.g., a prime contractor, or leases such a party's trucks on an <u>ad hoc</u> basis for a specific job.

If the commercially useful function being performed is not that of a qualified SBE vendor / supplier, but rather that of delivery of products, obtaining bonding or insurance, procurement of personnel, acting as a broker or manufacturer's representative in the procurement of supplies, facilities, or materials, etc., only the fees or commissions will apply towards the goal.

For example, a business that simply transfers title of a product from manufacturer to ultimate purchaser; e. g., a sales representative who re-invoices a steel product from the steel company to the Contractor, or a firm that puts a product into a container for delivery would not be considered a qualified SBE vendor / supplier. The Contractor would not receive credit based on a percentage of the cost of the product for working with such firms.

Concerning the use of services that help the Contractor obtain needed supplies, personnel, materials or equipment to perform a contract: only the fee received by the service provider will be counted toward the goal. For example, use of a SBE sales representative or distributor for a steel company, if performing a commercially useful function at all, would entitle the Contractor receiving the steel to count only the fee paid to the representative or distributor toward the goal. This provision would also govern fees for professional and other services obtained expressly and solely to perform work relating to a specific contract.

Concerning transportation or delivery services: if an SBE trucking company picks up a product from a manufacturer or a qualified vendor / supplier and delivers the product to the Contractor, the commercially useful function it is performing is not that of a supplier, but simply that of a transporter of goods. Unless the trucking company is itself the manufacturer or a qualified vendor / supplier in the product, credit cannot be given based on a percentage of the cost of the product. Rather, credit would be allowed for the cost of the transportation service.

The City is aware that the rule's language does not explicitly mention every kind of business that may contribute work on this project. In administering these programs, the City would, on a case-by-case basis, determine the appropriate counting formula to apply in a particular situation.

#### 2.3 Certification of SBE by City of Madison

The Affirmative Action Division maintains a directory of SBEs which are currently certified as such by the City of Madison. All contractors, subcontractors, vendors and suppliers seeking SBE status must complete and submit the Targeted Business Certification Application to the City of Madison Affirmative Action Division by the time and date established for receipt of bids. A copy of the Targeted Business Certification Application is available by contacting the Contract Compliance Officer at the address and telephone indicated in Section 2.2 or you may Targeted access the Business Certification Application online at www.citvofmadison.com/dcr/aaTBDir.cfm. Submittal of the Targeted Business Certification Application by the time specified does not guarantee that the applicant will be certified as a SBE eligible to be utilized towards meeting the SBE goal for this project.

#### 2.4 Small Business Enterprise Compliance Report

#### 2.4.1 Good Faith Efforts

Bidders shall take all necessary affirmative steps to assure that SBEs are utilized when possible and that the established SBE goal for this project is achieved. A contractor who self performs a portion of the work, and is pre-qualified to perform that category of work, may subcontract that portion of the work, but shall not be required to do so. When a bidder is unable to achieve the established SBE goal, the bidder must demonstrate that a good faith effort to do so was made. Such a good faith effort should include the following:

- 2.4.1.1 Attendance at the pre-bid meeting.
- 2.4.1.2 Using the City of Madison's directory of certified SBEs to identify SBEs from which to solicit bids.
- 2.4.1.3 Assuring that SBEs are solicited whenever they are potential sources.
- 2.4.1.4 Referring prospective SBEs to the City of Madison Affirmative Action Division for certification.
- 2.4.1.5 Dividing total project requirements into smaller tasks and/or quantities, where economically feasible, to permit maximum feasible SBE participation.
- 2.4.1.6 Establishing delivery schedules, where requirements permit, which will encourage participation by SBEs.
- 2.4.1.7 Providing SBEs with specific information regarding the work to be performed.
- 2.4.1.8 Contacting SBEs in advance of the deadline to allow such businesses sufficient time to prepare a bid.
- 2.4.1.9 Utilizing the bid of a qualified and competent SBE when the bid of such a business is deemed reasonable (i.e. 5% above the lowest bidder), although not necessarily low.
- 2.4.1.10 Contacting SBEs which submit a bid, to inquire about the details of the bid and confirm that the scope of the work was interpreted as intended.

#### 2.4.2 **Reporting SBE Utilization and Good Faith Efforts**

The Small Business Enterprise Compliance Report is to be submitted by the <u>bidder</u> with the bid: This report is due by the specified bid closing time and date. Bids submitted without a completed SBE Compliance Report as outlined below

shall be deemed non-responsible and the bidder ineligible for award of this contract.

- 2.4.2.2 If the bidder <u>does not meet</u> the goal established for SBE utilization, the Small Business Enterprise Compliance Report shall consist of the following:
  - 2.4.2.2.1 **Cover Page**, Page C-6;
  - 2.4.2.2.2 Summary Sheet, C-7; and
  - 2.4.2.2.3 **SBE Contact Report,** C-8 and C-9. (A <u>separate</u> Contact Report must be completed for <u>each applicable</u> SBE which is <u>not</u> utilized.)

#### 2.5 Appeal Procedure

A bidder which does not achieve the established goal and is found non-responsible for failure to demonstrate a good faith effort to achieve such goal and subsequently denied eligibility for award of contract may appeal that decision to the Small Business Enterprises Appeals Committee. All appeals shall be made in writing, and shall be delivered to and received by the City Engineer no later than 4:30 PM on the third business day following the bidder's receipt of the written notification of ineligibility by the Affirmative Action Division Manager. Postmark not acceptable. The notice of appeal shall state the basis for the appeal of the decision of the Affirmative Action Division Manager. The Appeal shall take place in accordance with Madison General Ordinance 33.54.

#### 2.6 SBE Requirements After Award of the Contract

The successful bidder shall identify SBE subcontractors, suppliers and vendors on the subcontractor list in accordance with the specifications. The Contractor shall submit a detailed explanation of any variances between the listing of SBE subcontractors, vendors and/or suppliers on the subcontractor list and the Contractor's SBE Compliance Report for SBE participation.

No change in SBE subcontractors, vendors and/or suppliers from those SBEs indicated in the SBE Compliance Report will be allowed without prior approval from the Engineer and the Affirmative Action Division. The contractor shall submit in writing to the City of Madison Affirmative Action Division a request to change any SBE citing specific reasons which necessitate such a change. The Affirmative Action Division will use a general test of reasonableness in approving or rejecting the contractor's request for change. If the request is approved, the Contractor will make every effort to utilize another SBE if available.

The City will monitor the project to ensure that the actual percentage commitment to SBE firms is carried out.

#### 2.7 SBE Definition and Eligibility Guidelines

A Small Business Enterprise is a business concern awarded certification by the City of Madison. For the purposes of this program a Small Business Enterprise is defined as:

- A. An independent business operated under a single management. The business may not be a subsidiary of any other business and the stock or ownership may not be held by any individual or any business operating in the same or a similar field. In determining whether an entity qualifies as a SBE, the City shall consider all factors relevant to being an independent business including, but not limited to, the date the business was established, adequacy of its resources for the work in which it proposes to involve itself, the degree to which financial, equipment leasing and other relationships exist with other ineligible firms in the same or similar lines of work. SBE owner(s) shall enjoy the customary incidents of ownership and shall share in the risks and profits commensurate with their enjoyment interests, as demonstrated by an examination of the substance rather than form or arrangements that may be reflected in its ownership documents.
- B. A business that has averaged no more than \$4.0 million in annual gross receipts over the prior three year period and the principal owner(s) do not have a personal net worth in excess of \$1.32 million.

Firm and/or individuals that submit fraudulent documents/testimony may be barred from doing business with the City and/or forfeit existing contracts.

SBE certification is valid for one (1) year unless revoked.

## CAPITAL CITY PATH RECONSTRUCTION AND BRIDGE REPLACEMENT CONTRACT NO. 7245

It is the intent of these Special Provisions to set forth the final contractual intent as to the matter involved and shall prevail over the Standard Specifications and plans whenever in conflict therewith. In order that comparisons between the Special Provisions can be readily made, the numbering system for the Special Provisions is equivalent to that of the Specifications.

Whenever in these Specifications the term "Standard Specifications" appears, it shall be taken to refer to the City of Madison Standard Specifications for Public Works Construction and Supplements thereto.

#### SECTION 102.10: PREVAILING WAGE

For this project, payment of prevailing wages (white sheet) shall be required unless the box indicating prevailing wages are not required is checked below.



Prevailing wages shall not be required when this box is checked.

#### SECTION 102.12: BEST VALUE CONTRACTING

This Contract shall be considered a Best Value Contract if the Contractor's bid is equal to or greater than \$55,500 for a single trade contract; or equal to or greater than \$271,500 for a multi-trade contract pursuant to MGO 33.07(7).

#### ARTICLE 104 SCOPE OF WORK

This work generally consists of the widening and reconstruction of an existing, asphalt path from Marquette Street to Dennett Drive, with the exception of the segment from Starkweather Creek to Walter Street. The contract includes replacement of an existing steel truss bridge with a new pre-fabricated steel bridge on concrete substructure units, new storm pipes and structures, pavement marking, and channel restoration.

Work shall include, but is not limited to: clearing & grubbing; grading and construction of embankments; installation of storm pipe and structures; adjustment of sanitary sewer structures; concrete retaining wall and steel railings; new or replaced curb and gutter and concrete sidewalk; base course, riprap bank protection, asphaltic paving, pavement marking and restoration.

#### SECTION 105.12 COOPERATION BY THE CONTRACTOR

AT&T has an overhead power pole in conflict with the path at Station 16+30 RT. AT&T will relocate the pole to easement on private property south of the path, either prior to or in coordination with the construction under this contract. The City of Madison is not aware of other projects taking place in the vicinity of the project.

#### SECTION 107.1 PUBLIC CONVENIENCE AND SAFETY

Access to the site and hauling shall be via S Marquette Street, Fair Oaks Avenue, Garrison Street, Walter Street and Dennett Drive. No hauling shall take place on other local streets without prior written approval of the Construction Engineer.

In addition, arrangements have been made with City of Madison Parks Division for access through the portion of Olbrich Park north of the rail corridor, known as the Garver property(at Sugar Avenue), This access consists of permitted use of the existing unpaved access drive through the property from Fair Oaks Avenue to the north end of Sugar Avenue. The following conditions apply to use of this access point:

- Sugar Avenue through Olbrich Gardens, south of the railroad corridor, shall not be used for access or hauling of any sort
- No equipment or materials may be stored on the Garver property without prior written consent of Parks Division
- The fence gate at the north side of the building shall be locked at the end of each working day

The project is immediately adjacent to railroad property owned by Wisconsin Department of Transportation (WisDOT) and operated by Wisconsin & Southern Railroad (WSOR). The Contractor shall take great care to avoid disturbance of railroad property beyond the construction limits, which shall be assumed to be the slope intercepts shown on the plans. The City will make arrangements with WisDOT and WSOR for very limited disturbance of the rail corridor in certain locations where such work is necessary to construct drainage facilities or match grades. See Special Provision 107.12 for additional information.

For the portion of the project in Olbrich Park, from Garrison Street to Starkweather Creek, the Contractor shall take care to avoid disturbance of Parks property beyond the construction limits, which shall be assumed to extend 5 feet beyond the slope intercepts shown on the plans.

Contractor shall obtain advance approval from the Construction Engineer to occupy or disturb additional areas for a construction trailer, material storage or other use. Such additional areas shall be clearly delineated in the field with construction fence or other means. Contractor shall restore all such areas to the satisfaction of the Construction Engineer, and will be paid for this restoration under the appropriate bid items. Any areas outside those approved by the Construction Engineer that are disturbed shall be restored by the Contractor at his own expense.

The Contractor shall use care around existing trees to remain. No trees, other than those shown on the plan to be removed, shall be cut without the approval of the Engineer and the City Forester.

#### SECTION 107.7 MAINTENANCE OF TRAFFIC

All traffic control shall conform to Part VI of the Federal Highways Administrations "Manual on Uniform Traffic Control Devices" (MUTCD), the State of Wisconsin Standard Facilities Development Manual (including Chapter 16 – Standard Detail Drawings) and the City of Madison Standards for sidewalk and bikeway closures.

The Contractor shall submit an acceptable, complete Traffic Control Plan, including all necessary phases and any required sidewalk or bike route closures, to the office of the City Traffic Engineer, at 215 Martin Luther King, Jr. Blvd, Suite 100, Madison, WI 53703, a minimum of five (5) working days, prior to the preconstruction meeting. The Traffic Control Plan shall address all requirements of this section of the Special Provisions. The contractor shall not start work on this project until the Traffic Engineering Division has approved a traffic control plan and traffic control devices have been installed, in accordance with the approved plan. Failure of the Contractor to obtain approval of a Traffic Control Plan, as specified above, may prevent the Contractor from starting work and shall be considered a delay of the project, caused by the Contractor. The Contractor will be responsible for installing and maintaining traffic control in accordance with the Traffic Control Plan and as directed by the City Traffic Engineer. The Contractor shall install and maintain modifications or additions to the traffic control, as directed by the City Traffic Engineer, at no cost to the City.

The General Contractor shall be responsible for making daily inspections of the traffic control to ensure that all required signs are in place and all warning lights are functional.

Capital City Path may be closed to all traffic in segments as follows:

Marquette St to Fair Oaks Av for a maximum duration of 60 Calendar Days Fair Oaks Av to Walter St for the full duration of the contract Walter St to Dennett Dr for a maximum of 45 Calendar Days

The Contractor shall maintain a marked detour route for bicycles and pedestrians as shown in the plans, with appropriate modifications when east or west segments of the route are open while the center segment is closed.

NOTE: in addition, during the duration that the western segment is closed, the contractor shall maintain a paved connection between the north end of S Marquette Street and the existing Capital City Path west of Marquette Street. This connection shall be on any combination of existing, temporary or new pavement, a minimum of 4 feet wide and meeting ADA standards. WALK BIKES and other appropriate warning signage shall be posted on temporary barricades at either end of this temporary connection. Temporary construction fencing shall be used to separate this access from the construction zone and clearly delineate the route for pedestrians and dis-mounted bicyclists. Most likely this temporary route will have to be moved one or more times during the construction to stage construction of the project in this immediate area. The cost to construct, maintain sign, mark and remove this temporary connection shall be considered incidental to the item of Traffic Control.

Two-way traffic on all adjacent public streets shall be maintained at all times, except:

- Half of Fair Oaks Avenue may be closed during non-peak hours to construct the storm sewer facilities, replace curb and ramps or to mill and overlay the street. Two-way traffic shall be maintained during this time by means of flaggers and appropriate signage.
- Half of Walter Street may be closed during non-peak hours to construct or to replace curb and ramps. Two-way traffic shall be maintained during this time by means of flaggers and appropriate signage.
- Half of Dennett Drive may be closed during non-peak hours to construct or to replace curb and ramps. Two-way traffic shall be maintained during this time by means of flaggers and appropriate signage.

One changeable message sign shall be installed on each end of the project for the one week prior to the path closure. The sign shall read as follows or as otherwise directed by the City Traffic Engineer:

PATH CLOSURE BEGINS DAY DATE

The work areas shall be backfilled, plated, or protected by traffic control devices during non-working hours. If steel plates are used, the Contractor shall notify the City of Madison Streets Division, 266-4681, one (1) working day prior to placement of the plates.

The Contractor shall provide ADA/Handicap Accessible pedestrian access, where such accommodations are originally available, at all intersections within the construction area at all times. Contractor shall maintain a functional temporary connection between the end of the Blackhawk Path and Westbound Old Middleton Road at all times.

No construction equipment or materials shall be stored in the roadway or street right-of-way that is open to traffic during non-working hours. Construction equipment and materials are not to be stored within the street right-of-way that is outside the project limits as shown on the approved plan.

The Contractor shall not remove or cover any traffic signs. For removal, replacement, or covering of traffic and parking signs, contact the City of Madison Traffic Engineering Field Operations, 1120 Sayle Street, 266-4767, 8:00 a.m. to 4:00 p.m., a minimum of two working days in advance of when any existing signs need to be removed or covered. This service is free of charge. If the Contractor removes or covers the signs, the Contractor will be billed for the reinstallation or repair of, and any damage to, the signing equipment.

#### MEASUREMENT

Traffic Control will be measured as a single lump sum for all traffic control measures required, except for the Portable Changeable Message signs. Any traffic control required on other streets will not be measured for payment and will be considered incidental to other items of work.

#### PAYMENT

Payment for the Traffic Control is full compensation for furnishing, erecting, maintaining and removing non permanent traffic signs, drums, barricades, and similar control devices; for furnishing, installing, maintaining and removing detour signage and for constructing, maintaining, moving and removing the temporary connection at N Marquette St as described above. Maintaining shall include replacing damaged or stolen traffic control devices and moving or altering traffic control devices for altered or unexpected field conditions as required by the Engineer. Portable Changeable Message signs will be measured and paid for separately under the appropriate bid item.

#### SECTION 107.12 OPERATIONS ON RAILROAD RIGHT OF WAY

In addition to the conditions under these Special Provisions in Section 107.1 Contractor shall comply with the provisions of Article 107.12 of the Standard Specifications regarding operations on Railroad right of way while doing any work within the rail right of way or within 25 feet of the track centerline:

Contractor will be required to sign and adhere to the conditions of a Temporary Authorization Permit from Wisconsin department of Transportation. A sample copy of the Permit is attached to these special Provisions. Execution of the permit and adherence to all conditions except Condition 7 shall be considered incidental to the work under this contract and no additional payment will be made therefor.

Contractor will be required to obtain railroad protective liability insurance and provide a certificate of insurance naming Wisconsin & Southern Railroad LLC and the Wisconsin Department of Transportation as additional insured. Payment will be made for this at the contract Lump Sum price for RAILROAD INSURANCE.

#### ARTICLE 108.2 PERMITS

The City of Madison has obtained coverage under a WPDES General Permit No. WI-S067831-04 for Construction Site Storm Water Runoff regarding erosion control for a disturbed area greater than one acre. Coverage was issued March 30, 2015

The City of Madison has submitted a DNR Water Resources Application for Projects Permits (WRAPP) for the following and permit coverage is pending:

- Individual Permit for a bridge over a waterway with width greater than 25 feet at Ordinary High water.
- Individual Permit for storm water discharge greater than 24-inch diameter into Starkweather Creek

A City of Madison Erosion Control permit has been obtained and weekly inspections will be completed by City Staff. Contractor may be required to complete additional inspections following storm events, and this work will be paid for under the appropriate bid item. See **SECTION 210.1(b)**. A copy of the permit is available at the City of Madison, Engineering Division office.

The Contractor shall meet the conditions of the permits by properly installing and maintaining the erosion control measures shown on the plans, specified in these Special Provisions, or as directed by the Construction Engineer or his designees. This work will be paid for under the appropriate contract bid items. If appropriate items are not included in the contract, they shall be considered Extra Work. A copy of the permit is available at the City of Madison, Engineering Division office.

Copies of these permits will be provided to Contractor prior to start of construction. The Contractor must keep a copy of each individual permit on site at all times throughout construction.

The City's obtaining of these permits is not intended to be exhaustive of all permits that may be required to be obtained by the Contractor for construction of this project. It shall be the responsibility of the Contractor to identify and obtain any other permits needed for construction.

The City will obtain general permission for limited work on the WisDOT railroad corridor provided all the following conditions are met:

- 1. Project shall be constructed substantially in conformance with the plans with respect to portions on railroad property. Any significant modifications shall be approved by WisDOT and WSOR prior to construction.
- 2. No work shall take place within 25 feet of the centerline of track at any time without prior advance written approval of the Construction Engineer and WSOR. This includes movement or parking or vehicles or equipment, storage of materials, boom swings or movement of personnel. If Contractor believes such work is necessary he shall: 1) inform the Construction Engineer in writing; 2) make all necessary arrangements with WSOR to obtain their permission; and 3) pay at his own expense any costs for flagging or other safety measures by the Railroad.
- 3. Contractor will be required to sign and adhere to the conditions of a Temporary Authorization Permit from Wisconsin Department of Transportation as noted in Section 107.12.
- 4. Contractor will be required to obtain railroad protective liability insurance as noted in Sectin 107.12.

#### SECTION 109.2 PROSECUTION OF WORK

The Contractor shall begin work on or before <u>JUNE 15, 2015</u>. Total time for completion of this contract shall be <u>100 CALENDAR DAYS</u>.

This the contract start date above is intended to allow the Contractor time to begin design and shop drawing review of the pre-fabricated bridge in advance of actual construction. Construction operations requiring closure of the path shall begin no earlier than **June 29, 2015**.

Work shall begin only after the start work letter is received.

In addition to the above requirements, Contractor shall schedule operations such that segments of the project which can be completed in shorter periods of time are not closed for the full duration of the contract. Specifically:

- The west segment from Marquette Street to Fair Oaks may be closed and traffic detoured for a maximum of **60 CALENDAR DAYS**.
- The east segment from Walter Street to Dennett Drive may be closed and traffic detoured for a maximum of **45 CALENDAR DAYS**.

Contractor may choose to begin these segments later in the contract period or to complete and re-open them prior to the total time for completion, or a combination of these options. In any case, the interim duration shall be considered to begin when the segment is closed to use and to end when the segment is re-opened for use on the new pavement.

Interim Liquidated Damages of **\$500 per Calendar Day** will be assessed for failure to complete either of the segments within the stated duration. Maximum Liquidated Damages for any calendar day will not exceed those calculated per Section 109.9 of the City of Madison Standard Specifications.

It is expected that the Contractor may need to utilize multiple crews working in multiple locations within the project limits to complete all work by the contract end date.

#### **BID ITEM 20101 - EXCAVATION CUT**

The item of Excavation Cut shall apply to all excavation for paths, curbs, and sidewalk within the project limits except for removal of concrete items, excavation for the bridge substructure units or trenching for storm sewer, which are paid for under other items. Excavation Cut shall be in accordance with Article 201 of the Standard Specifications except as provided below.

Suitable material, as determined by the Construction Engineer, from the cut shall be used on site to construct embankments as indicated on the plans. Placing, grading and compaction of excavated materials will be considered incidental to this bid item.

The Contractor shall be responsible for determining a suitable off-site disposal location for excess or unsuitable material. Contractor shall comply with all laws and permit conditions for off-site disposal.

#### METHOD OF MEASUREMENT

The quantity of Unclassified Excavation above the subgrade line as shown on the cross sections will not be measured in the field, but will be assumed to be the Plan Quantity as shown on the Plans. Excavation below Subgrade (EBS or undercut, including topsoil stripping), where required by the Construction Engineer, will be measured in the field. The pay quantity for the item of Excavation Cut shall be the sum of the plan quantity for Unclassified Excavation and the measured quantity of EBS.

#### **BASIS OF PAYMENT**

Excavation Cut, measured as provided above, will be paid at the contract unit price per Cubic Yard, which shall be full compensation for all excavation of asphalt, granular materials or soil, compaction of the subgrade where required, removal and disposal of all excess materials of all types, and all labor, tools, equipment, and incidentals necessary to complete this item of work.

#### **BID ITEM 20217 - CLEAR STONE**

#### DESCRIPTION

Clear Stone shall meet the requirements for Gradation Number One (No. 1) of the Standard Specifications, commonly known as three-inch clear stone. The clear stone shall be utilized for a construction entrance and/or other purposes as directed by the Engineer.

#### **BID ITEM 20221 - TOPSOIL**

#### DESCRIPTION

Topsoil shall include furnishing, spreading, fine grading and raking the surface in preparation for seeding, in accordance with Section 202 of the Standard Specifications. Contractor may use salvaged topsoil obtained from excavation within the project limits for some or all of the topsoil required. If salvaged topsoil is used, this item includes any additional effort to strip the topsoil, stockpile it on site and prepare it to meet the material specifications. If off-site topsoil is required, no extra compensation will be allowed. All areas within the limits of disturbance, except areas of hard surface, shall have topsoil placed to a minimum thickness of four (4) inches unless otherwise shown on plans.

#### METHOD OF MEASUREMENT

Topsoil will be measured by the square yard, in place.

#### **BASIS OF PAYMENT**

Topsoil will be paid at the contract price per square yard, which shall be full payment for segregating, stockpiling and preparing salvaged topsoil, furnishing additional topsoil from offsite if needed, placing, grading and raking finished surface, all materials, labor and incidentals necessary to complete the work as provided.

#### BID ITEM 20230 – HEAVY RIPRAP

#### Description

The work shall consist of placing Heavy Riprap at the bridge abutments and 33-inch storm sewer outfall in accordance with the plans and these specifications.

#### Materials

Heavy Riprap shall conform to Section 212.2 of the Standard Specifications. Existing riprap in the area being disturbed may be salvaged and re-used, provided the material is sound, generally meets the dimension requirements of these specifications and its use is approved by the Construction Engineer.

#### **Construction Methods**

Heavy Riprap shall be placed in conformance with Section 212.3 of the Standard Specifications and as provided herein. Prior to riprap being delivered to the site, the Contractor shall review the existing site conditions with the Construction Engineer, who shall then establish the limits of removal of existing riprap. Much of the area of new riprap as shown on the plans has existing riprap, which was installed either with the original bridge installation or with a recent channel restoration project. If existing riprap is properly installed on fabric, the Engineer may direct that this material remain in place and additional riprap be added to bring the final line and grade to that shown on plans. For other areas it will be necessary to remove (and salvage if appropriate) existing riprap and prepare the base with fabric as shown on the plans.

#### Method of Measurement

Heavy Riprap, delivered and installed, or salvaged and re-installed, will be measured by the Ton. The quantity of new riprap brought to the site will be determined conventionally by truck tickets. The quantity of salvaged riprap will be determined by direct measurement of the stockpile and the resulting volume converted to Tons based on an assumed density of 1.8 Tons per Cubic Yard. Only accepted work will be measured for payment and the computation of the quantity thereof will be based on the area within the limiting dimensions designated on the plans, in the contract or established by the engineer.

#### Basis of Payment.

This work, measured as provided, will be paid for at the contract unit price under the following bid item:

Payment is full compensation for excavation and preparation of the bed, including backfilling and disposal of surplus material; furnishing and placing Heavy Riprap, for restoring the site of the work; and for furnishing all equipment, tools, labor and incidentals necessary to complete the work.

#### BID ITEM 20233 - RIPRAP FILTER FABRIC TYPE HR

#### Description

The work shall consist of placing Geotextile Fabric Type HR at the abutments or other riprap locations in accordance with the plans and these specifications.

#### Materials

Geotextile Fabric Type HR shall conform to Section 645 of the State of Wisconsin Standard Specifications for Highway and Bridge Construction, 2015 Edition.

#### **Construction Methods**

Geotextile Fabric Type HR shall conform to Section 645 of the State of Wisconsin Standard Specifications for Highway and Bridge Construction, 2015 Edition.

#### Method of Measurement

Geotextile Fabric Type HR, delivered and installed, will be measured by the square yard. Only accepted work will be measured for payment and the computation of the quantity thereof will be based on the area within the limiting dimensions designated on the plans, in the contract or established by the engineer.

#### **Basis of Payment**

This work, measured as provided, will be paid for at the contract unit price under the following bid item:

Payment is full compensation for excavation and preparation of the bed, including backfilling and disposal of surplus material; furnishing and placing Geotextile Fabric Type HR, for restoring the site of the work; and for furnishing all equipment, tools, labor and incidentals necessary to complete the work.

#### **BID ITEM 20326 - REMOVE FENCE**

#### DESCRIPTION

All work under this bid item shall be completed in accordance with Section 203 of the Standard Specifications and as provided herein.

The approximate length of fence to be removed is indicated on the plans. This work shall also include modifying the remaining fence by providing a new end section and end post where necessary. Existing fence fabric and hardware which can be salvaged in good condition may be used to construct the end section. Any new materials necessary to complete the installation, including posts and foundations, shall substantially match or exceed the existing fence with respect to material strength and thickness, post embedment and finish.

#### METHOD OF MEASUREMENT

Remove Fence will be measured along the existing fence from end post to end post of the new fence, not including any work beyond these limits to construct new end posts for the existing fence to remain, as described above.

#### **BASIS OF PAYMENT**

Remove Fence will be paid at the contract price per Linear Foot, which shall be full payment for removing a portion of the existing fence and establishing a new end post(s) as described, including salvaging or disposal of removed materials and furnishing all new materials necessary to properly support the remaining existing fence.

#### BID ITEM 20336 – PIPE PLUG

With regard to the City of Madison Standard Specifications for Public Works Construction 2015 Edition Article 203.2c, any pipe found in a trench that is less than 10" inside diameter while installing a sewer facility shall be considered incidental to the pipe being installed.

Any pipe plugs required to abandon or remove sewer access structures (pipes directly connected to the structure) shall be considered incidental to abandoning or removing the structure regardless of the size of pipe being abandoned.

#### BID ITEM 20401 and 20403 – CLEARING AND GRUBBING

#### DESCRIPTION

Work under these items consists of the clearing and grubbing of individual trees shown on the plans for removal or trees removed at the direction of the Construction Engineer or City Forrester.

Clearing and Grubbing shall be done in accordance with Article 204 of the Standard Specifications as modified in these Special Provisions.

#### CONSTRUCTION METHODS

Contractor shall mark the removals in the field and shall review the individual trees to be removed with the Construction Engineer prior to removing them. The construction Engineer and /or Forrester may designate certain trees near or within the intercepts to be saved or protected. Such trees shall be clearly marked and if necessary silt fence, construction fencing or other marking used to ensure that they are not damaged.

#### METHOD OF MEASUREMENT

Clearing and Grubbing will be measured by Inch-Diameter as provided in the Standard Specifications. Only trees with a 3-inch or greater diameter, measured approximately 4.5 feet above ground level will be measured.

#### **BASIS OF PAYMENT**

Clearing and Grubbing, measured as provided above, will be paid at the contract price per Inch-Diameter, which shall be full payment for all work to complete this item in accordance with the Standard Specifications.

#### **BID ITEM 21002 – EROSION CONTROL INSPECTION**

Work under this bid item shall be for weekend inspections (inspections required for rain events, half inch or larger, that occur on a Friday or Saturday) by the Contractor after half inch or greater rain events or as directed by the construction engineer. All weekly inspections and rain event inspections required during the work week (Monday-Friday) shall be completed by the City of Madison construction inspector.

#### BID ITEM 40101 – CRUSHED AGGREGATE BASE COURSE GRADATION NO. 1

#### DESCRIPTION

Work under this item consists of constructing a sub-base in the locations and to the depth and widths shown on the plans.

#### CONSTRUCTION METHODS

Excavate to a depth required to provide the aggregate sub-base, base course and asphalt pavement thickness shown on plans. Prepare subgrade, place and compact crushed aggregate in accordance with Section 401.2 of the Standard Specifications.

#### MEASUREMENT AND PAYMENT

This item will be measured and paid for in accordance with Section 401.3 of the Standard Specifications supplemented as follows: Contract unit price for Crushed Aggregate Base Course, Gradation No. 1 shall be considered full payment for layout of the lines and grades, preparation of the subgrade, furnishing, placing and compacting aggregate. Base course and HMA pavement above the sub-base will be paid for separately under the appropriate items.

#### **BID ITEM 40301 – FULL WIDTH GRINDING**

#### DESCRIPTION

This work shall consist of milling or "cold planning" of existing asphalt surface to a nominal depth of two (2) inches to establish a new surface profile, in accordance with Section 403.2 of the Standard Specifications.

#### CONSTRUCTION METHODS

The depth of grinding will vary to create the finish grades shown on plans and details. To the extent practical the grinding depth shall be adjusted to allow for a 2-inch thick asphaltic surface, but in no case shall the new surface thickness be less than 1.75 inches. The approximate limits of grinding are shown on the plans. Exact limits will be established by the Construction Engineer.

#### METHOD OF MEASUREMENT

Full Width Grinding will be measured as the actual area of asphalt pavement remaining, generally bounded by saw cuts of existing pavement, acceptably completed.

#### **BASIS OF PAYMENT**

This work will be paid at the contract price for Full Width Grinding per Square Yard, in accordance with Section 403.2 of the Standard Specifications.

#### ARTICLE 501 STORM SEWER STRUCTURES

501.1 Description

#### STORM SEWER GENERAL

The storm sewer designer for this project is Corey Stelljes. He may be contacted by phone at (608) 266-9721 or by email at cstelljes@cityofmadison.com.

Reconnection of existing pipes at new structures, or new pipes at new structures, shall be considered to be part of the work required to construct the new structure or to construct the new sewer pipe and shall not be rewarded with additional compensation. However, if the structure being removed is larger than the new structure, thus requiring additional pipe, the new pipe shall be paid under the appropriate bid item and the connection of the old pipe to the new pipe shall be accomplished with a concrete collar.

Where a new structure is to be constructed at an existing pipe, it is expected that the contractor shall saw cut the existing pipe in the required location to accommodate the placement of the new structure. If the contractor for his/her convenience deems it more suitable to remove the existing pipe to a full joint, the additional pipe and concrete collar required to reconnect to the new structure shall be the contractor's responsibility and shall not be compensated.

Connection of new pipes to existing structures shall be accommodated with a Storm Sewer Tap – Bid Item 50792.

If there are structures where the pipe walls are to be poured into the structure roof or both the pipe walls and the structure casting are to be poured in the structure roof, the Contractor shall not be provided additional compensation for complying with the structure requirements detailed on the storm sewer chart and plans.

Precast structures are only allowed where field poured structures are not specifically called for, and no precast structures are allowed until ULO's are completed and approval of the design engineer has been received.

#### Coordination with Olbrich Gardens

Storm sewer structures RS-6 and S-8 are located within the boundaries of Olbrich Gardens. The contractor is expected to access these structures from the Capitol City Path. The contractor shall remove and replace a section of the chain link fence in order to gain access.

There are two existing Arbor Vitae trees that will be impacted by storm sewer work. Olbrich Gardens intends to remove these trees with a tree spade, move them to an alternate location, and reinstall the trees after this section of storm sewer is complete. The contractor shall coordinate with Olbrich Gardens on the tree removal and shall provide a minimum of 2 weeks notice prior to starting storm sewer work in this area. Upon starting work the contractor shall have no more than 14 calendar days to complete the storm sewer work inside Olbrich Gardens, restore the area, replace the section of chain link fence, and again notify Olbrich Gardens that work is complete.

#### SANITARY SEWER GENERAL

The Sanitary Sewer designer for this project is Corey Stelljes. He may be contacted at (608) 266-9721 or cstelljes@cityofmadison.com.

#### MMSD Sewer Access Structures:

There are several sewer access structures belonging to MMSD on the project. Some of these are to be adjusted. Sanitary Sewer casting adjustments are included as part of the project as shown on the plans. Contractor shall coordinate operations with the MMSD. MMSD will supply a rubber adjustment ring and new casting. Contact Ray Schneider (608)347-3628, rays@madsewer.org, 5 days prior to adjusting the manhole casting to grade.

#### BID ITEM 50795 PRIVATE STORM RECONNECT TYPE 2

#### Madison Kipp Corporation private storm lateral

Madison Kipp Corporation has a private storm sewer lateral that connects to existing storm sewer structure RS-13. This is known to be a force main used to discharge water used in a private industry process and has been approved to discharge to the City of Madison storm sewer system. Maximum discharge volume for this lateral is 45 GPM. This item shall include all work, materials, labor and incidentals necessary to control of all water discharged from the pipe.

#### Olbrich Park storm lateral

Madison Parks Division has a storm sewer lateral that connects to the City storm sewer system approximately 10 feet upstream of structure RS-3. This storm sewer lateral is currently tapped into the wall of existing pipe RP-5. This pipe RP-5 shall be removed. The existing private storm sewer lateral shall be located and removed back to a point further upstream than the crossing of the proposed storm sewer. It shall then be connected to either existing inlet 6041-048 or proposed structure S-4.

#### BID ITEM 90001 - CONCRETE CURB AND GUTTER 36-INCH, SPECIAL

#### DESCRIPTION

Work under this item consists of constructing concrete curb and gutter in the location shown and in accordance with the details provided in the plans. All work and materials shall in accordance with the applicable provisions of Article 302 of the Standard Specifications for concrete curb and gutter, and as provided herein.

#### CONSTRUCTION METHODS

Saw cut existing hard surfaces a minimum of 1 foot behind the back of proposed curb and remove existing pavement and base to subgrade elevation. Care shall be taken in removing the materials to not unnecessarily disturb subgrade beneath it. Any materials disturbed below subgrade level shall be

removed by hand or with a smooth bucket, backfilled with crushed aggregate base and mechanically compacted.

Place and compact base course for full width of excavation. Form and construct concrete curb and gutter to the lines and grades shown on plans and details as a monolithic concrete pour. Finish the exposed face of the back of curb the same as all other exposed surfaces. **MEASUREMENT** 

This item, acceptably placed and finished, will be measured along the face of curb in Linear Feet, which will include transition sections at either end and modified section for the sidewalk curb opening.

#### PAYMENT

This work, measured as provided, will be paid for at the contract unit price per linear foot for Concrete Curb and Gutter 36-inch, Special, which shall be considered full payment for preparation of the base, furnishing and finishing concrete to the dimensions and shapes shown on the plans and all incidentals as provided in Section 302 of the Standard Specifications.

Saw cutting will be paid for separately. Removal of asphalt and base to subgrade will be considered included in Excavation Cut. Any cost to remove disturbed soil, backfill and compact will be considered incidental to this item.

#### BID ITEM 90003 – FENCE CHAIN LINK, 6-FT GALVANIZED

#### DESCRIPTION

This work shall consist of furnishing and installing a chain link fence in accordance with the applicable portions of Section 616 of the State of Wisconsin Standard Specifications for Highway and Structure Construction, 2015 Edition (WisDOT Standard Specifications) and these provisions.

#### MATERIALS

Fence materials shall conform to section 616.2.3 of the WisDOT Standard Specifications with the following exceptions:

The fabric shall be 9 gauge, steel core with a 2-inch mesh size provided this material reasonably matches the existing fencing material. If there is a visible difference, the Contractor shall request guidance from the Construction Engineer prior to delivering materials to the site.

#### CONSTRUCTION

Details shall generally conform to WisDOT Standard Detail drawing 15B3 Sheet b: Chain Link Fence.

#### MEASUREMENT

Fence Chain Link, 6-FT Galvanized will be measured by the linear foot acceptably completed, measured from center to center of end posts at the ground line.

#### PAYMENT

Fence Chain Link, 6-FT Galvanized, measured as provided above, will be paid for at the contract unit price per linear foot. Payment will be full compensation for furnishing, erecting, tensioning, including any modifications necessary to match and provide continuity with the existing fence to remain, and for all labor, tools, equipment and incidentals necessary to complete this item of work.

#### **BID ITEM 90006 - TREE PROTECTION**

#### DESCRIPTION

No trees may be removed except those specifically indicated for removal on the plans or as directed by the Construction Engineer. Contractor shall not grade, excavate, store materials or equipment or otherwise disturb areas within five (5) feet of any tree to remain in accordance with Article 107.2 of the Standard Specifications. Contractor shall take care at all times to conduct operations in a way that avoids damage to any trees not designated for removal. All above precautions are considered incidental to other items of the work.

There are trees which, because of their proximity to the construction, their susceptibility to damage and/or their importance to the landscape, warrant additional protective measures. Such trees are shown on the plans or will be designated in the field by the Construction Engineer. Contractor shall take extra precautionary measures to protect such trees as provided herein.

#### MATERIALS

Construction fencing shall be International Orange color, high-density polyethylene mesh conforming to the following:

- Mesh opening: 1 inch min to 3 inch max
- Height: 4 feet
- Ultimate tensile strength: Avg 3000 lb per 4' width (ASTM D638)

Posts shall be conventional metal "T" or "U" shaped posts

#### CONSTRUCTION METHODS

All trees to be protected shall be flagged with yellow ribbon tied around trunk, not by paint. Erect and maintain construction fencing between the construction area and the trees a minimum of 5 feet from trunks. Support construction fence on posts spaced no more than 7 ft apart driven 12 to 18 inches.

Trees may be individually fenced or fencing may be extended longitudinally to protect several trees. Fencing must extend a minimum of 15 feet beyond the tree or group of trees to be protected in both directions longitudinal to the reference line, or as directed to clearly separate the construction activity from the tree or trees.

All rough grading, excavation or trenching within the drip line of protected trees shall be done under the supervision of a City of Madison Forestry representative. Contractor shall notify the Construction Engineer a minimum of two working days in advance of any such work to arrange for the Forestry representative to be present. Where it is likely that grading or trenching will encounter roots of a protected tree greater than 1 inch in diameter, the roots shall be exposed by hand and the Forestry representative will determine where to sever root(s). Roots shall be cut cleanly with a saw or ax.

If in the opinion of the Forestry representative excavation to subgrade as shown on the plans cannot be done without unacceptable damage to trees to be protected, the Construction Engineer may request a reduced base thickness or other modifications to reduce damage to the tree. Likewise, excavation below subgrade (undercutting) may be deleted as directed by the Construction Engineer in certain locations where necessary to protect trees. Any horizontal alignment modifications shall be made only in consultation with the Design Engineer.

If it is necessary in the opinion of the Construction engineer to remove additional overhanging branches of protected trees, the contractor may prune the trees for crown cleaning and raising as defined by ANSI A3000 for Tree Care Operations. Such work shall be done under the supervision of the Forestry representative.

#### METHOD OF MEASUREMENT

Tree Protection will be measured as complete units of work for each individual tree designated for protection, flagged and protected as provided herein. Any tree which is damaged in any way as a result of insufficient care on the part of the Contractor or failure to implement the measures provided above will not be measured for payment. In addition, damages may be assessed in accordance with Article 107.2 of the Standard Specifications.

#### BASIS OF PAYMENT

Tree Protection, measured as provided above, will be paid for at the contract price each, which shall be full compensation for all work, materials, labor, and incidentals required to complete the work including furnishing, erecting, maintaining and removing safety fencing, hand excavating and cutting of roots and trimming of branches, coordination with City Forestry and all labor, materials, equipment and incidentals necessary to complete the work. 50% of the bid price for Tree Protection will be paid after installation of fencing and 50% of the bid price will be paid after removal of fencing and completion of operations with potential to damage trees.

#### BID ITEM 90010 - TURBIDITY BARRIER

#### DESCRIPTION

A turbidity barrier shall be installed per the Wisconsin Department of Natural Resources Conservation Practice Standard 1069 (<u>http://dnr.wi.gov/topic/stormwater/documents/TurbidtyBarrier\_1069\_.pdf</u>). Work includes installation, maintenance and removal of the barrier.

#### METHOD OF MEASUREMENT

Turbidity Barrier shall be measured by the linear foot acceptably installed.

#### **BASIS OF PAYMENT**

Turbidity Barrier measured as described above shall be full payment for all work, materials and incidentals required to complete the work in accordance with the description.

#### BID ITEM 90021- REMOVING OLD STRUCTURE STATION 38+71

#### Description

This work shall consist of removing and disposing of the existing steel truss bridge, concrete abutments and concrete approach slabs located at the proposed bridge site.

Conform to Section 203 of the State of Wisconsin Standard Specifications for Highway and Structure Construction, 2015 Edition as modified in this special provision.

Add the following to standard spec 203.3.6.1 Removing Old Structure Over Waterway

Remove the existing Pedestrian Structure over Starkweather Creek conforming to the contractor's approved structure removal and clean-up plan. Remove all reinforcing steel, all concrete, and all other debris that falls into the waterway or wetland. Remove large pieces of the structure within 36 hours.

Submit a structure removal and clean-up plan as part of the erosion control implementation plan required under standard spec 107.20. Do not start work under the structure removal and clean-up plan without the department's written approval of the plan. Include the following information in the structure removal and clean-up plan:

- 1. Methods and schedule to remove the structure.
- 2. Methods to control potentially harmful environmental impacts.
- 3. Methods for removing abutments. Blasting is prohibited.
- 4. Methods for cleaning the waterway or wetlands.

If stockpiling spoil material, place it on an upland site an adequate distance from the waterway, wetland, or any open water created by excavation. Install silt fence between the spoil pile and the waterway, wetland, or excavation site.

#### Method of Measurement

Removing Old Structure Station 38+71 will be measured as a single unit of work, acceptably completed.

#### **Basis of Payment**

This work, measured as provided, will be paid for at the contract unit price under the following bid item:

#### Description

The work shall consist of providing Piling CIP Concrete 10 3/4 X 0.5 Inch delivered and installed for the bridge as shown on the drawings.

#### Materials

Piling CIP Concrete 10 3/4 X 0.5 Inch shall conform to Section 550 of the State of Wisconsin Standard Specifications for Highway and Structure Construction, 2015 Edition.

#### **Construction Methods**

Piling CIP Concrete 10 3/4 X 0.5 Inch shall be constructed as shown on the drawings and as specified in Section 550 of the State of Wisconsin Standard Specifications for Highway and Structure Construction, 2015 Edition.

#### Method of Measurement

Piling CIP Concrete 10.75 X 0.5 Inch will be measured by the linear foot acceptably completed.

#### **Basis of Payment**

This work, measured as provided, will be paid for at the contract unit price under the following bid item:

## ITEM 90023 - REINFORCED CONCRETE BRIDGE ABUTMENTS, WINGWALLS, AND RETAINING WALL

The work shall consist of providing reinforced concrete abutments, wingwalls, and retaining wall as shown on the drawings. RUBBERIZED MEMBRANE WATERPROOFING: Rubberized Membrane Waterproofing shall conform to Section 516 of the State of Wisconsin Standard Specifications for Highway and Bridge Construction, 2015 Edition.

PIPE UNDERDRAIN WRAPPED 6-INCH: Pipe Underdrain Wrapped 6-Inch shall conform to Section 612 of the State of Wisconsin Standard Specifications for Highway and Bridge Construction, 2015 Edition.

#### **Construction Methods**

EXCAVATION FOR STRUCTURES: Backfill Structure shall conform to Section 206 of the State of Wisconsin Standard Specifications for Highway and Bridge Construction, 2015 Edition.

BACKFILL STRUCTURE: Backfill Structure shall conform to Section 210 of the State of Wisconsin Standard Specifications for Highway and Bridge Construction, 2015 Edition.

CONCRETE: Concrete shall conform to Sections 501 and 502 of the State of Wisconsin Standard Specifications for Highway and Bridge Construction, 2015 Edition. Dewatering the formwork prior to the footing pour, if necessary, shall be included in this bid item.

BAR STEEL REINFORCEMENT HS BRIDGES: High strength bar steel reinforcement shall conform to Section 505 of the State of Wisconsin Standard Specifications for Highway and Bridge Construction, 2015 Edition.

RUBBERIZED MEMBRANE WATERPROOFING: Rubberized Membrane Waterproofing shall conform to Section 516 of the State of Wisconsin Standard Specifications for Highway and Bridge Construction, 2015 Edition.

PIPE UNDERDRAIN WRAPPED 6-INCH: Pipe Underdrain Wrapped 6-Inch shall conform to Section 612 of the State of Wisconsin Standard Specifications for Highway and Bridge Construction, 2015 Edition.

A notch shall be provided in the concrete abutment paving block so that the steel sliding plate over the expansion gap is flush with the top of the abutment backwall.

#### Measurement

Reinforced Concrete Bridge Abutments, Wingwalls, and Retaining Wall will be measured as a single unit of work for the structure where the abutments, wingwalls, and retaining wall are satisfactorily furnished and installed.

#### Payment

This work, measured as provided, will be paid for at the contract unit price under the following bid item:

Payment is full compensation for Excavation for Structures; Backfill Structures, furnishing and installing Concrete Masonry Bridges including providing forms and falsework; for furnishing, placing, finishing, curing, and protecting concrete and for measuring and evaluating concrete strength including fabricating and testing cylinders, and evaluating maturity; furnishing and installing Bar Steel Reinforcement HS Bridges; furnishing and installing Rubberized Membrane Waterproofing; and furnishing and installing Pipe Underdrain Wrapped 6-Inch; and for furnishing all labor, tools, equipment, materials and incidentals necessary to satisfactorily complete the work.

- 1. Basic design criteria shown on the design plans.
- 2. Complete detailed drawings of all structural steel connections, sizes of members, span lengths between bearing points, skews, walkway widths, bearing assembly details, anchor bolt locations, concrete deck reinforcement, design data, materials data, and dead and live load bearing reactions.
- 3. Engineer's certification. The plans shall be sealed, signed and dated by a Professional Engineer registered in the State of Wisconsin.
- 4. One set of design calculations with independent checks.

One set of prints from this submittal, and any subsequent submittals, will be returned to the Contractor, either indicating acceptance or marked with required revisions and/or corrections. Provide the engineer copies of final plans to be used in fabrication and construction.

#### **B MATERIALS**

#### **B1 Prefabricated Steel Truss Bridge Superstructure**

Structural design of the pedestrian steel truss superstructure shall be by a Professional Engineer registered in the State of Wisconsin.

Design the superstructure in accordance with the 17th Edition of the AASHTO Standard Specifications for Highway Bridges, all current interims, and the AASHTO Guide Specifications for Design of Pedestrian Bridges, except as modified herein.

The bridge superstructure shall be a "Half-H" shape truss with profile as shown on the plans with one diagonal per panel and square end vertical members. The top of the finished concrete deck surface shall match the profile as supplied in the plans plus a minimal camber for dead load as described below. An underhung pony truss with floor beams hung under the lower chords will not be allowed.

The bridge shall be constructed of unpainted weathering steel.

All fabrications shall be produced from high strength, low alloy, atmospheric corrosion resistant ASTM A847 cold-formed welded square and rectangular tubing, ASTM A606 sheet, and/or ASTM A588, ASTM A242, or ASTM A709 Grade 50W plate and structural steel shapes (Fy=50,000 psi) with a minimum corrosion index of 5.8 per ASTM G101.

Design welded tubular connections in accordance with the Structural Welding Code-Steel ANSI/AWS D1.1. The fracture critical requirements of ANSI/AWS D1.5 do not apply, and Charpy V-notch impact testing will not be required. Loading shall be as stated in Article 1.2 of the AASHTO Guide Specifications for Design of Pedestrian Bridges. The bridge superstructure shall be a half-through truss. Chords, diagonals, verticals, bracing, and floor beams may be tube steel. Tube steel shall have a minimum thickness of 1/4-inch. All other steel shapes shall have a minimum thickness of 5/16-inch. Field splices shall be bolted with ASTM A325 high strength bolts in accordance with the "Specifications for Structural Joints Using ASTM A325 or A490 Bolts". Type 3 bolts are required for weathering steel. For top and bottom chord field splices, splice plates are required on both the inside and outside surface of the spliced tubing so that each bolt will be acting in double shear. Nuts may be welded to the splice plates to hold them in place during installation. When the collection of water inside a structural tube is a possibility, either during construction or during service, provide the tube with a drain hole at its lowest point.

Camber the bridge to follow the path profile plus the calculated dead load deflection.

Concrete bridge decks shall be continuous over the floor beams and supported by 20-gauge, 1.5 to 2.0 inch deep corrugated galvanized steel stay-in-place deck forms. The minimum slab thickness shall be 5.5 inches measured from the bottom of the deck form. Design the longitudinal reinforcing steel in the slab based on a wheel load from the design truck located one foot from the face of the curb or toe plate, or a pedestrian live load of 90 psf, whichever controls. The design truck shall be a 20,000-pound four-wheeled vehicle (no impact allowance is required) with 60% to rear axle loading, 120" wheelbase, and 72" tire track.

The total depth of the structure measured from top of the finished concrete deck to the bottom of the bearing pad shall not exceed 2'-4". This dimension shall be verified by the contractor.

Concrete strength (f'c) shall be 4,000 psi and Fy of bar steel shall be 60,000 psi. The maximum unit weight of the deck concrete shall be 120 pcf. Use a design dead load of 120 pcf. Use load factors of 1.3 for dead load and 1.75 for live load for the design of the concrete slab. Minimum concrete cover shall be 2 inches for top reinforcement and 1 inch for bottom reinforcement. Design the bridge for expansion and contraction with a temperature range of -30° F to 120° F. Utilize teflon slip pads or other approved material on the sliding surface of the expansion bearing assembly.

The top chords and end verticals shall be offset 1-1/2" from the interior verticals and diagonals so that the rails and rub rail are flush with the top chords and end verticals.

HSS horizontal rails shall be incorporated into the truss as shown on the plans.

The bridge fabricator shall provide a Ipe rub rail under this bid item. The rub rail shall be a 1"x 5-1/2" (actual size) naturally durable hardwood Ipe (Tabebuia Spp Lapacho Group) rubrail. Rubrail shall be partially air dried to a moisture content of 15% to 20%, shall be supplied S4S (surfaced four sides), E4E (eased four edges), with the edges eased to a radius of 1/8". Measured at 30% moisture content, the width and thickness shall not vary from specified dimensions by more than  $\pm$  0.04 inches. Ends of each piece shall be sealed with "Anchorseal" Mobil CER-M or an equal aqueous wax log sealer. Connections for the rail shall be provided under this bid item. Rubrails shall be attached flush to the inside face of the bridge truss verticals and fastened with two carriage bolts at each support location. The height of the rubrail shall be centered at 36" above the top of the deck. The span of the rubrail from centerline to centerline of support shall not exceed 6'-6".

The bridge shall be supplied with a steel toe plate mounted to the inside face of both trusses. The toe plate shall be a minimum of 4 inches high. Toe plating will be welded to the truss members at a height adequate to provide a 2" gap between the bottom of the plate and the top of the deck or the top of the bottom chord, whichever is higher. The span of unstiffened flat toe plating (from center to center of supports) shall not exceed 5'-8".

The bridge shall be supplied with steel sliding plates at the ends of the bridge as shown on the plans, to be installed by the contractor when the concrete deck is poured. The cover plates are to bridge the gap between the concrete deck and the concrete abutments. A notch shall be provided in the concrete abutment so the steel plate is flush with the top of the abutment backwall.

Shim plates shall be provided by the contractor in order to level the bridge. The shim plates shall be supplied of varying thicknesses and shall match the size of the bearing plate and bolt pattern on the bearing plate.

Anchor bolts shall be supplied and installed by the contractor as recommended by the prefabricated bridge manufacturer.

#### B2 Weld Testing

An independent agency shall perform nondestructive weld testing; the manufacturer shall pay for this testing. All welds are to be visually inspected.

Ten percent of all fillet welds shall be magnetic particle tested.

All full penetration welds of chords shall be ultrasonically or radiographically tested.

Bottom chord welded tube splices for tube thicknesses less than 3/8-inches thick shall be radiographically tested or covered with fillet welded splice plates with non intersecting welds which develop 75% of the spliced member strength.

Submit a written testing report upon completion.

#### **C CONSTRUCTION**

**C1 Delivery and Erection:** Deliver the bridge by truck to the location that is nearest to the site and accessible by road. The Contractor is responsible for unloading the bridge from the truck at the time of arrival.

The manufacturer shall notify the Contractor in advance of the expected arrival time. Information regarding delays after the trucks depart the plant such as inclement weather, delays in permits, rerouting by public agencies, or other circumstances shall be passed on to the Contractor as soon as possible.

The manufacturer shall advise the Contractor of the actual lifting weights, attachment points, anchor bolt size, length, embedment depth, pattern and all other pertinent information needed to install the bridge. Unloading, splicing, bolting, and providing proper lifting equipment as well as all tools, equipment, labor, and miscellaneous items required to complete the work is the responsibility of the Contractor. The procedure for bolting field splices shall be given to the Contractor by the manufacturer.

The sliding plate on each end of the bridge shall be placed after the concrete deck has been poured and before initial set unless it can be held in place prior to the concrete pour and concrete can be placed under the cover plate sufficiently.

Shim plates shall be used at the bearing pads in order to provide level placement of the bridge. Some grinding of the bearing area at the existing abutments may be required to provide a smooth and level bearing area.

Anchor bolt pattern shall be supplied by the prefabricated bridge manufacturer. Anchor bolts shall be installed per manufacturer's recommendations and to the proper embedment depth.

C2 Finishes: The steel for the prefabricated steel truss shall be unpainted A588 Weathering Steel.

Blast-clean all exposed surfaces of weathering steel in accordance with Steel Structures Painting Council Surface Preparation Specifications No. 7 Brush-Off Blast Cleaning (SSPC-SP7), latest edition. Exposed surfaces of weathering steel shall be defined as those surfaces seen from the deck and from outside the structure. Stringers if used, floor beams, lower brace diagonals and the inside face of the truss below the deck, and bottom of the bottom chord do not need to be blasted.

#### D METHOD OF MEASUREMENT

Prefabricated Steel Truss Bridge Furnished and Installed will be measured as single lump sum unit, completed and accepted.

This work, measured as provided, will be paid for at the contract unit price under the following bid item:

Payment is full compensation for designing, manufacturing, weld testing, blast cleaning, transporting and erecting the steel truss, providing and installing sliding plates, providing and installing stay-in-place formwork and reinforced concrete deck, providing and installing shim plates as required, furnishing bearing plates, pads, anchor bolts, anchors bolts, and grout, providing and installing connections for railings; and for furnishing all labor, tools, equipment, materials, and incidentals necessary to complete the contract work.

#### **BID ITEM 90025 – REINFORCED CONCRETE APPROACH SLABS**

#### Description

The work shall consist of providing reinforced concrete pavement approach slabs as shown on the drawings.

#### Materials

Reinforced Concrete Approach Slabs shall conform to Sections 415, 501, 502, and 505 of the State of Wisconsin Standard Specifications for Highway and Structure Construction, 2015 Edition.

#### **Construction Methods**

Reinforced Concrete Approach Slabs shall be constructed as shown on the drawings and as specified in Section 415 of the State of Wisconsin Standard Specifications for Highway and Structure Construction, 2015 Edition.

The concrete for the approach slabs shall be designed to meet a minimum compressive strength of 3500 psi.

#### Method of Measurement

Reinforced Concrete Approach Slabs will be measured by the square yard acceptably completed.

#### **Basis of Payment**

This work, measured as provided, will be paid for at the contract unit price under the following bid item:

Payment is full compensation for providing the concrete, bar steel reinforcement, and jointing materials; and for furnishing all equipment, tools, labor and incidentals necessary to complete the work.

#### BID ITEM 90026 - STEEL RAILING

#### A Description

This special provision describes fabricating, galvanizing, painting and installing steel railing on the concrete wingwalls in accordance with Sections 506, 513 and 517 of the 2015 Standard Specifications and the plan details, as directed by the Engineer, and as hereinafter provided.

#### **B** Materials

All materials for the steel railing shall be new stock, free from defects impairing strength, durability and appearance. Railing assemblies shall be galvanized and receive a two-coat paint system. Bubbles, blisters and flaking in the coating will be a basis for rejection.

This item includes base plates and masonry anchors.

Base plates shall conform to ASTM A709 Grade 36

Steel Tubes shall conform to ASTM A500 Grade B

All welds shall be 3/16 inch fillet welds with E70XX electrodes unless otherwise noted.

Post based plates shall be flat with all surfaces smooth and free from warp and all edges smooth, straight and vertical. All plate cuts shall be machine or machine flame cut.

Fill bolt slot openings in post shims and base plate with non-staining gray, non-bituminous joint sealer.

Steel post shills may be used under posts where required for alignment.

Mounting hardware shall conform to ASTM 325.

#### **B1** Coating System

#### B1.1 Galvanizing

After fabrication, blast clean steel railing assemblies per SSPC-SP6 and galvanize according to ASTM A123. Vent holes shall be drilled in members as required to facilitate galvanizing and drainage. Location and size of vent holes are to be shown on the shop drawings. All burrs at component edges, corners and at holes shall be removed and sharp edges chamfered before galvanizing. Condition any thermal cut edges before blast cleaning by shallow grinding or other cleaning to remove any hardened surface layer. Remove all evident steel defects exposed in accordance to AASHTO M 160 prior to blast cleaning. Lumps, projections, globules, or heavy deposits of galvanizing, which will provide surface conditions that when painted, will produce unacceptable aesthetic and/or visual qualities, will not be permitted.

#### B1.2 Two-Coat Paint System

After galvanizing, paint all exterior surfaces of steel railing assemblies and inside of rail elements at field erection and expansion joints as hereinafter provided. All galvanized surfaces to be painted shall be cleaned per SSPC-SP1 to remove chlorides, sulfates, zinc salts, oil, dirt, organic matter and other contaminants. The cleaned surface shall then be brush blast cleaned per SSPC-SP16 to create a slight angular surface profile per manufacturer's recommendation for adhesion of the tie coat. Blasting shall not

fracture the galvanized finish or remove any dry film thickness. After cleaning, apply a tie coat from an approved coating system that is specifically intended to be used on a galvanized surface, per manufacturer's recommendations. The tie coat shall etch the galvanized rail and prepare the surface for the top coat. Apply a top coat per manufacturer's recommendations, matching the specified color shown on the plans. Use a preapproved top coat that is resistant to the effects of the sun and is suitable for a marine environment. The tie and top coats should be of contrasting colors, and come from the same manufacturer.

Ensure that the paint manufacturer reviews the process to be used for surface preparation and application of the paint coating system with the paint applier. The review shall include a visit to the facility performing the work if requested by the paint manufacturer. Provide written confirmation, from the paint manufacturer to the engineer, that the review has taken place and that issues raised have been addressed before beginning coating work under the contract.

Use one of the qualified paint manufacturers and products given below. An equivalent system may be used with the written approval of the Engineer.

#### B1.3 Color

The top coat shall be black (federal color 27038)

#### **B2 Shop Drawings**

Submit shop drawings showing the details of railing construction. Show the railing height post spacing, rail location, weld sizes and locations and all dimensions necessary for the construction of the railing. Show location of shop rail splices, field erection joints and expansion joints. State the name of the paint manufacturer and the product name of the tie coat and top coat used along with the color. State the size and material type used for all components. Also show the size and location of any vent or drainage holes provided.

#### C Construction

#### C1 Delivery, Storage and Handling

Deliver material to the site in an undamaged condition. Upon receipt at the job site, all materials shall be thoroughly inspected to ensure that no damage occurred during shipping or handling and conditions of

materials is in conformance with these specifications. If coating is damaged, Contractor shall repair or replace railing assemblies to the approval of the Engineer at no additional cost to the Owner. Carefully store the material off the ground to ensure proper ventilation and drainage. Exercise care so as not to damage the coated surface during railing installation. No field welding, field cutting or drilling will be permitted without the approval of the Engineer.

#### C2 Touch-up and Repair

For minor damage caused by shipping, handling or installation to coated surfaces, touch-up the surface in conformance with the manufacturer's recommendations. If damage is excessive, the railing assembly shall be replaced at no additional cost to the Owner. The Contractor shall provide the Engineer with a copy of the manufacturer's recommended repair procedure and materials before repairing damaged coatings.

#### C3 Installation

The top of rail height shall be 4'-0" feet above the deck surface. The rail will be attached to the steel bridge with connections provided by the bridge manufacturer.

The rail at the concrete wingwalls and shall include be installed with masonry anchors.

#### D Measurement

Steel Railing will be measured by the linear foot along the centerline of the rail, completed and accepted.

#### E Payment

This work, measured as provided, will be paid for at the contract unit price under the following bid item:

#### BID ITEM 90031 - STORM CONTROL

#### DESCRIPTION

Work under this item shall include all work, materials, equipment, and incidentals required to control dry and wet weather flow in the storm sewer system during the reconstruction project. The Contractor shall take all necessary steps to protect the new and existing storm mains from damage during construction and to accommodate the existing flows during construction.

This item includes all storm control necessary for all aspects of the Construction.

Work under this item shall include all work, materials, equipment, and incidentals required to control dry and wet weather flow in the storm sewer system during the reconstruction project to minimize damage to the treatment structure during installation of the structure and during concrete cure times.

#### METHOD OF MEASUREMENT

Storm Control shall be measured by the lump sum for all dewatering necessary throughout construction.

#### **BASIS OF PAYMENT**

Storm Control shall be paid for at the contract price, which shall be full compensation for all work as outlined in the description.

#### BID ITEM 90032 - 33 INCH RCP STORM SEWER PIPE; ITEM 90033 - 33 INCH RCP AE; AND ITEM 90034 - 33 INCH RCP AE GATE

#### DESCRIPTION

Work under this item shall include all work, materials, equipment, and incidentals to install 33 INCH RCP storm sewer pipe, apron endwall, and endwall gate in accordance with ARTICLE 504 of City of Madison Standard Specifications for Public Works Construction 2015 Edition.

#### MEASUREMENT AND PAYMENT

Items shall be measured and paid for in accordance with ARTICLE 504.4 of the City of Madison Standard Specifications for Public Works Construction 2015 Edition for the corresponding RCP items of different diameters.

#### BID ITEM 90070 - ADJUST SAS SPECIAL

#### DESCRIPTION

This special provision describes adjusting sanitary sewer access structure castings as called for on the plan set to the final proposed grades. This bid item is required because the casting adjustment is greater than 9" of vertical adjustment to set the casting to the final grade or the chimney was determined to be in poor condition. Manhole adjustments less than 9" shall be paid for separately under standard bid item 20501 Adjust Sewer Access Structure. If the manhole being adjusted is a poured in place structure, the maximum vertical adjustment of 9" will not apply.

The contractor shall furnish precast concrete barrel sections and manhole adjustment rings meeting the requirements City of Madison Standard Specifications for Public Works Construction 2015 Edition.

The contractor shall remove adjustment rings and install concrete barrel sections. The maximum allowed adjustment on the Sewer Access Structure shall not exceed 9 inches and the final configuration of the structure shall be in accordance of SDD 5.7.2 and 5.7.15 of the City of Madison Standard Specifications for Public Works Construction 2015 Edition. If the sewer access structure being adjusted is a poured in place structure (4 x 4, 5 x 5, 6 x 6), a 4' diameter barrel sections shall be installed on top of the roof of the poured in place structure. Trowelable mastic shall be placed on the poured in place manhole rooftop and a concrete collar around where the barrel section connects to the manhole. The barrel section shall be centered over the casting opening. If the existing casting is offset, the rooftop shall be sawcut to create an opening centering the barrel section on the manhole structure.

#### METHOD OF MEASUREMENT

Adjust SAS Special shall be measured by each unit, acceptably completed.

#### **BASIS OF PAYMENT**

Adjust SAS Special shall be measured as described above and shall be full payment for all work, materials and incidentals required to complete the work in accordance with the description. Payment is full compensation removing existing covers, frames, adjustment rings, cone sections, and barrel sections; for installing barrel sections; for re-installing and rotating existing offset cone sections; and for installing adjustment rings, frames and covers all in accordance to Article 507 of the City of Madison Standard Specifications for Public Works Construction 2015 Edition, and for furnishing all labor, tools, equipment, and incidentals necessary to complete the contract work. If necessary sawcutting the roof, installing mastic and concrete collars shall be considered incidental to this bid item.



NOW, THEREFORE, the Contractor and the City, for the consideration hereinafter named, agree as follows:

1. **Scope of Work.** The Contractor shall, perform the construction, execution and completion of the following listed complete work or improvement in full compliance with the Plans, Specifications, Standard Specifications, Supplemental Specifications, Special Provisions and contract; perform all items of work covered or stipulated in the proposal; perform all altered or extra work; and shall furnish, unless otherwise provided in the contract, all materials, implements, machinery, equipment, tools, supplies, transportation, and labor necessary to the prosecution and completion of the work or improvements:

- 2. **Completion Date/Contract Time.** Construction work must begin within seven (7) calendar days after the date appearing on mailed written notice to do so shall have been sent to the Contractor and shall be carried on at a rate so as to secure full completion <u>SEE SPECIAL PROVISIONS</u>, the rate of progress and the time of completion being essential conditions of this Agreement.
- 3. **Contract Price.** The City shall pay to the Contractor at the times, in the manner and on the conditions set forth in said specifications, the sum of \_\_\_\_\_\_(\$\_\_\_\_) Dollars being the amount bid by such Contractor and which was awarded to him/her as provided by law.

#### 4. Wage Rates for Employees of Public Works Contractors

**General and Authorization.** The Contractor shall compensate its employees at the prevailing wage rate in accordance with section 66.0903, Wis. Stats., DWD 290 of the Wisconsin Administrative Code and as hereinafter provided unless otherwise noted in Section D: Special Provisions, Subsection 102.10 – Minimum Rate of Wage Scale.

"Public Works" shall include building or work involving the erection, construction, remodeling, repairing or demolition of buildings, parking lots, highways, streets, bridges, sidewalks, street lighting, traffic signals, sanitary sewers, water mains and appurtenances, storm sewers, and the grading and landscaping of public lands.

"Building or work" includes construction activity as distinguished from manufacturing, furnishing of materials, or servicing and maintenance work, except for the delivery of mineral aggregate such as sand, gravel, bituminous asphaltic concrete or stone which is incorporated into the work under contract with the City by depositing the material directly in final place from transporting vehicle.

"Erection, construction, remodeling, repairing" means all types of work done on a particular building or work at the site thereof in the construction or development of the project, including without limitation, erecting, construction, remodeling, repairing, altering, painting, and decorating, the transporting of materials and supplies to or from the building or work done by the employees of the Contractor, Subcontractor, or Agent thereof, and the manufacturing or furnishing of materials, articles, supplies or equipment on the site of the building or work, by persons employed by the Contractor, Subcontractor, or Agent thereof.

"Employees working on the project" means laborers, workers, and mechanics employed directly upon the site of work.

"Laborers, Workers, and Mechanics" include pre-apprentices, helpers, trainees, learners and properly registered and indentured apprentices but exclude clerical, supervisory, and other personnel not performing manual labor.

**Establishment of Wage Rates.** The Department of Public Works shall periodically obtain a current schedule of prevailing wage rates from DWD. The schedule shall be used to establish the City of Madison Prevailing Wage Rate Schedule for Public Works Construction (prevailing wage rate). The Department of Public Works may include known increases to the prevailing wage rate which can be documented and are to occur on a future specific date. The prevailing wage rate shall be included in public works contracts subsequently negotiated or solicited by the City. Except for known increases contained within the schedule, the prevailing wage rate shall not change during the contract. The approved wage rate is attached hereto.

**Workforce Profile.** The Contractor shall, at the time of signature of the contract, notify the City Engineer in writing of the names and classifications of all the employees of the Contractor, Subcontractors, and Agents proposed for the work. In the alternative, the Contractor shall submit in writing the classifications of all the employees of the Contractor, Subcontractors and Agents and the total number of hours estimated in each classification for the work. This workforce profile(s) shall be reviewed by the City Engineer who may, within ten (10) days, object to the workforce profile(s) as not being reflective of that which would be required for the work. The Contractor may request that the workforce profile, or a portion of the workforce profile, be submitted after the signature of the contract but at least ten (10) days prior to the work commencing. Any costs or time loss resulting from modifications to the workforce profile as a result of the City Engineer's objections shall be the responsibility of the Contractor.

**Payrolls and Records.** The Contractor shall keep weekly payroll records setting forth the name, address, telephone number, classification, wage rate and fringe benefit package of all the employees who work on the contract, including the employees of the Contractor's subcontractors and agents. Such weekly payroll records must include the required information for all City contracts and all other contracts on which the employee worked during the week in which the employee worked on the contract. The Contractor shall also keep records of the individual time each employee worked on the project and for each day of the project. Such records shall also set forth the total number of hours of overtime credited to each such employee for each day and week and the amount of overtime pay received in that week. The records shall set forth the full weekly wages earned by each employee and the actual hourly wage paid to the employee.

The Contractor shall submit the weekly payroll records, including the records of the Contractor's subcontractors and agents, to the City Engineer for every week that work is being done on the contract. The submittal shall be within twenty-one (21) calendar days of the end of the Contractor's weekly pay period.

Employees shall receive the full amounts accrued at the time of the payment, computed at rates not less than those stated in the prevailing wage rate and each employee's rate shall be determined by the work that is done within the trade or occupation classification which should be properly assigned to the employee.

An employee's classification shall not be changed to a classification of a lesser rate during the contract. If, during the term of the contract, an employee works in a higher pay classification than the one which was previously properly assigned to the employee, then that employee shall be considered to be in the higher pay classification for the balance of the contract, receive the appropriate higher rate of pay, and she/he shall not receive a lesser rate during the balance of the

contract. For purposes of clarification, it is noted that there is a distinct difference between working in a different classification with higher pay and doing work within a classification that has varying rates of pay which are determined by the type of work that is done within the classification. For example, the classification "Operating Engineer" provides for different rates of pay for various classes of work and the Employer shall compensate an employee classified as an "Operating Engineer" based on the highest class of work that is done in one day. Therefore, an "Operating Engineer's" rate may vary on a day to day basis depending on the type of work that is done, but it will never be less than the base rate of an "Operating Engineer". Also, as a matter of clarification, it is recognized that an employee may work in a higher paying classification merely by chance and without prior intention, calculation or design. If such is the case and the performance of the work is truly incidental and the occurrence is infrequent, inconsequential and does not serve to undermine the single classification principle herein, then it may not be required that the employee be considered to be in the higher pay classification and receive the higher rate of pay for the duration of the contract. However, the Contractor is not precluded or prevented from paying the higher rate for the limited time that an employee performs work that is outside of the employee's proper classification.

Questions regarding an employee's classification, rate of pay or rate of pay within a classification, shall be resolved by reference to the established practice that predominates in the industry and on which the trade or occupation rate/classification is based. Rate of pay and classification disputes shall be resolved by relying upon practices established by collective bargaining agreements and guidelines used in such determination by appropriate recognized trade unions operating within the City of Madison.

The Contractor, its Subcontractors and Agents shall submit to interrogation regarding compliance with the provisions of this ordinance.

Mulcting of the employees by the Contractor, Subcontractor, and Agents on Public Works contracts, such as by kickbacks or other devices, is prohibited. The normal rate of wage of the employees of the Contractor, Subcontractor, and Agents shall not be reduced or otherwise diminished as a result of payment of the prevailing wage rate on a public works contract.

**Hourly contributions.** Hourly contributions shall be determined in accordance with the prevailing wage rate and with DWD. 290.01(10), Wis. Admin. Code.

**Apprentices and Subjourney persons.** Apprentices and sub journeypersons performing work on the project shall be compensated in accordance with the prevailing wage rate and with DWD 290.02, and 290.025, respectively, Wis. Admin. Code.

**Straight Time Wages.** The Contractor may pay straight time wages as determined by the prevailing wage rate and DWD 290.04, Wis. Admin. Code.

**Overtime Wages.** The Contractor shall pay overtime wages as required by the prevailing wage rate and DWD 290.05, Wis. Admin. Code.

**Posting of Wage Rates and Hours.** A clearly legible copy of the prevailing wage rate, together with the provisions of Sec. 66.0903(10)(a) and (11)(a), Wis. Stats., shall be kept posted in at least one conspicuous and easily accessible place at the project site by the Contractor and such notice shall remain posted during the full time any laborers, workers or mechanics are employed on the contract.

**Evidence of Compliance by Contractor.** Upon completion of the contract, the Contractor shall file with the Department of Public Works an affidavit stating:

a. That the Contractor has complied fully with the provisions and requirements of Sec. 66.0903(3), Wis. Stats., and Chapter DWD 290, Wis. Admin. Code; the Contractor has received evidence of compliance from each of the agents and subcontractors; and the

names and addresses of all of the subcontractors and agents who worked on the contract.

b. That full and accurate records have been kept, which clearly indicate the name and trade or occupation of every laborer, worker or mechanic employed by the Contractor in connection with work on the project. The records shall show the number of hours worked by each employee and the actual wages paid therefore; where these records will be kept and the name, address and telephone number of the person who will be responsible for keeping them. The records shall be retained and made available for a period of at least three (3) years following the completion of the project of public works and shall not be removed without prior notification to the municipality.

**Evidence of Compliance by Agent and Subcontractor.** Each agent and subcontractor shall file with the Contractor, upon completion of their portion of the work on the contract an affidavit stating that all the provisions of Sec. 66.0903(3), Wis. Stats., have been fully complied with and that full and accurate records have been kept, which clearly indicate the name and trade or occupation of every laborer, worker or mechanic employed by the Contractor in connection with work on the project. The records shall show the number of hours worked by each employee and the actual wages paid therefore; where these records shall be kept and the name, address and telephone number of the person who shall be responsible for keeping them. The records shall be retained and made available for a period of at least three (3) years following the completion of the project of public works and shall not be removed without prior notification to the municipality.

**Failure to Comply with the Prevailing Wage Rate.** If the Contractor fails to comply with the prevailing wage rate, she/he shall be in default on the contract. In addition, if DWD finds that a contractor or subcontractor violated the prevailing wage law, DWD will assess liquidated damages of 100% of the wages owed to employees.

**Establishment of Wage Rates.** The Department of Public Works shall periodically obtain a current schedule of prevailing wage rates from DWD. The schedule shall be used to establish the City of Madison Prevailing Wage Rate Schedule for Public Works Construction (prevailing wage rate). The Department of Public Works may include known increases to the prevailing wage rate which can be documented and are to occur on a future specific date. The prevailing wage rate shall be included in public works contracts subsequently negotiated or solicited by the City. Except for known increases contained within the schedule, the prevailing wage rate shall not change during the contract. The approved wage rate and DWD prevailing wage requirements are attached hereto as Sec. I of the contract.

5. Affirmative Action. In the performance of the services under this Agreement the Contractor agrees not to discriminate against any employee or applicant because of race, religion, marital status, age, color, sex, disability, national origin or ancestry, income level or source of income, arrest record or conviction record, less than honorable discharge, physical appearance, sexual orientation, gender identity, political beliefs, or student status. The Contractor further agrees not to discriminate against any subcontractor or person who offers to subcontract on this contract because of race, religion, color, age, disability, sex, sexual orientation, gender identity or national origin.

The Contractor agrees that within thirty (30) days after the effective date of this agreement, the Contractor will provide to the City Affirmative Action Division certain workforce utilization statistics, using a form to be furnished by the City.

If the contract is still in effect, or if the City enters into a new agreement with the Contractor, within one year after the date on which the form was required to be provided, the Contractor will provide updated workforce information using a second form, also to be furnished by the City. The second form will be submitted to the City Affirmative Action Division no later than one year after the date on which the first form was required to be provided. The Contractor further agrees that, for at least twelve (12) months after the effective date of this contract, it will notify the City Affirmative Action Division of each of its job openings at facilities in Dane County for which applicants not already employees of the Contractor are to be considered. The notice will include a job description, classification, qualifications and application procedures and deadlines. The Contractor agrees to interview and consider candidates referred by the Affirmative Action Division if the candidate meets the minimum qualification standards established by the Contractor, and if the referral is timely. A referral is timely if it is received by the Contractor on or before the date started in the notice.

#### Articles of Agreement Article I

The Contractor shall take affirmative action in accordance with the provisions of this contract to insure that applicants are employed, and that employees are treated during employment without regard to race, religion, color, age, marital status, disability, sex, sexual orientation, gender identity or national original and that the employer shall provide harassment free work environment for the realization of the potential of each employee. Such action shall include, but not be limited to, the following: employment, upgrading, demotion or transfer, recruitment or recruitment advertising, layoff or termination, rates of pay or other forms of compensation and selection for training including apprenticeship insofar as it is within the control of the Contractor. The Contractor agrees to post in conspicuous places available to employees and applicants notices to be provided by the City setting out the provisions of the nondiscrimination clauses in this contract.

#### Article II

The Contractor shall in all solicitations or advertisements for employees placed by or on behalf of the Contractors state that all qualified or qualifiable applicants will be employed without regard to race, religion, color, age, marital status, disability, sex, sexual orientation, gender identity or national origin.

#### Article III

The Contractor shall send to each labor union or representative of workers with which it has a collective bargaining agreement or other contract or understanding a notice to be provided by the City advising the labor union or worker's representative of the Contractor's equal employment opportunity and affirmative action commitments. Such notices shall be posted in conspicuous places available to employees and applicants for employment.

#### Article V

The Contractor agrees that it will comply with all provisions of the Affirmative Action Ordinance of the City of Madison, including the contract compliance requirements. The Contractor agrees to submit the model affirmative action plan for public works contractors in a form approved by the Affirmative Action Division Manager.

#### Article VI

The Contractor will maintain records as required by Section 39.02(9)(f) of the Madison General Ordinances and will provide the City Affirmative Action Division with access to such records and to persons who have relevant and necessary information, as provided in Section 39.02(9)(f). The City agrees to keep all such records confidential, except to the extent that public inspection is required by law.

#### Article VII

In the event of the Contractor's or subcontractor's failure to comply with the Equal Employment Opportunity and Affirmative Action Provisions of this contract or Section 39.03 and 39.02 of the Madison General Ordinances, it is agreed that the City at its option may do any or all of the following:

- 1. Cancel, terminate or suspend this Contract in whole or in part.
- 2. Declare the Contractor ineligible for further City contracts until the Affirmative Action requirements are met.
- 3. Recover on behalf of the City from the prime Contractor 0.5 percent of the contract award price for each week that such party fails or refuses to comply, in the nature of liquidated damages, but not to exceed a total of five percent (5%) of the contract price, or five thousand dollars (\$5,000), whichever is less. Under public works contracts, if a subcontractor is in noncompliance, the City may recover liquidated damages from the prime Contractor in the manner described above. The preceding sentence shall not be construed to prohibit a prime Contractor from recovering the amount of such damage from the non-complying subcontractor.

#### Article VIII

The Contractor shall include the above provisions of this contract in every subcontract so that such provisions will be binding upon each subcontractor. The Contractor shall take such action with respect to any subcontractor as necessary to enforce such provisions, including sanctions provided for noncompliance.

#### Article IX

The Contractor shall allow the maximum feasible opportunity to small business enterprises to compete for any subcontracts entered into pursuant to this contract. (In federally funded contracts the terms "DBE, MBE and WBE" shall be substituted for the term "small business" in this Article.)

6. Substance Abuse Prevention Program Required. Prior to commencing work on the Contract, the Contractor, and any Subcontractor, shall have in place a written program for the prevention of substance abuse among its employees as required under Wis. Stat. Sec. 103.503.

Any employer interested in using a subjourney classification on this project MUST complete Form ERD-10880 and request the applicable wage rate from the Department of Workforce Development PRIOR to using the subjourney worker on this project.

This document **MUST BE POSTED** by the **CONTRACTING AGENCY** in at least one conspicuous and easily accessible place **on the site of the project**. A local governmental unit may post this document at the place normally used to post public notices if there is no common site on the project. This document **MUST** remain posted during the entire time any worker is employed on the project and **MUST** be physically incorporated into the specifications and all contracts and subcontracts. # The following statutory provisions apply to local governmental unit projects of public works and are set forth below pursuant to the requirements of s. 66.0903(8), Stats.

s. 66.0903 (1) (f) & s. 103.49 (1) (c) "PREVAILING HOURS OF LABOR" for any trade or occupation in any area means 10 hours per day and 40 hours per week and may not include any hours worked on a Saturday or Sunday or on any of the following holidays:

- 1. January 1.
- 2. The last Monday in May.
- 3. July 4.
- 4. The first Monday in September.
- 5. The 4th Thursday in November.
- 6. December 25.
- 7. The day before if January 1, July 4 or December 25 falls on a Saturday.
- 8. The day following if January 1, July 4 or December 25 falls on a Sunday.

#### s. 66.0903 (10) RECORDS; INSPECTION; ENFORCEMENT.

(a) Each contractor, subcontractor, or contractor's or subcontractor's agent performing work on a project of public works that is subject to this section shall keep full and accurate records clearly indicating the name and trade or occupation of every person performing the work described in sub. (4) and an accurate record of the number of hours worked by each of those persons and the actual wages paid for the hours worked.

#### s. 66.0903 (11) LIABILITY AND PENALTIES.

(a) 1. Any contractor, subcontractor, or contractor's or subcontractor's agent who fails to pay the prevailing wage rate determined by the department under sub. (3) or who pays less than 1.5 times the hourly basic rate of pay for all hours worked in excess of the prevailing hours of labor is liable to any affected employee in the amount of his or her unpaid wages or his or her unpaid overtime compensation and in an additional amount as liquidated damages as provided under subd. 2., 3., whichever is applicable.

2. If the department determines upon inspection under sub. (10) (b) or (c) that a contractor, subcontractor, or contractor's or subcontractor's agent has failed to pay the prevailing wage rate determined by the department under sub. (3) or has paid less than 1.5 times the hourly basic rate of pay for all hours worked in excess of the prevailing hours of labor, the department shall order the contractor to pay to any affected employee the amount of his or her unpaid wages or his or her unpaid overtime compensation and an additional amount equal to 100 percent of the amount of those unpaid wages or that unpaid overtime compensation as liquidated damages within a period specified by the department in the order.

3. In addition to or in lieu of recovering the liability specified in subd. 1. as provided in subd. 2., any employee for and in behalf of that employee and other employees similarly situated may commence an action to recover that liability in any court of competent jurisdiction. If the court finds that a contractor, subcontractor, or contractor's or subcontractor's agent has failed to pay the prevailing wage rate determined by the department under sub. (3) or has paid less than 1.5 times the hourly basic rate of pay for all hours worked in excess of the prevailing hours of labor, the court shall order the contractor, subcontractor, or agent to pay to any affected employee the amount of his or her unpaid wages or his or her unpaid overtime compensation and an additional amount equal to 100 percent of the amount of those unpaid wages or that unpaid overtime compensation as liquidated damages. 5. No employee may be a party plaintiff to an action under subd. 3. unless the employee consents in writing to become a party and the consent is filed in the court in which the action is brought. Notwithstanding s. 814.04 (1), the court shall, in addition to any judgment awarded to the plaintiff, allow reasonable attorney fees and costs to be paid by the defendant.

#### **BUILDING OR HEAVY CONSTRUCTION**

Includes sheltered enclosures with walk-in access for the purpose of housing persons, employees, machinery, equipment or supplies and non-sheltered work such as canals, dams, dikes, reservoirs, storage tanks, etc. A sheltered enclosure need not be "habitable" in order to be considered a building. The installation of machinery and/or equipment, both above and below grade level, does not change a project's character as a building. On-site grading, utility work and landscaping are included within this definition. Residential buildings of four (4) stories or less, agricultural buildings, parking lots and driveways are NOT included within this definition.

# PREVAILING WAGE – Contractors

Any public works project that has a total estimated project cost that equals or exceeds prevailing wage project thresholds requires a prevailing wage rate determination issued by the Department of Workforce Development (DWD). Public works include erecting, constructing, remodeling, repairing, demolishing, alterations, painting and decorating projects for a local governmental unit or state agency. State law excludes minor service or maintenance work, warranty work, or work under a supply-and-installation contract. There is a statutory definition for most of these exclusions. The prevailing wage laws that apply to local governmental units and their contractors are §§66.0903 and 103.503, Wis. Stats. The prevailing wage laws that apply to state agencies and their contractors are §§103.49 and 103.503, Wis. Stats. The applicable administrative rules for all prevailing wage projects are DWD 290 and DWD 294, Wis. Adm. Code. These laws include provisions that apply to all contractors and subcontractors working on prevailing wage projects.

Any contractor or subcontractor working on a local governmental unit or state agency's public works project that equals or exceeds current prevailing wage project thresholds must do all of the following:

- Receive and review the project's prevailing wage rate determination (i.e., white sheet).
- Tell subcontractors the project is subject to state prevailing wage law and include the prevailing wage rate determination in the construction contract, or if there is no written contract, provide a copy of the project determination to each subcontractor.
- Hire subcontractors who do not appear on the "Consolidated List of Debarred Contractors."
- Have a written substance abuse testing program in place that fulfills the requirements of §103.503, Wis. Stats., before commencing work on the project.

- Notify subcontractors that if DWD finds that a contractor or subcontractor violated the prevailing wage law, DWD will assess liquidated damages of 100% of the wages owed to employees.
- Apply to DWD for subjourney wage rates prior to employing these individuals on the project.
- Receive and retain a completed Affidavit of Compliance from each subcontractor brought on to the project before providing final payment to those subcontractors.
- Submit a completed Affidavit of Compliance to the contractor who brought the subcontractor on to the project before receiving final payment for the project.
- Maintain payroll records for 3 years that comply with §§66.0903(10)(a) or 103.49(5)(a), Stats. and DWD 274.06.
- Respond to requests from DWD or the project owner to provide payroll records and/or respond to prevailing wage complaints filed by employees or third parties.
