STANDARD SPECIFICATIONS

The City of Madison's Standard Specifications for Public Works Construction - 2014 Edition, as supplemented and amended from time to time, forms a part of these contract documents as if attached hereto.

These standard specifications are available on the City of Madison Public Works website, www.cityofmadison.com/Business/PW/specs.cfm.

The Contractor shall review these Specifications prior to preparation of proposals for the work to be done under this contract, with specific attention to Article 102, "BIDDING REQUIREMENTS AND CONDITIONS" and Article 103, "AWARD AND EXECUTION OF THE CONTRACT." For the convenience of the bidder, below are highlights of three subsections of the specifications.

SECTION 102.1: PRE-QUALIFICATION OF BIDDERS

In accordance with Wisconsin State Statutes 66.0901 (2) and (3), all bidders must submit to the Board of Public Works proof of responsibility on forms furnished by the City. The City requires that all bidders be qualified on a biennial basis.

Bidders must present satisfactory evidence that they have been regularly engaged in the type of work specified herein and they are fully prepared with necessary capital, materials, machinery and supervisory

personnel to conduct the work to be contracted for to the satisfaction of the City. All bidders must be prequalified by the Board of Public Works for the type of construction on which they are bidding prior to the opening of the bid.

In accordance with Section 39.02(9)(a)I. of the General Ordinances, all bidders shall submit in writing to the Affirmative Action Division Manager of the City of Madison, a Certificate of Compliance or an Affirmative Action Plan at the same time or prior to the submission of the proof of responsibility forms.

The bidder shall be disqualified if the bidder fails to or refuses to, prior to opening of the bid, submit a Certificate of compliance, Affirmative Action Plan or Affirmative Action Data Update, as applicable, as defined by Section 39.02 of the General Ordinances (entitled Affirmative Action) and as required by Section 102.11 of the Standard Specifications.

SECTION 102.4 PROPOSAL

No bid will be accepted that does not contain an adequate or reasonable price for each and every item named in the Schedule of Unit Prices.

A lump sum bid for the work in accordance with the plans and specifications is required. The lump sum bid must be the same as the total amounts bid for the various items and it shall be inserted in the space provided.

All papers bound with or attached to the proposal form are considered a part thereof and must not be detached or altered when the proposal is submitted. The plans, specifications and other documents designated in the proposal form will be considered a part of the proposal whether attached or not.

A proposal submitted by an individual shall be signed by the bidder or by a duly authorized agent. A proposal submitted by a partnership shall be signed by a member/partner or by a duly authorized agent thereof. A proposal submitted by a corporation shall be signed by an authorized officer or duly authorized registered agent of such corporation, and the proposal shall show the name of the State under the laws of which such corporation was chartered. The required signatures shall in all cases appear in the space provided thereof on the proposal.

Each proposal shall be placed, together with the proposal guaranty, in a sealed envelope, so marked as to indicate name of project, the contract number or option to which it applies, and the name and address of the Contractor or submitted electronically through Bid Express (www.bidexpress.com). Proposals will be accepted at the location, the time and the date designated in the advertisement. Proposals received after the time and date designated will be returned to the bidder unopened.

The Bidder shall execute the Disclosure of Ownership form. REFER TO SECTION F.

SECTION 102.5: BID DEPOSIT (PROPOSAL GUARANTY)

All bids, sealed or electronic, must be accompanied with a Bid Bond equal to at least 5% of the bid or a Certificate of Annual/Biennial Bid Bond or certified check, payable to the City Treasurer. Bid deposit of the successful bidders shall be returned within forty-eight (48) hours following execution of the contract and bond as required.

Prevailing Wage Rates may be required and are attached in Section J of the contract. See Special Provisions to determine applicability.

Instructions to Bidders City of Madison SBE Program Information

2 Small Business Enterprise (SBE) Program Information

2.1 Policy and Goal

The City of Madison reaffirms its policy of nondiscrimination in the conduct of City business by maintaining a procurement process which remains open to all who have the potential and ability to sell goods and services to the City. It is the policy of the City of Madison to allow Small Business Enterprises (SBE) maximum feasible opportunity to participate in City of Madison contracting. The bidder acknowledges that its bid has been submitted in accordance with the SBE program and is for the public's protection and welfare.

Please refer to the "ADVERTISEMENT FOR BIDS" for the goal for the utilization of SBEs on this project. SBEs may participate as subcontractors, vendors and/or suppliers, which provide a commercially useful function. The dollar value for SBE suppliers or 'materials only' vendors shall be discounted to 60% for purposes of meeting SBE goals.

A bidder which achieves or exceeds the SBE goal will be in compliance with the SBE requirements of this project. In the event that the bidder is unable to achieve the SBE goal, the bidder must demonstrate that a good faith effort to do so was made. Failure to either achieve the goal or demonstrate a good faith effort to do so will be grounds for the bidder being deemed a non-responsible contractor ineligible for award of this contract.

A bidder may count towards its attainment of the SBE goal only those expenditures to SBEs that perform a commercially useful function. For purposes of evaluating a bidder's responsiveness to the attainment of the SBE goal, the contract participation by an SBE is based on the percentage of the total base bid proposed by the Contractor. The total base bid price is inclusive of all addenda.

Work performed by an SBE firm in a particular transaction can be counted toward the goal only if it involves a commercially useful function. That is, in light of industry practices and other relevant considerations, does the SBE firm have a necessary and useful role in the transaction, of a kind for which there is a market outside the context of the SBE Program, or is the firm's role a superfluous step added in an attempt to obtain credit towards goals? If, in the judgment of the Affirmative Action Division, the SBE firm will not perform a commercially useful function in the transaction, no credit towards goals will be awarded.

The question of whether a firm is performing a commercially useful function is completely separate from the question of whether the firm is an eligible SBE. A firm is eligible if it meets the definitional criteria and ownership and control requirements, as set forth in the City of Madison's SBE Program.

If the City of Madison determines that the SBE firm is performing a commercially useful function, then the City of Madison must then decide what that function is. If the commercially useful function is that of an SBE vendor / supplier that regularly transacts business with the respective product, then the City of Madison will count 60% of the value of the product supplied toward SBE goals.

To be counted, the SBE vendor / supplier must be engaged in selling the product in question to the public. This is important in distinguishing an SBE vendor / supplier, which has a regular trade with a variety of customers, from a firm which performs supplier-like functions on an <u>ad hoc</u> basis or for only one or two contractors with whom it has a special relationship.

A supplier of bulk goods may qualify as an eligible SBE vendor / supplier if it either maintains an inventory or owns or operates distribution equipment. With respect to the distribution equipment; e.g., a fleet of trucks, the term "operates" is intended to cover a situation in which the supplier leases the equipment on a regular basis for its entire business. It is not intended to cover a situation in which the firm simply provides drivers for trucks owned or leased by another party; e.g., a prime contractor, or leases such a party's trucks on an <u>ad hoc</u> basis for a specific job.

If the commercially useful function being performed is not that of a qualified SBE vendor / supplier, but rather that of delivery of products, obtaining bonding or insurance, procurement of personnel, acting as a broker or manufacturer's representative in the procurement of supplies, facilities, or materials, etc., only the fees or commissions will apply towards the goal.

For example, a business that simply transfers title of a product from manufacturer to ultimate purchaser; e. g., a sales representative who re-invoices a steel product from the steel company to the Contractor, or a firm that puts a product into a container for delivery would not be considered a qualified SBE vendor / supplier. The Contractor would not receive credit based on a percentage of the cost of the product for working with such firms.

Concerning the use of services that help the Contractor obtain needed supplies, personnel, materials or equipment to perform a contract: only the fee received by the service provider will be counted toward the goal. For example, use of a SBE sales representative or distributor for a steel company, if performing a commercially useful function at all, would entitle the Contractor receiving the steel to count only the fee paid to the representative or distributor toward the goal. This provision would also govern fees for professional and other services obtained expressly and solely to perform work relating to a specific contract.

Concerning transportation or delivery services: if an SBE trucking company picks up a product from a manufacturer or a qualified vendor / supplier and delivers the product to the Contractor, the commercially useful function it is performing is not that of a supplier, but simply that of a transporter of goods. Unless the trucking company is itself the manufacturer or a qualified vendor / supplier in the product, credit cannot be given based on a percentage of the cost of the product. Rather, credit would be allowed for the cost of the transportation service.

The City is aware that the rule's language does not explicitly mention every kind of business that may contribute work on this project. In administering these programs, the City would, on a case-by-case basis, determine the appropriate counting formula to apply in a particular situation.

2.2 Contract Compliance

2.3 Certification of SBE by City of Madison

The Affirmative Action Division maintains a directory of SBEs which are currently certified as such by the City of Madison. Contact the Contract Compliance Officer as indicated in Section 2.2 to receive a copy of the SBE Directory or you may access the SBE Directory online at www.cityofmadison.com/dcr/aaTBDir.cfm.

All contractors, subcontractors, vendors and suppliers seeking SBE status must complete and submit the Targeted Business Certification Application to the City of Madison Affirmative Action Division by the time and date established for receipt of bids. A copy of the Targeted Business Certification Application is available by contacting the Contract Compliance Officer at the address and telephone indicated in Section 2.2 or you may Targeted access the Business Certification Application online www.citvofmadison.com/dcr/aaTBDir.cfm. Submittal of the Targeted Business Certification Application by the time specified does not guarantee that the applicant will be certified as a SBE eligible to be utilized towards meeting the SBE goal for this project.

2.4 Small Business Enterprise Compliance Report

2.4.1 Good Faith Efforts

Bidders shall take all necessary affirmative steps to assure that SBEs are utilized when possible and that the established SBE goal for this project is achieved. A contractor who self performs a portion of the work, and is pre-qualified to perform that category of work, may subcontract that portion of the work, but shall not be required to do so. When a bidder is unable to achieve the established SBE goal, the bidder must demonstrate that a good faith effort to do so was made. Such a good faith effort should include the following:

- 2.4.1.1 Attendance at the pre-bid meeting.
- 2.4.1.2 Using the City of Madison's directory of certified SBEs to identify SBEs from which to solicit bids.
- 2.4.1.3 Assuring that SBEs are solicited whenever they are potential sources.
- 2.4.1.4 Referring prospective SBEs to the City of Madison Affirmative Action Division for certification.
- 2.4.1.5 Dividing total project requirements into smaller tasks and/or quantities, where economically feasible, to permit maximum feasible SBE participation.
- 2.4.1.6 Establishing delivery schedules, where requirements permit, which will encourage participation by SBEs.
- 2.4.1.7 Providing SBEs with specific information regarding the work to be performed.
- 2.4.1.8 Contacting SBEs in advance of the deadline to allow such businesses sufficient time to prepare a bid.
- 2.4.1.9 Utilizing the bid of a qualified and competent SBE when the bid of such a business is deemed reasonable (i.e. 5% above the lowest bidder), although not necessarily low.
- 2.4.1.10 Contacting SBEs which submit a bid, to inquire about the details of the bid and confirm that the scope of the work was interpreted as intended.

2.4.2 Reporting SBE Utilization and Good Faith Efforts

The Small Business Enterprise Compliance Report is to be submitted by the <u>bidder</u> with the bid: This report is due by the specified bid closing time and date. Bids submitted without a completed SBE Compliance Report as outlined below

shall be deemed non-responsible and the bidder ineligible for award of this contract.

- 2.4.2.1 If the Bidder <u>meets or exceeds</u> the goal established for SBE utilization, the Small Business Enterprise Compliance Report shall consist of the following:
 - 2.4.2.1.1 **Cover Page,** Page C-6; and
 - 2.4.2.1.2 **Summary Sheet,** C-7.
- 2.4.2.2 If the bidder <u>does not meet</u> the goal established for SBE utilization, the Small Business Enterprise Compliance Report shall consist of the following:
 - 2.4.2.2.1 **Cover Page**, Page C-6;
 - 2.4.2.2.2 **Summary Sheet,** C-7; and
 - 2.4.2.2.3 **SBE Contact Report**, C-8 and C-9. (A <u>separate</u> Contact Report must be completed for <u>each applicable</u> SBE which is not utilized.)

2.5 Appeal Procedure

A bidder which does not achieve the established goal and is deemed <u>non-responsible</u> for failure to demonstrate a good faith effort to achieve such goal and subsequently denied eligibility for award of contract may, within 72 hours of receiving such notification, appeal that decision to a special appeals committee composed of three (3) members of the Affirmative Action Commission, three (3) members of the Board of Public Works and a seventh member appointed by the Mayor. All appeals must be made in writing to the City Engineer and <u>received</u> within 72 hours of City of Madison's notice. Postmark not applicable.

2.6 SBE Requirements After Award of the Contract

The successful bidder shall identify SBE subcontractors, suppliers and vendors on the subcontractor list in accordance with the specifications. The Contractor shall submit a detailed explanation of any variances between the listing of SBE subcontractors, vendors and/or suppliers on the subcontractor list and the Contractor's SBE Compliance Report for SBE participation.

No change in SBE subcontractors, vendors and/or suppliers from those SBEs indicated in the SBE Compliance Report will be allowed without prior approval from the Engineer and the Affirmative Action Division. The contractor shall submit in writing to the City of Madison Affirmative Action Division a request to change any SBE citing specific reasons which necessitate such a change. The Affirmative Action Division will use a general test of reasonableness in approving or rejecting the contractor's request for change. If the request is approved, the Contractor will make every effort to utilize another SBE if available.

The City will monitor the project to ensure that the actual percentage commitment to SBE firms is carried out.

2.7 SBE Definition and Eligibility Guidelines

A Small Business Enterprise is a business concern awarded certification by the City of Madison. For the purposes of this program a Small Business Enterprise is defined as:

- A. An independent business operated under a single management. The business may not be a subsidiary of any other business and the stock or ownership may not be held by any individual or any business operating in the same or a similar field. In determining whether an entity qualifies as a SBE, the City shall consider all factors relevant to being an independent business including, but not limited to, the date the business was established, adequacy of its resources for the work in which it proposes to involve itself, the degree to which financial, equipment leasing and other relationships exist with other ineligible firms in the same or similar lines of work. SBE owner(s) shall enjoy the customary incidents of ownership and shall share in the risks and profits commensurate with their enjoyment interests, as demonstrated by an examination of the substance rather than form or arrangements that may be reflected in its ownership documents.
- B. A business that has averaged no more than \$4.0 million in annual gross receipts over the prior three year period and the principal owner(s) do not have a personal net worth in excess of \$1.32 million.

Firm and/or individuals that submit fraudulent documents/testimony may be barred from doing business with the City and/or forfeit existing contracts.

SBE certification is valid for one (1) year unless revoked.

SECTION D: SPECIAL PROVISIONS

NORTH STREET, HOARD STREET AND COMMERCIAL AVENUE RECONSTRUCTION ASSESSMENT DISTRICT - 2014 CONTRACT NO. 7248

It is the intent of these Special Provisions to set forth the final contractual intent as to the matter involved and shall prevail over the Standard Specifications and plans whenever in conflict therewith. In order that comparisons between the Special Provisions can be readily made, the numbering system for the Special Provisions is equivalent to that of the Specifications.

Whenever in these Specifications the term "Standard Specifications" appears, it shall be taken to refer to the City of Madison Standard Specifications for Public Works Construction and Supplements thereto.

SECTION 102.10: PREVAILING WAGE

SECTION 102.12: BEST VALUE CONTRACTING

This Contract shall be considered a Best Value Contract if the Contractor's bid is equal to or greater than \$54,000 for a single trade contract; or equal to or greater than \$264,500 for a multi-trade contract pursuant to MGO 33.07(7).

ARTICLE 104 SCOPE OF WORK

The project limits for the work to be done are on North Street from East Washington Avenue to Commercial Avenue; on Commercial Avenue from North Street to Packers Avenue; and on Hoard Street from North Street to Seventh Street. The project is approximately 5000 feet in length.

The work under this contract shall include but not be limited to installation of sanitary sewer, water main, storm sewer, curb and gutter, drive aprons, base preparation, asphalt pavement, topsoil placement and seeding and sidewalk repair.

The Contractor shall view the site prior to bidding to become familiar with the existing conditions. It will be the responsibility of the Contractor to work with the utilities located in the right of way to resolve conflicts during the construction process.

SECTION 105.12 COOPERATION BY THE CONTRACTOR

The City of Madison has been given to understand that work may be undertaken by others in approximately the same time frame and the same area as the proposed project. It shall be the Contractor's responsibility to verify this information and any subsequent changes in the scheduling of the work by others and to make corrections in his/her construction timetable as required.

The Contractor shall use care around existing trees, plantings, fences, walls, steps and driveways that are indicated on the plans to remain. Damage to these items during construction shall be repaired or replaced at the Contractor's expense. No trees shall be cut without the approval of the Engineer and the City Forester; the abutting property owners shall be notified in accordance with the City's Administrative Procedure Memorandum No. 6-2.

City Traffic Engineering crews will be installing traffic signal loops in the stone base course before the paving near the following intersections:

- North St-E Washington Ave
- North St-Johnson St
- Commercial Ave-Packers Ave

The contractor shall coordinate installation of any loop detectors and conduit with Traffic Engineering. The Contractor shall notify City Traffic Engineering Electrical Section (Jason Chandler, 266-4767), 48 hours prior to final paving.

Cost to repair damage to traffic signal loops that occur after their installation due to Contractor negligence, and cost for extra work to install the traffic signal loops in newly paved streets due to improper notice to the Traffic Engineering Division, will be deducted from the contract.

SECTION 107.7 MAINTENANCE OF TRAFFIC

The Contractor shall submit an acceptable Traffic Control Plan to the office of the City Traffic Engineer, at 215 Martin Luther King, Jr. Blvd, Suite 100, Madison, WI 53703, prior to the pre-construction meeting. The Traffic Control Plan shall address all requirements of this section of the Special Provisions. The successful bidder shall work with the City Traffic Engineering Division to develop an approved Traffic Control Plan. The Contractor shall not start work on this project until the Traffic Engineering Division has approved a traffic control plan and traffic control devices have been installed, in accordance with the approved plan. Failure of the Contractor to obtain approval of a Traffic Control Plan, as specified above, may prevent the Contractor from starting work and shall be considered a delay of the project, caused by the Contractor.

The Contractor shall be responsible for installing and maintaining traffic control in accordance with the approved Traffic Control Plan and as directed by the City Traffic Engineer. The traffic control plan may need to be altered as conditions change in the field or as unexpected conditions occur. This may include relocating existing traffic control or providing additional traffic control. The Contractor shall install and maintain any necessary modifications or additions to the traffic control, as directed by the City Traffic Engineer.

All signing and barricading shall conform to the Federal Highways Administrations "Manual on Uniform Traffic Control Devices" (MUTCD).

North Street may be closed to through traffic within the project limits, beginning on June 16, 2014 for the duration of the project, except that two (2)-way traffic shall be maintained crossing North Street on East Johnson Street. Any work at the intersection of E Johnson Street & North Street where two(2)-way traffic on East Johnson Street cannot be maintained shall be done during weekends or during off-peak hours with approval of the Traffic Engineer. Local and emergency vehicle access shall be maintained at all times.

Work on Commercial Avenue shall be done in three(3) phases while maintaining two(2)-way traffic at all times as described below:

Phase 1

Remove the median island at Packers Avenue and install temporary pavement on Commercial Ave from Sta. 60+35 to 63+20 and the remove of the median island and install temporary pavement on Commercial Avenue from Sta. 69+26 to 69+63.

Phase 2

Close the north portion of Commercial Ave and maintain two(2)-way traffic on the southern portion within a minimum of 20' space between the existing curb and the work zone.

Phase 3

Close the south portion of Commercial Ave and maintain two(2)-way traffic on the northern portion within a minimum of 20' space between the curb and the work zone.

Two(2)-way traffic shall be maintained through the intersection of Commercial Ave & North St. Any work at the intersection of Commercial Ave & North St where two(2)-way traffic cannot be maintained shall be done during weekends or during off-peak hours with approval of the Traffic Engineer.

Hoard Street may be closed to through traffic at the project limits, for the duration of the project. Local and emergency vehicle access shall be maintained at all times. Hoard Street within the project limits is a designated bike route. A bike detour plan is included in the plans. Provide and maintain all signage for the bike detour as shown in the plans. Provide an accessible bicycle crossing of North Street to be utilized by bicycles to access the detour route shown in the plans. The bicycle crossing shall be paid under Bid Item 90004 – Maintain Temporary Bicycle Access.

The Contractor shall provide ADA/Handicap Accessible pedestrian access at all intersections within the construction area at all times.

Construction equipment and materials are not to be stored within the street right-of-way that is outside the project limits as shown on the approved plan.

The work areas shall be backfilled, plated, or protected by traffic control devices during non-working hours. If steel plates are used, the Contractor shall notify the City of Madison Streets Division, 266-4681, one (1) working day prior to placement of the plates.

SECTION 107.8 <u>NOTIFICATION WHEN CLOSING STREET</u>

The Contractor shall not remove traffic signs. For removal or replacement of traffic and parking signs, contact the City of Madison Traffic Engineering Field Operations, 1120 Sayle Street, 266-4767, 8:00 a.m. to 4:00 p.m., a minimum of twenty-four (24) hours in advance of when any existing signs need to be removed. This service is provided free of charge. If the Contractor removes the signs, the Contractor will be billed for the reinstallation of, and any damage to, the signing equipment.

SECTION 107.10 OPENING OF SECTION OF HIGHWAY TO TRAFFIC

Upon completion of all concrete work, final surface course of pavement, landscaping, topsoil, seed or sod, the City Construction Engineer shall certify that it is complete and shall contact the City of Madison Traffic Operations Section, 266-4767. The Contractor shall leave all barricades and traffic control in place until such time that the permanent pavement marking and signing has been installed by the City. The City shall notify the Contractor when the final pavement marking and signing is complete and the Contractor shall remove all temporary construction signs and barricades within 24 hours of the notification.

SECTION 108.2 PERMITS

The City of Madison has submitted a DNR Notice of Intent (NOI) to obtain coverage under a Construction Site General Permit.

The Contractor shall meet the conditions of the permit by properly installing and maintaining the erosion control measures shown on the plans, specified in these Special Provisions, or as directed by the Construction Engineer or his designees. This work will be paid for under the appropriate contract bid items or, if appropriate items are not included in the contract, shall be paid for as Extra Work. A copy of the permit is available at the City of Madison, Engineering Division office.

This permit covers trench dewatering to a maximum of 70 gallons/minute from the project, provided appropriate control measures are in place. The City's obtaining this permit is not intended to be exhaustive of all permits that may be required to be obtained by the Contractor for construction of this project. It shall be the responsibility of the Contractor to identify and obtain any other permits needed for construction.

SECTION 109.2 PROSECUTION OF WORK

The Contractor shall begin work on or before <u>MAY 19, 2014</u>. The total time of completion of the contract shall be **ONE HUNDRED FOURTY FIVE (145)** calendar days.

Work shall begin only after the start work letter is received. The Contractor shall limit workdays to 7:00 a.m. to 7:00 p.m. unless approved by the Engineer in writing.

ARTICLE 201 EXCAVATION CUT

Work under this section shall be accomplished in accordance with the Standard Specifications and as modified herein.

Soil borings indicates concrete pavement is present beneath the asphalt pavement on North Street, Hoard Street and Commercial Avenue. An estimated plan quantity of concrete pavement removal is included in the proposal as Bid Item 20321. Actual removal quantities may be adjusted based on field measurements. The total quantity for excavation cut includes the volume of concrete pavement present beneath the asphalt pavement.

BID ITEM 20336 - PIPE PLUG

With regard to the City of Madison Standard Specifications for Public Works Construction 2014 Edition Article 203.2c, any pipe found in a trench that is less than 10" diameter while installing a sewer facility shall be considered incidental to the pipe being installed.

Any pipe plugs required to abandon or remove sewer access structures (pipes directly connected to the structure) shall be considered incidental to abandoning or removing the structure regardless of the size of pipe being abandoned.

BID ITEM 20361 – WASTEWATER CONTROL

Wastewater Control shall include all equipment, labor, materials, coordination, and incidentals required to control or divert, to the Engineer's satisfaction, sanitary sewer flows during reconstruction of sanitary sewer mains under 15" diameter on the job.

This shall include pumps with adequate capacity of 100 g.p.m. and all associated equipment required to maintain a functioning sanitary sewer system during construction. At no time shall the normal flow of wastewater in sanitary sewer service laterals be disrupted without prior approval from the Engineer. This condition shall also hold at the time of connection of an existing lateral to the new sewer main. If the Contractor elects to use bypass pumping as a means of wastewater control, the methods, equipment,

type of hose, etc. shall be subject to approval by the Engineer. Hoses crossing streets, driveways, parking areas, etc., are to be ramped over to prevent damage to hoses. Spillage of wastewater is to be contained within the trenches and disposed of downstream to previously installed sewer piping. No spillage of wastewater to adjacent streets, lawns, etc. shall be tolerated. If any such spillage should occur, all construction operations shall cease. Cleanup shall commence immediately and be completed to the satisfaction of the Engineer prior to the resumption of any construction operations.

BID ITEM 20401 - CLEARING BID ITEM 20403 - GRUBBING

It is anticipated City Forestry will remove trees within the project limits based on their review of potential sanitary lateral conflicts and present tree condition. It is the Contractor's responsibility to grub stumps for trees removed by City Forestry and as directed by the Construction Engineer. Grubbing of stumps shall be to a depth of 18-inches below existing ground elevation.

BID ITEM 21002 - EROSION CONTROL INSPECTION

Work under this bid item shall be for weekend inspections (inspections required for rain events, half inch or larger, that occur on a Friday or Saturday) by the Contractor after half inch or greater rain events or as directed by the construction engineer. All weekly inspections and rain event inspections required during the work week (Monday-Friday) shall be completed by the City of Madison construction inspector.

BID ITEM 21014 - CONSTRUCTION ENTRANCE

Work under this bid item shall be in accord with the City of Madison Standard Specifications for Public Works Construction. Construction Entrances shall be located by the Construction Engineer and the Contractor based on site needs. The Contractor shall be aware that specifications call for a construction entrance to be 50' long, construction of an entrance not meeting this specification will result in no payment for this item not a partial payment.

ARTICLE 401 CRUSHED AGGREGATE BASE COURSE

The clear stone base course and the crushed stone base course shall be placed on the same day as the existing stone base is removed.

The Contractor shall maintain a minimum of six (6") inches of stone base course (existing or new) on all portions of the roadway open to vehicle access. No additional compensation will be given for stone used to maintain the six (6") required for access.

Crushed stone base course shall be used for bringing temporary ramps to grade. This material shall be reused after ramp is removed.

The material commonly known as crusher run or breaker run shall be used in undercut areas as designated by the Engineer.

ARTICLE 501 <u>SEWER AND SEWER STRUCTURES GENERAL</u>

STORM SEWER GENERAL

The storm sewer designer for this project is Corey Stelljes. He may be contacted by phone at (608) 266-9721 or by email at cstelljes@cityofmadison.com.

Reconnection of existing pipes at new structures, or new pipes at new structures, shall be considered to be part of the work required to construct the new structure or to construct the new sewer pipe and shall not be rewarded with additional compensation. However, if the structure being removed is larger than the new structure, thus requiring additional pipe, the new pipe shall be paid under the appropriate bid item and the connection of the old pipe to the new pipe shall be accomplished with a concrete collar.

Where a new structure is to be constructed at an existing pipe, it is expected that the contractor shall saw cut the existing pipe in the required location to accommodate the placement of the new structure. If the contractor for his/her convenience deems it more suitable to remove the existing pipe to a full joint, the additional pipe and concrete collar required to reconnect to the new structure shall be the contractor's responsibility and shall not be compensated.

Connection of new pipes to existing structures shall be accommodated with a Storm Sewer Tap – Bid Item 50792.

If there are structures where the pipe walls are to be poured into the structure roof or both the pipe walls and the structure casting are to be poured in the structure roof, the Contractor shall not be provided additional compensation for complying with the structure requirements detailed on the storm sewer chart and plans.

Precast structures are only allowed where field poured structures are not specifically called for, and no precast structures are allowed until ULO's are completed and approval of the design engineer has been received.

SANITARY SEWER GENERAL

The Sanitary Sewer designer for this project is Corey Stelljes. He may be contacted at (608) 266-9721 or cstelljes@cityofmadison.com.

Sanitary sewer pipe work shall include installing approximately 2320 feet of new 8" PVC, 83' of new 15" PVC, 1353' of new 18" PVC, and 3560' of sanitary sewer lateral at locations that are specified on the plan set and in accordance with the Standard Specifications. All necessary fittings for pressure pipe laterals shall be considered incidental to the cost of the lateral.

All new sanitary sewer access structures shall include Neenah R-1550 castings with the new City of Madison casting detail (see S.D.D. 5.7.16) of the City of Madison Standard Specifications for Public Works Construction 2014 ed. All new sewer main connections may be factory cored and shall be included in the structure. All existing main connections shall be field cored to accommodate existing conditions and shall be compensated under BID ITEM 50791 SANITARY SEWER TAP. All sewer main and/or laterals not slated for replacement that are damaged during the installation of a structure shall be replaced by the Contractor and shall be considered incidental to the project. All benches and flowlines shall have a smooth trowel finish. ASTM D3034 SDR 35 and SDR 26 sewer main and lateral as called for on the plan set shall be payable under Sanitary Sewer Main (BID ITEM 50301) and Sanitary Sewer Lateral (BID ITEM 50353.) No additional compensation shall be granted for ASTM D3034 SDR 26 material. Proposed 18" diameter sewer shall be PS115, ASTM F679 and shall be considered the equivalent of ASTM D3034 SDR 26 material.

Contractors shall have a locator device on-site if they intend to start laying lateral pipe at the property line to minimize the amount of extra sidewalk removal. No additional compensation shall be awarded beyond this amount for the replacement of a sewer lateral. If laterals called for reinstatement on the plans are to be plugged under the direction of the engineer on-site, contractors are required to use a sonde device to confirm that the laterals that are called abandonment are not active.

It is advised that the Contractor visit the site prior to bidding to determine the type of trench protection and erosion control measures that will be necessary for the sanitary sewer main installation.

Some of the sanitary sewer laterals were located and surveyed prior to design, these are marked as LAT LOCATED on the plan set. These laterals were located and marked at the property line, wye locations from TV inspection were used. Laterals that were not located are shown on the plans as per City records as well as the TV inspection reports for the wye locations on the City's Sanitary Sewer main. Proposed sanitary lateral locations near trees are subject to change based upon data obtained in the field and property owner involvement. Excavation near trees shall comply with Article 107.13 of the Standard

Specifications. If 5 ft of separation from the tree to the excavation cannot be maintained, lateral replacement shall stop at the curb.

BID ITEM 50202 TYPE II DEWATERING

Groundwater Control

The Contractor shall be responsible for managing both groundwater and surface water throughout the construction site. This shall include management of contaminated groundwater if encountered. Contaminated groundwater is known to exist at 2301 Commercial Avenue due to a release of gasoline. The most recent boring logs from this location show groundwater to be approximately 13.5 feet below ground surface.

The Contractor shall manage storm water and groundwater in accordance with WDNR permits and regulations. If high-capacity dewatering, or Type II Dewatering, is required, the Contractor shall be responsible for obtaining the necessary WDNR permits. Payment for work, equipment, materials, and incidentals necessary to manage Type I Dewatering shall be considered incidental to the construction activity being performed at the time (i.e. sanitary sewer installation, water main installation, etc.). This shall include the appropriate management of any contaminated groundwater. Payment for work, equipment, materials, and incidentals necessary to manage Type II Dewatering shall be included in this item. This shall include the appropriate management of any contaminated groundwater.

Non-contaminated groundwater and storm water may be discharged to the storm sewer system, provided appropriate sediment removal has taken place.

If during trench dewatering, contaminated groundwater is encountered, as evidenced by a sheen or odor, the Contractor shall immediately notify the Construction Inspector and Brynn Bemis of City Engineering at (608) 267-1986. This may include storm water that has entered the trench and become contaminated. Contaminated groundwater shall be discharged to the sanitary sewer system after appropriate sediment removal has taken place and the appropriate permits have been obtained from the City of Madison and Madison Metropolitan Sewerage District (MMSD).

If Type II Dewatering is anticipated, the Contractor shall consult with Ms. Bemis to determine relative risk for encountering contaminated groundwater and, if necessary, develop a sampling regiment to characterize groundwater prior to disposal. The City will assume responsibility for costs associated with groundwater sampling. Prior to the disposal of contaminated water in the sanitary sewer system, the Contractor shall obtain the necessary City of Madison and MMSD permits.

BID ITEM 50354 - RECONNECT SANITARY LATERAL

The first 5 feet of pipe shall be included with this bid item regardless of pipe type or fittings used. Beyond 5' shall be paid for separately Bid Item 50353 SANITARY SEWER LATERAL)

The first 5 feet of sewer lateral pipe/ fittings measured from the sewer main shall be considered the reconnect for all sewer lateral reconnections. Lateral connections connecting to sewer access structures shall be paid for separately as a sanitary tap. 5' of lateral pipe is not considered incidental to the sanitary tap connection.

The sanitary main between SAS#1 and SAS#8 is much greater than standard depth and it is anticipated that riser pipes will need to be installed. The top of riser pipes shall be brought to a point between nine (9) and ten (10) feet below the proposed finished street grade. The method as shown on Standard Detail Drawing 5.3.1, Riser Detail shall be indicated on the plans or by the engineer. Unless otherwise specified, the riser pipes shall be of the same size and material as the sanitary sewer lateral to be installed. In the event that a sanitary sewer lateral is not being installed coincident with the riser pipe, the size of the riser pipe shall meet the sizing requirements set forth for sanitary sewer laterals in article 503.3(c) - Sanitary Sewer Laterals of these Specifications.

For those instances in which a sanitary lateral is not being installed coincident with the riser pipe, a vertical reinforcing rod, one half (1/2) inch in diameter, shall be strapped to the riser pipe and extended to within eighteen (18) inches of the proposed finished street grade for the case of future location by the City. In backfilling the trench, special care must be used at the location of riser pipes to tamp the backfill material about the entire length of the risers in such a way as to maintain them in a vertical position and not to disturb them. Vertical piping and select fill in the amount of 5' shall be paid as a reconnect.

Work under this item shall include all work, materials, labor and incidentals necessary to install sanitary sewer riser pipes where required and shall be considered incidental to this item.

BID ITEM 50390 - SEWER ELECTRONIC MARKERS

With regard to the City of Madison Standard Specifications for Public Works Construction 2014 Edition Section 503.3(c), each sanitary lateral shall have a minimum of two (2) electronic markers with the City providing the Contractor with the required number of electronic markers. For sanitary laterals, which only include the installation of a wye, a marker ball shall be installed directly above the wye connection to the main.

SECTION 601 ELECTRICAL, GENERAL REQUIREMENTS

The existing signal and lighting poles, conduits, handholes, and manholes shall be protected during construction. If the contractor believes that damage to such facilities is unavoidable, the contractor shall not damage or remove any facilities until the City Traffic Engineering electrical inspector has reviewed and approved such actions. Any damage or removal of City electrical conduit, wire, or structures, without the specific approval by the City Traffic Engineering electrical inspector shall be promptly repaired or replaced by and at the expense of the contractor. The City may elect to do repair work with City crews. The cost for any repair work done by the City will be billed to the contractor.

Unless a traffic signal or street light pole or base is specifically designated for removal, it shall be saved. Unless a manhole, handhole or conduit is specifically designated for removal, it shall be saved.

The City of Madison Traffic Engineering Division will remove and reinstall traffic signal controller cabinet at TC1 and traffic signal pole at TS1 at the North St-Johnson St intersection. The Contractor shall notify the Traffic Operations Shop (Mike Christoph at 266-9031) five (5) working days prior to needing the cabinet and pole to be removed. The contractor shall be responsible for removing the concrete bases at TC1 and TS1.

City Traffic Engineering will need five (5) working days to reinstall traffic signal equipment to re-activate the traffic signals, after the contractor fully completes all electrical conduits and structures, and after all concrete bases cure for a minimum of seven (7) days. The contractor shall coordinate with Traffic Operations Shop (Mike Christoph at 266-9031) for signal installation.

SECTION 601.10 MATERIALS FURNISHED BY THE CITY OF MADISON

The following materials which are to be furnished by the City shall be picked up by the Contractor at the Traffic Engineering Shop, 1120 Sayle Street, unless otherwise specified. Contact Dennis Rowe at 266-9034 at least 24 hours in advance for pick-up. All costs of the work included in this Section shall be at the expense of the Contractor unless otherwise provided. The Contractor shall provide equipment and labor to load materials onto Contractor's vehicle or trailer.

ITEM Quantity 3/4" x 24" anchor bolts 4

SECTION 701 PROVISIONS FOR WATER INSTALLATION AND ABANDONMENT

The Water designer for this project is: Pete Holmgren 608-261-5530 pholmgren@madisonwater.org

A general outline of the work is as follows:

- North St.: This street will involve work to replace the existing 8-inch water main with new 8-inch
 main, and reconnection of services and intersecting street main as shown on the plans. Water
 main will likely need to be installed before the sanitary sewer on this street due to the proximity of
 the existing water to very deep proposed sanitary sewer.
- Hoard St.: This street will involve work to replace the existing 6-inch water main with new 8-inch main, and reconnection of all services on the street as shown on the plans.
- Commercial Ave.: This street will involve work to replace the existing 8-inch water main with new 12-inch main, and reconnection of all services on the street as shown on the plans.

Once the new systems have passed the required pressure and water quality tests, cut off, extend as necessary, and reconnect the existing water service laterals to the new water mains (unless the service is to be abandoned). Services will be reconnected to the new main as shown on the plans.

View the site prior to bidding and become familiar with existing conditions and utilities.

SECTION 703 CONSTRUCTION METHODS

Perform all work in accordance with these provisions and the City of Madison *Standard Specifications For Public Works Construction*, 2014 Edition (adopted January 21, 2014) or most recent.

BID ITEM 90001 - PAVED SURFACE TEMPORARY, ASPHALT PAVEMENT

DESCRIPTION

This work shall include all work, materials, labor and incidentals necessary to construct a 4-inch minimum thick HMA pavement with a minimum 8-inch crushed stone base suitable for use as temporary motor vehicle access during the construction. Preparation for the Paved Surface Temporary, Asphalt Pavement is included with this item, including excavation or fill and crushed stone as needed. The Contractor shall be responsible for maintaining the temporary pavement and all components with no additional compensation.

Removal and disposal of the Paved Surface Temporary, Asphalt Pavement and all related components, upon no longer needing the surface, shall be incidental to this item. Restoration of the areas of the Paved Surface Temporary will be paid for under respective bid items.

METHOD OF MEASUREMENT

Paved Surface Temporary, Asphalt Pavement shall be measured by the square yard acceptably installed.

BASIS OF PAYMENT

Paved Surface Temporary, Asphalt Pavement measured as described above shall be full payment for all work, materials and incidentals required to complete the work in accordance with the description.

BID ITEM 90002 - MONOLITIC CONCRETE MEDIAN ISLAND

DESCRIPTION

This special provision describes furnishing and installing Monolithic Concrete Median Island, complete and accepted in place, in accordance with Article 303 of the Standard Specifications, and the plans, details, and as hereinafter provided. Monolithic Concrete Median Island shall be placed as shown in the plans, on Commercial Avenue at Packers Avenue, and shall match the existing section of the existing concrete median island.

BID ITEM 90003 - TEXTURED AND COLORED CONCRETE SIDEWALK - 5 INCH

DESCRIPTION

This special provision describes furnishing and installing Textured and Colored 5-Inch Concrete Sidewalk, complete and accepted in place, including base materials, sealer and samples in accordance with Article 303 of the Standard Specifications, and the plans, details, and as hereinafter provided.

MATERIALS – GENERAL

At least fifteen working days prior to the start of textured and colored concrete installation, supply one 4 foot x 4-foot panel sample of the textured and colored concrete. Obtain approval from the Engineer for the final color and stamp pattern prior to placing any colored imprinted concrete in the field.

The sample shall become the property of the City of Madison upon completion of this project.

WATER EVAPORATIVE REDUCER (CON FILM)

Use a water evaporative reducer to hold in the bleed water for the dry shake color hardener application. The water evaporative reducer shall be Dayton Superior Sure Film (J-74), Master Builders Confilm, or equal as approved by the Engineer. It is recommended that the Contractor confirm the type of water evaporative reducer to be used with the manufacturer of color hardener.

DRY SHAKE COLOR HARDENER

Use Brickform Rafco Products color #700, Terra Cotta, dry shake color hardener.

RELEASE AGENT

Use Brickform Rafco Products color #300, Nutmeg powder release agent.

CURING COMPOUND

The curing compound shall meet the specifications of ASTM C 1315 Type I Class A clear non-yellowing curing compound.

IMPRINTING PATTERN

Use a 6" x 6" cobblestone pattern matching previous segments of East Washington Avenue.

CONSTRUCTION

An experienced Contractor who has installed a minimum of 30,000 square feet of colored and imprinted concrete shall install Textured and Colored 5-Inch Concrete Sidewalk. The Contactor shall submit written documentation of imprinted concrete work to the Engineer prior to the start of construction.

Apply water evaporative reducer per manufacturer's recommendations. Protect all adjoining areas of concrete. Finish concrete and apply dry shake color hardener in accordance to the manufacturer's

recommendations. Hand-broadcast the color hardener uniformly across the concrete in two separate broadcasting operations (shakes). Apply two-thirds of the material in the first shake and without one-third for the second shake and final touch-up, as necessary. Apply the two shakes at 90 degrees to each other. The necessary moisture for wetting the color hardener must come from the concrete substrate. Adding water to the concrete surface to work in the dry shake color hardener is not permitted. Use a wood float for applying the dry shake color hardener unless the use of a wood float is in conflict with the manufacturer's recommendation.

Apply release agent in accordance to the manufacturer's recommendations.

Stamping method shall be in accordance to the manufacturer's specified methods. Check all depths of imprints by tool-to-tool surface leveling.

Perform tooling as stamping tools are removed after imprinting. Eliminate all squeeze joints between stamping tools, if any, with hand tools prior to concrete settings.

Remove excess release agent from the concrete seventy two (72) hours after placement using a stiff brush and a mild murataic acid solution (approximately 4 oz per 2.5 gallons water) to achieve desired color. Rinse and let dry. Apply curing compound at 350 SF/gal coverage rate or in accordance to manufacturer's recommendations to seal the concrete immediately after drying.

Joint the concrete in accordance with the standard specifications amended as follows: Saw joints such that the saw joint follows the concrete recess.

Textured and Colored 5-Inch Concrete Sidewalk shall match the visual appearance of the approved reference sample. Replace Textured and Colored 5-Inch Concrete Sidewalk not conforming to the reference sample at a Contractor expense.

METHOD OF MEASUREMENT

Textured and Colored 5-Inch Concrete Sidewalk shall be measured by the square feet of Textured and Colored 5-Inch Concrete Sidewalk installed and accepted.

BASIS OF PAYMENT

Textured and Colored 5-Inch Concrete Sidewalk shall be measured as described above which shall be full compensation for all work, all materials and incidentals necessary to complete the work as described above.

BID ITEM 90004 - MAINTAIN TEMPORARY BICYCLE ACCESS

DESCRIPTION

This special provision describes maintaining an accessible bicycle crossing of North Street at the Hoard Street intersection during construction on North Street. Hoard Street within the project limits is a designated on-street bicycle route.

MATERIALS

Furnish a hard temporary surface material consisting of asphaltic surface temporary according to standard spec 465.2, any grade of concrete according to standard spec 602.2, or alternative material as approved by the engineer. Gravel or base course material are not acceptable.

CONSTRUCTION

Maintain Temporary Bikeway Access on existing pavement, new pavement, or temporary surface material where shown on the plans or directed by the engineer.

Install, maintain, relocate (if necessary to accommodate work or operations), and remove temporary surface material at Hoard Street as shown on the plans and as directed by the engineer. Level and compact the surface prior to placing temporary surface material. The temporary bikeway shall have a minimum clear width of 8 feet; be located outside the immediate work area, as approved by the engineer; and meet the requirements of the current Americans with Disabilities Act Accessibility Guidelines (ADAAG). Install safety fence along both sides of the temporary bikeway. Provide a gap in the safety fence as necessary to provide access for construction vehicles across the temporary crosswalk. The maximum width of the gap shall be 18 feet. Reconstruct temporary bikeway access when disturbed by construction operations or utility trenches. Sweep temporary bikeway access daily. Prevent motor vehicle from entering temporary bikeway.

MEASUREMENT

Maintain Temporary Bikeway Access by the day in service, acceptably completed. The measured quantity will equal the number of calendar days a bikeway through the work area is open to bicycle traffic. A bikeway is defined as an accessible two-way crossing of an intersection. Each day that the bikeway is out of service for more than 2 hours will result in 1 day being deducted from the quantity measured for payment.

PAYMENT

Payment is full compensation for furnishing, loading, and hauling materials; for preparing the foundation; for furnishing, placing, maintaining, and removing temporary surface material; and for reconstructing or relaying the temporary surface material.

BID ITEM 90030 - RAIN GARDEN

DESCRIPTION

Work under this item shall include: all work (including but not limited to: excavation, removal, and disposal of existing material, provision and placement of engineered material) and materials (including but not limited to castings, pipes, engineered fill, mulch, & sidewalk drains), labor, and incidentals required to construct the rain gardens meeting the sizes, locations, specifications, and detail drawings contained in Article 211 of the 2014 City of Madison Standard Specifications and in accord with Standard Detail Drawing 2.09. All pipe bends, sidewalk, and incidentals to make this connection and construct this rain garden as shown on page RG-1 of the plans are included in this item.

The Contractor shall review the detail drawings for each system in detail. The size of the garden is specific as is the means of providing storm water to the system. All gardens are fed with street runoff via a curb outlet structure (Neenah R-3268, a depressed curb flow-line and a 6" PVC pipe).

The City reserves the right to add or remove rain gardens from the contract. The Contractor shall not be compensated in any matter for the removal or addition of rain gardens from the contract.

METHOD OF MEASUREMENT

Rain Garden shall be measured by the square feet acceptably installed.

BASIS OF PAYMENT

Rain Garden shall be measured as described above which shall be full compensation for all work, materials and incidentals to complete the work as described above.

BID ITEM 90031 PRIVATE STORM RECONNECT TYPE 2

DESCRIPTION

Work under this item shall include all work, materials, labor and incidentals necessary to connect existing private storm sewers to the new storm sewer main. Specifically, this item includes (at a minimum) the following: up to Fifty (50) feet of six (6) inch, ten (10) inch, or twelve (12) inch schedule 30 PVC pipe or RCP pipe (concrete pipe must be used under the roadway), compression couplings, or concrete collar to connect to the existing private system, and up to four (4) precast bends. The Contractor shall complete the following as part of this item:

- 1) Find the end of the existing system.
- 2) Remove the pipe to a point where it is covered by at least 6 inches of topsoil.
- 3) Connect to the pipe with a bend directing the pipe underground to a depth where a second or third bend can be installed directing the lateral toward the new storm sewer structure/pipe.
- 4) The lateral shall then be connected to the new storm sewer structure

METHOD OF MEASUREMENT

Private Storm Sewer Lateral Reconnect shall be measured as complete when each completed unit is installed in the field.

BASIS OF PAYMENT

Private Storm Sewer Lateral Reconnect shall be measured as described above which shall be full compensation for all work, materials and incidentals to complete the work as described above.

BID ITEM 90032 - STORM CONTROL

DESCRIPTION

Work under this item shall include all work, materials, equipment, and incidentals required to control dry and wet weather flow in the storm sewer system during the reconstruction project. The Contractor shall take all necessary steps to protect the new and existing storm mains from damage during construction and to accommodate the existing flows during construction.

This item includes all storm control necessary for all aspects of the Construction.

Work under this item shall include all work, materials, equipment, and incidentals required to control dry and wet weather flow in the storm sewer system during the reconstruction project to minimize damage to the treatment structure during installation of the structure and during concrete cure times.

METHOD OF MEASUREMENT

Storm Control shall be measured by the lump sum for all dewatering necessary throughout construction.

BASIS OF PAYMENT

Storm Control shall be paid for at the contract price, which shall be full compensation for all work as outlined in the description.

BID ITEM 90070 - WASTEWATER CONTROL- HEAVY FLOW

DESCRIPTION

Work under this bid item shall include wastewater control (bypass pumping of the sewer being replaced) in the amount of 5000 gpm. All work shall be done in conformance of Part V of the City of Madison Standard Specifications for Public Works Construction- Latest Addition. It is anticipated that pumping trucks will need to be utilitized while the pipe at Johnson St is under construction.

Work under this item includes all equipment, labor, materials, coordination, and incidentals required to control or divert, to the engineer's satisfaction, sanitary sewer flows during reconstruction of the 15" and larger sanitary sewer mains on the job.

Contractor shall provide a pump with a capacity of 5000 gallons per minute and all associated equipment required to maintain a functioning sanitary sewer system during construction. It is not acceptable, at any time, to disrupt normal flow of wastewater in sanitary sewer service laterals without prior approval from the engineer. This condition also holds at the time of connection of an existing lateral to the new sewer main.

If the contractor elects to use bypass pumping as a means of wastewater control, the methods, equipment, type of hose, etc. are subject to approval by the City of Madison Engineer. Ramp any hoses crossing streets, driveways, parking areas, etc., to prevent damage to hoses. Contain spillage of wastewater to be within the utility trench and dispose of spillage into existing sewer downstream to previously installed sewer piping. Spillage of wastewater to adjacent streets, lawns, etc. not will be tolerated. Should spillage occur, cease all construction operations immediately and begin cleanup operations. Clean site thoroughly to the satisfaction of the engineer prior to the resumption of any construction operations.

METHOD OF MEASUREMENT

Heavy Wastewater Control is measured as a single lump sum unit of work acceptably completed.

BASIS OF PAYMENT

Heavy Wastewater Control will be paid for at the contract price, and is considered full compensation for all work as listed above.

BID ITEM 90071 - EXCAVATION AND HAULING OF CONTAMINATED SOIL

DESCRIPTION

Work under this bid item includes all work, materials, equipment, and incidentals required to excavate, segregate, and haul contaminated soil per these special provisions.

The gas station located at 2301 Commercial Avenue is registered as a closed remediation site where residual contamination remains. In the late 1990's, a gasoline release was discovered, monitored, and remediated to the extent practical, based on utilities and public facilities. At the time remediation activities were completed, gasoline contaminated soil and groundwater remained adjacent to the public right-of-way (Commercial Avenue). It is anticipated that this contamination may be encountered during the installation of sanitary sewer and water mains adjacent to 2301 Commercial Avenue. While working with contaminated material, the Contractor shall comply with all federal, state, and local regulations and shall provide appropriate personal protective equipment and training to on-site personnel that may come in contact with contaminated material.

The Contractor shall identify contaminated soil by visual observations (uniformly gray, discolored material) and odor (petroleum). If the Contractor has any questions regarding identification of contaminated material, they may contact Brynn Bemis of City Engineering at (608) 267-1986. If contaminated material

is encountered the Contractor shall immediately notify the Construction Inspector and Ms. Bemis. Contaminated material shall be segregated from clean material and hauled to Waste Management Madison Prairie Landfill. Please note the landfill has limited hours.

The Contractor is allowed to stockpile small amounts of contaminated material on site in order to continue excavating after landfill operating hours. If material is stockpiled, an impermeable membrane shall be placed beneath any contaminated material. Impermeable membrane shall also be placed over any contaminated material. The Contractor shall not stockpile contaminated material for longer than 24 hours, unless approved by the Construction Inspector.

The Contractor shall haul all material in accordance with all federal, state, and local regulations. The City of Madison will pay the landfill directly for all tipping fees associated with the disposal of contaminated material.

The provision and hauling of replacement (clean) material shall be considered incidental to this bid item.

The City reserves the right to eliminate this bid item at no additional cost.

METHOD OF MEASUREMENT

Excavation and Hauling of Contaminated Soil will be measured in tons of contaminated soil accepted by the approved landfill as documented by weight tickets generated by the landfill.

BASIS OF PAYMENT

Payment for Excavation and Hauling of Contaminated Soil shall be considered full compensation for contaminated soil excavation, segregation, and hauling; assistance with soil sampling; temporary stockpiling; provision of replacement fill; weighing of trucks; obtaining weight tickets from scale attendant; providing original copies of weight tickets to the engineer; and for furnishing all labor, tools, equipment, and incidentals necessary to complete the work.

BID ITEM 90072 - SANITARY SEWER STRUCTURE JOINT SEAL

DESCRIPTION

Work under this bid item includes all work, materials, equipment, and incidentals required to seal sanitary sewer structure external joints below elevation 850.00. Manhole joint seal shall be minimum of nine (9) inches wide, and consist of flexible rubberize seal conforming to ASTM C923 held in place with stainless steel compression bands or butyl adhesive tape conforming to ASTM C877 or heat shrink sleeve over visco-elastic adhesive sealant.

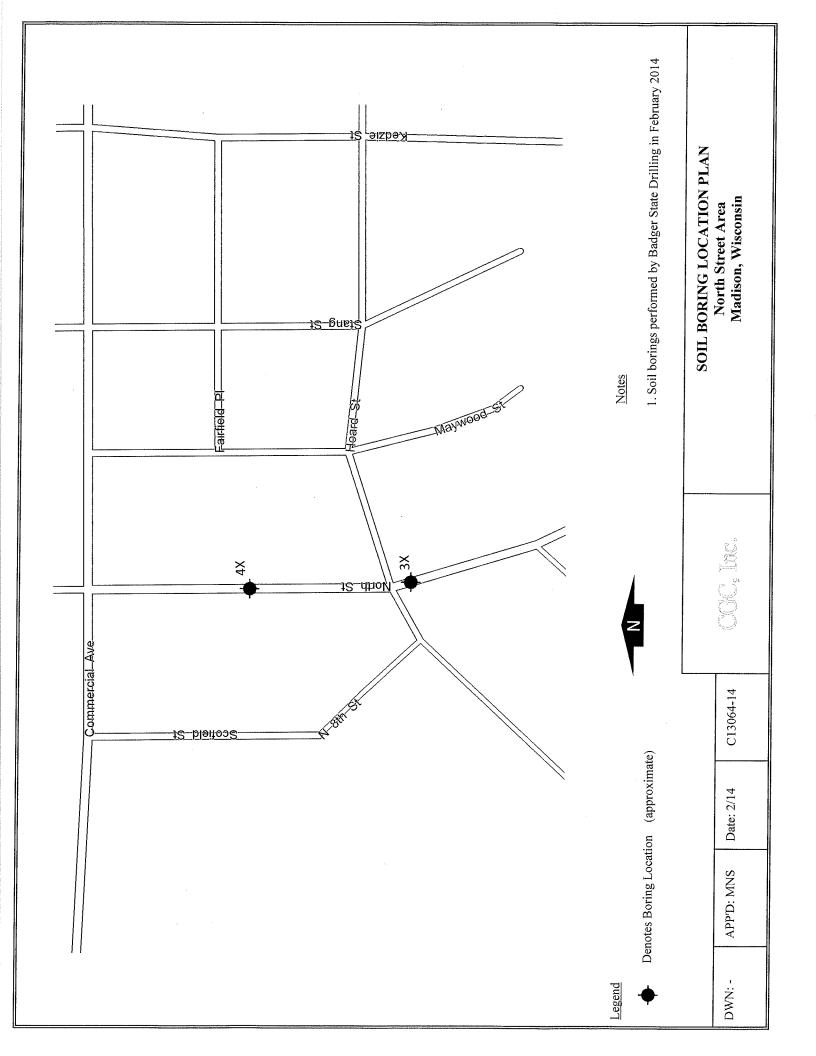

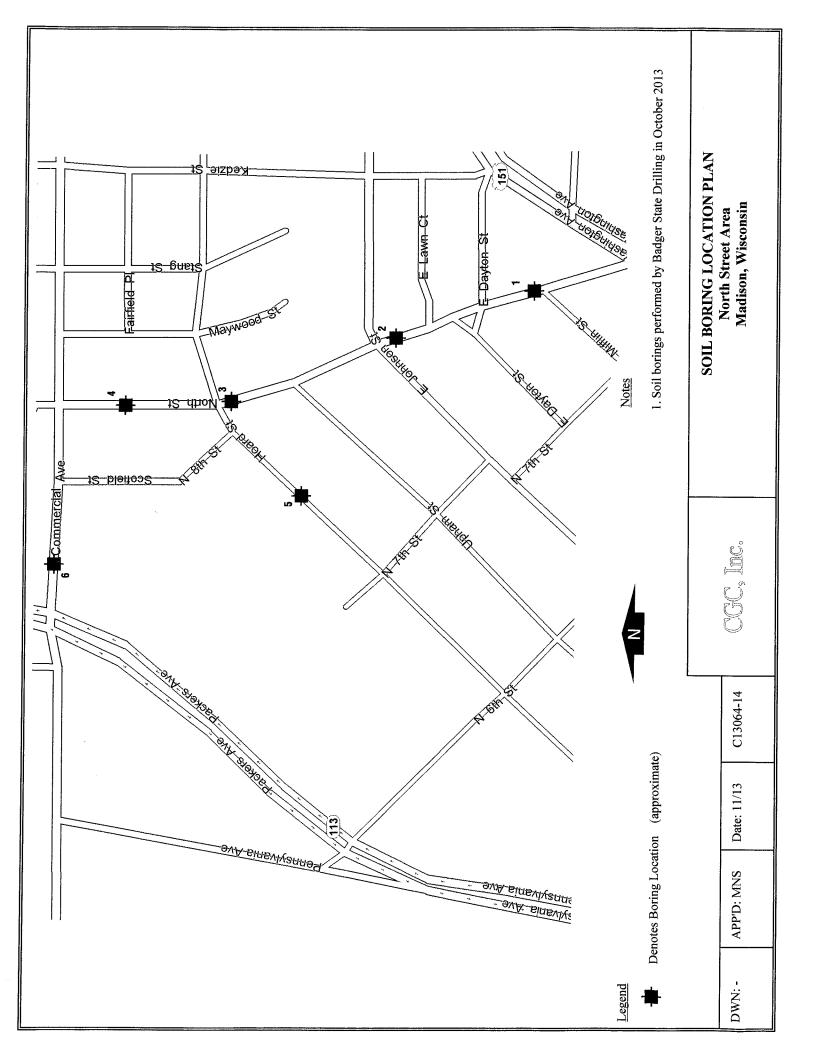

materials, articles, supplies or equipment on the site of the building or work, by persons employed by the Contractor, Subcontractor, or Agent thereof.

"Employees working on the project" means laborers, workers, and mechanics employed directly upon the site of work.

"Laborers, Workers, and Mechanics" include pre-apprentices, helpers, trainees, learners and properly registered and indentured apprentices but exclude clerical, supervisory, and other personnel not performing manual labor.

Establishment of Wage Rates. The Department of Public Works shall periodically obtain a current schedule of prevailing wage rates from DWD. The schedule shall be used to establish the City of Madison Prevailing Wage Rate Schedule for Public Works Construction (prevailing wage rate). The Department of Public Works may include known increases to the prevailing wage rate which can be documented and are to occur on a future specific date. The prevailing wage rate shall be included in public works contracts subsequently negotiated or solicited by the City. Except for known increases contained within the schedule, the prevailing wage rate shall not change during the contract. The approved wage rate is attached hereto.

Workforce Profile. The Contractor shall, at the time of signature of the contract, notify the City Engineer in writing of the names and classifications of all the employees of the Contractor, Subcontractors, and Agents proposed for the work. In the alternative, the Contractor shall submit in writing the classifications of all the employees of the Contractor, Subcontractors and Agents and the total number of hours estimated in each classification for the work. This workforce profile(s) shall be reviewed by the City Engineer who may, within ten (10) days, object to the workforce profile(s) as not being reflective of that which would be required for the work. The Contractor may request that the workforce profile, or a portion of the workforce profile, be submitted after the signature of the contract but at least ten (10) days prior to the work commencing. Any costs or time loss resulting from modifications to the workforce profile as a result of the City Engineer's objections shall be the responsibility of the Contractor.

Payrolls and Records. The Contractor shall keep weekly payroll records setting forth the name, address, telephone number, classification, wage rate and fringe benefit package of all the employees who work on the contract, including the employees of the Contractor's subcontractors and agents. Such weekly payroll records must include the required information for all City contracts and all other contracts on which the employee worked during the week in which the employee worked on the contract. The Contractor shall also keep records of the individual time each employee worked on the project and for each day of the project. Such records shall also set forth the total number of hours of overtime credited to each such employee for each day and week and the amount of overtime pay received in that week. The records shall set forth the full weekly wages earned by each employee and the actual hourly wage paid to the employee.

The Contractor shall submit the weekly payroll records, including the records of the Contractor's subcontractors and agents, to the City Engineer for every week that work is being done on the contract. The submittal shall be within twenty-one (21) calendar days of the end of the Contractor's weekly pay period.

Employees shall receive the full amounts accrued at the time of the payment, computed at rates not less than those stated in the prevailing wage rate and each employee's rate shall be determined by the work that is done within the trade or occupation classification which should be properly assigned to the employee.

An employee's classification shall not be changed to a classification of a lesser rate during the contract. If, during the term of the contract, an employee works in a higher pay classification than the one which was previously properly assigned to the employee, then that employee shall be considered to be in the higher pay classification for the balance of the contract, receive the appropriate higher rate of pay, and she/he shall not receive a lesser rate during the balance of the

contract. For purposes of clarification, it is noted that there is a distinct difference between working in a different classification with higher pay and doing work within a classification that has varying rates of pay which are determined by the type of work that is done within the classification. For example, the classification "Operating Engineer" provides for different rates of pay for various classes of work and the Employer shall compensate an employee classified as an "Operating Engineer" based on the highest class of work that is done in one day. Also, as a matter of clarification, it is recognized that an employee may work in a higher paying classification merely by chance and without prior intention, calculation or design. If such is the case and the performance of the work is truly incidental and the occurrence is infrequent, inconsequential and does not serve to undermine the single classification principle herein, then it may not be required that the employee be considered to be in the higher pay classification and receive the higher rate of pay for the duration of the contract. However, the Contractor is not precluded or prevented from paying the higher rate for the limited time that an employee performs work that is outside of the employee's proper classification.

Questions regarding an employee's classification, rate of pay or rate of pay within a classification, shall be resolved by reference to the established practice that predominates in the industry and on which the trade or occupation rate/classification is based. Rate of pay and classification disputes shall be resolved by relying upon practices established by collective bargaining agreements and guidelines used in such determination by appropriate recognized trade unions operating within the City of Madison.

The Contractor, its Subcontractors and Agents shall submit to interrogation regarding compliance with the provisions of this ordinance.

Mulcting of the employees by the Contractor, Subcontractor, and Agents on Public Works contracts, such as by kickbacks or other devices, is prohibited. The normal rate of wage of the employees of the Contractor, Subcontractor, and Agents shall not be reduced or otherwise diminished as a result of payment of the prevailing wage rate on a public works contract.

Hourly contributions. Hourly contributions shall be determined in accordance with the prevailing wage rate and with DWD. 290.01(10), Wis. Admin. Code.

Apprentices and Subjourney persons. Apprentices and sub journeypersons performing work on the project shall be compensated in accordance with the prevailing wage rate and with DWD 290.02, and 290.025, respectively, Wis. Admin. Code.

Straight Time Wages. The Contractor may pay straight time wages as determined by the prevailing wage rate and DWD 290.04, Wis. Admin. Code.

Overtime Wages. The Contractor shall pay overtime wages as required by the prevailing wage rate and DWD 290.05, Wis. Admin. Code.

Posting of Wage Rates and Hours. A clearly legible copy of the prevailing wage rate, together with the provisions of Sec. 66.0903(10)(a) and (11)(a), Wis. Stats., shall be kept posted in at least one conspicuous and easily accessible place at the project site by the Contractor and such notice shall remain posted during the full time any laborers, workers or mechanics are employed on the contract.

Evidence of Compliance by Contractor. Upon completion of the contract, the Contractor shall file with the Department of Public Works an affidavit stating:

a. That the Contractor has complied fully with the provisions and requirements of Sec. 66.0903(3), Wis. Stats., and Chapter DWD 290, Wis. Admin. Code; the Contractor has received evidence of compliance from each of the agents and subcontractors; and the

names and addresses of all of the subcontractors and agents who worked on the contract.

b. That full and accurate records have been kept, which clearly indicate the name and trade or occupation of every laborer, worker or mechanic employed by the Contractor in connection with work on the project. The records shall show the number of hours worked by each employee and the actual wages paid therefore; where these records will be kept and the name, address and telephone number of the person who will be responsible for keeping them. The records shall be retained and made available for a period of at least three (3) years following the completion of the project of public works and shall not be removed without prior notification to the municipality.

Evidence of Compliance by Agent and Subcontractor. Each agent and subcontractor shall file with the Contractor, upon completion of their portion of the work on the contract an affidavit stating that all the provisions of Sec. 66.0903(3), Wis. Stats., have been fully complied with and that full and accurate records have been kept, which clearly indicate the name and trade or occupation of every laborer, worker or mechanic employed by the Contractor in connection with work on the project. The records shall show the number of hours worked by each employee and the actual wages paid therefore; where these records shall be kept and the name, address and telephone number of the person who shall be responsible for keeping them. The records shall be retained and made available for a period of at least three (3) years following the completion of the project of public works and shall not be removed without prior notification to the municipality.

Failure to Comply with the Prevailing Wage Rate. If the Contractor fails to comply with the prevailing wage rate, she/he shall be in default on the contract.

5. **Affirmative Action.** In the performance of the services under this Agreement the Contractor agrees not to discriminate against any employee or applicant because of race, religion, marital status, age, color, sex, disability, national origin or ancestry, income level or source of income, arrest record or conviction record, less than honorable discharge, physical appearance, sexual orientation, gender identity, political beliefs, or student status. The Contractor further agrees not to discriminate against any subcontractor or person who offers to subcontract on this contract because of race, religion, color, age, disability, sex, sexual orientation, gender identity or national origin.

The Contractor agrees that within thirty (30) days after the effective date of this agreement, the Contractor will provide to the City Affirmative Action Division certain workforce utilization statistics, using a form to be furnished by the City.

If the contract is still in effect, or if the City enters into a new agreement with the Contractor, within one year after the date on which the form was required to be provided, the Contractor will provide updated workforce information using a second form, also to be furnished by the City. The second form will be submitted to the City Affirmative Action Division no later than one year after the date on which the first form was required to be provided.

The Contractor further agrees that, for at least twelve (12) months after the effective date of this contract, it will notify the City Affirmative Action Division of each of its job openings at facilities in Dane County for which applicants not already employees of the Contractor are to be considered. The notice will include a job description, classification, qualifications and application procedures and deadlines. The Contractor agrees to interview and consider candidates referred by the Affirmative Action Division if the candidate meets the minimum qualification standards established by the Contractor, and if the referral is timely. A referral is timely if it is received by the Contractor on or before the date started in the notice.

Articles of Agreement Article I

The Contractor shall take affirmative action in accordance with the provisions of this contract to insure that applicants are employed, and that employees are treated during employment without regard to race, religion, color, age, marital status, disability, sex, sexual orientation, gender identity or national original and that the employer shall provide harassment free work environment for the realization of the potential of each employee. Such action shall include, but not be limited to, the following: employment, upgrading, demotion or transfer, recruitment or recruitment advertising, layoff or termination, rates of pay or other forms of compensation and selection for training including apprenticeship insofar as it is within the control of the Contractor. The Contractor agrees to post in conspicuous places available to employees and applicants notices to be provided by the City setting out the provisions of the nondiscrimination clauses in this contract.

Article II

The Contractor shall in all solicitations or advertisements for employees placed by or on behalf of the Contractors state that all qualified or qualifiable applicants will be employed without regard to race, religion, color, age, marital status, disability, sex, sexual orientation, gender identity or national origin.

Article III

The Contractor shall send to each labor union or representative of workers with which it has a collective bargaining agreement or other contract or understanding a notice to be provided by the City advising the labor union or worker's representative of the Contractor's equal employment opportunity and affirmative action commitments. Such notices shall be posted in conspicuous places available to employees and applicants for employment.

Article V

The Contractor agrees that it will comply with all provisions of the Affirmative Action Ordinance of the City of Madison, including the contract compliance requirements. The Contractor agrees to submit the model affirmative action plan for public works contractors in a form approved by the Affirmative Action Division Manager.

Article VI

The Contractor will maintain records as required by Section 39.02(9)(f) of the Madison General Ordinances and will provide the City Affirmative Action Division with access to such records and to persons who have relevant and necessary information, as provided in Section 39.02(9)(f). The City agrees to keep all such records confidential, except to the extent that public inspection is required by law.

Article VII

In the event of the Contractor's or subcontractor's failure to comply with the Equal Employment Opportunity and Affirmative Action Provisions of this contract or Section 39.03 and 39.02 of the Madison General Ordinances, it is agreed that the City at its option may do any or all of the following:

- 1. Cancel, terminate or suspend this Contract in whole or in part.
- 2. Declare the Contractor ineligible for further City contracts until the Affirmative Action requirements are met.

3. Recover on behalf of the City from the prime Contractor 0.5 percent of the contract award price for each week that such party fails or refuses to comply, in the nature of liquidated damages, but not to exceed a total of five percent (5%) of the contract price, or five thousand dollars (\$5,000), whichever is less. Under public works contracts, if a subcontractor is in noncompliance, the City may recover liquidated damages from the prime Contractor in the manner described above. The preceding sentence shall not be construed to prohibit a prime Contractor from recovering the amount of such damage from the non-complying subcontractor.

Article VIII

The Contractor shall include the above provisions of this contract in every subcontract so that such provisions will be binding upon each subcontractor. The Contractor shall take such action with respect to any subcontractor as necessary to enforce such provisions, including sanctions provided for noncompliance.

Article IX

The Contractor shall allow the maximum feasible opportunity to small business enterprises to compete for any subcontracts entered into pursuant to this contract. (In federally funded contracts the terms "DBE, MBE and WBE" shall be substituted for the term "small business" in this Article.)

s. 66.0903 (10) RECORDS; INSPECTION; ENFORCEMENT.

(a) Each contractor, subcontractor, or contractor's or subcontractor's agent performing work on a project of public works that is subject to this section shall keep full and accurate records clearly indicating the name and trade or occupation of every person performing the work described in sub. (4) and an accurate record of the number of hours worked by each of those persons and the actual wages paid for the hours worked.

s. 66.0903 (11) LIABILITY AND PENALTIES.

- (a) 1. Any contractor, subcontractor, or contractor's or subcontractor's agent who fails to pay the prevailing wage rate determined by the department under sub. (3) or who pays less than 1.5 times the hourly basic rate of pay for all hours worked in excess of the prevailing hours of labor is liable to any affected employee in the amount of his or her unpaid wages or his or her unpaid overtime compensation and in an additional amount as liquidated damages as provided under subd. 2., 3., whichever is applicable.
- 2. If the department determines upon inspection under sub. (10) (b) or (c) that a contractor, subcontractor, or contractor's or subcontractor's agent has failed to pay the prevailing wage rate determined by the department under sub. (3) or has paid less than 1.5 times the hourly basic rate of pay for all hours worked in excess of the prevailing hours of labor, the department shall order the contractor to pay to any affected employee the amount of his or her unpaid wages or his or her unpaid overtime compensation and an additional amount equal to 100 percent of the amount of those unpaid wages or that unpaid overtime compensation as liquidated damages within a period specified by the department in the order.
- 3. In addition to or in lieu of recovering the liability specified in subd. 1. as provided in subd. 2., any employee for and in behalf of that employee and other employees similarly situated may commence an action to recover that liability in any court of competent jurisdiction. If the court finds that a contractor, subcontractor, or contractor's or subcontractor's agent has failed to pay the prevailing wage rate determined by the department under sub. (3) or has paid less than 1.5 times the hourly basic rate of pay for all hours worked in excess of the prevailing hours of labor, the court shall order the contractor, subcontractor, or agent to pay to any affected employee the amount of his or her unpaid wages or his or her unpaid overtime compensation and an additional amount equal to 100 percent of the amount of those unpaid wages or that unpaid overtime compensation as liquidated damages. 5. No employee may be a party plaintiff to an action under subd. 3. unless the employee consents in writing to become a party and the consent is filed in the court in which the action is brought. Notwithstanding s. 814.04 (1), the court shall, in addition to any judgment awarded to the plaintiff, allow reasonable attorney fees and costs to be paid by the defendant.

BUILDING OR HEAVY CONSTRUCTION

Includes sheltered enclosures with walk-in access for the purpose of housing persons, employees, machinery, equipment or supplies and non-sheltered work such as canals, dams, dikes, reservoirs, storage tanks, etc. A sheltered enclosure need not be "habitable" in order to be considered a building.
