## CONTRACT NO. 7884 ALICIA ASHMAN LIBRARY – ROOF REPLACEMENT

This addendum is issued to modify, explain or correct the original Drawings, Specifications, or Contract Documents of the subject contract and is hereby made a part of the contract documents.

### A. **GENERAL CONTRACT CONDITIONS**

- 1. Pre-bid contractor access to the Alicia Ashman Library roof may be scheduled with the City Construction Manager (CCM) David Schaller.
- 2. Access for loading the roof will be from the neighboring access road that is behind the library. Please allow a minimum of two days notice to the City Construction Manager so that access can be coordinated with the neighboring owner's representative.

### D. **SPECIFICATIONS**

- A. SECTION 07 01 50.19 PREPARATION FOR RE-ROOFING
  - PART 1, 1.1, A, delete "roof system" and add "existing ballast (to be redistributed following the installation of the new EPDM membrane) and removal of the existing EPDM membrane' in its place.
  - ii. PART 3, A, delete "roof system down to the roof deck including all existing composition base flashing" and add "existing ballast (to be redistributed following the installation of the new EPDM membrane) and removal of the existing EPDM membrane' in its place.
  - iii. PART 3, B, delete in its entirety.
  - iv. PART 3, C, delete in its entirety.
- B. SECTION 07 53 23 ETHYLENE-PROPYLENE-DIENE-MONOMER (EPDM) ROOFING
  - i. 1 GENERAL, 1.1 SUMMARY, B, 1, delete "Adhered" and add "ballasted to match existing" in its place.
  - ii. 1 GENERAL, 1.1 SUMMARY, B, 1, b, add at the end of the sentence, after flashings, "only as necessary to be able to provide a 30 manufacturer's warranty.
  - iii. 1 GENERAL, 1.1 SUMMARY, B, 1, c, delete in its entirety.
  - iv. PART 2 PRODUCTS, 2.2 INSULATION, delete and add "existing insulation to remain."
  - v. PART 2 PRODUCTS, 2.2 INSULATION, B, delete in its entirety.
  - vi. PART 2 PRODUCTS, 2.2 INSULATION, C, delete in its entirety.
  - vii. PART 2 PRODUCTS, 2.2 INSULATION, D, delete in its entirety.
  - viii. PART 3 EXECUTION, 3.3 INSULATION INSTALLATION, delete in its entirety.

### E. SPECIAL PROVISIONS -

- A. Reference Article 104: Scope of Work
  - i. Delete "roofing materials" from the first sentence and add "EPDM membrane" in its place.
  - ii. Delete "with an average insulation value of R-30" from the first sentence, add a period after the word system, and add "The existing insulation is to remain." It has been determined that the existing insulation is 6" of high density polystyrene that shall remain. The scope is to include the mechanically fastened installation of 1/2" cover board per the EPDM manufacturer's material and fastening recommendation over the existing insulation. The scope is to be the removing of the existing

aggregate ballast off of the existing EPDM, for the removal of the existing EPDM, the installation of the new EPDM, and then placing the existing aggregate ballast properly distributed on the new EPDM. This addendum changes the roof system to match the existing aggregate ballasted system in lieu of a fully adhered system.
