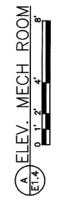
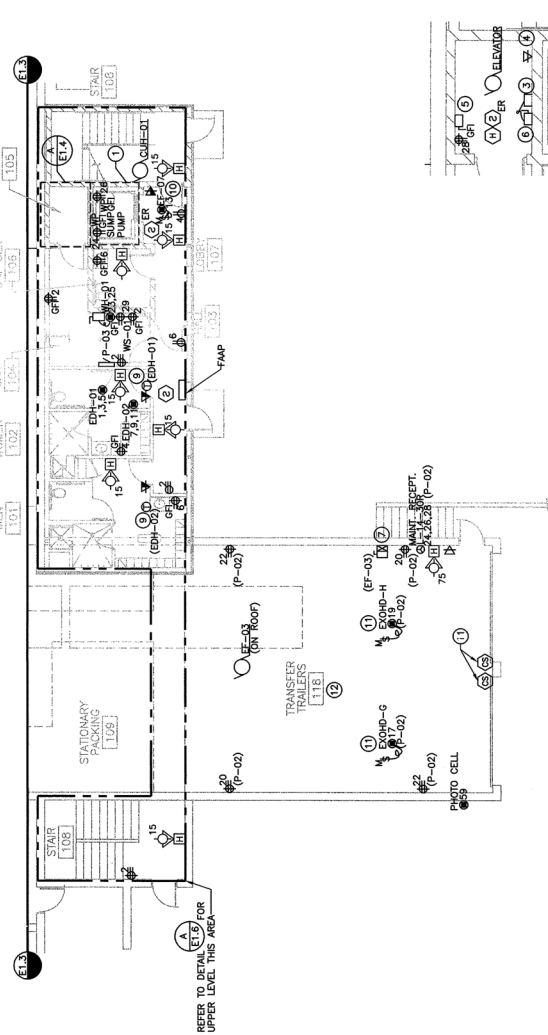

 OLIN AVENUE WASTE TRANSFER STATION MODIFICATIONS

GENERAL NOTES:
 1. ELECTRICAL EQUIPMENT AND DEVICES ON THIS DRAWING SHALL BE POWERED FROM P-03 UNLESS NOTED OTHERWISE.

- KEY NOTES:**
- ELECTRICAL EQUIPMENT IN THIS AREA SHALL BE LOCATED IN ELEVATOR PIT.
 - PROVIDE DEDICATED PHONE LINE FOR ELEVATOR CONTROL PANEL.
 - PROVIDE ELEVATOR RECALL ADDRESSABLE CONTROL MODULE FOR MONITORING ELEVATOR CALL SHOCK AND REDUCED SPEEDS. CONTROL MODULES SHALL BE LOCATED WITHIN 5 FEET OF THE ELEVATOR CONTROL PANEL.
 - PROVIDE DEDICATED PHONE LINE FOR ELEVATOR CONTROLLER.
 - PROVIDE 120V SINGLE POLE LOCKABLE TYPE DISCONNECT FOR ELEVATOR CAB LIGHTS, P-03, CIRCUIT 30.
 - PROVIDE DISCONNECT WITH AUXILIARY DRY CONTACTS FOR HYDRAULIC ELEVATOR BATTERY LOWERING SYSTEM AND ELEVATOR SHUNT TRIP SYSTEM. DISCONNECT SHALL BE WIRED SUCH THAT IN THE "OFF" POSITION, THE LOWERING SYSTEM AND SHUNT TRIP SYSTEMS SHALL BE DEACTIVATED ALLOWING FOR ELEVATOR PIT ACCESS/MAINTENANCE. IN THE "ON" POSITION, ELEVATOR LOWERING AND SHUNT TRIP SYSTEMS SHALL BE DEACTIVATED. PROVIDE NECESSARY FUSING FOR ELEVATOR LOWERING AND SHUNT TRIP SYSTEMS DISCONNECT IN ELEVATOR PANEL.
 - REFER TO SPECIFICATION SECTION 16480 FOR CONTROL DESCRIPTION AND SPECIFIC STARTER REQUIREMENTS.
 - NOT USED.
 - PROVIDE LOW VOLTAGE THERMOSTAT JUNCTION BOX AND 3/4" CONDUIT FROM THERMOSTAT TO DUCT HEATER.
 - EF-07 SHALL BE CIRCUITED THROUGH SINGLE POLE CONTRACTOR. PROVIDE 120 VOLT, 20 AMP RATED CONTACTOR IN NEMA 1 ENCLOSURE FOR CONTROL OF EF-07. PROVIDE 2-#14 IN 3/4" CONDUIT FROM CONTRACTOR TO RU-01 PROGRAMMABLE THERMOSTAT FOR CONTROL OF FAN.
 - REFIT EXISTING COILING MOTOR AND PROVIDE NEW MOTOR WITH 240V CONTROL CIRCUIT. MOTOR TERMINALS TO BE PROVIDED AS SPECIFIED IN DIVISION 8.
 - ALL ELECTRICAL DEVICES IN THIS AREA SHALL BE RATED NEMA 4X. ALL RECEPTACLES IN THIS AREA SHALL BE GFI AND WEATHER PROOF. SPECIAL USE RECEPTACLES SHALL BE WEATHER PROOF.

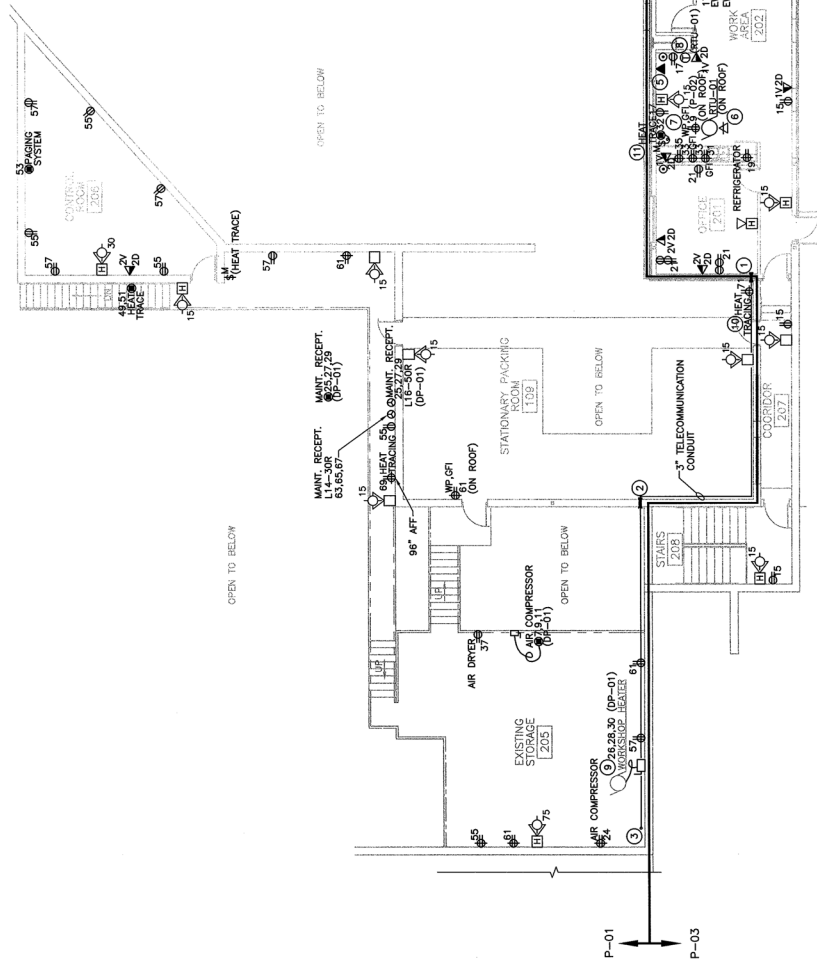


POWER AND SYSTEMS PLAN (EAST)

GENERAL NOTES:
 1. ALL ELECTRICAL DEVICES ON THIS SHEET SHALL BE CIRCUITED PER PANEL DIVISION LINES.

- KEY NOTES:
1. PROVIDE 3" CONDUIT SLEEVE THROUGH INTERIOR WALL ABOVE SUSPENDED CEILING FOR TELECOMMUNICATION CONDUIT.
 2. PROVIDE 3" CONDUIT SLEEVE THROUGH INTERIOR WALL FOR TELECOMMUNICATION CONDUIT.
 3. PROVIDE 3" SLEEVE THROUGH FLOOR SLAB FROM WORKSHOP FOR TELECOMMUNICATION CONDUIT. PENETRATION SEALANT TO MATCH EXISTING STRUCTURE FIRE RATING.
 4. HEAT AND SMOKE DETECTORS SHALL BE MOUNTED AT THE TOP OF ELEVATOR SHAFT.

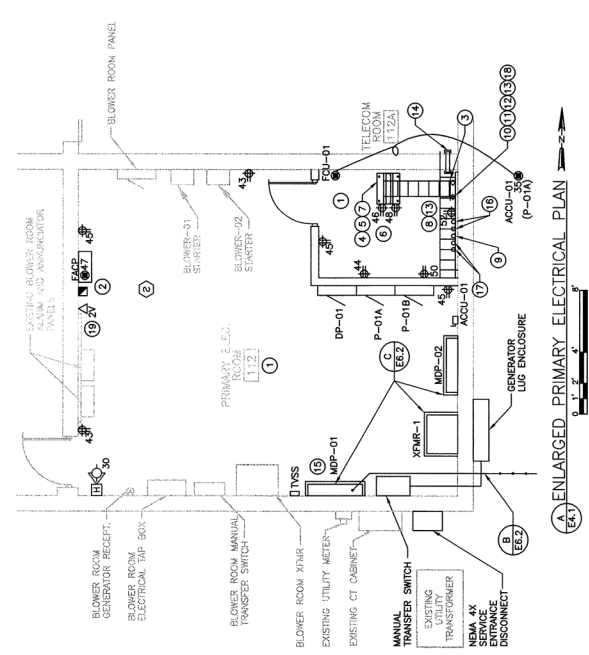

 1. SEE ONE-LINE DIAGRAM ON SHEET ES.2 FOR ADDITIONAL INFORMATION.

- REL. NOTES:**
- 1 ALL ELECTRICAL DEVICES IN THIS AREA SHALL BE CIRCUITED TO PANEL P-01A.
 - 2 FIRE ALARM CONTROL PANEL SHALL BE FED FROM A DEGRADED CIRCUIT BREAKER. CIRCUIT BREAKER SHALL BE RED IN COLOR AND PERMANENTLY LABELED FACT.
 - 3 PROVIDE TELECOMMUNICATIONS GROUNDING BUSBAR ON EQUIPMENT MOUNTING BACKBOARD. BOND EQUIPMENT RACKS TO TGB WITH #6 GROUNDING CONDUCTORS. TGB SHALL BE CONNECTED DIRECTLY TO MDP-01 GROUND GRID. PROVIDE 3/0 GROUNDING CONDUCTOR IN 1 1/2" PVC CONDUIT FROM TGB TO MDP-01 GROUND GRID.
 - 4 PROVIDE #4 FREE STANDING EQUIPMENT RACK. PROVIDE EQUIPMENT RACK SHALL BE MOUNTED ON RACK VERTICAL MEMBERS AT 24" AND 60" AFF. PROVIDE HORIZONTAL CABLE MANAGEMENT, 2-24 PORT PATCH PANEL (ONE VOICE, ONE DATA), 1-POWER STRIP/SURGE SUPPRESSOR AND EQUIPMENT GROUND BAR.

 - 11 WALL MOUNT PHONE SERVICE DEMARC AND ENTRANCE PROTECTION ON EQUIPMENT BACKBOARD. DEMARC AND ENTRANCE PROTECTION PROVIDED BY TELEPHONE COMPANY.
 - 12 PROVIDE 110 TERMINATION BLOCKS ON EQUIPMENT BACKBOARD FOR VOICE CROSS CONNECTS BETWEEN THE DEMARC AND THE PATCH PANEL.
 - 13 TERMINATE VOICE AND DATA STATION CABLES IN RACK MOUNTED PATCH PANEL. PROVIDE 1/2" GROUNDING CONDUCTOR TO STABILIZE RACK. BOND THE WALL SLEEVE AND THE EQUIPMENT RACK.
 - 14 PROVIDE 3" CONDUIT SLIDE THROUGH INTERIOR WALL FOR TELECOMMUNICATION CONDUIT. PROVIDE VERTICAL CABLE TRAY SECTION FROM CONDUIT PENETRATION TO HORIZONTAL CABLE TRAY.
 - 15 PROVIDE ADDRESSABLE CONTROL MODULE FOR ELEVATOR SHUNT TRIP CIRCUIT. ENLARGED PRIMARY ELECTRICAL PLAN

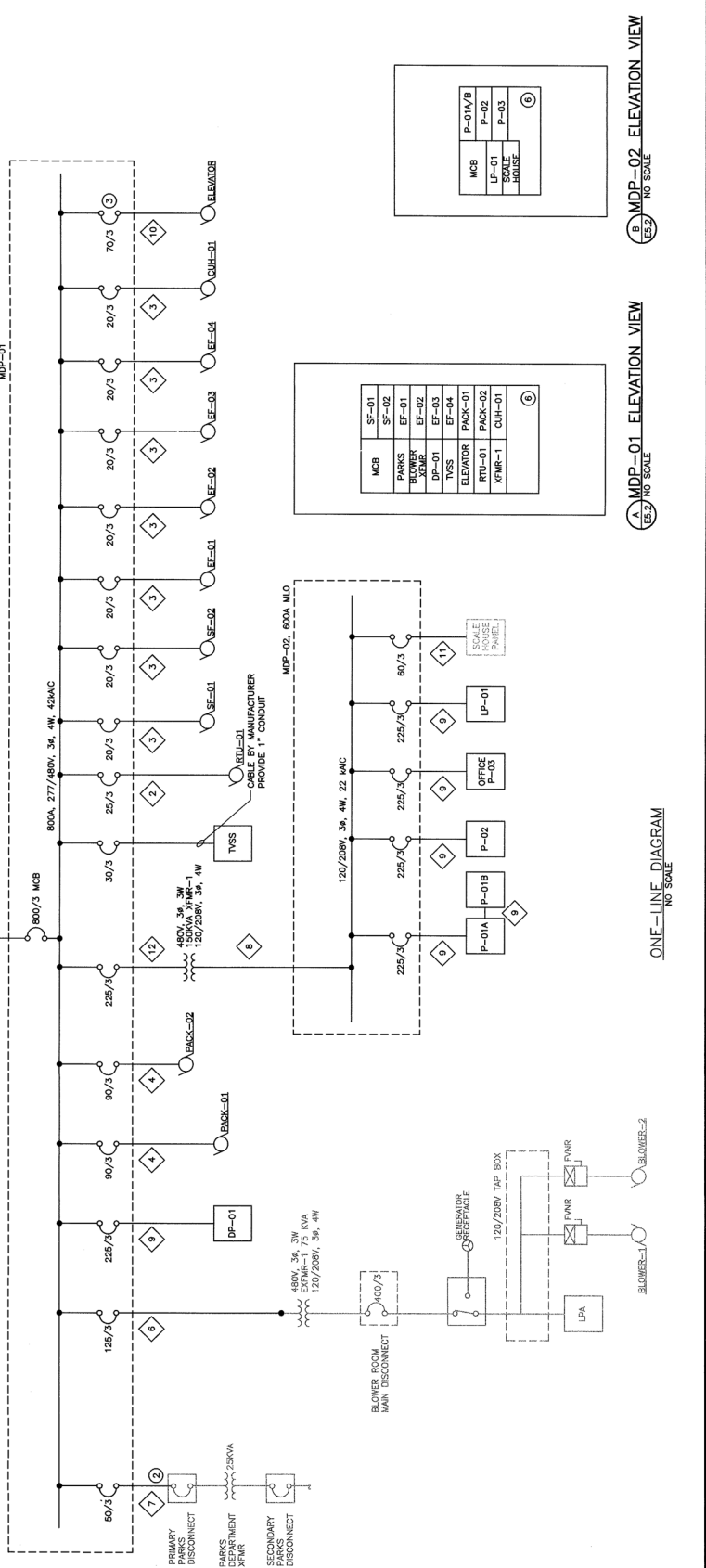
