 - 2. to direct the Chief to advise the named individuals of the stated conditions to the Board's approval of the preliminary recommendation to promote and to advise them further that any unsatisfactory performance or conduct occurring or coming to the attention of the department during the during the 18 months following the effective date of the Chief's preliminary recommendation shall be sufficient basis for separation from the department, whether by the Chief's determination in his sole discretion not to include the name in his final recommendation, or by recision of the Board's preliminary approval of the Chief's recommendation, or otherwise. - 3.. Report of Counsel: Herrick confirmed that the Initial Hearing in the pending Shabani matter will be scheduled for the regular August meeting on August 14, 2017.
