APPROVAL OF MINUTES

NEW BUSINESS ITEMS

- 2. Invite guests to speak regarding Emergent Immigration, Deportation and Housing Issues
 - Discuss how housing ties with the EOC
 - ICE @ City County Building invite representative from the Police/Sheriff Department
 - Invite Tenant Resource Center representative to provide an overview

Discussion was held regarding allowing a 20-minute presentation and with Questions and Answers for a total of 30 minutes. We planned to invite a representative from the Tenant Resources Center for the October meeting. Inviting a representative from the Police or Sheriff Department to discuss protocol or policy concerning ICE was considered. The November speakers will be Peng Her, The Hmong Institute, and Dane County Supervisor, Brenda Yang, and the December speaker will be Fabiola Hamdan, Dane County Immigration Affairs Office.

 - Initial Annual Retreat Planning

A discussion was held. The annual retreat planning is postponed due to staffing and will be discussed with the full commission. Possible retreat locations suggested were the Pinney Library and the location of last year's retreat, Fleet Services. Commissioner Esparza suggested was made to go ahead and start reserving the location for possibly in March. The Vice President proposed that if they see in January that staffing is still not there, then they can go ahead and do the planning at that time.

In addition, having one vacancy on the Executive Committee was discussed. The Vice President proposed that they wait until the regular nomination process in November for vote in January.

Updates were provided. The Hearing Examiner would have to call a meeting; however, another Commissioner will be needed to join this subcommittee. This was asked to be removed from the agenda until the EOC Ordinance Subcommittee has been reinstated and the Hearing Examiner has the time.

The Executive Committee would like to see a presentation on issues that management companies encounter with their renters and those with low income, Section 8 and Section 42 programs. Commissioner Klebba will call the Tenant Resources Center to make an inquiry to determine who to invite and will also reach out to Commonwealth for management company contacts.

Staff will ensure a reminder is sent to the Appeals Committee.
