- 4. Fire Dept. Report: AC Popovich presented the attached monthly report, noting that the interview steps in the current hiring process are now being planned and scheduled. Command staff

rotations will occur in February, with AC Popovich moving to Support Services and AC Laurenzi taking over personnel and training duties, inleuding working with the PFC.

- 5. Police Dept. Report: Capt. Snyder presetned the balance of the monthly report. The promotional cycle is on schedule. Applications for the next hiring cycle are very low, despite special efforts at trecruting and outreach; demographic information on the pool should be available for the December meeting. Several personnel files are ready for commissioner review in anticipation of upcoming promotions; Comm. Sparkman will arrange to conduct those reviews.

# Recruiting/Hiring

As we previously discussed, early application numbers for our next Pre-service campaign were above normal. Unfortunately the application numbers slowed significantly over the past two months. As the deadline of November 1st passed, we tallied a total of 640 applications. This is slightly down from 2015 when we received 681 applications. In fact there have only been three years, out of the last 25, when we have received fewer than 640. This is quite disappointing, particularly in the context of doubling down on recruiting efforts throughout the Midwest, spending more money on advertising than recent years and utilizing a larger cadre of recruiters. By December's PFC meeting we will have a full demographic breakdown of all our applicants.

Below is our current hiring process timeline for the 2017/2018 Pre-Service Academy:

- Written & Physical Agility Testing: November 6, December 11
- Consolidated Testing for Distant Candidates (those living more than 6 hours from Madison) - January 8, 2017

- Background Investigations: May begin immediately after an Oral Board interview, but no later than February, 2017
- Seek PFC Approval of Eligibility Hiring List March 2017
- **Trilogy:** Chief's Interview, Personality Assessment and Ride-Along with a Field Training Officer April 17-28, 2017
- Seek PFC Approval of Hiring List Candidates and Contingency List May, 2017
- Tentative Job Offers: May, 2017
- Medical Clearance: Mid-July, 2017
- Final Job Offers: Early August, 2017
- Academy begins: September 11, 2017
