Children's Disability Services

Eligibility: Age and disability requirements vary by program

Details:

- **Birth to Three Program** provides early intervention services for infants and toddlers from birth to age 36 months who present a 25% delay in their development, or have been diagnosed with a long-term disability or medical condition that affects their development.
- **Children's Long-Term Support (CLTS)** Medicaid Waiver is available to Medicaid-eligible children and youth under the age of 22 in Dane County who have a diagnosis of an intellectual and/or developmental disability, physical disability, and/or mental health disability who are living at home or in the community. Funding can be used to support a range of services based on an assessment of the needs of the child and their family.
- **Children's Community Options Program** provides a coordinated approach to supporting families who have a child with a

disability under the age of 22. The intention is to better support, nurture, and facilitate self-determination, interdependence, and inclusion in all facets of community life for the child and family not covered by other Medicaid-funded programs.

- **Vocational Futures Planning** provides services to transition age youth and young adults ages 18 to 21 with Intellectual and Developmental Disabilities (I/DD) to help reach work goals.
