Pursuant to Wisconsin State Statute 11.20, you are hereby notified of the requirement to file your July Continuing Campaign Finance Report

Finance report forms are available online at <a href="https://www.cityofmadison.com/election/candidateResources/">www.cityofmadison.com/election/candidateResources/</a>. The short form (ETHCF-2a) may be used if you did not receive contributions, make disbursements, or incur obligations during the reporting period. The long form (ETHCF-2L) must be used if there were any transactions.

The Clerk's Office accepts reports via e-mail or fax; there is no need to follow-up with a hard copy. E-mail your complete and **signed** report to <u>clerk@cityofmadison.com</u> or fax it to 608-266-4666.

Reporting Period: January 1, 2020 through June 30, 2020 (unless you submitted a preelection report this year, then it is March 19, 2020 through June 30, 2020).

Deadline: July 15, 2020

The penalties for failure to file the Campaign Finance Reports are stated in Wisconsin Statutes 11.60 and 11.61. State Statute 11.22(5) requires that a list of delinquents be available for public inspection. This list is posted on the City Clerk's Office bulletin board, and on our website.

You are responsible for familiarizing yourself with the campaign finance requirements that apply to your committee/campaign, which you may obtain from either the Wisconsin Statutes or from your private attorney. In carrying out the election duties assigned by State Statute, local officials/filing officers do not represent candidates or committees. Accordingly, it may be necessary for you to direct some specific questions about your campaign finance obligations to the Wisconsin Ethics Commission. Keep in mind that the information you receive may not be interpreted as legal advice or a release from your responsibility to comply with the law.
