Register to Vote

- **Up to 20 days before an election**, you can register to vote at the front desk of any City of Madison agency with proof of address (Res-16-00491).
- **Up to 20 days before an election**, you can register online at <https://MyVote.wi.gov> if you have a Wisconsin driver license or Wisconsin ID, and you have updated your address with the DMV (can update DMV address online).
- **Up to 20 days before an election**, you can register to vote through the mail with proof of address.
- **Within 20 days of an election**, you can register in the City Clerk's Office or any Madison absentee voting location with proof of address. There is no registration the Saturday, Sunday, or Monday before an election.
- **On Election Day** you can register to vote at your polling place with proof of address. To find your polling place, visit www.cityofmadison.com/WhereDoIVote.

Acceptable Proof of Address for Voter Registration (may be electronic)

Note: you only prove your address at the time you register to vote

- A – Affidavit from agency providing homeless services
- B – Bank/Credit Union statement, credit card statement, mortgage statement
- C – Care facility intake document
- G – Government document/check (public school, city agency, public library, county agency, state agency, federal agency, or tribal government)
- H – Certified housing list from UW-Madison or Edgewood College
- P – Paycheck
- R – Residential lease current on the day of registration (this option is not available for registrations sent through the mail)
- S – Student ID & Edgewood fee statement
- T – Tax bill (this year or last year)
- U – Utility bill (water, gas, electric, cable, internet, cell phone, landline phone)
- W – WI driver license/ID (unexpired)

Acceptable Voter ID at the polls (address on ID does not matter)

Note: you prove your identity every time you vote. Voters without acceptable ID may cast a provisional ballot at the polls.

- Wisconsin driver license expiring after 11/6/2018
- WI DOT-issued photo ID card expiring after 11/6/2018
- U.S. passport expiring after 11/6/2018
- Military ID card expiring after 11/6/2018
- Certificate of naturalization issued within last 2 years
- Unexpired Wisconsin driver license or state ID receipt
- ID card issued by a federally recognized Indian tribe in Wisconsin
- ID issued by a Wisconsin accredited university or college—must contain issuance date, student signature, and expiration date within 2 years of issuance, along with proof of current enrollment.
- Unexpired Veterans Affairs ID card
