Project Location	Alder District	Proposed Improvements
East Washington (US Hwy 30 to Annamark)	17	This project includes a number of improvements to address safety and connectivity for people walking and biking including lighting, pedestrian signal improvements, enhanced crosswalk marking and signage. The proposed project also includes filling sidewalk gaps on the south side of the street, adding a shared-use path connection on the north side of the street, driver speed feedback boards and adding wayfinding signage to help people navigate this area.
Schroeder Rd (Whitney Way to Gammon Rd)	19, 20	Proposed improvements included reducing the speed limit to 25 mph , adding medians to narrow the road, new marked crosswalks, driver speed feedback boards, and bus stop improvements. Funds are also included to add trees in the median and placemaking to support the new speed limit.
