

Area Plans: Background

- The Common Council adopted a new approach to planning in 2022 to simplify and standardize the City's planning ([Legistar 71147](#)).
- The Planning Division now has two main approaches to planning:
 - Comprehensive Plan – citywide plan; lower level of detail; broad process and public engagement
 - Area Plan – city split into 12 areas; more detail; focused planning process and public engagement




Previous Planning Approach: Variability


- Sub-area plans vary widely in:

Area Plans Benefits: Coverage





Area Plans Benefits: Sequence

Area Plans Benefits: Consistent Topics

Consistent Topics:

1. Land Use
 2. Transportation
 3. Neighborhoods & Housing
 4. Economy & Opportunity
 5. Culture & Character
 6. Green & Resilient
 7. Effective Government
 8. Health & Safety
- Focus on physical changes: infrastructure, amenities, guiding private development
 - Street network/connection
 - Shared-use path network
 - Building heights
 - Urban design districts
 - Historic resources
 - Park access
 - Etc.

Area Plans: Coordination

- Each area plan has an interagency staff team (IST) that includes staff from Engineering, Parks, Transportation, and many other City agencies
- IST meetings allow coordination of efforts and allow for more topics/projects to be covered through one planning process
- Area plan feedback can inform other City efforts
- Area plan process includes meetings with other jurisdictions – depending on the planning area that may include:
 - Wisconsin Department of Transportation
 - Dane County
 - School District(s)
 - Adjoining municipalities

Planning Process and Public Engagement

Phase Zero

Data Gathering and Review

- Plan authorization by Common Council
- Pop-up engagements (Parks Alive, resource fairs, etc)
- Small group meetings (PTOs, Neighborhood Associations, etc.)
- Online interactive commenting map
- Background data gathering
- Regular email notifications and website updates (applies to all phases)

Phase One

Issues and Opportunities

- Open house and public meetings (in-person and virtual)
- Community survey
- Focus group meetings
- Small group meetings (PTOs, Neighborhood Associations, etc.)
- Check-in with City Boards, Commissions, and Committees
- Check-in with adjacent municipalities and school districts

Phase Two

Develop Recommendations

- Outreach to businesses
- Art workshop
- Public meetings (in-person and virtual)
- Focus group meetings
- Small group meetings (PTOs, Neighborhood Associations, etc.)
- Check-in with City Boards, Commissions, and Committees

Phase Three

Draft Plan Review

- Public meetings (in-person and virtual)
- Focus group meetings
- Public feedback on Draft Plan
- Check-in with adjacent municipalities and school districts
- Small group meetings (PTOs, Neighborhood Associations, etc.)

Phase Four

Adoption and Implementation

- Plan review and adoption by City Boards, Commissions, and Committees
- Implementation of Plan recommendations
