- They can assign Officers to monitor traffic flow and speed, or enact a pro-enforcement stance on certain roads or for certain offenses. This can involve Patrol Officers, Neighborhood Officers, the District's Community Policing Team, and/or the Traffic Enforcement Safety Team (T.E.S.T.)
- For physical changes to the roadway (lights, roundabouts, speed limits), consult Traffic Engineering

## What is the Department Structure? How Many Officers do you have?


- 492 Sworn Officers at all ranks, including those in the academy
- 92 non-sworn/professional staff.
- Major organizational units in the Department are:
  - 6 Patrol Districts
  - Investigative Support Bureau
  - Community Outreach
  - Traffic and Specialized Services
  - Records and Court Services
  - Finance
  - Training/Academy
  - Executive Section

### What are the boundaries of my District?



#### What Are the Goals of the District

- Goals will vary from unit to unit, or District to District.
- Your district commanders will know what the District's specific annual goals are.
- In addition, any Officers you encounter should be able to tell you the crime prevention, crime reduction, and traffic enforcement priorities for their district.

### What is Stratified Policing?

- Stratified Policing is a combination of crime analysis, problemoriented policing, and accountability, with the goal of shifting Departments from a reactive policing model to a proactive one.
- A major focus is on leveraging best/most appropriate resources to identified problems, with the most appropriate leadership for the scope of the problem.
- Department leadership has received training on the topic;
   Department-wide and unit-specific training to commence in 2023

### What are the plans for Mifflin St? Halloween?

- Planning for these events begins months in advance. In the case of Halloween, early meetings help determine the scope of the event (e.g. is it sponsored or not). MPD, MFD, Traffic Engineering, and the Mayor's Office are the key participants at this stage.
- The Special Events Planning section creates operations plans, identifies resources needed, and staffs the various assignments. Typical assignments include Special Events Team, SWAT, Command Post, Traffic Control, Strike Teams, Arrest Transport and Processing.
- Central District Command connects with community partners regarding expectations, plans, etc. For Mifflin, the focus is on the residents and landlords in the neighborhood. For Halloween, the focus is on the taverns. City Attorney, Licensing and Vending, Traffic Engineering, and UW Dean's Office may also be involved.

### How Can I file a complaint against an Officer?

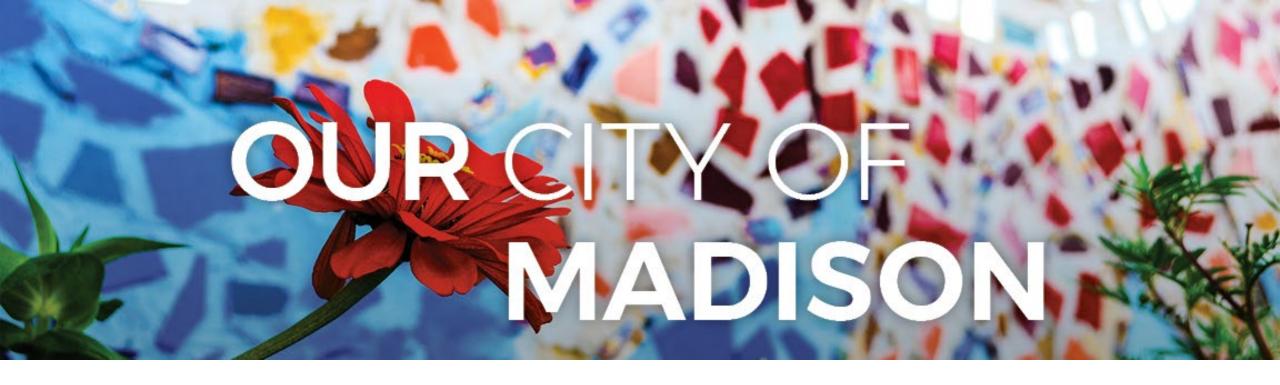
- We accept complaints in a variety of ways:
